## County Agent J. M. Cooper Cited for Leadership, Service In Screwworm Eradication Job

A certificate of appreciation has been presented to County Agent J. M. Cooper for his active support of the screwworm eradication program. The presentation was made Friday afternoon by Oscar Schaefer, chairman of the county eradication committee.

Schaefer commended Cooper and Assistant Agent Bill McCutchen for devoting many hours to the popular eradication project. He noted that the agent has been the key man in the county concerned with screwworm eradication activities, serving as an important link between program officials and local farmers and ranchers.

Total funds contributed by the county toward the program amounted to \$8,000. All five banks in Eastland County accepted the voluntary contributions.

Stark results from the program are evident in this county which had "thousands" of cases of Screwworm attack in 1962. There were 14 cases in 1963 and no cases in 1964. There were only 56 cases in the state last year.

There are about two dozen species of flies that lay eggs in animal wounds along with

the screwworm fly, Schaefer said, but only the larval of the screwworm will eat rotten flesh. After hatching in the wound, it burrows to good flesh and sucks the blood and body fluids, thus resulting in the ultimate death of the animal. ## Olden Group To Meet With Commission Monday Night

The Olden Water Committee is expected to appear before the Eastland City Commission at its regular monthly meeting Monday evening to ask for a definite commitment for the sale of water to the proposed Water System.

Both Eastland and Ranger city officials are confronted with the problem that their respective towns are using nearly all the water that is guaranteed to them by the Water District at certain periods during the summer. The district and cities have contracts providing that a minimum of 1,800,000 gallons will be available to both towns per day. Last year Eastland

used an average of some 1,400,000 gallons during the month of July.

The Olden residents are also considering negotiating with Water District to buy raw water, and include the cost of piping from the present filter plant, and adding a filter plant of their own in their original FHA building loan. Designers have estimated that their base water system will cost about \$88,000. It is estimated that a line could be laid for about \$15,000 and a filter plant for about \$25,000, making their total 40-year program come to about \$118,000. It is about two and a quarter miles from the filter plant to Olden.

Eastland and Ranger each pay the District seven cents a thousand gallons for treatment. (Continued on Page 2.)

ed water, plus both pay a monthly fixed amount of \$3,743 to the district toward the retirement of debts. Olden residents reason that they should be permitted to purchase the water for approximately 25 cents per thousand, which would include seven cents (Eastland's price), plus five cents for usage of the 14-inch line from a point at the filter plant to the Olden limits, plus three cents for proportioned share of taxes and ten cents for profit. Both Eastland and Ranger officials have assured the Olden people that they want to help in every way possible and to help the town as they can. Of the two towns, Eastland appears to be the logical seller because of its proximity to Olden, but it remains to be seen if the city can "spare" the water to sell, and at what price.

herd in 1962). Savings from medications, gas, oil, labor, wear and tear, besides frustration and worn nerves from elimination of screwworms has meant a savings of thousands of dollars to livestock raisers in this county, he said. Total value of the livestock and livestock by-products such as milk, mohair and wool amounts to around \$4 million annually.

Schaefer also expressed thanks to all contributors and workers in the campaign. He further stated that if and when the Southwestern Animal Health Research Foundation, Dolph Briscoe Jr., of Uvalde, president, initiates another voluntary fund-raising campaign that his group will seek the aid and cooperation of all farmers, ranchers and others interested to keep the pest controlled.

substandard drivers and to remove totally unqualified, dangerous and lawless drivers from the streets and highways through denial or revocation of license quickly and surely.

More highway patrolmen—The National Safety Council has repeatedly affirmed that the Texas Department of Public Safety and its Highway Patrol are among the nation's best in performing their duties—but there aren't enough of them. "Texas needs higher pay for its career patrolmen, at least 100 more men each year until its present strength (791 men) is doubled, to about 1,800 to 2,000 men."

Driver education for all teen-agers—It will be proposed that state aid be provided for driver education in the public schools through the Gilmer-Aikin Minimum Foundation Program.

Traffic Courts of Record—Presently, a frequent violator may not only find ways of delaying his trial; he may eventually "wear out" the case and have all charges dismissed. Establishing the corporation and Justice of the Peace courts as courts of records will help prevent this, because appealed cases to higher courts (county, etc.) will be reviewed on the basis of the original trial, rather than "re-trying" the case because the lower courts was not a court of record—after the evidence is "cold," and witnesses "scattered."

# 9 County Firms Asked Financial Statements

J. Hemphill, district manager of the Fort Worth office of Dun & Bradstreet, announced statement requests were mailed to 379 firms in Eastland County. He said figures obtained from a physical count of the Dun & Bradstreet Reference Book for January, 1965, Hemphill noted that each firm's business concerns in the United States are listed by Dun & Bradstreet for copies of their financial statements. This year's figures are being sent to three million business men — to the corner grocer or to the newspaper publisher — as well as to the attorney, banker, insurance broker, wholesaler, and retailer who seek or grant credit but it does not include some of the services of professional business men such as beauty and barber security dealers and estate brokers. There are 150 firms in the United States whose sales are higher than the million quoted above. In the past year, 220 changes were made in the Dun & Bradstreet Reference Book of Eastland County firms, including 73 new firms, 64 names deleted, and 83 changes in the status of continuing businesses. The changes occurring in Eastland County are about the same as the rest of the country where a change of significance is counted every five seconds.

# Legion Opposes Closing Two VA Posts, Hospital

AUSTIN — The Veterans Administration's disclosure that it will close two regional offices and one hospital in Texas, comes as a shock to the American Legion, according to Department Commander Lewis W. Emerich of Houston.

Under the plan the VA offices in Lubbock and San Antonio and the McKinney Hospital will be closed, effective June 30.

At its State Convention in San Antonio last year, the Legion adopted a resolution asking for additional beds in the McKinney Hospital due to the long waiting lists. More beds are needed, not less. These patients cannot be transferred to the Dallas VA Hospital, for they are already extremely overcrowded with a long waiting list. Closing of McKinney will cost the north Texas area 312 sorely needed beds, and will further tax the facilities at Dallas.

The American Legion fails to see how money can be saved in consolidating the San Antonio VA Office with Houston and the Lubbock office with Waco, Emerich added. "Does the VA realize how far it is from Amarillo or El Paso to Waco? The extra costs to the government in travel and per diem would offset any savings realized by putting employees out of work."

The closing of these facilities will eliminate jobs for about 600 trained people. These will be thrown into the labor market, thus increasing unemployment.

**1 A Modern Driver License Law**

The Texas driver license law has not been revised substantially since 1941. By all standards, many of its provisions have become obsolete, and time has proved that it is inadequate to do the job for which it is intended — to protect the average driver from the small percentage of dangerous drivers who repeatedly refuse to operate motor vehicles in a safe and legal manner.

The proposed revision of the Texas Driver License Law is designed to plug numerous loopholes through which wanton violators of the laws of safety who have long records of lawlessness can presently retain a valid driver's license and continue to endanger the life and property of others.

For example, there have been cases where people have been killed by drivers with extensive records of flagrant law violations while in the act of committing another serious violation and holding a valid driver's license. The proposed new law would help to remedy this situation, and make many other badly needed improvements in the driver license law. These would include:

1. Authority to give special attention to the improvement of substandard drivers.
2. Authority to remove totally unqualified, dangerous and lawless drivers from streets and highways through denial or revocation of license quickly and surely.

**TEXAS MUST KEEP PACE**

Its accident prevention programs must be as up-to-date as space-age living. In 1963:

- Texas' 2,729 motorcides were 13% higher than in 1962.
- Texas traffic killed one person every 3 hours and 12 minutes.
- Texas motor vehicle accidents cost \$13.72 per second.

**2 More Highway Patrolmen**

**Adequate pay!**

The National Safety Council has repeatedly affirmed that the Texas Department of Public Safety and its Highway Patrol are among the nation's best in performing their duties.

But the Texas Highway Patrol is operating with less than half the number of men needed to cover our vast highway system, based on national standards, and is finding it increasingly more difficult to fill the ranks because of inadequate salaries to compete with industry.

Records of the National Safety Council show that Texas has 791 patrolmen looking after 32,440 miles of paved state highways as compared with 2,707 patrolmen for 11,110 miles of paved roads in California and 2,180 men on 20,730 miles in Pennsylvania. Illinois has 1,304 patrolmen for 12,610 miles of state roads, and Ohio has 1,178 men for 15,730 miles.

A considerable percentage of all Texas traffic crashes are not investigated by the Highway Patrol because there are too few Patrolmen, although they average 54 hours a week, longer in emergencies and without overtime pay.

Texas needs higher pay for its career patrolmen, at least 100 more men each year until its present strength is doubled, to about 1,800 to 2,000 men.

**3 Driver Education For All Teen-Agers**

Texas is pouring some 150,000 new Teen-Age drivers into its vast traffic streams every year. Less than half receive any training in the arts and skills of driving an automobile, yet most of them drive.

For years now, about one-fourth of the Texas traffic death toll is composed of young Texans from 15 to 24 years of age, and they are involved in 31% of the rural-traffic crashes while holding 20% of the driver's licenses.

In many other states, reliable studies indicate this crash involvement can be reduced by 50% among trained young drivers as compared with their untrained classmates.

While a high school education is estimated to cost about \$15,000, Driver Education courses are being taught in various Texas high schools at \$40 to \$110 per student. This is a tremendous educational bargain.

But Driver Education still costs more than some schools and some students can afford, so it is proposed that all Texas students shall have the opportunity to learn how to stay alive in Texas traffic through proper high school training. To make this possible, it is proposed that state aid be provided for driver education through the Gilmer-Aikin Minimum Foundation Program, long and successfully used in our state to provide all school district and students with minimum-level high school education.

**4 Traffic Courts of Record**

Texas traffic cases are tried by Corporation Courts in the cities, by Justice of Peace courts in rural areas.

No written record is kept in these courts, so that any case which is appealed to a higher court is tried all over again.

In many counties, county courts receiving these appeals are overloaded, since they handle many other types of cases, too. Delays in trials may stretch into months or years; witnesses may move away; facts grow stale; a new judge may "clear the docket" and may dismiss hundreds of cases in which all defendants are cleared without trial.

A frequent violator may not only find ways of delaying his trial; he may eventually "wear out" the case and have all charges dismissed.

Both the American Bar Association and the State Bar of Texas have favored establishment of courts of record for traffic cases. The State Bar has proposed traffic courts of record which would also be empowered to try more serious traffic cases—driving while intoxicated, driving while license is suspended, homicide and assault cases—which present Corporation and Justice Courts may not hear.

Traffic Courts of Record, operating under standards established by the Association of Chief Justices of State Supreme Courts and the American Bar Association, can provide immediate, fair and impartial trials. Thus, traffic defendants may be found innocent or proven guilty, but in either event, these courts can administer justice efficiently and fairly.
