Henry Pullman Gives Program At Rotary Club

Longtime Eastland resident Henry Pullman gave a review of his life in Eastland and the United States since immigrating from Lithuania some 50 years ago and his reasons for being a Rotarian at the weekly Rotary luncheon held at noon Monday at the White Elephant Restaurant.

Pullman, who was introduced by program chairman Jack Germany, left Lithuania some 50 years ago. The 65 year old Orthodox Jew stated that he was a member of the Sherrod Israel Temple in Dallas and was born on the border of East Prussia near Russia and Germany. He was one of 10 children, three of whom survived World War II. He went to elementary school in Russia and received his higher education in Germany.

After graduating in 1913 he worked in a department store and applied for and received a job as a smuggler of black-market goods. After being caught, he finally came to Germany and later to Galveston where he lived with his uncle and sister.

He worked in a junk yard in Amarillo, then joined the Army after war broke out. He was sent to Fort Bliss. After the war he returned to Amarillo and married his wife, Tillie. He worked for his father-in-law until coming to Eastland where he ran a grocery business. Eventually he opened a junk yard business. He is a member of the VFW, American Legion, Masons, Shriners and Rotary. He has been a Rotarian since approximately 1929.

Rotary visitors included E. W. Mince of Cisco, V. L. Clements and E. W. Berry, both of Abilene, and R. E. Stearns of Overton.

John Moore was introduced as a new Rotary member.

Membership Data Is Outlined In By-Laws

ARTICLE V. (Membership Certificates-Seal).

Section 1. (Certificates of Membership) The certificates of membership in the corporation shall be in such form, not inconsistent with the charter, as shall be prepared or approved by the Board of Directors. The certificates shall be signed by the president or a vice-president, and also by the secretary-treasurer.

All certificates shall be consecutively numbered. The name of the person owning the certificate, the amount of his contribution to the capital of the corporation, and the date of issue, shall be entered on the corporation's books.

No certificate shall be valid unless it is signed by the president or a vice-president, and by the secretary-treasurer. All certificates surrendered to the corporation shall be

County Grand Jury Probing July 4 Slaying At Ranger; Battle, Witnesses Testify

The case of James Will Battle, 49-year-old Negro hotel owner charged with murder in the shooting death of Don Gonzales, 45, in Ranger on July 4, is being weighed by the grand jury which convened for the summer term at Eastland Tuesday.

Five other cases also are being investigated by the grand jury, according to Earl Conner Jr., county-district attorney.

These include one for burglary of an automobile, two cases of child desertion, one theft by false pretext, and one case of driving while intoxicated.

During the opening day's proceedings, the grand jury heard testimony in the Ranger murder case and also weighed evidence in the auto burglary and one of the child desertion cases.

Testimony of seven witnesses were heard by the grand jurors Tuesday in the Battle

case: Billy Ray Collins, Fanny B. Cook, Johnny Tucker, Battle, the defendant, all colored of Ranger, Lupe Costero, Les Barnett and Herbert G. Hess.

Further probe of the murder case is expected when the grand jury reconvenes Thursday morning at 9 o'clock, County-District Attorney Conner said.

Firemen Halt Sunday Blaze At Lake Leon

About 500 acres of range and grassland near Lake Leon were ravaged by a roaring fire Sunday. But cabins in the vicinity — valued at about \$100,000 — were saved.

The blaze was touched off about 3:30 o'clock Sunday afternoon and was not brought under control until about 10:30 p.m.

About 30 firemen from Ranger, Eastland and Gorman battled the raging fire with three trucks.

"I bet the wind was blowing 50 miles an hour, Eastland Fire Chief Robinson said. "We couldn't catch it, we just had to wait. It had to go to the road — and then it jumped the road on us!"

The fire started on FR 570 on the old Dr. Weir place, belonging to his daughter, Mrs. Pete A. Jameson, a cattle rancher. A man told officials that he had seen another man — who apparently is known by name — stop a car and set the blaze. About a mile of fence — about half the ranch's fence-line — was destroyed along with the grass.

The blaze burned down to the shore on the north side. About 15 living units, tourist courts and private cabins in the vicinity were not damaged.

At first Chief Robinson and Sheriff Lee Horn speculated arson might have been involved. An investigation, however, indicated that it probably was an accident. They said the fire probably started as the result of a match or cigarette carelessly tossed from a passing automobile.

BLACKLEG REPORTED ON AREA FARMS. CALVES DIE

A reported outbreak of blackleg in the Sabanno, Atwell and Nimrod areas resulted in increased sales of blackleg serum last week, according to reports from suppliers of veterinary medicines.

A Baird veterinarian determined that the disease was the cause of death of four calves at the Lewis Brawley place, two miles east of Sabanno. A veterinarian was said to have given the same report on two animals owned by Jim Hewes of Atwell.

Although most ranches customarily vaccinate all cattle in their pastures, some of the smaller herds do not always receive this protection, it was said. An infectious disease, blackleg is usually fatal to young cattle. It is characterized by high fever and crackling swellings under the skin and is thought to be sometimes prevalent in swine and sheep.

Livestock losses from undetermined causes have recently been reported by scar Shafer of Sabana, several residents of he Nimrod vicinity, and the W. B. Holcomb farm.

The Board of Directors, when satisfied that such certificate has been lost and that the steps necessary for the protection of the corporation have been taken, may thereupon cause to be issued a new certificate in lieu of the certificate lost, and shall show on the membership records of the corporation the fact of such loss and issuance of the new certificate.

Section 3. In order to maintain the corporation as a strictly nonprofit, civic organization, and to further the purpose set forth in the charter, no certificate of membership shall be transferred to any person other than the heirs, legatees, or legal representatives of an individual member or the successor of a firm or corporate member without the approval in writing of the Board of Directors. At the time that application is made for the transfer of any certificate, the corporation shall have the privilege of purchasing such certificate for the amount of the contribution to the capital of the corporation shown in the face thereof. The certificates of membership in the corporation shall be transferable on the conditions above stated by the holder thereof in person, or by his duly authorized attorney, upon surrender and cancellation of such certificate properly endorsed.

Section 4. (Dividend) No dividend shall ever be declared or paid from the profits of the corporation, but any and all profits accruing or earned shall be placed in a surplus fund to be used in the furtherance of the purposes and objectives of the corporation.

Section 5. (seal) The Board of Directors shall provide a corporate seal which shall be in the form of a circle and shall have inscribed thereon the name of the corporation and the words "Corporate Seal". The seal shall be in charge of the secretary-treasurer.

ARTICLE VI. (Fiscal Year) The fiscal year of the corporation shall begin on the first day of July and terminate on the 30th day of June in each year.

State Capital NEWS

By Vern Sanford

AUSTIN—A study of the recent party primaries and runoff elections reveals that the number of Republican candidates on the upcoming General Election ballot, in the grassroots area, will strengthen the ever-growing trend toward a complete two-party state.

For example, 18 Democratic nominees for sheriff will face Republican opponents in November.

Also, the Republican party is engaged in one county judge race (in Lubbock County); seven races for county attorney; two for county clerk; 12 for county tax assessor; two for county superintendent of schools; and 78 for county commissioner.

GOP also has candidates for most top state posts and for more than half of the 150 House of Representative posts. In addition George Bush will carry the Republican banner in the U. S. Senate race against incumbent Democrat Ralph W. Yarborough.

Gov. John Connally returned from the national Governors Conference in Cleveland, Ohio, with an important new appointment. His selection as first chairman of the Democratic Governors Caucus was a unanimous one by the 50 Democratic state chief executives.

Reportedly, Connally also was given some consideration for chairman of the 1965 Governors Conference, although he is in his first term. The governors will hold their first major caucus just before the National Democratic Convention in Atlantic City, N. J., during August.

Texas National Guard Association expressed concern over reports that U.S. Department of Defense would stop logistical support to the so-called "reinforcing reserve."

These units, said NGAT, would provide a mobilization base on which the country would build its force in event of large-scale war.

Texas' 49th Armored and 36th Infantry divisions are both part of this "reinforcing reserve," as is the 90th Reserve Division.

Texas had a total of 10,325 manufacturing plants which added \$6,400,000,000 of value by processing raw materials into finished goods in 1962, according to the "Annual Survey of Manufacturers," recently released by the Bureau of Census.

Figures represent an expenditure for new plants during a single year. Some 500,000 plant workers earned a total of \$2,700,000,000 for the year, while 350,000 production workers earned \$1,600,000.

Food processing was the largest employer with 80,239 employees. Biggest investment was made by the chemical industry, with \$167,000,000 in new capital expenditures.

The petroleum refining industry spent \$155,000,000 for plant construction and improvement.

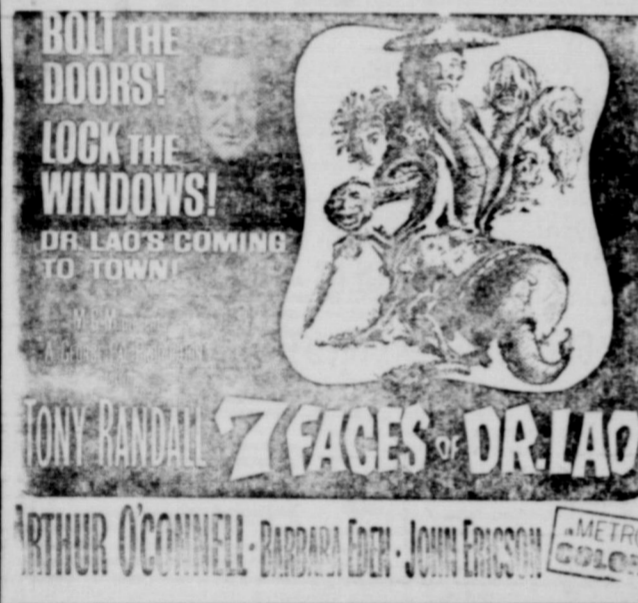
