Persons knowing of or seeing stray cats or dogs have been asked to contact the city hall or the city police and the animals will be picked up. They were especially warned about rabid skunks, which are particularly bad about spreading rabies.

Investigation Begins As Man's Skeleton Is Found

County Officers Checking Matter

Eastland County authorities launched an investigation Monday after the discovery of a man's skeleton in a pasture northwest of Eastland in the Yellow Mound community.

The complete skeleton, believed to be that of a middle aged man, was discovered by a farm hand employee of R.

The possibility that the skeleton might be that of a Latin American who disappeared from the Gordon Woods Ranch in the Yellow Mound area two years ago was being investigated Wednesday, this newspaper learned from reliable sources.

The Latin American — Jesse Torres — was a young man who had been ill and left the ranch where he worked. He was reported seen several places in the community but an extensive search conducted for a week or more failed to find him.

It was understood that authorities planned to have a dentist, who employed the man at one time, check the skeleton's teeth for possible identification.

M. Sneed of Eastland in a pasture seven miles northwest of Eastland. The pasture is leased by Mr. Sneed from Mrs. Roy Miller for grazing purposes.

The skeleton was discovered at about 9:30 a.m. Monday morning. By noon Sheriff Lee Horn, Deputy Sheriff Lefty Sublett and District Attorney Earl Connor Jr. went to the site and moved the remains back into Eastland where they were stored in a box at the sheriff's office. They were to be re-assembled by physicians, it was reported.

Plans also included having a longtime Eastland dentist examine the skeleton teeth which appear to be those of an adult male. The teeth include two bridged teeth and four gold-capped teeth.

A black leather sport shoe with white stitching and a white shoe lace was found with the skeleton. Portions of one foot's toe bones were still in the shoe, positively linking it with the skeleton, Sheriff Horn said. The shoe, approximately a size 6, was in good repair, but was very small and indicated a man of small stature.

Investigating officers said that indications were that the skeleton was definitely not buried, but on top of the ground when the body was deposited. Sheriff Horn estimated the bones had been in the pasture from 12 to 15 years. They were bleached white by the sun.

Persons knowing of relatives or others missing in the last 10 to 20 years who had gold capped teeth were asked to contact the sheriff's department for further identification. Sheriff officials stated that there is a possibility of the missing person's division in Washington being called in to help solve the mystery.

More complete information on the skeleton, including size, age and definite identification as to male or female is expected after the bones are re-assembled by physicians.

Contract, Power, Funds Directed for Foundation

(ED: NOTE: This is the third in a series outlining the by-laws of the Eastland Industrial Foundation Inc. Eastland residents are being urged to clip and save the articles for permanent reference.)

Section 8. (Contracts) Inasmuch as the directors of this corporation are likely to be connected with other corporations with which, from time to time, this corporation may have business dealings, no director of this corporation who has a substantial interest in, or is an officer or director of, such other corporation, shall be entitled to vote on any contract or other transaction between this corporation and such other corporation, but such contract or other transaction may be made, authorized or confirmed by this corporation if there shall be present at the meeting of the board of this corporation making, authorizing or confirming such contract or transaction, a quorum of directors not so interested in such other corporation, provided that such contract or

transaction shall be approved or ratified by the affirmative vote of at least a majority of the members of the Board of Directors who are not so interested.

The Board of Directors, at its discretion, may submit any contract or act for approval or ratification at any annual meeting of the membership, or at any meeting of the membership called for the purpose of considering any such act or contract; and any contract or act that shall be approved or ratified by a majority in interest of the members of the corporation represented in

Area Livestock Meeting Set At Brownwood

An area meeting to discuss livestock problems will be held Monday, July 13 at the Chisholms Restaurant in Brownwood according to Jack Cozart Rt. 2, Cisco, president of the Eastland County Farm Bureau.

Mr. Cozart urged all interested livestock producers in the county to attend the meeting which is one of eight being sponsored over the state by the Texas Farm Bureau. The meeting will begin at 10 a.m. and adjourn at 3 p.m., the county Farm Bureau added.

Main purpose of the meeting is to evaluate the current livestock situation and to give producers an opportunity to give their ideas on solving the various problems, Cozart said. Among subjects to be covered are: beef imports, declining prices, build-up in cattle numbers, present USDA actions to alleviate the problems, proposals for government programs for livestock, voluntary proportion programs, and related farm programs affecting the industry.

Discussing and evaluating these subjects will be Ed McKay, TBF assistant legislative director, and W. C. (Bill) Wedemeyer, TBF research and education director, both of Waco, District 7 Director Bill Joe Gist of Abilene will preside.

"The lizard feeds on beetles, caterpillars, grasshoppers, weevils and ants. The method employed in catching prey probably gave the lizard its familiar name of 'toad'. Like toads, the lizard flicks out its tongue, and its prey adheres to a sticky substance on the organ. This action is almost too quick for the human eye to catch, but the silent gulp of satisfaction as the prey is swallowed is quite evident. "A horned lizard measures from three to six inches in length, including the tail, and it is found throughout most of the state, particularly in regions of flat, dry land where vegetation is scanty. "This lizard is a welcome find to almost anyone who happens upon it, from small boys who love to claim it as a pet, to older observers who find it an intriguing little creature in spite of its ugly appearance."

(Continued From Page 1) person or by proxy, at such meeting (provided that a lawful quorum of members be there represented in person or by proxy), shall be as valid and as binding upon the corporation and upon all the members as though it has been approved and ratified by all members of the corporation.

Section 9. (Additional Powers) In addition to the powers and authorities these by-laws expressly conferred upon them, the Board of Directors may exercise all such powers of the corporation and do all lawful acts and things as are not by statute or by the charter or these by-laws directed or required to be exercised or done by the members. Without prejudice to such general powers and the other powers conferred by statute by the charter and by these by-laws, it is hereby expressly declared the Board of Directors shall have the following powers, that is to say:

(1) To purchase or otherwise acquire for the corporation any property, rights or privileges which the corporation is authorized to acquire, at such price or consideration and generally on such terms and conditions as they think fit; and at their discretion to pay therefore either wholly or partly in money, stock, bonds, debentures, or other securities of the corporation.

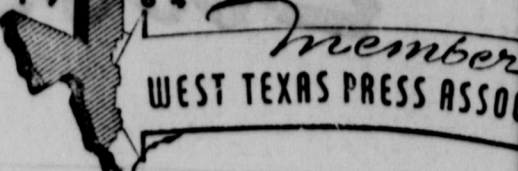
(2) To create, make and issue notes, mortgages, bonds, deeds of trust, trust agreements and negotiable or transferable instruments and securities, secured by mortgage or deed of trust on any real property of the corporation or otherwise, and to do every other act and thing necessary to effect the same.

(3) To sell or lease the real or personal property of the corporation on such terms as the board may see fit and to execute all deeds, leases and other conveyances or contracts that may be necessary for carrying out the purposes of this corporation.

(4) To delegate any of the powers of the board in the course of the current business of the corporation to any standing or special committee or to any officer or agent, and to appoint any persons the agents of the corporation with such powers (including the power to subdelegate) and upon such terms as they think fit.

Section 10. (Compensation of Directors and Officers) Directors and officers, as such, shall not receive any salary for their services, but by resolution of the board, expense incurred in the corporation's business may be refunded.

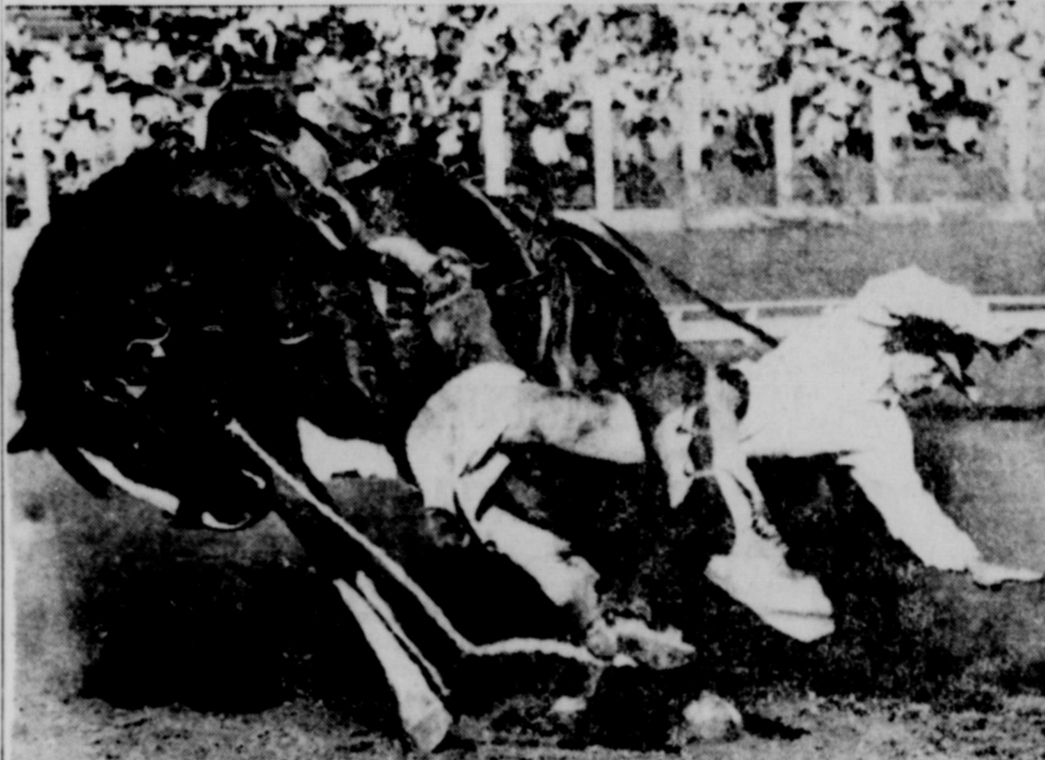

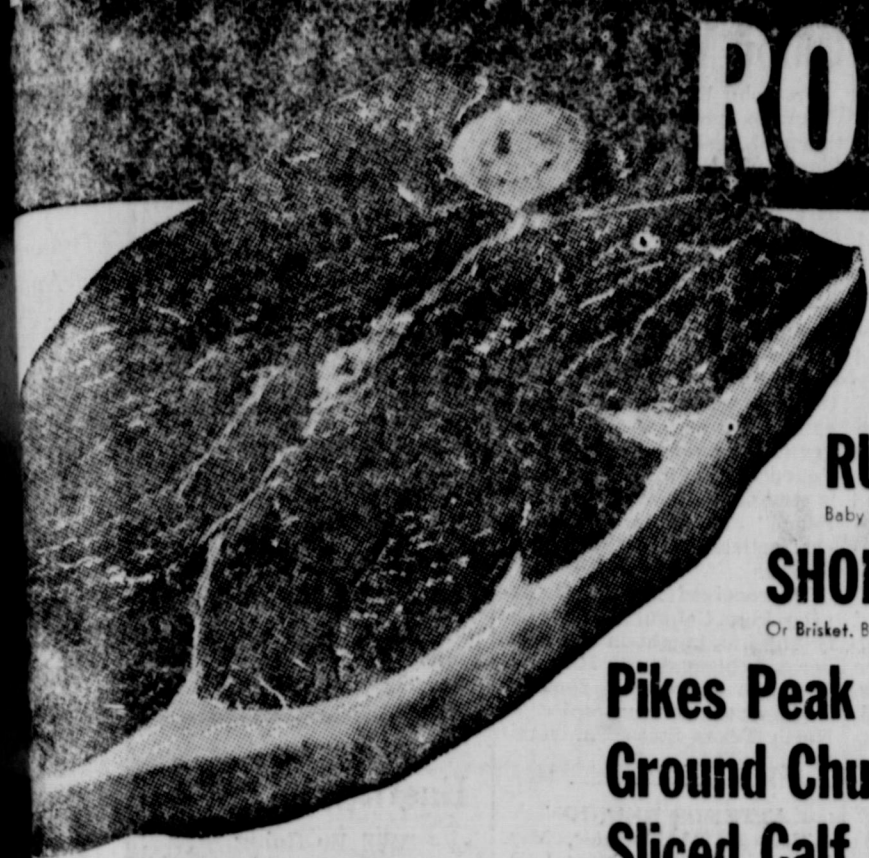

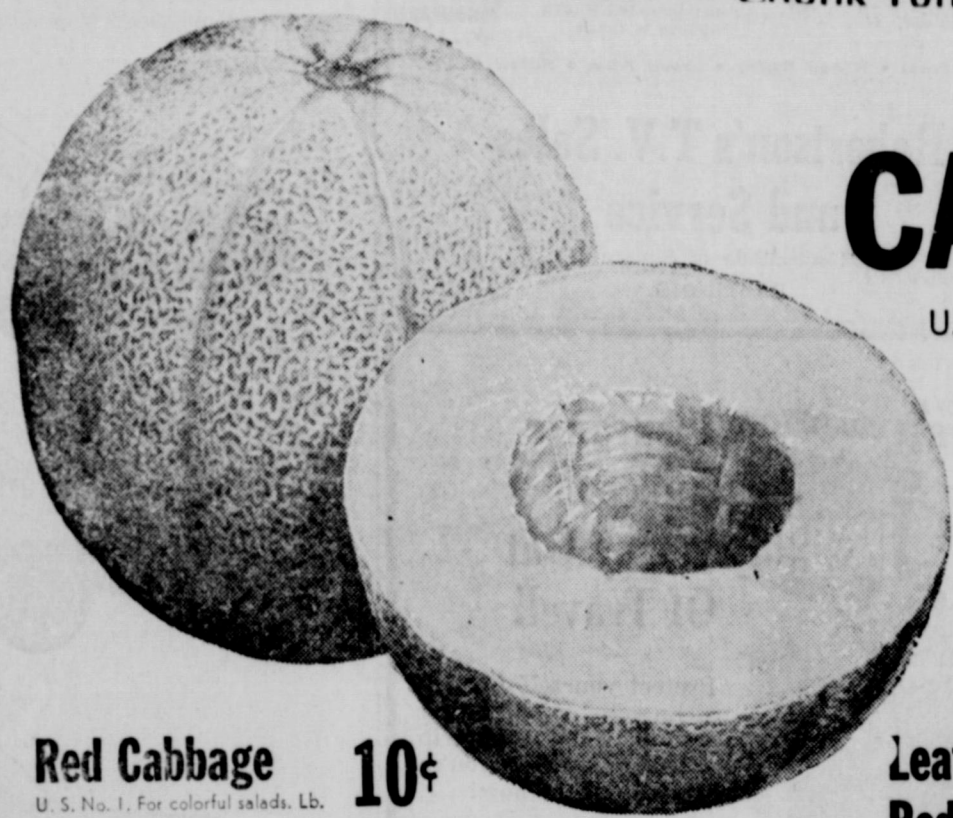
