THE RESIGNATION OF M. H. PERRY

Perry as school board member and president will come as quite a surprise and shock to most in Eastland, and coming as it does only three months before his term expires, it could raise speculation as to whether there might be a rift within the board. Nothing could be further from the truth than what we've learned. Perry "caught in the middle" in a situation which will explain itself before the week's out. He's about to be named to an important post in our town, and ever-conscious of conflict-interest, as he's always been through long years of diligent service and leadership in the school system, Perry did the thing he knew was right. That's pretty well his approach to his o-p-a-y schoolboard job all along. Board members and we can attest that meetings never adjourn until all points have been heard, discussed and decided on even though the hour may be late—late often as 1 or 2 a.m. The school and M. H., sometimes considered synonymous, realized a long hoped for team with the new facilities and Eastland youngsters today and for a long-time to come, can well thank M. H. Perry for his hard-headed negotiating for them—getting the best available with what's available to get it with.

When Perry went on the stand in 1940, Mr. Norris Wilson was board president, and Supt. Wendell Siebert was principal. Pat Miller succeeded Mr. Wilson and Perry, Miller.

Perry's successor, Truitt Gregory says that the advice and counsel of the well-versed schoolman will be welcome and sought in days to come, and they may even vote him a raise in salary. That's one thing Perry's always done—doubled his own and his hard-working board members' salaries every year. "Course when you start with nothing, that don't amount to much."

M. H. Perry Resigns From School Board

M. H. Perry, Eastland school board member for the past 15 years and president the past 12 years, resigned this week because of the press of personal business.

Mr. Perry submitted his resignation at the regular board meeting Monday evening and it was accepted "with reluctance."

Leading the local schools though perhaps their most difficult years what with integration, a consolidation issue, a recent bond election and gigantic building program, Mr. Perry announced his decision to resign and explained that he could not at this time reveal other details. "It has to do with my business, and will be made public this week," he said. He is Southland Life Insurance representative and a successful local businessman.

The terms of Perry, Willard Griffin and Dr. Bob Alexander expire in April. Mr. Perry had already decided that he would not seek re-election, he said.

He has during this past term realized one of his most cherished dreams, in the completion of the new elementary school building which the "system has needed for many years."

Board Vice-President J. T. Gregory has assumed leadership of the board and is guessed to be picked to continue as president at re-organization time after the April election. Dr. J. O. Jolly is the other member of the board.

Supt. Wendell Siebert issued the following statement: "The resignation of M. H. Perry from the Eastland Independent School District Board of Trustees after having served with this group for the past 15 years, most of which was in the capacity as chairman, has been received with sincere regret. "The guidance he has rendered this group during these years, and especially during the last few years through any number of various school issues which culminated in

the passage of a \$525,000 bond issue, and the construction of new school facilities, has been invaluable.

"His counsel and personal interest in all levels of school affairs will be sorely missed by the Board of Trustees, the Administrative Staff, and members of the faculty.

Mr. Perry was generous with praise for present and past board members, to Supt. Wendell Siebert and to the general public in Eastland for their support and assistance to the school during the years he has served the board.

Supt. Siebert and the board were equally generous in their thanks to Mr. Perry for his leadership.

In announcing his resignation Mr. Perry asked specifically that these be recognized for their contributions to the school and its welfare during the past:

The present school board; former members; those who have served on equalization boards; Supt. Siebert; principals; faculty; School Secretary Ima Ruth Taylor; Tax Officer Secretary Nell Hightower; former county commissioner Tip Arther for donation of materials and other help; engineers and personnel of the Texas Highway Department; local attorneys; Eastland National Bank for financial advice and assistance; members of the Quarterback Club; members of the Band Boosters Club; the Eastland Jaycees; the news media; Dusty Rhodes; Texas Electric Service Co.; Lone Star Gas Co.; Southwestern Bell Telephone Co.; members of the Eastland City Commission; the mayor and past mayors; the city manager; city employees; members of the Texas Department of Public Safety; Eastland Police Department and the Eastland Volunteer Fire Department; the school cafeteria supervisor and staff; and to "everyone else who has helped the schools through the years."

"Actually, he said, "I hate to try to list all who deserve to be thanked because every citizen in Eastland has been so cooperative with the board and the school, in every matter. Thanks go to all."

"Our goal has always been to provide the best education possible for our children and children to come," Perry said in his resignation.

The text of his resignation is as follows:

"I wish to submit my resignation as a member of the Eastland Independent School Board as of Jan. 11, 1965. It has been an honor and a privilege to serve with each of you and I want to thank you for your dedicated work and your wonderful cooperation through the years.

"I want to express my appreciation to Wendell Siebert for his untiring efforts and devotion to school affairs.

"May God bless, keep and guide you in the months and years to come.

"Sincerely, M. H. Perry."

Petty Thievery Tops Crime List In County

With raids the past two Sundays resulting in the arrest of nearly 100 people for dice shooting and chicken fighting in the county, one naturally begins to ask "What exactly is the crime situation here?"

A raid Sunday a week ago near Cisco turned up eight arrests for dice shooting and a raid this past Sunday charged 72 people with "being concerned with a chicken fight." One can hardly wait for the next installment.

Going to the top law enforcement officer in the county, County Sheriff L. E. (Lefty) Sublett, you learn "There's plenty of crime all the time." Keeping him and his department "plenty busy," Sublett was sworn in Jan. 1.

What's the biggest problem right now? "The most serious and most frequent is petty thefts," the sheriff said, "with such crimes most often reported. Some 95 per cent are night-time thefts."

Bootlegging? "Not to much right now," he said, "judging from the few complaints we're getting so far."

Gambling? "Well, these two raids pretty well take care of that," he said, "and they were the first cases since I was sworn in."

Check swindling? Also very prevalent and probably second only to petty theft in frequency, he said. "There's lots of it."

Prostitution? Not too much right now from what we've learned, he said.

Civil Rights problems? "None."

Dope? No complaints or cases since the first of the year, he said, but of course, "There's always problems with barbituates and benies." (Continued on Page 2.)

Air Traffic Is Program For Local Lions Club

The Federal Aviation Agency, which has 45,000 employees and a \$750,000,000 annual budget, has become the largest of the 60 independent federal agencies for two reasons, K. K. Jones, FAA executive of Fort Worth, told Eastland Lions Tuesday.

Guest of Dr. Bob Alexander, program chairman, Mr. resident and nephew of the late Frank A. Jones, one-time Eastland post master and newspaper publisher, cited the growth of general aviation and the advent of the jet aircraft as reasons for the need for a large aviation control unit.

Defining the three types of aviation, Jones pointed out that there are 85-87,000 craft in the general category which are private and industrially owned; 25,000 military; and 2,100 airliners.

"The FAA was organized in 1958 from the federal aviation act following several tragic mid-air collisions of jet aircraft," Jones said.

Some 40 per cent (18,000) FAA employees are directly connected with air traffic control—the supervision of take-offs, routes and landings, he said.

He also showed a film entitled "Air Traveler Meets Air Traffic Control."

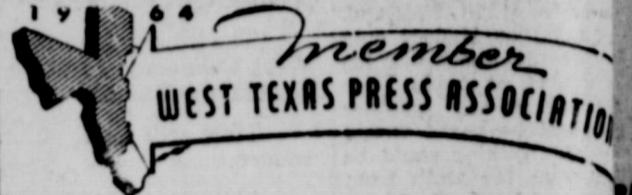

An Honor For Our Area

(An Editorial)

How many of us have set goals for ourselves, two years from now? And if we have, how many have done anything definite toward accomplishing those goals?

A young Texan — an Eastland County neighbor — not only had his goal set, but had gone to work to accomplish it.

Then when opportunity presented itself, State Sen. Ben Barnes of DeLeon was ready, and accomplished his goal of becoming Speaker of the Texas House of Representatives two years ahead of schedule.

The 26-year-old Barnes is typical of the new breed of representatives in the state legislative halls.

Another example — of a man whose ties are closer to this county — is State Sen. Tom Creighton of Mineral Wells. Only 36 years old, Sen. Creighton has just been elected President Pro-Tempore of this session, which puts him in line behind the lieutenant governor as successor to the governorship. Eastland County is in Sen. Creighton's district.

Rep. Barnes left law school last September to begin campaigning for the 1967 speakership. When Sen. Byron Tunnell resigned recently to accept an appointment, the young lawmaker was front-runner, with groundwork laid, for the Speaker's gavel.

State Rep. Wayne Gibbons of Breckenridge, whose district also includes this county, is a close friend of both a hard worker who has earned himself numerous committee appointments in the past. Rep. Gibbons assisted Rep. Barnes in his bid for the Speakership, entered a rules change resolution which carried the new speaker broad appointment power.

Working together this new breed of young lawmakers has a "get things done" quality which serves the people well.

Tuesday during a conference between the Ranger man and LCB officials. The officers made the raid on the old Parrish place about six miles south of Ranger on Farm-to-Market Highway 571.

Complaints were filed at the downtown office of Ranger Justice of Peace M. D. Underwood. By Wednesday at 5 p. m., 24 of the men charged had paid fines of \$25.00, plus costs, which totaled \$40.50 each.

In addition 16 others had posted appearance bonds of \$200 each. A group of Abilene men, Justice of Peace Underwood said, posted bonds through a legal counsel and declared intentions to "fight" their cases.

About half a dozen of those arrested were from Ranger. Practically every community in the county was represented and also present were men from New Mexico, Oklahoma, Baytown, Houston and Abilene.

The Sunday morning raid was one of several conducted recently by the Texas Rangers in this section of the state. Chicken fighting is illegal in Texas. It is lawful, however, in Oklahoma and New Mexico, although betting on the fighting cocks is an offense in those states.

An officer said it was his "understanding" that chicken fights were scheduled to get underway Sunday afternoon at 2 p. m.

In addition to the men picked up at the rural site, it was also reported that there were several dozen others in Ranger Sunday morning and allegedly were "planning" to attend the afternoon fights. As evidence the Rangers picked up many sets of gaffs and also took a picture of the pit which they say was to be used for the fights.

Constable Ralph Veal said Tuesday that about a year ago he warned a Ranger man against staging chicken fights at the same location. The Ranger heeded the warning. Veal said, and hurriedly cancelled the event.

Only one of the men arrested was jailed. He was held in the city jail in Ranger only a few hours. "You can't put me in jail unless my roosters go with me," the man said.

Chief of Police Bill Orden, acting on Rangers' orders, locked the man in a cell along with three roosters in coops.

"It was the first time," Chief Orden said, "that we ever locked up any chickens in the city jail."

After a few hours the Abilene man was released after paying a \$40.50 fine to Justice of Peace Underwood.

(Continued from Page One) Vandalism? Quite a bit, Sublett says. Particularly to rural houses and to road equipment on highway construction jobs. There's been quite a bit of damage done to tractors and equipment on the job south of Cisco. "Wouldn't be surprised if we don't start spending some nights patrolling out there." Cattle theft? "Yes, we have our problems there. We've made about five trips out of the county checking on the some 150 head of goats stolen near Rising Star recently, but haven't turned up anything definite yet." There's a certain amount of brazenness about the jobs being done, he said. Last week two rural houses, separated by a carport, were broken into — while an elderly woman was at home in one of the houses. The incident happened about seven miles south of Ranger on the Chayne Road. The woman heard someone in the other house, occupied by her son and family, who were away at the time, but thought that it was just someone helping themselves to gasoline from her pickup to get into town and therefore didn't disturb them. They jostled around for about an hour, took quite a bit of clothing, and finally topped their raid by breaking into her lighted room. She screamed then and called for help.

franchise to supply the community's needs.

In a meeting late in December, an Abilene engineer presented a preliminary report on the proposed project which embodied two possible plans.

One of the plans outlined construction of a distribution system at an estimated cost of \$59,820, and another plan includes distribution and pumping station, air gap and 50,000-gallon capacity elevated water storage tank at an estimated cost of \$68,000.

At the same time Mayor Frank Deaton and City Manager Lewis Tiner of Eastland met with a group of Olden citizens to discuss possible purchase of water for the proposed FHA system from Eastland.

Last week a group of Olden citizens met with Mayor Morris Newnham and members of the Ranger City Commission to discuss the possibility of purchasing water from Eastland.

The group was headed by Pat Moseley, chairman, and Leon Deck, consulting engineer of Abilene, who told the Ranger group that Olden's needs would be around 2½ million gallons of water per month. They also stated that to meet FHA regulations they would require a 40-year contract for such a supply.

Mavor Newnham said Monday that Ranger's supply of water from Eastland County Water Supply District is not sufficient to allow sale of gallonage required by Olden.

The city's 40-year contract with ECWSD, executed July 12, 1952 expires in 1992 — about 27 years hence.

The contract calls for 1,800,000 gallons of water daily, Mayor Newnham said. The Ranger city head also stated that on several occasions last summer, the city's water consumption was only little less than that maximum figure.

In order for Ranger to supply Olden with water, he explained, it would be necessary for a new contract to be executed with the ECWSD which would extend the time period to the year 2004. Also, the daily gallonage allowed would have to be increased.

The mayor said Ranger "would be glad to assist if arrangements can be made. "We consider the citizens of Olden our good friends and neighbors," Newnham added, "and we feel sure that the same feeling exists between Eastland and Olden.

"We feel sure that there is a solution to this problem, especially since there is an abundance of water in this area.

"The citizens of Olden can rest assured," the mayor concluded, "that we will do everything possible to assist our friends in making their water system a reality."

State Park Work Progressing; Big Year In Prospect

AUSTIN — Authorized state park improvements are well ahead of schedule, according to J. Weldon Watson, executive director of the Parks and Wildlife Department. He said indications point to 1965 as the greatest park year in history.

The executive director said during the year substantial new facilities were completed at Bastrop State Park, Goose Island State Park, Tyler State Park, Buesher State Park and Port Lavaca Causeway State Park.

But the major emphasis, said Watson, was in creating a new park at Dam "B" near Woodville, and the development marked creation of a "The LBJ State Park" near Johnson City, in honor of Texas' own, President Lyndon B. Johnson.

In addition, said Watson, the park field staff was busy serving an increase of more than a half million guests during the year. The 1964 attendance was 7,900,000, compared with 7,200,000 in 1963.

"We consider the attendance noteworthy," said Watson, "because the near record heat of the early summer curtailed visitations. Then there were prolonged drought spells in some areas that definitely curbed patronage."

Watson said the 1.2 million dollar development program has advanced so well that it is anticipated every contract will be encumbered, as of December 29. The last deal was for a new concession building at Falcon State Park.

Falcon State Park has been open for partial use with screened shelters, a large boat ramp and the airplane landing strip completed since early fall.

Subject to weather conditions and other undetermined factors, Watson said the other two parks, also on large reservoirs already noted for their fishing, will be ready for the summer season.

 WASHINGTON, D. C.—Perhaps it was ever thus, but it seems increasingly difficult to debate issues before the American public and in the Halls of Congress without imputing to those of differing views, either the thickest stupidity or the darkest of motives.
 As a result, every issue, whether of principle or practice, tends to become an all-or-nothing proposition. Policies or programs are treated as if they must be accepted in their entirety or totally rejected. The ancient distinction of wise men, the effort to distinguish between what may be a bad policy and what may be a policy badly abused, becomes all too easily lost.
 In the few days of the 89th Congress there appears to be less grey between black and white than at any time in recent years. The self-styled terms of liberal and conservative take on more definite identity but remain under anyone's definition.

This situation, if viewed correctly, is doubtless a hang-over from the elections of last November. The cleavage in the Republican Party manifested itself early last year and came into full bloom at their Convention. Democrats did not find it necessary to really debate many issues. It was enough to deal in generalities and pretty much let nature take its course.
 Now the Republicans, who seemingly feel that, since their principal representative was rejected, this makes it in the other direction in order to establish a new image and to catch the popular fancy of the voters.
 As example of the trend, a sizeable number of Republicans joined Democrats last week in approving the most

each legislative proposal as a tub to sit on its own bottom — as to what is best for our Nation, our State and our immediate area of interest — but it is still America and American.
 Time may tell and time may bring encouragement — It is a pity if it does not.

1. The Union is opposed to making any changes in the peanut program which would cause marketing quotas to be stated in terms of pounds and or bushels.

2. The Union recommends that a research program between the USDA, State Experiment Station, and growers be initiated, which will emphasize efforts to remedy serious peanut production diseases and to improve peanut harvesting methods.

3. Recommendations that the Agricultural Research Service, USDA, State Department of Agriculture and the State Experiment Station work cooperatively toward more uniform methods of testing seed germination, and that more effective ways of supervising and controlling these tests be established.
