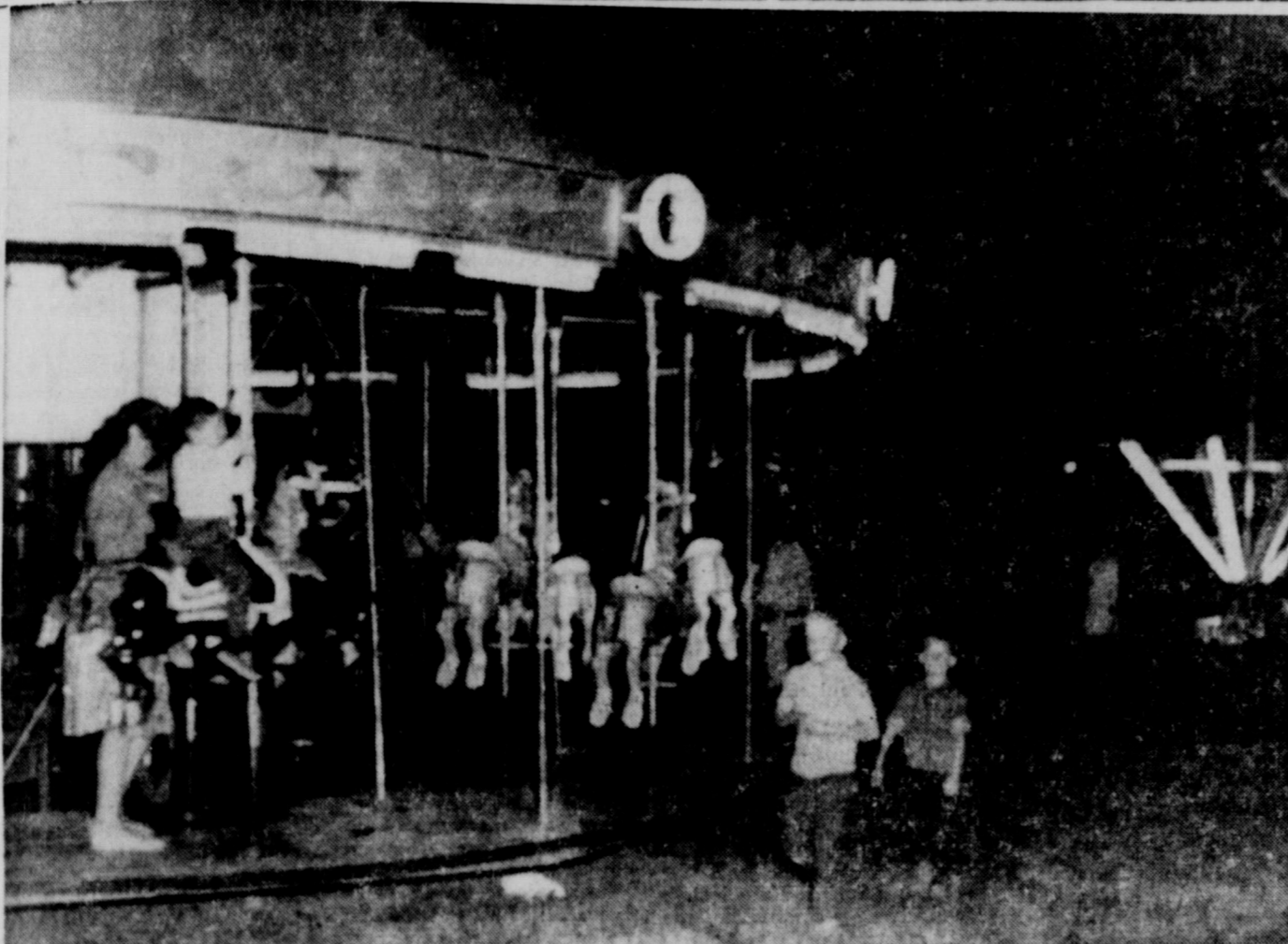

Funeral services for B. Orvel Harrell, 72, were held Monday, April 13, at 2:30 p.m. in the Eastland Methodist Church with Dr. Cyrus Barcus, pastor, officiating, assisted by the Rev. B. L. McCord of Ranger. Burial was in Eastland Cemetery with Hamner Funeral Home in charge.



Mr. Harrell died at 9:45 p.m. Saturday at his home, 604 West Patterson, following an apparent heart attack. He came to Eastland from Lampasas in 1922. He had been a car salesman for the past few years for the King Motor Company. Born in Coryell County, May 22, 1891, he was a member of the Methodist Church. He married Sarah Hair February 18, 1912 at Pidoce, Texas. Survivors include his wife; three daughters, Mrs. Herman Foust of Turnerville, Mrs. Bill Walters of Eastland, Mrs. B.S. Dudley, Jr. of Ranger; two sons, Orvel of Fort Worth and Travis of Eastland; four grandchildren; and one great grandchild. Pallbearers were Hood King, Bill Leslie, A. D. Webb, Frank Crowell, Curtis Young, Jay Whitley, Bernard Hanna and R. E. Head.

Bill Holliday Is Transferred to Galveston Burn Hospital Monday

Bill Holliday, 25 year old Olden man, who has been in critical condition in a Fort Worth hospital with burns for about three weeks, was to have been transferred to John Sealey Hospital in Galveston Monday night. The young man was critically burned in an automobile accident about three weeks ago and has been hospitalized in a Fort Worth hospital where he has been receiving intensive, specialized care. Preliminary steps were taken to have him transferred to a Veterans Hospital but it was found that he was not eligible to be admitted to a Veterans Hospital because he was in service during peace time. He

was in the service from August 1961 until August 1963. Friends of the young man have responded to the need for funds to pay for this expensive care. TO DICKENS COUNTY — Eastland Assistant County Agent Roger Blackmon has resigned and will assume the county agents duties at Dickens County May 1, it has been announced here. Mr. Blackmon, a native of Balinger, has been in this county for 30 months. He and his wife Karen and daughter Kara will move from Eastland April 31. An assistant will probably be named by the County Commissioners Court at a later date, it is reported. Mr. J. M. Cooper is county agent here.

County Has 16 Accidents In March; 2 Deaths to Date

Eastland County had no traffic deaths during the month of March, according to the rural monthly traffic accident summary released by the Texas Department of Public Safety.

The county had three personal injury accidents, 13 property damage accidents, and six injured, for a total of 16 accidents during the month.

Eastland County ranks third in the Eastland Sergeants area in the amount of property damage with \$6,744. Callahan County was the only county to have a fatal accident in the Eastland sergeants area during March.

Accidents in March for the Eastland Sergeants office area totaled 64 with one fatal accident, 20 personal injury, 43 property damage, and 34 injuries. Sergeant Roger Sosebee is sergeant for the Eastland area which includes Brown, Callahan, Coleman, Eastland, Shackelford, and Stephens counties.

A comparison of rural traffic accidents in the Abilene Area of the Texas Department of Public Safety for the first three months of 1964 with the

same period of 1963 shows that Eastland County has had two fatal accidents for 1964 compared to one for the three month period in 1963.

Property damage is lower for this year, \$23,000 compared to \$34,000 in 1963. Personal injury accidents were 10 for 1964 and 13 for 1963; property damage accidents are up from 25 in 1963 to 39 for 1964; total accidents are up for 1964 with a total of 51 compared to 39 for 1963; and the injured to total 16 compared with a total of 27 for 1963.

New Series U. S. Bond Due May 1

A reminder that the new \$75 series E United States savings bond, bearing the portrait of the late President Kennedy, will go on sale May 1, 1964.

The county chairman said that due to the heavy demand for the new bond which is anticipated, many banks and other issuing agents throughout the nation will accept orders before May 1 from those purchasers who may desire an early date of issue to appear in the validating stamp.

Decision to issue the \$75 bond which fills a gap in the lower denomination range of savings bonds, was announced by the White House late in January. The issue date of May 1 was fixed to coincide with the launching of "Operation Security," a nation-wide savings bonds campaign which runs until July 4, 1964. May 1 is also the 23rd anniversary of the issuance of the first series E bond.

Purchase price of the bond, which will reach full redemption value in seven years and nine months, is \$56.25.

Mr. Parker explained that the bond is not a "memorial" to the late President, in that it is no different from other denominations of savings bonds, all of which bear the portrait of deceased chief executives. However, beneath the portrait of Mr. Kennedy are carried the words from his inaugural address: "Ask not what your country can do for you; ask what you can do for your country."

"The reproduction of this memorable statement on the face of the bond," said Mr. Parker "is a fresh reminder that our citizens help strengthen their own security and, consequently, the security of their community and their country when they invest a portion of their savings in savings bonds."

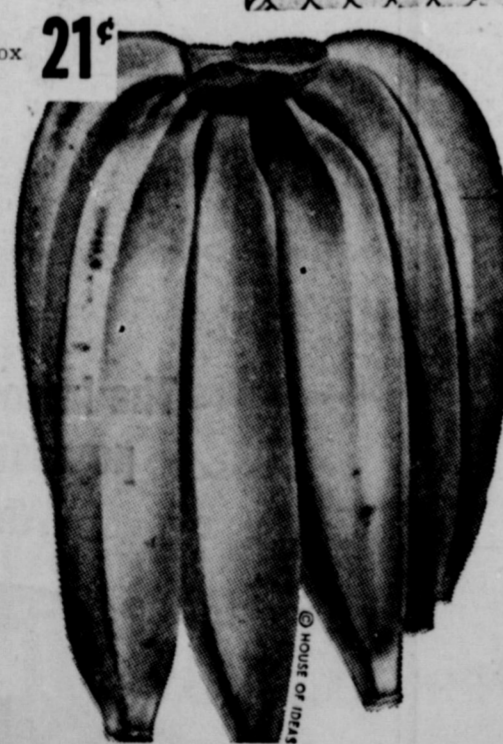

This newspaper does not attempt to tell its readers how to vote. But we feel an obligation to point out facts pertinent to questions on which the readers will decide for themselves the stand they will take at the polls. First Church of God Was Organized 42 Years Ago

The First Church of God of Eastland was organized in 1922. Rev. Paul Bennett came to Eastland on January 20, 1922 in response to an invitation of Rev. T. H. McNeal. Together they started a meeting in a building at the corner of Commerce and Lamar Streets. The attendance increased and the meeting was moved to the Methodist Tabernacle, now a warehouse, while arrangements were being made to move to a larger building that stood in the block now occupied by the Coca Cola Company. As a result of a seven weeks meeting in which attendance was unusually good, a Sunday School was started in the building which is now the site of the Venetian Blind Company.

Rev. Henry McNeal remained as pastor. Toward the close of the year a building site was purchased at the corner of Lamar and Valley Streets, and work was begun on the present building.

Rev. E. W. Barnett of Indiana became the second pastor in 1924. Other pastors who have served the church in their respective order are W. S. Hancock, H. M. Sell, John Batdorf, E. W. Barnett (a second time), R. E. Bowden, H. C. Hathcoat, L. B. Morrison, A. A. Gerard, J. R. Hale, W. E. Halenbeck, and Joseph L. Downs. Rev. Downs, pastor of the

church now, has served the church since July 1962. Rev. and Mrs. Downs and their daughter Pamela reside in the church parsonage at 210 West Valley Street. In the past two years the parsonage has been completely redecorated. Plans are now being made for redecoration of the church.

The Church of God believes in "A United Church for a Divided World," which is the slogan of the "Christian Brotherhood Hour," a radio program sponsored by the Churches of God throughout the world. The membership is made up of all people who have been born into the family of God by experiencing the new birth, and is not confined to the membership of this movement alone. Satisfaction as a definite second work of grace, and the doctrine of divine healing are also teachings of the Church of God.

Ordinances practiced by the Church are baptism by immersion, the Lord's Supper, and feet washing. However, the primary concern of the Church is sending lost souls to Christ.

The business of the local church is transacted by four committees which are Board of Trustees Pulpit Committee, Board of Christian Education, and the Executive Committee. The officers of the church are Joe Downs, chairman, Marlyn Jackson, Sunday

School superintendent Darrell Basham, secretary-treasurer, and Orval Johnson, vice-chairman.

The order of services of the local church is Sunday School at 9:45 a. m., Morning Worship at 11 a. m., Evening Worship at 7 p. m. and Youth Fellowship at 8 p. m.

Other activities of the church include the Wednesday night prayer meeting and the Woman's Missionary Society which meets twice monthly.

A revival is scheduled to begin May 10-17th with Rev. Edwin Ogle, Executive vice-president of Gulf Coast Bible College, our Church School in Houston, Texas. The Church of God extends a welcome to everyone to attend.

Leaving Bora Bora -- On South Pacific Tour

March 27, 1964

We were up early this morning and soon after sunrise saw the island of Bora Bora clothed in clouds. As we got closer to it we found it to be a series of steep mountain peaks forested to the summits with bright green verdure. These tropical islands get rain showers nearly every day and plants and trees grow well. Our ship entered the lagoon on the island's west side and anchored a mile off shore.

Soon several launches appeared and took the passengers ashore at two different landing places four miles apart. The launch which we boarded landed us at the "Village" a most beautiful spot amid coconut palms and flowering trees and shrubs. There were shops, churches, a school and many thatched covered houses. Children were everywhere and many of the natives had bicycles, also.

There appears to be only one road four miles long practically level that runs between the Village and Hotel located at the other landing place. We decided to walk part way in order to see the sights along the shore line. The ship's Chaplain and his wife walked with us so we were in good company.

As we walked past the Cathedral the people were just coming out from the morning service on Good Friday. They were in gay colors, straw hats and attractively dressed, although many were barefooted. The scenery along the way was delightful and we took several pictures including some of native children who picked flowers to give to us.

I have just taken time out for four o'clock tea served in the main lounge on the promenade deck, just as the ship got underway, and Emily and I stepped out on deck to take a last look at beautiful Bora Bora.

While ashore we took lunches put up by the ship's waitresses and we ate them under trees at the edge of the lagoon. Soon a sharp shower came almost out of a clear sky, and we took refuge on the porch of one of the hotel's cottages. The occupant, a gentleman from Ohio made us welcome and visited with us. The rain stopped and we were amazed at the color of the lagoon, with its turquoise and purple colors, nature at her very best!

Tomorrow morning we will land at Papeete, Tahiti, and take the Tahiti Island Tour, the description of which follows:

This unique tour by bus leaves the ship's side at 9:15 a. m. You will motor to the tomb of Tahiti's late King Pomare V then on through the strikingly beautiful panorama of Taharua, called by Captain Cook "One Tree Hill", and continue then to Point Venus the spot where Tahiti's history began.

Your drive then takes you to Punaauia, called the "Wonder district of Tahiti", where the great French painter Gauguin once lived. You will also see the Marae Arahurau the ancient open air temple.

Arriving next at the Tahiti Village Hotel, a delightful spot on the beach with a view of Tahiti-iti and the beautiful island of Moorea. You can swim, or sun on the lovely white sand beach, or enjoy cool refreshments on the terrace.

Luncheon will be served in this enchanting atmosphere, and your appetite will be satisfied by excellent European cuisine, supplemented by exotic Tahitian dishes. After luncheon you will be entertained with an exhibition of Tahitian dancing and music--an excellent subject to capture by camera. This tour returns to the ship at approximately 3 p.m. leaving you free to shop and sample the quaint and colorful life of Tahiti.

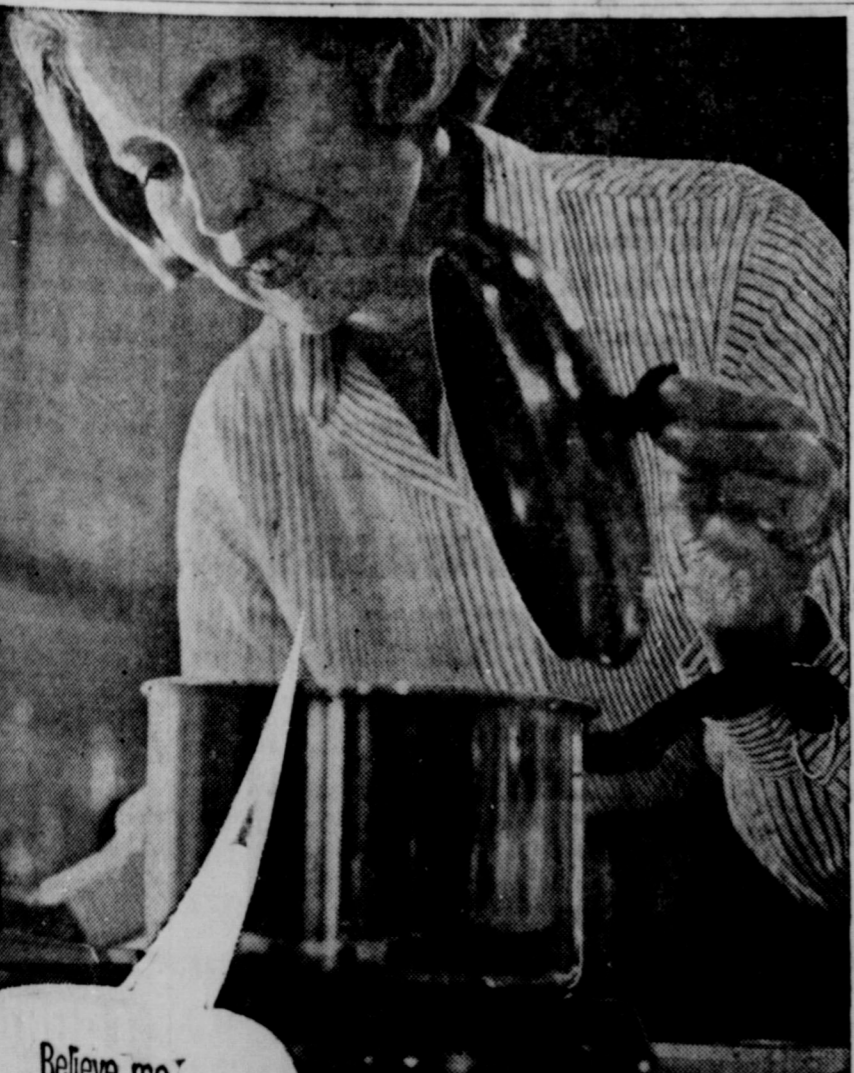

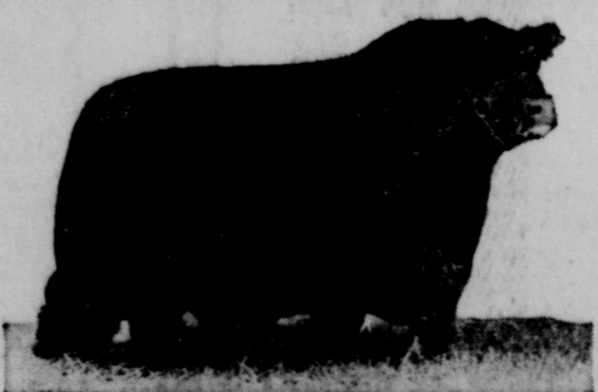

15 Year Old - Eastlander Writes Kennedy Tribute

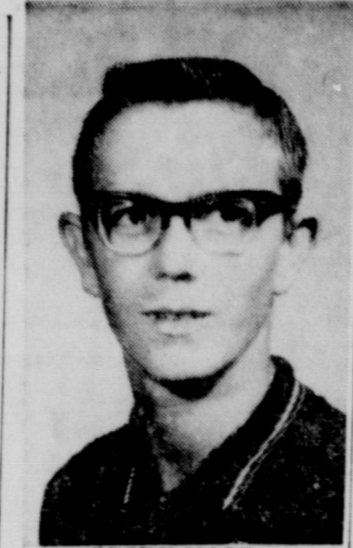
