Placing the U. S. Flag Back on the High Sea

One of the queerest things in American history has been the way in which the country has allowed its merchant marine—once one of the finest and most famous on the seven seas—to sink to the position of unwanted and sadly undernourished stepchild.

A century ago American ships were seen in every port on the globe, and the flag was a familiar sight on every sea. This not only meant that American exporters were doing a whale of a business; it meant that the nation was fully alive to its membership in the world community, and that the odd idea of building prosperity inside a Chinese wall had not yet been thought of.

But during the past generation the merchant marine dwindled and almost died. Save for the coastwise trades, American-flag ships were rarely seen. An enormous fleet had been built during the war, but it was rusting to obsolescence in remote harbors. The country seemed to have forgotten the part its ships had once played in building up prosperity.

A few years ago, attempts were made to revive the merchant marine. The government awarded mail-carrying contracts to divers steamship lines, paying out fabulous sums so that a packet of a dozen letters might be dropped off at out-of-the-way ports. The contracts were really subsidies, to enable steamers to make runs which otherwise would not pay. Since they were disguised subsidies, they were expensive and inefficient.

Now, at long last, it begins to look as if the merchant marine is to be established on a straightforward basis. The old mail contracts have been canceled. In their place are a set of straightforward basis. The old mail contracts have been canceled. In their place are a set of straight-out subsidies, under which the companies will receive direct money payments from Uncle Sam so that they can compete with foreign-flag lines on an equal basis.

Oddly enough, the direct payments are proving less expensive than the indirect ones which were made under the mail contract system. For instance: agreements which will keep 151 ships in operation during the next six months are costing the government \$4,600,000; under the mail contract system, the cost for the same ships in the same period would have been \$7,600,000.

Furthermore, the subsidies are set up in such a way that steamship companies, by returning to the government all profits above 12 per cent, actually stand in some cases to return the full price of the subsidies.

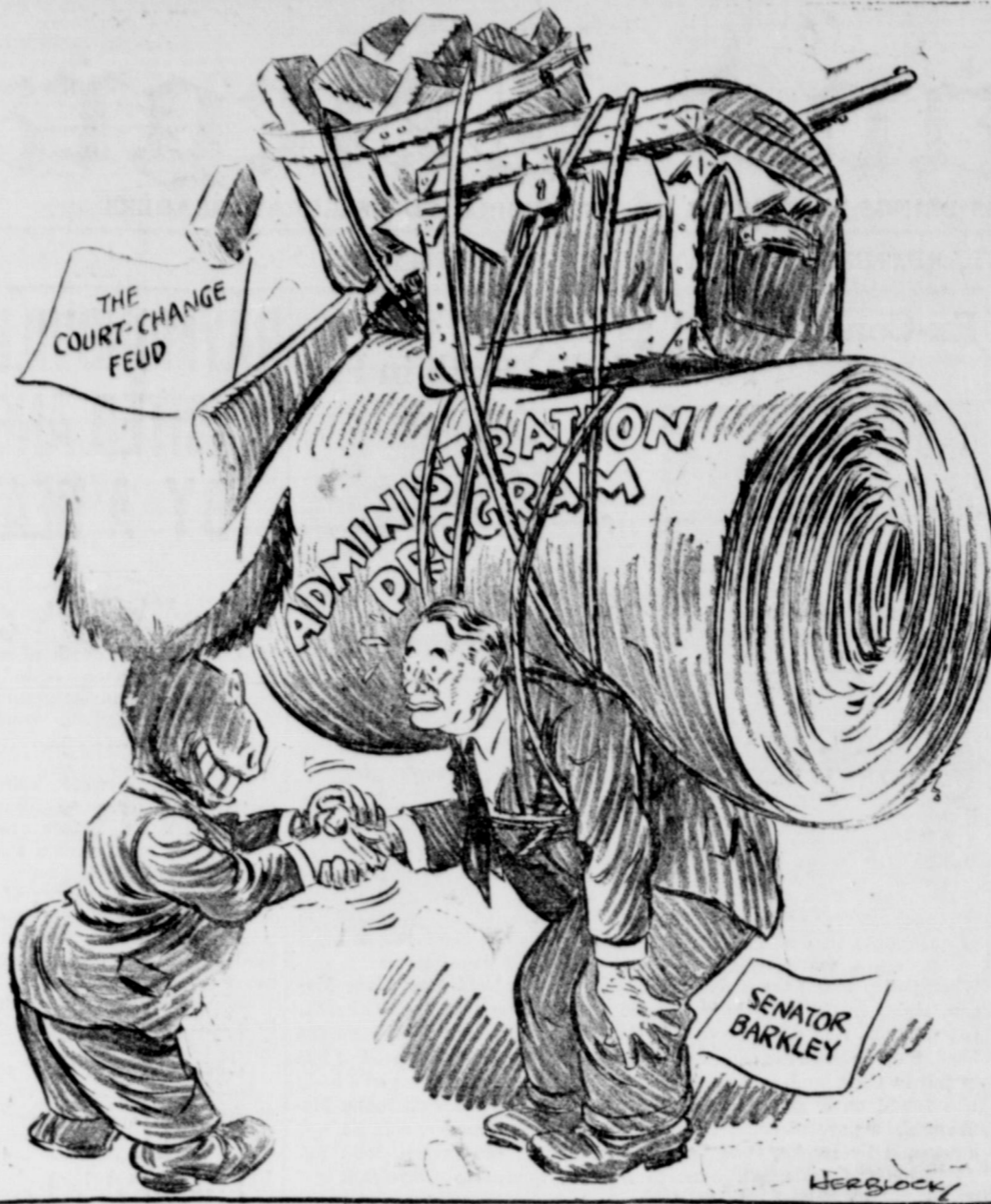
The net result of this new system should be all to the good. In the first place, it should revive the American merchant marine on a sound, healthy basis. In the second place, it will lead to much new ship building—it is estimated, for instance, that 100 fast new ocean ships will be built in the next few years.

attempt at rug-making from rags discarded from the WPA sewing rooms. A stock of raw wool was bought and a group of workers assigned to card it, the first step in the making of woolen cloth.

The wool is cleaned of foreign matter with wire brushes and then rolled into short hands. The carded wool is then spun into two-ounce swatches on the spinning wheels and is ready for washing and dyeing. Much of the hand woven cloth has a fastness and delicacy of color impossible to obtain in machine-made goods.

At present six wooden spinning wheels of ancient manufacture are in use along with eight hand looms. No products from the project are sold commercially.

SISTER MARY'S KITCHEN

LITTLE sweet tooth should learn something about the facts of cooking. Give them a white apron, a bowl or two, a simple recipe and the ingredients. Of course, for the very young cook, the use of the stove is out. But there are several excellent candies and salads and desserts that can be made by little hands without benefit of the kitchen stove. The following were selected as helps to modern mothers who believe in teaching young children the rudiments of food preparation.

Prune Whip (4 to 6 servings) Two egg whites, 1 cup cooked or canned prunes, 1-2 teaspoon lemon juice, 6 candied cherries.

Beat whites until very stiff. Mash prunes through sieve. Combine mashed prunes, egg white and lemon juice. A little sugar may be added if needed, but the natural sweetness of prunes should be enough. Pile into sherbet glasses and top with whipped cream and a bright red cherry. Any tiny cook will love to see the results of her efforts, and a few words of deserved praise from the rest of the family will do a lot to make cooking seem less work and more interesting to the future housewife.

French Cocoa Balls

Three-quarter cup cocoa, cups confectioners' (4X) sifted, 1 cup nut meats, 1-2 sweetened condensed milk, 1/2 cup blueberry jam, 1/2 cup blespoon vanilla. Mix 1-2 cup cocoa and cups confectioners' sugar. Put nut meats and add. Moisten sweetened condensed milk with vanilla. Shape into balls. Bake in rolling sugar and into balls in it.

Apricot Cocomat Balls

(Makes 24) One and one-half cups apricots, ground, 1 cup shredded coccomat, 1-2 cup sweetened condensed milk, confectioners' sugar. Put apricots through a chopper. Mix with coccomat. Moisten with sweetened condensed milk. Drop by spoon into confectioners' sugar. Shape into balls. Allow to stand firm.

WASHINGTON WITH RODNEY DUTCHER

WASHINGTON.—The "senator closely identified with the labor movement," reported in dispatches to have asked Roosevelt to settle the fratricidal C. I. O.-A. F. of L. carnage, and to have offered a peace formula of his own, is—perhaps one should add "of course"—the Hon. George Berry of Tennessee, head of the pressmen's union.

The prominent guest closely identified with the White House who has just thrown the formula into his wastebasket is the Hon. Mr. Roosevelt.

The fellow who laughed hardest when he heard about it was John Lewis, who hasn't enjoyed many uproarious laughs lately. The formula proposed to provide a place for Lewis subordinate to a new president of the A. F. of L., who would have been elected to succeed William Green.

Some sort of truce or semi-truce probably will be arranged sooner or later, perhaps sooner. Jurisdictional battles between C. I. O. and A. F. of L. unions, strikes which make no sense to the public and only make the public mad, are beginning to be recognized by organized labor's friends as dangerous, dumb business.

The "scop" in this column, however, is the fact that a group of liberal senators and congressmen, friendly to labor as a whole but beset by both A. F. of L. and C. I. O. lobbyists, is planning a public appeal to both sides. Realists know that hatred between Lewis and certain craft union chiefs wouldn't permit any closely knit coalition.

But these members of Congress hope and plan to ask for an agreement that there shall be no jurisdictional strikes, that the A. F. of L. will not try to break any more C. I. O. strikes, and that disputes between the two labor organizations will be referred to some impartial board or court.

This congressional group may never go to bat. But its present plans are the only things which promise a formula for relative peace between Lewis and Green et al.

YOUR correspondent desires to welcome back an old friend who once favored him with no end of mail, but who for many months had been cruelly neglected. It's the Board of Temperance, Prohibition and Public Morals of the Methodist Episcopal Church, which in prohibition days produced its "slip sheet" each week for correspondents here, but which seemed to fold up after there wasn't any prohibition any more.

Here's the "slip sheet" again, however, and it's entirely devoted to a long and learned summary of Supreme Court decisions in cases having to do with strong drink. It seems the court from away back has taken a sock at strong drink every time it had the chance. In these days when the Supreme Court is beleaguered by the force of Mr. Roosevelt, the big repeal man of four years ago, the Methodist Board comes salutarily to the defense of an old ally.

Of course the nation has gone wet again and your guess is as good as mine as to whether the board is going to do the opponents of the President's court plan more good than harm.

NEW YORK—Another member of the Old Guard is gone—Jack Curley. He was the most versatile and resourceful of the outstanding promoters and one of the more colorful. None surpassed him in background and variety.

After launching them on a shoestring or less, Curley mastered sports promotional problems that required every form of ingenuity and scheming and saw nearly all of them through to a successful conclusion.

Curley had more real friends than any other sports promoter who ever lived. Few in the sports world ever were known by sight to so many persons. Curley talked to everybody and in such a manner that total strangers felt that they had known him all their lives.

Great is the word, for Jacques Armand Curley was great in size and great in achievement.

CURLEY did many charitable acts, and never attempted to capitalize them. He'd take the shirt off his back for a pal in distress. Sometimes the operation was so tough that the skin would come with it, but he never hollered.

He didn't drink, smoke, nor was he a playboy in any sense of the term, but he had a much more costly habit. Money to him was something to spend, and he went on veritable shopping sprees, buying everything in sight—automobiles, watches, shirts, shoes, hats. He ordered suits of clothes in half-dozen lots, yet never appeared well dressed.

It wasn't a question of what Curley promoted, but what he didn't promote—fights, wrestling, bicycle races, tennis, marathon dances, lecturing, choir singing, swimming.

BUT Jack Curley's memory will live chiefly through wrestling. His name was synonymous with pulling and tugging. Curley made bone bending big business and resurrected it time after time. Most everybody suspected that the last rites had been pronounced over the cockeyed world day after day, with no trace of smile on his large guileless pan and without batting his innocent blue bulbs, that cur massaging was the grandest sport of all, that it was dead on the level, and that no crooked match ever had taken place anywhere, some began to believe Curley. And the shrewd mathematicians built from there.

No other promoter ever came quite as close to making the customers believe something they knew wasn't true. That, no doubt, was one of the biggest secrets of the success of Jacques Armand Curley.

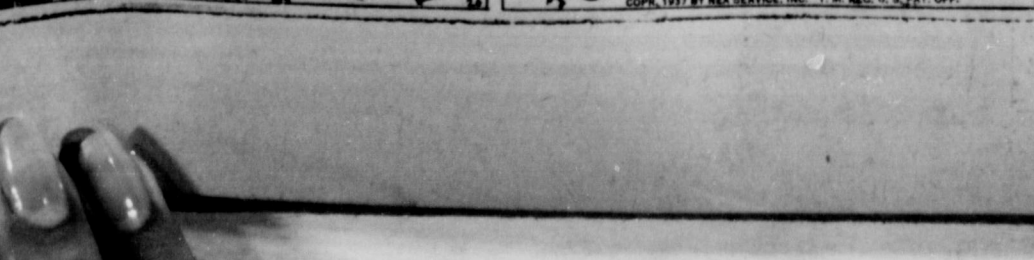

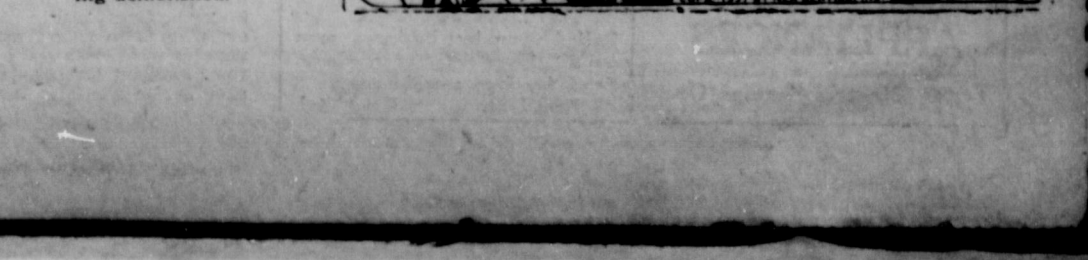

"My heart is set, as it has been for some time, upon another great office. Regardless of what may be said to the contrary or what might happen between now and the time when the sap begins to rise, I will not be a candidate in 1938 for any office except attorney general.

"This is final."
