can, however, line up at the bar with veteran tipplers and order all they want to eat, just so they keep off the drinks.

The words "bar," "saloon" and "cocktail" lounge are barred from advertising signs, but there is nothing to prevent such signs as "Cozy Wozy Elbow Tippery," and California is filled with a whole nomenclature of words that leave no doubt of the fact that the place is a saloon or bar.

Signs outside a resort will provoke legal action if they exceed 720 square inches in size. Why this should be so the law does not state.

All places selling liquor must serve sufficient food to constitute a meal. If the customer fails to ask for the food, that makes no difference, just so the establishment always has on hand sufficient food to serve a meal at any hour.

Liquor licenses are only granted after a thorough examination of the fitness of a person to whom they are granted, but he can then transfer them to someone else without any investigation of the second person.

Barmen must have the most

expert qualifications for determining what constitutes an intoxicated person, for they are forbidden to sell liquor to anyone with glassy eyes, or other indications of intoxication, or even to people

who are sober, provided they are known to be habitual drinkers. Finally, the sale of "miniatures," or small bottles containing two drinks, is barred, except on trains or boats, although the same two

drinks can be purchased in glasses. Wives of licensees, or women holding licenses, can mix drinks, but the ordinary woman bartender must only sell straight ones.

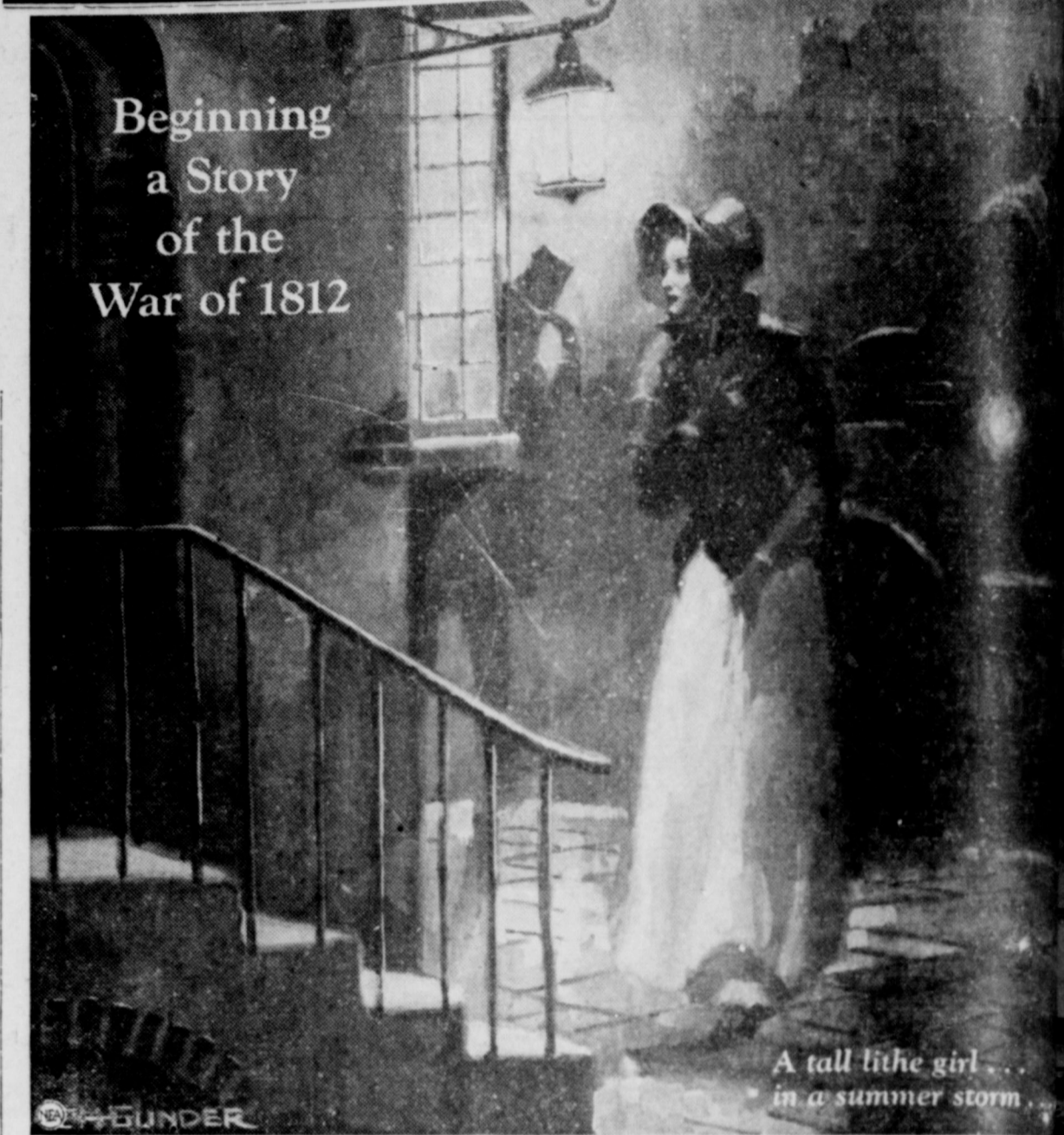

Arbitration—the Poor Man's Friend

Once there was a small-time produce merchant who bought \$50 worth of fruit of specified grade from a wholesaler. When the fruit arrived, the merchant refused to accept or pay for it because it did not come up to specifications.

So the wholesaler hired a lawyer and sued for payment. It was six months before the case came up on a crowded court docket. By the time the trial ended both litigants had lost money after paying lawyer fees, witness fees, and court costs. And the fruit had long since spoiled.

How many times has that story, with variations, been told in the history of American jurisprudence? The fact of the matter is that "going to court" is a luxury which few can afford in the United States. More and more the saying is heard: "The law is made for lawyers."

But there is a remedy—arbitration. Arbitration is sponsored chiefly by the American Arbitration Association, formed by far-sighted business leaders who were willing to give their time and experience to the task of cutting through the oceans of red tape which had made "justice" a jest to the man without means.

Here, it would appear, is the answer to a man's prayer for immediate legal relief. Before impartial arbiters—not lawyers but experts in the matter involved in the case—a man may explain his grievance and expect a fair and unbiased decision.

For a fee of only 5 per cent of the amount involved, litigants may come before one or several arbiters and adjust claims ranging anywhere from a few dollars to millions. The association is entirely non-profit-making, and its nominal fee for expenses compares with conservative estimates that the average court suit costs the litigant as high as 40 per cent of the amount involved.

There is no formal trial. Each litigant states his side of the case, bringing witnesses if desired. The arbiters listen, unimpeded by legal technicalities, and arrive at decisions on a common sense basis. There is no delay, no drawn-out court proceedings, very little squawking at the rulings.

Forty-six of the 48 states have now given legal status arbitration. Many industries, particularly those in which there are many disputes involving small amounts, are writing arbitration clauses into all contracts.

Approximately 7000 business and professional men have volunteered their services to act as arbiters without pay. Their decisions are binding.

Leaders of the movement are heartened by the public response. Arbitration looks like a great thing except, perhaps, for the lawyers.

It's to be hoped that the Duke of Windsor gets to New York quickly, before all the surplus ticker tape run off during the recent stock market crash is thrown away.

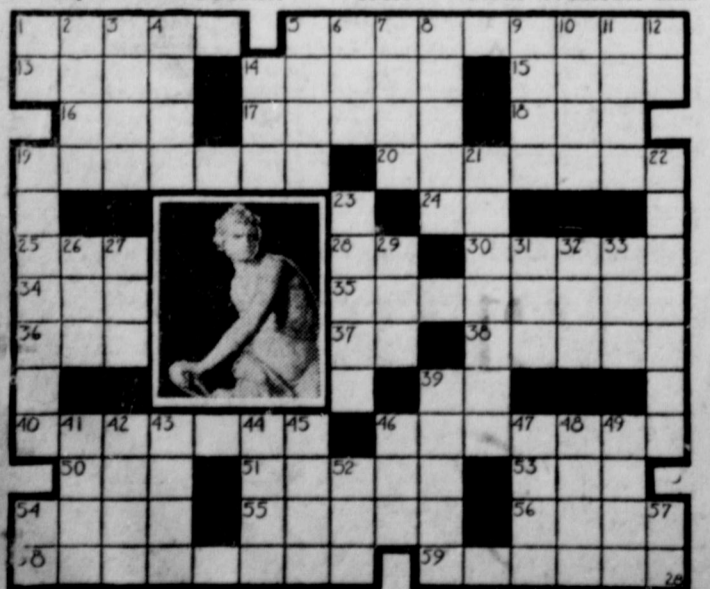

BEHIND THE SCENES IN WASHINGTON WITH RODNEY DUTCHER

WASHINGTON. — Roosevelt's expressed desire to eliminate all holding companies is a part of his ambition to bring the country under financial control, mostly from New York, over a large section of industry. If he embarks on the sort of a campaign which he has suggested in recent private conversations, you will be hearing plenty about such groups as the Morgan interests with their fast-flying control over steel, public utilities, automobiles, railroads and other industries. Banker control over industry, New Deal theory holds, is the real secret of monopoly, price-fixing and other factors alleged to have helped bring on the recession. New Dealers charge that bankers standing behind industrialists are responsible for sweeping layoffs, wage-cuts and curtailments of production to a degree beyond which actual managements would go if left to themselves.

Although Roosevelt may get nowhere near his goal, that goal is a major reform in the present business system. It is perhaps his most radical idea to date.

HEARINGS on the fitness of Ebert K. Burell as Assistant Secretary of the Interior, bringing up again charges of wire-tapping in the Interior Department, also call attention to a mechanical device Ickes has in his office. Sport Glances. By Grayson

CHICAGO.—King Levinsky, who has won several matches in a row since he quit busting beaks to bend bones, tells about his closest shave . . . the night he almost threw himself. Hammers and locks might just as well be hammers and shws, for all the Kingfish can do with them, so imagine his embarrassment when one of those cavemen tossed him over his shoulder like a sack of smelt and took hold of him in several places at once. "All I could see was feet sticking up in the air," beams Levinsky, "so I grabbed the handiest one and gave it a twist. I never before realized my strength. It was my own toe." Flat broke after earning \$300,000 with his fists, Levinsky now is being badly bent by journeymen wrestlers. The Kingfish, who collected \$35,000 a couple of summers back for sitting on a strand of rope, burying his face in his gloves, and begging the referee not to let Joe Louis hit him, averages about \$35 an exhibition these wintry nights, but takes his plight philosophically. The erstwhile fish peddler never knew what to do with money, anyway, and says that it wouldn't have done him any good if he had. "My family always took it away from me," he explains.

LEVINSKY, now only 27, fought nine world champions. He was paid \$23,000 for three starts against Jimmy Slattery, \$20,000 for as many against Max Baer, \$18,000 for an equal number against Tommy Loughran and as much for a single shot with Mickey Walker, \$12,000 for two fights with Primo Carnera, \$10,000 for a four-rounder with Jack Dempsey, and \$9000 for dropping and beating Jack Sharkey. He tackled Smaxie Maxie Rosenbloom . . . practically everywhere of any account. "Where did the money go?" "Well, for one thing," asserts Levinsky, "I dropped \$35,000 on King's Palace, a delicatessen and restaurant at Maxwell and Halstead. I once bought five automobiles at the same time. "When Harold Steinman, who still is with me, suggested that \$5000 be deposited toward a trust fund for me, my sister, Lena, told him that she could make money with money. She had an idea that it was going to last forever. So did I. But I was good to the folks." They told Levinsky that the wrestling racket was soft, but, as he points out, in boxing they at least give you a count. HENRY ARMSTRONG is an old-fashioned fighter in more ways than one. Armstrong, who sealed 134½ pounds when he chased, fouled, and stopped Enrico Venturi at Madison Square Garden the other night, has agreed to defend his crown against K. O. Morgan of Toledo in Detroit, Feb. 11. That means getting down to 126½, paring off eight and a half pounds. And Armstrong's training program chiefly will consist of fights with Frankie Castillo in Phoenix, Jan. 21; Al Ceterino in San Francisco, Jan. 26; and Chalky Wright in Los Angeles, Feb. 1. A remarkable young mah, Henry Armstrong, and one who doesn't see any percentage in paying sparring partners when he can get paid for sparring.

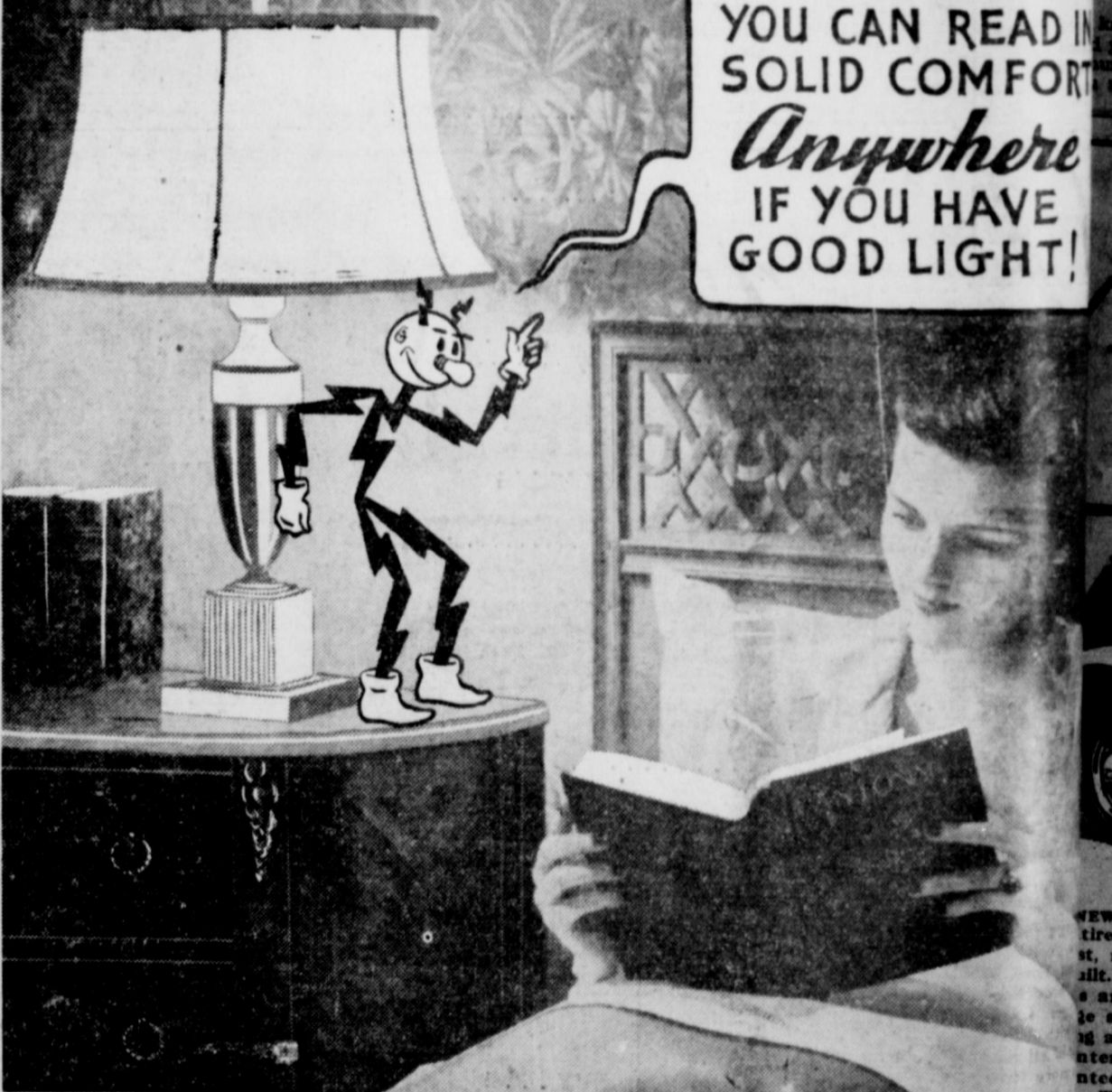

Scotch Parkins contains the following ingredients:
 1 lb. butter 1/4 oz. ginger
 1 lb. oatmeal 1/4 oz. caraway seeds
 1 lb. molasses 1/4 cup milk
 1/4 oz. pepper 1/2 teaspoon soda

Rub butter into oatmeal. Warm molasses and add to mixture along with pepper, ginger and caraway seeds. Stir in milk into which soda has been dissolved. Beat mixture well and bake in greased tin. Cut into rounds when cold and serve.

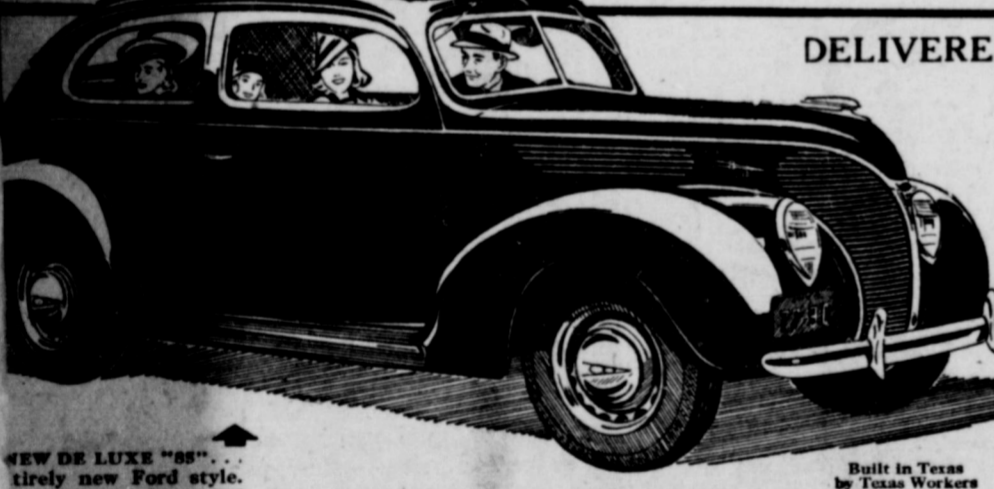

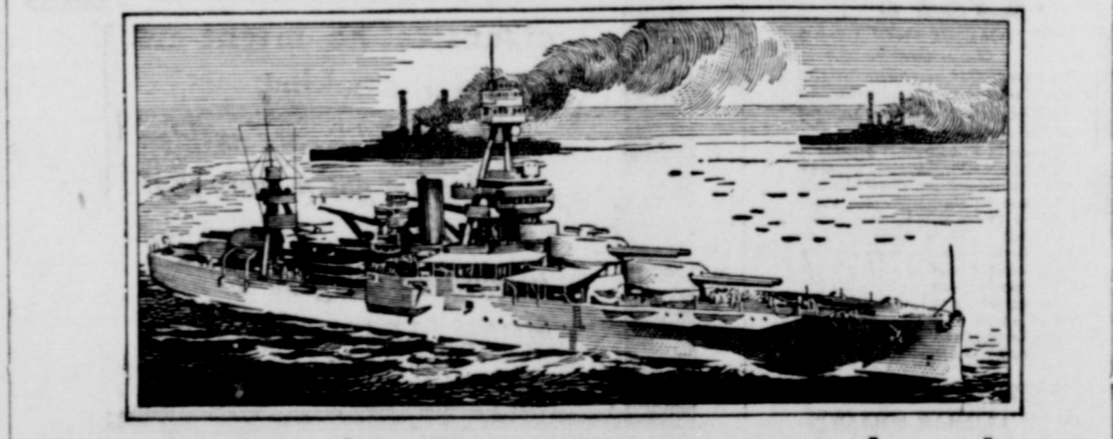
