Adolf Hitler offered his "final" seace terms to Europe today and threatened the allies with warfare if they rejected them.

A conference of nations to achieve peace security and economic readjustment in favor of the totalitarian bloc, a plea for friendship with Britain and France, a vague argument for disarmament, creation of a dominated Polish state, the solution of the Jewish problem and restoration of German colonies were the chief points in Hitler's proposal for eace on his own terms.

Hitler told the cheering Reichstag the Nazi regime can never be iquidated, that Soviet Russia and Germany will stand together and brook no interference in solving Eastern European problems, and that if the allies choose war Germany will triumph.

In Paris the highest French sources described Hitler's terms as "wholly unacceptable," constituting a threat to bombard open cities

In London the government prom ised consideration of the proposals but it was stated with certainty they were not acceptable.



In deciding whether or not we should vote beer out of Eastland county when we go to the polls tomorrow, let us not be swept off our feet by emotional appeals and exaggerated statements. Married men who work for companies that have transferred their staffs from vulnerable areas face the problem of maintaining two residences.





There are a hundred good reasons why the good people of Eastland county should vote against prohibiting the sale of beer in the election to be held Saturday, October 7, 1939.

It would take too much space to enumerate all the reasons-but here are a few-plenty to cause the average voter to stop and think bfore he votes in the coming election.

Fourth-Out of every dollar of tax on beer, 75c goes for the old age assistance and another 25c goes for educating the children. If beer is voted out how are we going to get this money for our aged citizens and what are we going to do in regard to helping finance the schools? Here is the answer: The legislature will add another tax of some sort to the already tax heavy public in order to get the money the beer has been bringing into these funds.

Fifth-Figures taken from the Tax Collector's records and from sworn reports made to the Texas Liquor Control Board show that during 1938 there was collected a total of \$77,096.20 in taxes and license fees on beer legally sold in Eastland County alone. Where will this money come from should the county go dry? Think this over. The money that has been coming into Eastland county will go to our neighboring counties and part of it will be used to give the needy employment, to repair roads and other worth while things while we in Eastland County will take just that much from the needy in our own county. Think that over!

Sixth-There are business investments in the county that operate trucks. Their drivers spend their money, support their families, pay house rent, and patronize all business interests. Who will take their place should we vote to make the County DRY?

Think these things over! Why force our people to vote for something that will not be -something that only leads to make citizens disregard and disrespect the law ... go away from home and in alleys and bootlegging joints, where there is no police protection and where bootleggers thrive without paying one cent to help support the government. # WHAT ABOUT REVENUE FROM THE SALE OF LEGAL BEER?

The records in the Tax Collector's office in Eastland show that there was colleced during the calendar year 1938, the following sums in license fees from those permitted to sell beer in the wet precincts of Eastland Couny: State of Texas \$1,325.00; Eastland County \$612.50; Cities of Cisco, Eastland and Ranger, \$525.00; Federal government, \$970.00. This makes a total of \$3,432.50 in license fees alone. This amount, however, is only a small portion of the total amount collected from the legal sale of beer in the county. Figures taken from sworn reports by dealers to the Texas Liquor Control Board show that a tax of \$14,732.74 was collected by the State of Texas on beer legally sold in Eastland county during 1938. This same beer paid \$58,930.96 in taxes to the Federal government during the same period. Thus we see that a total of \$77,096.20 of badly needed revenue was collected from the sale of beer in this county in one year's time. The State of Texas during 1938 collected a total of \$6,498,066.26 from taxes and license fees on alcobolic beverages. Three-fourths of the tax goes to the payment of Old Age Pensions and one-fourth to the Available School Fund. (Figures and information taken from Page 34, Fourth Annual Report. Texas Liquor Control Board). The importance of the Federal tax mentioned above will be realized when it is remembered that the Federal government matches the state dollar for dollar in the payment of Old Age Pensions.

## HOW WILL OLD AGE PENSIONS BE AFFECTED?

Every informed person knows that the Old Age Pension fund is in worse shape than ever before. It has recently been announced that all pension checks for October will be reduced by \$6.00 cach in every case. We know of many of these old people who will suffer because of this fact. This condition has been brought about because the state has been running short of money, in spite of the large amounts collected by the beer tax. Many counties in Texas which do not permit the sale of beer are paying nothing to the Old Age Pension fund from this source. It is reasonable to presume that any county which votes dry is voting to deprive the old people of Texas of a large sums of tax money which is needed worse at this time than ever before.

With taxes higher than ever before, and the need for tax money greater, we feel that it would be a grave mistake to cut ourselves off from this valuable source of revenue.

# HOW WILL BUSINESS BE AFFECTED?

A careful survey shows that 167 people are employed directly in the sale of legal beer in the wet precincts of Eastland County. These people have many others depending on them for their support. If prohibition is permitted to carry, these people will be thrown out of work and their dependents made to suffer. We wonder if those who are sponsoring this election, which will cost the county many hundreds of dollars, will guarantee that these people will find other work to support themselves and their families. The merchants with whom they do business would feel the effects of prohibition in a most serious way. Much of the business now being drawn to the larger cities of the county because of the fact that beer can legally be purchased in these cities, would go to the merchants of our neighboring counties which permit the sale of beer.

In addition to the enormous loss to the county and state in tax revenues, the business interests of Eastland county would be seriously affected if beer is voted out of the county. The loss in salaries, to automobile and truck concerns, to garages and filling stations, and to property owners who are renting buildings to legal beer establishments, can hardly be estimated. Certainly it will run into hundreds of thousands of dollars. In fact, there is no line of business in the county which would not be adversely affected by the loss of business if beer is voted out. We can think of no one who would be benefited in a business way except the bootleggers and businessmen in adjoining counties.

# WHAT IS THE REAL ISSUE?

We believe the real issue in this election can be boiled down to this one question: Shall the sale of beer in Eastland County be regulated under the laws and kept in the hands of responsible people, or shall we return to the days of wildcat corn whiskey and home-brew by the bootlegger?

DO YOU PREFER the sale of beer under a strict, legalized licensed system, with the safe-guards of the law surrounding its sale, or do you prefer to return to unlicensed and unregulated sale by irresponsible and disreputable persons?

DO YOU PREFER that the money derived from the taxes on beer go into the public treasury, to pay old age pensions and the expenses of your schools, or that it go into the pockets of racketeers and bootleggers?





TYLER, Tex .- There are more than 10,000 varieties of roses, and anyone who is somebody (and some who aren't) may have a rose named for him.

Alfred E. Smith, Herbert Hoover and the late Amelia Earhart are some of the persons who have es named for them.

But, ironically, the person who, more than anyone else, stimulated rose culture is never mentioned in rose guides or nursery catalogs. That person is the Empress Josephine, wife of Napoleon Bonaparte, who finally connived her way to a throne.

The Empress Josephine, one of the most ardent lovers of roses, encouraged rose fanciers in artificial pollination. Until the empress gave the rose business a shot in the arm, growers relied on wind, which crossed the pollen, and extensive cultivation to develop new types.

Throughout the last century rose fanciers the world over used their microscopes, tiny tweezers and razor-like scalpels to develop ew varieties.

Not all of these varieties are grown in the South, and only a fraction are grown in Tyler-one of the largest rose marts in the world.

Experts, with several thousand names on the tips of their tongues may rattle off many of the varieties as they wander through the sandy loam of the Tyler rose fields. 


