





Most printers know by now that gum arabic is in short supply in this country; in fact, it's well nigh impossible to get it nowadays. You can tell by the name that the Arabs must have something to do with the shortage, just as they do with oil, but in the case of gum arabic they had an ardent ally in the weather - extended drought.

Given off in a way that is not very well understood by scraggly, flat - topped acacia trees in arid parts of Africa, gum arabic finds it way into or onto products as diverse as fruit gums, postage stamps, soft drinks, sugar - coated pills, and last, but not least for the graphic arts industry, lithoraaphic plates. Most major countries, including the U.S., import it.

Among the more popular candies in England is a transluent grmdrop, known variously as wine, fruit or salad gums, depending on their flavor. The British devour them in great quantities and don't really like subsitutes.

The problem is that Africa's lengthy drought has led to sharp drop in gum collection by the nomadic tribesmen who roam so called "gum gardens" and collect the stuff in the Sudan parts of West Africa. The shortage has forced the price of gum arabic up alarmingly - as much as ninefold from \$364 to \$3,172 a ton.

Lithorgaphers have found several substitutes in this country; the British use starches; a cellulosebased gum has been found for postage stamps, but nobody is really very happy with the end results. Why don't we just plant a million or two acacia trees in the hot desert sections of this country and raise gum American? Our aim is for U.S. lithographers to be self - sufficient by 1980.

## **Ouick Dips For Hostesses**

Clyatt, consumer marketing information specialist with the Texas Agricultural Extension Service, the Texas A&M University System, compiled a collection of dips and spreads created to please holiday guests of the working woman.

'These items are easy to prepare-- and easy to plan. They use ingredients the homemaker can purchase ahead of time and have on hand--for fixing within a few minutes. Only one requies a few hours chilling", she noted

#### SHOPPING LIST

Purchase these items ahead of time for easy preparation: cream cheese, jars of cheese spread, cheddar cheese, blue cheese, bulk processed cheese, Gouda cheese, deviled ham, corned beef, canned tiny meat balls, Vienna sausages, liver spreads, crushed pineapple, canned tuna, finely chopped dried beef, finely chopped parsley, horseradish.

Also dry onion soup, potato chips, crisp crackers, pretzels, pecans, green onions, mayonnaise, prepared mustard, chili sauce, chives, Worchestershire, vinegar, bottled thick meat sauce, celery seeds, celery salt. Also bologna, salami, boiled ham or canned spiced ham, cleaned shrimp, chopped bottled capers, soy sauce. It's a good idea to scan the

## Called National Disgrace

"A national disgrace" was how the nation's rural transportation system was describbed October 31 by Senator Hubert H. Humphrey who was speaking to over 200 persons attending the annual meeting of Minnesota Good Roads, Inc., at the Ramada Inn McGuire's, Arden Hills.

While indicating that the interstate system is good, Humphrey said soaring food prices at the supermarket, skyrocketing transport costs for farmers, abandonment of family farms and thousands of miles of rail, high rural unemployment, and rail lines colgged with grain and other commerce are symptoms of 30 to 40 years of neglect of rural transportation.

After noting that most of the federal road dollard have gone into the interstate highway system which is based on national security, he said that national security also relates to whetheryou can bring produce from rural areas into the cities. 'There's no queston,' continued, "that much too little has gone into the roads that are the lifeline of rural America, the secondary roads, the farm to - market roads that link America's consumers with its producers.

In the last five years, Minnesota has received more that \$400 million in federal highway assistance. Seventy percent of the funds were used on the interstate system. The remaining 30 percent, or \$124 million, was spread over the rest of the road system for the entire state. Humphrey also said that the federal govern-ment is withholding about \$130 million in federal highway funds that belong to Minnesota. Recent studies showed, according to the Senator, 81 percentof the nation's rural roads are either unpaved or nothard surfaced, or incapable of carrying heavy loads. Minnesota's rural roads are slightly worse off with about 83 percent in that condition. The nation is still using 95 percent of the rural bridges build before 1935, and most of them are too weak and to narrow to serve rural communities and famrs efficiently. Since 1940, 46,000 miles of rail, mostly rural, have been abandoned by the railroads. Minnesota lost nearly 10 percent of rail mileage between 1938 and 1972. From 1960 to 1973, the Interstate Commerce Commission approved 97 percent of the railroads' requests for rail line abandonments.

A railroad system is ab solutely essential for the commerce of this country, he said. To make the railroads more responsive to the needs of the nation, Humphrey is of the opinion that the government







Forth, public officials who understand the importance of the rural transportation crises must do a better job of conveying the urgent need to act on it to the American people who must be told that "transportation begins at the commuter's breakfast table and if we don't improve our rural system, his cereal bowl will be empty, and certainly will be much more expensive to

Fifth, the requirements of national security demand an immediate modernization of our railroads and the immediate and long - term improvements of our rural transportation system.






