The Comets clinched the second half championship in Little League play here Tuesday night with a 16-3 victory over the Medics.

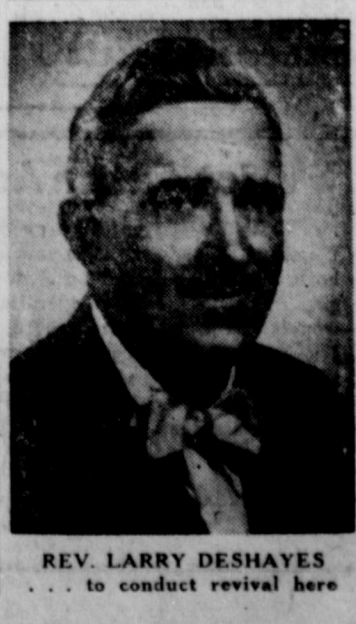
Church of God Revival Begins Sunday Morning

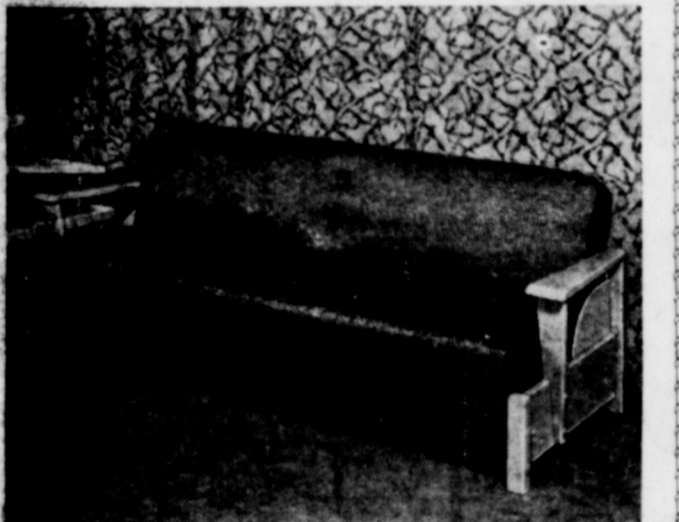
