Hamlin Overcomes Lead to Edge Locals

Eastland Defeated By 20 to 14 Count

Taking the kickoff on the 24, Eastland drove to the Hamlin 17 in 14 plays. From there it was second and three, but a penalty drove the Mavs back to the 22. An incomplete pass and a two yard gain wasn't enough for the first down.

Hamlin couldn't move the ball in three downs and booted out to the 49 yard line. The Mavs worked the ball down to the 16, but in two more plays got only one more yard. Then with time running out, a play jumped on a Hamlin fumble on the 15. With time for just one play, Manning took a pitchout and raced wide around the right end. It got it to the eighth before being hurled to the ground.

The Mavs, picked by sports writers to lose from anywhere from two to three touchdowns, led for three quarters, and held the heralded Hamlin 11 scoreless for the first two periods of play.

A smooth working quarterback deep or run play series, and hard running 160-pound Fullback Ken Prewitt finally was the down of the Mavs. Prewitt, on the same identical play, a pitchout from Quarterback Gene Murff, ripped off touchdown runs of 25, 12 and 47 yards. He was the difference in the ballgame.

Eastland Quarterback Clint Humphreys was the standout for the locals. Humphreys, a senior tri-captain, intercepted a pass in the first quarter and raced for a touchdown and ripped off 18 yards to the Pied Pipe seven yard stripe to set up the second.

Fumbles hurt the Mavs almost as much as did the Hamlin fullback. The Mavs lost the ball four times via all-tombs method, and one of the miscues set up the first Hamlin touchdown and got the Pipers' offense going after the visitors had made just 69 yards in the first half.

It was a good night for football, although the weather was a little warm. And Mav fans filled up the north half of the stands, and a large group of Hamlin backers were on hand for the non-district tilt. Hamlin represented District 6-AA and Eastland District 7-AA.

Eastland drove to the Hamlin 27 yard line the first time they got the ball, but a fumble stopped the drive at that point. Hamlin carried the ball to the 32 in two plays, then Murff went back for the first pass of the night. Humphrey grabbed it in the right flat and picked up good interference as he raced the distance to the goal line. The 40-yard gallop gave Eastland their first chance to try for a two-point extra point under the new extra point ruling, and halfback Larry Hollis punched it across to make it Eastland 8, Hamlin 0.

That score stood up until the halfway period in the game with Hamlin never getting past the Mav 49 yard line.

The Pied Pipers were back in the ball game after 1:25 minutes of the third quarter, however. A fumble on the kick-off return gave the visitors the ball on the Mav 38. Three plays later they drove to the 25, from where Prewitt took a pitchout and went into the promised land. Hamlin failed to run over their extra point attempt however, and the Mavs still were ahead 8-0.

The Mavs drove from their own 32 to the Hamlin 27 on the next series of plays, but lost the ball on downs. Charles Martin dived on a Piper fumble on first down though, giving Eastland the ball on the Hamlin 22. From there Humphreys raced 18 yards to the eight, then Hollis carried to the seven. The touchdown play came next, with Humphrey pitching to Hollis, who in turn threw a perfect pass to End Philip Lewis in the end zone. The extra try run failed to click and the score stood 14-6, Eastland.

Seven plays later Hamlin tied the game on a 60-yard drive, aided by a 29 yard pass from Murff to Halfback Ed Shields, did the trick. Prewitt carried the last 12 yards on a pitchout. Shields then ran over the extra point.

On the first play of the third quarter, Prewitt snagged another of Murff's pitchouts and went 47 yards to the endzone. The pass try for the extra points failed.

Time was running short, but Eastland still made a game of it.

THIRTEENTH TRAFFIC FATALITY OF YEAR

Ranger Boy Dies In Crash Near Eastland

A 13-year-old Ranger boy was crushed to death Thursday afternoon when the pickup truck driven by his mother overturned 2.2 miles north of Eastland on a dirt road.

The accident claimed the life of Royce K. Koerner, son of Mr. and Mrs. Rubin C. Koerner of Route 2, Ranger (Eastland Hill). Mrs. Koerner was also injured in the one vehicle crash. She suffered "four or five" broken ribs, severe bruises and possible internal injuries. Eastland Memorial Hospital attendants described her condition today as "... as well as can be expected." Dr. H. J. Bulgerin, attending physician, said it would be several days before he could determine the full extent of internal injuries.

The accident occurred just 400 feet east of Highway 6 on a country road. Mrs. Koerner was driving west in a 1958 Chevrolet. Tire tracks at the scene of the mishap showed that she hit her brakes, veered to the left, and then smashed into a dirt embankment on the right side of the road. The pickup then overturned.

Royce was thrown out of the vehicle and landed on the boy. An iron support post (headache bar) mounted just back of the car crushed the boy's head.

The dirt road was straight and level where the accident took place. As Mrs. Koerner was being loaded into a Hamner Funeral Home ambulance she muttered something about hitting a rock. Highway Patrolman Al White and Justice of the Peace C. E. Owen

said they were unable to find a rock she could have possibly hit, however.

A partially full gasoline drum was in the back of the pickup and some observers reasoned it possibly could have caused the driver to lose control by rolling suddenly to one side.

The accident occurred shortly before 5 p.m. First persons on the scene said Mrs. Koerner was frantically trying to free her boy. Rescuers jacked the truck up to get the boy free.

The traffic death was the 13th of the year in Eastland County and the second in four days. Records kept since 1951 by this newspaper show that 1958 is now tied with 1955 for the grim record of most deaths. Only four traffic deaths were recorded in 1957. Seven died in 1956, 13 in 1955, three in 1954, six in 1953, 12 in 1952 and nine in 1951.

Funeral services for Royce were held at 4 p.m. Friday in the Killingsworth Funeral Home chapel in Ranger. Rev. K. C. Edmonds, pastor of the Ranger East Side Baptist Church officiated with burial (Continued On Page Four)

Closing of the J. C. Penney department store at the end of business Oct. 15 was announced today by Robert J. Bell, the manager.

Bell explained that the store is being closed "because the sales volume does not justify an investment sufficient to maintain a well-rounded stock of representative Penney merchandise."

"People want and should find complete stocks of merchandise in all our stores," said Bell. "Today a large percentage of the merchandise we sell is style merchandise. This means that, to provide our customers with the variety and assortment they expect in a Penney store, it would involve carrying too large a stock of merchandise for the sales volume of this store."

"The Penney Company, after the most careful survey and consideration, has reluctantly decided to close the Eastland store rather than risk disappointing our customers or lowering our standards of customer service. We hope that our many friends in Eastland will understand our reason for this decision. It was made with deep regret because we appreciate the years our customers through the years have responded to our efforts to serve them well with Penney values in good merchandise. For this patronage we extend our sincere thanks."

Penneys first opened here in 1929 and has served this community continuously for the last 29 years.

County Social Security Recipients To Get Automatic 7 Percent Hike

The more than 17,000 persons in the district now receiving social security checks will get an increase of about seven percent on the checks to be mailed out early in February, according to R. R. Tuley, Jr., district manager. There is no need for any of them to write or call at their social security office to get that increase.

However, Tuley says, "I know there are several hundred others in this district who will need to

talk with a social security representative in order to get benefits started to them. For the quickest and most efficient way to start that action, he suggested that a card or letter be written to him, at P. O. Box, 5168, Abilene, briefly outlining the situation below which applies to a particular individual or family:

1. Certain dependents of persons now receiving disability insurance payments can now qualify for monthly benefits. These are wives at age 62, dependent husbands at age 65, and unmarried children under 18 or disabled children who have been disabled since before age 18.

2. Persons whose disability claims (either for benefits or the freeze) were previously denied only because they did not have 1 1/2 years of social security credits in the 3-year period just before becoming disabled.

Disabled adult children whose claims were previously denied solely because they were not receiving at least one-half of their support from the retired or deceased parent.

4. Dependent parents whose claims or inquiries were previously denied only because the deceased son or daughter was survived by a widow, widower or child who could possibly be entitled to benefits.

5. Anyone whose social security checks were stopped because of marriage, if he or she married a person who was also receiving social security checks.

Tuley suggests interested persons first write his office about possible benefits so that a mutually convenient interview time may be arranged, either at his office or one of his future visits to this county.

For more detailed information on the above changes, Tuley invites readers to write him for a copy of free Leaflet No. 1958-1. Those wanting just the changes in the disability provisions should ask for Leaflet No. 1958-2.
