### It's just funny-colored paper

An 80-year-old merchant in Barbaastro, Spain, recovered his savings after accidentally depositing \$95,000 in a trash bin.

Garbage collectors found a bag stuffed with peseta notes of various denominations and submitted it to town officials, police said.

The elderly merchant arrived at the police station hours later to say he had accidentally discarded his savings the night before, thinking it was a bag of old bills and receipts.

The man named the exact sum lost, and was handed his stash and took the cash to a bank.

### Where'd you get the tickets?

A man helped himself to his neighbor's New York Giants tickets and is now facing a penalty on the play, police say.

Police charged Edward Celardo, 33, of Hopatcong, N.J., with stealing four tickets to a football game, valued at \$180.

The tickets had been mailed to Joann Koslosky by a friend, but the envelope was mistakenly left in Celardo's mailbox, across the street from Koslosky's house.

Police said Celardo kept two tickets and sold the other pair.

Koslosky, who assumed her tickets had been lost in the mail, called the Giants box office and bought replacements.

Koslosky questioned Celardo about the tickets when she saw him at the game, and later called the police.

## Mules dominate Roosevelt Eagles 56-0

Muleshoe's Mules stampeded to a 23-0 lead in the first seven minutes Friday night and never looked back.

Their 56-0 win over Lubbock Roosevelt extended their season to 9-0, tying a 62-year-old record for the most wins ever by a Muleshoe team.

The Mules scored on the second play of the game. Chris Barrera set it up by returning the opening kick-

off to the Mule 32. Lincoln Riley connected with Joey Tucker to move the ball to the eight.

Then Danny Ramirez ran the "Hammer" through the right side of the line to score. T-Bird Cox found Tucker in the end zone for the two-point conversion.

D.J. Dominguez kicked off high. Lupe Nuñez and Tad Lutz combined to cause a fumble — and recover it for the Mules — on the Eagle 39.

Five plays later, Riley connected

with Darrell Lewis, who broke a tackle at the 10 and powered into the end zone for another score. Cox ran the two points.

Roosevelt gained only five yards on three carries before the Eagle punter fumbles the snap and Jeff King was there to claim the ball for the Mules at the Eagle 25.

Travis Tunnell checked in at quarterback for the Mules, and on second down hit Jeff Shelburne, who carried to the nine. Ramirez then runs in yet another touch-

down, and Dominguez's extra point makes the score 23-0. The Mules have run 10 plays.

In the second quarter, Ramirez scores with a 53-yard punt return and a 46-yard run, while Chris Vela adds six points on a one-yard dive. Dominguez goes three-for-three on extra-point kicks.

The scoring slowed down in the second half, with Lewis on a one-yard plunge in the third quarter and

## 729 early voters set county record; election is Tuesday

Assistant Bailey County Clerk Raygena Barrett reported Friday night that 729 people had voted early by the time her office closed at 7 p.m. Friday.

"It's a record for Bailey County," Barrett said, adding that the figure includes both mail ballots and in-person early voters.

The total means that just under 19 percent of the county's 3,869 voters already have cast ballots, with Election Day coming up Nov. 7.

Interest in the presidential race presumably is high, with native son George W. Bush in the race.

The only local race with opposition is for Precinct 1 commissioner, where incumbent Democrat Floyd "Butch" Vandiver is being opposed by Republican Jack Dunham.

Unopposed are incumbent Democrats Carrissa Cleavinger for county attorney, Joey Kindle for Precinct 3 commissioner, and Gary Don Gartin for Precinct 1 constable.

Sheriff Chance Coberley, appointed earlier this year, is seeking his first full term as a Republican without opposition. And Berta Combs, a Democrat, is unopposed for her first term as tax assessor-collector.

Polling places for Tuesday's voting will be:

- Precinct 1 — Voting box No. 1, Bailey County courthouse;
- Precinct 2 — Voting box No. 2, Bailey County Coliseum;
- Precinct 3 — Voting boxes No. 3, Three Way School, and No. 4, New Vision Church of the Nazarene, Ninth and Avenue C; and
- Precinct 4 — Voting boxes No. 5, Bula School; No. 6, Needmore Community Center; and No. 7, Muleshoe City Hall.

Polls will be open from 7 a.m. to 7 p.m. on Election Day.

## Mules close to having record season

The last time a Muleshoe High School football team had a 9-0 record, they weren't even called Mules.

The 1938 Muleshoe Yellowjackets finished the season at 9-0, and few Muleshoe teams since then have come close.

Some members of the 1938 team still live in the Muleshoe

area, and they will be honored before the kickoff of Friday's final regular-season game as the Mules take on Dimmitt.

While individual statistics are sometimes harder to come by than the team records, it is certain that two such yardsticks have fallen to a member of the 2000 edition of the Mules.

Darrell Oliver's single-season scoring record of 96 points has stood since 1958, eight

years after the Yellowjackets became Mules, and Dean Northcut owns the single-season rushing record with 1,375 yards, set in 1978.

Senior Danny Ramirez, at only 5 feet 9 and 165 pounds, has already rewritten those records, with 132 points this year, and unofficially has 1,397 yards rushing — with Dimmitt still to go. An "average" night could send him into orbit.

## Weevil battle continues after harvest

The cotton-growing season is winding down, and producers in non-eradicated areas should notice a decline in treatments for boll weevils.

But they also may notice that some harvested fields are still being treated.

These treatments reflect a difference in philosophy between control and eradication, said Texas Boll Weevil Eradication Foundation program director Charles Allen.

"Pests can cause little injury to the harvestable crop at this point in the season," Allen said.

"But during this time of year, control efforts intensify in boll-weevil eradication programs," he added. "The main difference is that the objective of a grower is to control boll-weevil populations to prevent economic damage to the crop, while that of the eradication program is to eliminate the pest."

The boll weevil's primary focus during the latter part of the season is feeding to gain enough fat to survive the winter, Allen said.

Because of this, weevils may be present in defoliated or harvested fields that still have green bolls or immature squares, which are weevils' prime food sources.

In Texas, foundation personnel continue to trap fields until all hostable material — plant parts that a weevil can feed on — has been eliminated from those fields, Allen said.

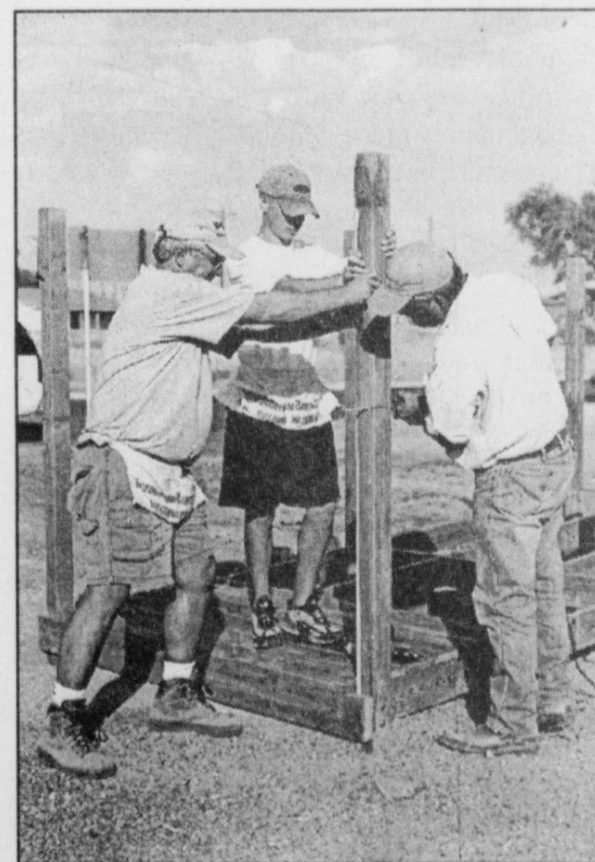
If trap catches on those fields meet or exceed established triggers, then the fields are treated to eliminate weevils before they can overwinter. Fewer overwintering weevils mean fewer emerging weevils to worry about in the spring, he said.

When the next season begins with lower populations, less spraying will be needed, saving the growers money and speeding the course of eradication, he added.

Growers can help reduce the number of treatments in their area by practicing good cultural controls, a key element in the eradication process, Allen said.

Such practices include harvesting fields as soon as possible after defoliation and shredding or plowing stalks after harvest to eliminate host material.

Some growers prefer to leave stalks in fields as ground cover, but they should be careful to check for regrowth as long as the weather remains warm and take steps to keep the fields free of host material.

## Shallowater loss drops freshmen record to 4-4

Big plays hurt the freshman Mules in their Oct. 26 game as they lost 24-8 to Shallowater.

The Mules moved the ball well in the middle of the field, but a fumble, an intercepted pass and failure to convert on a fourth-and-five at the Mustang 20 kept them out of the end zone until late in the third quarter.

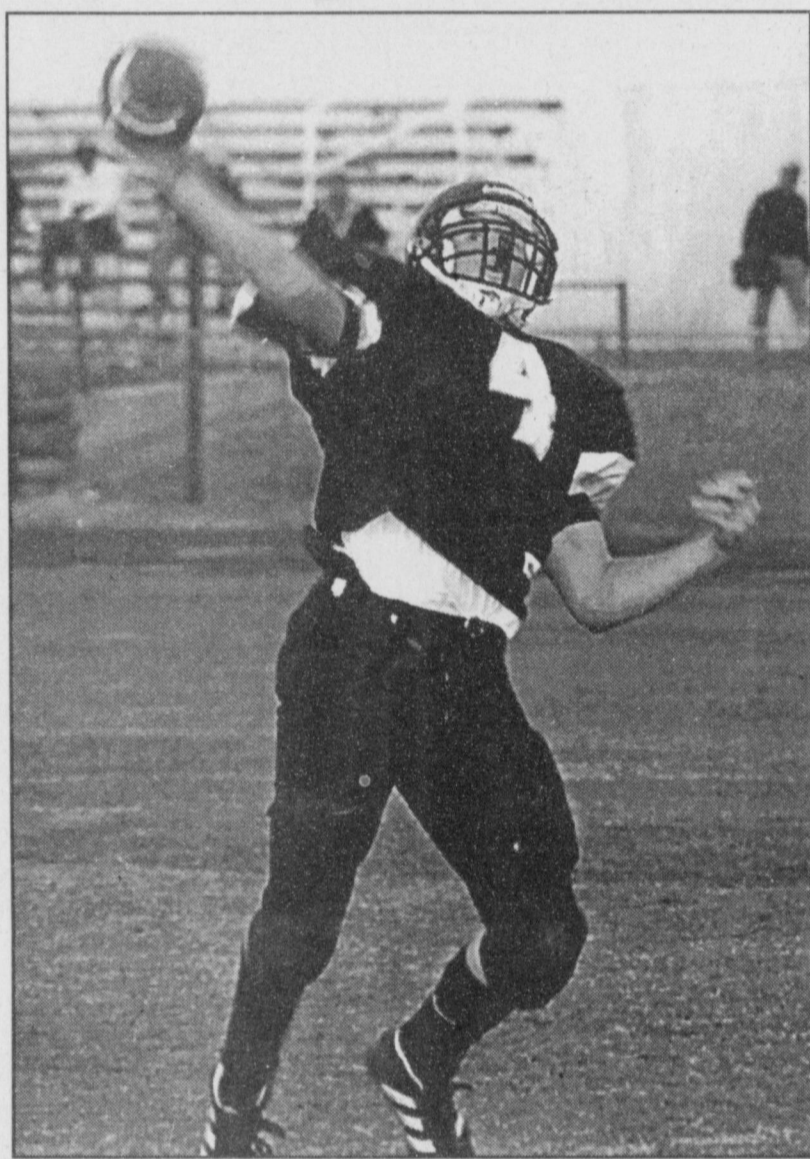
The first quarter was a defensive battle, with the Mules forcing the Mustangs four-and-out on their first two possessions.

Defensive stops by Brian King, Josué Sigala, Tyrel Gear and Miguel Castorena played a big part in the first-quarter shut-down of the big, fast Mustang offense.

The Mules started the second quarter on the Shallowater 39. They advance to the Mustang 14 in four plays, but are stopped at the 10 on fourth and five.

On the Mustangs' first down, they broke away for a 90-yard touchdown and then added a two-point conversion.

The Mules' hope of tying the score just before halftime ended when a Daniel Campolla pass to Tatom Heathington was tipped away.

Then, with 6:06 left in the third quarter, the Mustangs scored again on a one-yard plunge and made another two-point conversion.

After the ensuing kick, the Mules put together their best offensive drive of the night. Mixing running with a pass to Alex Agundis, the Mules ap-

peared to be on the move.

Then a Mustang picked off an I-back pass and returned it to the Mule 29.

After starting the fourth quarter by picking up a first down, the Mustangs score on a 55-yard run. Again the two-pointer is good, to make the score 24-0.

The Mules then benefit from first-down runs from King and Joseph Gonzales before Gonzales gathers in a pass from Campolla and runs 25 yards into the end zone. Campolla added two extra points.

The loss left the Muleshoe freshmen with a 4-4 record to this point in the season, while Shallowater moved to 7-0-1.

### Muleshoe 12 Lubbock Cooper 8

Fernando Toscano drew first blood as the Muleshoe freshman downed Lubbock Cooper 12-8 on Oct. 12.

Toscano's two-yard second-quarter touchdown was answered by a 70-yard Cooper run in the third quarter, but Josué Sigala came back to score the winning Mule touchdown in the fourth quarter on an eight-yard run.

Vote to love your mate and honor your vows as you kiss your spouse in the morning.

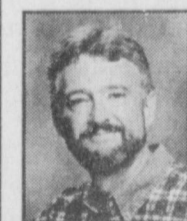
Vote to show your kids how much you love them by spending some time with them this evening.

# Shrubs can be multiplied by digging up suckers

Anyone who has a mature suckering shrub and wants more has a goldmine on their hands.

Probably the shrubs most commonly divided by suckers in our area are lilacs, simply because we have so many lilacs and their suckers are so numerous.

Suckers, by the way, are the shoots that spring up from the roots near the base of certain plants.

Once these suckers have a season's growth, they usually have enough root to survive on their own, so you can spade them up and put them where you like.

With a prolific sucker producer such as a lilac, it's easy to produce a whole hedge or small windbreak very quickly from one or two parent plants.

Another shrub that is a prolific producer of suckers is kerria, and it can be treated the same way as lilacs in this regard. Gaultheria, ruscus,



snowberry (*Symphoricarpos*) and sweet box (*Sarcococca*) also produce usable suckers.

This type of division works best when the plant is dormant; the two best times for us are fall, when the ground is still fairly warm, or early spring, when the ground is about to start warming up.

While most shrubs sucker from the roots, it is worth noting right from the beginning that a few — such as shrub roses — produce usable suckers from the main stem, between the roots and ground level.

(Suckers from hybrid tea or any other hybrid roses should simply be cut off and discarded, since they probably would not

match the parent plant.)

Once the sucker is dug up, cut the "umbilical cord" (the main root that came from the parent plant) as closely to the fibrous roots of the new plant as is practical.

If there is considerable top growth, it may be advisable to trim off some that, too, but you'll need to leave at least a few buds to start new growth. If you aren't comfortable deciding how much to trim, it's almost always all right to leave the whole thing.

I have read books that advise cutting back the tops of the suckers to 12 to 18 inches. Because of the digging involved, I prefer to deal with the suckers before they get more than 18 inches tall. With lilacs other than the old-fashioned Persian kind, you may be dealing with taller suckers simply because they get tall in one season.

It's a good idea to work some compost or rotted manure into the soil where you set these "baby" plants, and you will

need to pay special attention to moisture throughout their first summer.

Some shrubs don't really sucker, but they form clumps that can be treated in a similar way. This involves digging the whole clump and dividing it into good-sized pieces with good roots and top growth. You may need to use a spade to separate the parts, or maybe a sharp knife.

Discard any parts that look too old or unhealthy.

This kind of division works with shrubs that have formed big clumps and outgrown their location — such as those spiraeas your grandparents planted 60 years ago. This is another case where one big clump may be spread out to form a whole hedge.

Treat these divisions as you would the separated suckers. Happy planting!

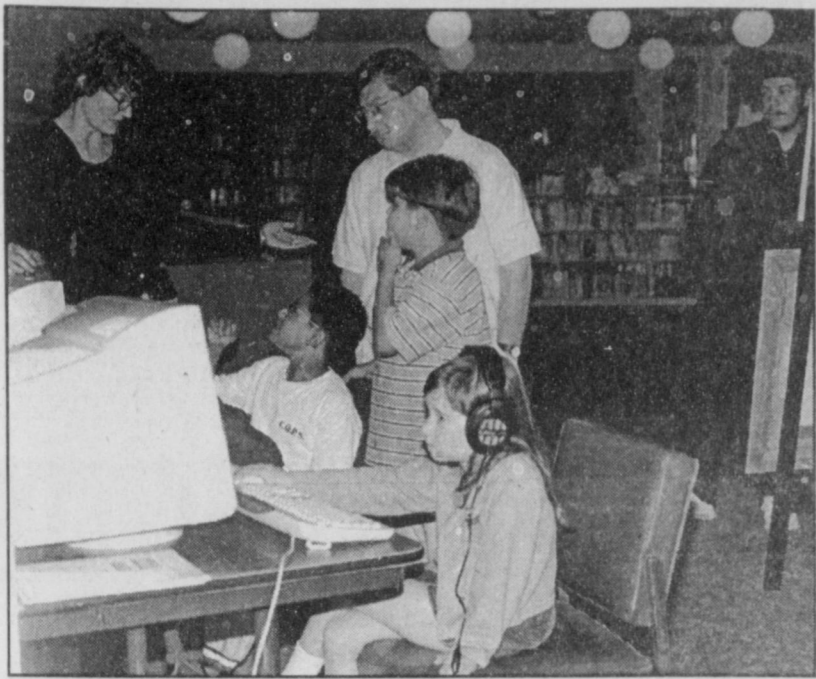

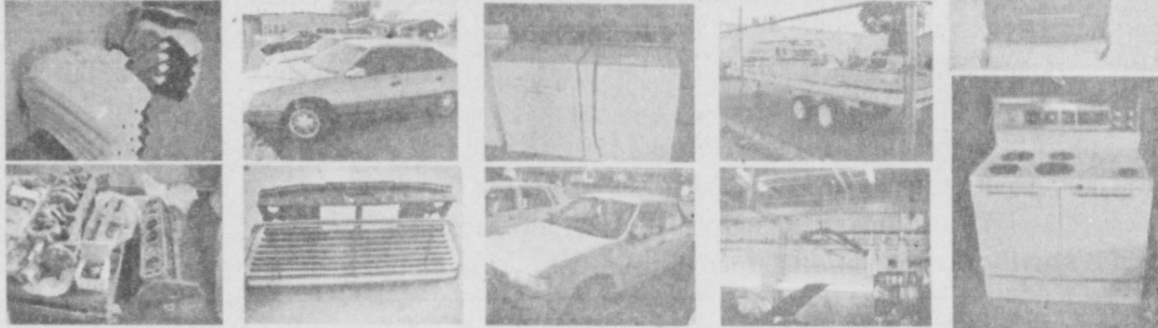

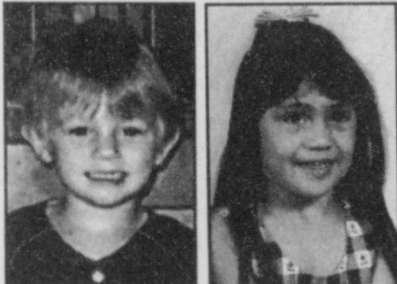

## Combest says Clinton is who played politics

(EDITOR'S NOTE: The following is a column of political opinion written by U.S. Rep. Larry Combest.)

Election Day is just around the corner. Our nation will choose a new president and a Congress. It is essential that we have a Congress and administration that work together for the good of our country, not partisan politics.

Over these past two years, we in Congress balanced the budget, stopped the raid on the Social Security Trust Fund, and paid off \$354 billion of the public debt.

In addition, we passed meaningful tax measures that put more money back in taxpayer pockets.

Taxpayers will not see all of the benefits from some of the legislation that was passed, because the administration chose to play politics with these initiatives.

Congress recently passed a ma-

ior tax-relief package that strengthens Medicare, helps rural communities, provides tax relief for small businesses and the self-employed, and expands retirement savings options.

The bill provides \$30 billion for Medicare and Medicaid, with \$12.5 billion for hospitals.

It increases Medicare payments and increases Medicaid funding for hospitals that treat a

disproportionate share of the uninsured and the indigent.

It takes a common-sense approach. The president has threatened to veto it, which would deny relief to millions.

For instance, 60 million workers without pension plans would miss out on IRA/pension reform, 5 million self-employed individuals would be deprived of access to affordable health and long-term care insurance, and 3.5 million schoolchildren would remain in overcrowded and non-operational classrooms.

In addition, 31 million uninsured low-income Americans, who would benefit the most from

Box 484, Muleshoe, Texas 79347, has applied to the Texas Natural Resource Conservation Commission (TNRCC) for issuance of Air Quality Permit No. 45895 which would authorize an expansion at its Masa Processing Plant located 1 1/4 miles East of Muleshoe on Highway 84, Muleshoe, Bailey County, Texas. The existing facility will emit the following air contaminants: particulate matter, carbon monoxide, nitrogen oxides, organic compounds and sulfur dioxide.

This application was submitted to the TNRCC on October 5, 2000. The application is available for viewing and copying at the TNRCC central office, TNRCC Lubbock regional office, and the Muleshoe Public Library, 332 West 2nd Street, Muleshoe, Texas. The facility's compliance file, if any exists, is available for public review in the Lubbock regional office of the TNRCC.

The TNRCC executive director has determined the application is administratively complete and will conduct a technical review of the application.

**PUBLIC COMMENT/PUBLIC MEETING** You may submit public comments, a request for a public meeting, or request a contested case hearing to the Office of the Chief Clerk at the address below. The TNRCC will consider all public comments in developing a final decision on the application. The deadline to submit public comments is 30 days after newspaper notice is published. After the deadline for public comments, the executive director will pre-

pare a response to all relevant and material or significant public comments.

The purpose of a public meeting is to provide the opportunity to submit comments or ask questions about the application. A public meeting will only be held if the executive director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

If only comments are received on the application, the response to comments, along with notice of the executive director's action on the application, will be mailed to everyone who submitted comments or is on the mailing list for this application.

If a hearing request is timely filed, the executive director will complete the technical review, issue a preliminary decision on the application, and a Notice of Application and Preliminary Decision will be published and mailed to those who are on the mailing list for this application. That notice will contain the final deadline for submitting public comments.

After the final deadline for public comments following any required Notice of Application and Preliminary Decision, the executive director will consider the comments and prepare a response to all relevant and material, or significant public comments. If comments are received, the response to comments, along with the executive director's decision on the application, will then be mailed to everyone who submitted public comments or is on a mailing list for this application.

**OPPORTUNITY FOR A CONTESTED CASE HEARING** You may request a contested case hearing. A contested case hearing is a legal proceeding similar to a civil trial in

state district court. Unless a written request for a contested case hearing is filed within 30 days from this notice, the executive director may approve the application. If no hearing request is received within this 30-day period, no further opportunity for hearing will be provided. A contested case hearing will only be granted based on disputed issues of fact that are relevant and material to the Commission's decision on the application. If the request is made by a group or an association, the one or more members who have standing to request a hearing, and the interests which the group or association seeks to protect, must also be identified. You may also submit your proposed adjustments to the application/permit which would satisfy your concerns. Requests for a con-

tested case hearing must be submitted in writing within 30 days following this notice to the Office of the Chief Clerk, at the address below.

If a hearing request is timely filed, additional notice may be provided. Following the close of all applicable comment and request periods, the executive director will forward the application and any requests for contested case hearing to the TNRCC Commissioners for their consideration at scheduled Commission meeting. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact relating to relevant and material air quality concerns raised during the comment period. Issues such as property values, noise, traffic safety, and zoning are outside of the Commission's jurisdiction to address in this proceeding.

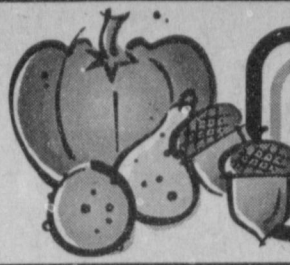
