



#### A LESSON FOR AMERICA

Now that John McDonald has been found, it is probable that the last chapter in the sensational Mooney case will soon be written.

Tom Mooney and Warren Billings, as you of course know, were sent to prison for life in 1917 after they were convicted of planting the bomb, which exploded during San Francisco's preparedness day parade, killing six people and injuring many more. They were convicted chiefly on the testimony of two men. One was McDonald, who swore he saw them de-nosit a suitcase containing the homb at a downtown street

posit a suitcase containing the bomb at a downtown street corner. The other was a man named Oxman, who also testified he had seen them in that neighborhood on that day.

Since then Oxman has been proved to be a perjurer. He was not in San Francisco at all on the day of the bombing, And now McDonald confesses that he never saw Mooney and Billings in his life until long after the bomb-ing. He intimates—and it i s a thing that ought to be looked into pretty thoroughly—that the prosecuting of-ficials of San Francisco willfully connived at his prejury in order to put Mooney and Billings in prison.

in order to put Mooney and Billings in prison. Mooney and Billings were extremely unpopular in San Francisco in those days. They were labor agitators, they did not use kid glove methods, and they had many enemies. Since they were imprisoned their friends have maintained that they were "railroaded" because of these enmities and not because anyone in authority really be-lieved that they were guilty of the bombing. Now it seems as if that charge might have been justified. The whole tragic story illustrates the dangers that arise when a whole community becomes infected with an

arise when a whole community becomes infected with an intense emotion. Mooney and Billings paid for running counter to this hectic emotion of wartime by spending up-wards of a dozen years in prison. It is impossible to give them back those last 12 years; but the least we can do is to take a warning from their case and remind ourselves that it is precisely the unpopular, much-hated prisoner who needs to be given the most scrupulously fair, unprejudiced treatment when he comes into court. In no other way can we avoid repeating this tragic mistake some time in the future .--- NEA.



ed hitting.


