# Our School Land is SOLD

# DEAL MADE Monday.

W L Saye is Now Owner of School Land. Consideration \$10 Per Acre. A Good Deal

The Commissioners Court met! in special session Monday with Judge E. R. Yellott presiding and Cumissioners Christopher. Abno ishop and Reeder pres-

A matter of much importance was disposed of, that of selling our school land. The 4 leagues situated in Dawson and Martin days, of Comunche, for a consideration of \$10 per agre.

This gives Borden county as large, if not the largest, availa ble school fund of any county in the stats. The interest on this land amounts to \$8,856 per annum, or \$21.40 for each scholastic in the county. This gives the Gail school \$2,267.34 which ness after adding our state and county tax of \$877 and our special tax of \$700 makes a total of \$3,944.34 or more than enough to run our school continuously twelve months in the year.

Gail offers educational advantages second to none in the state. We have the money, the building and the faculty and we have every right to be proud of our school and sanguine of its future

There is on display in the land office of Thornton & Pearce an agricultural exhibit of which any country may well feel proud. It consists of potatoes, beets, maize and cotton grown on the river arm of J. C. Benton without irrigation. If you are feeling blue o around and see this exhibit.
