Cellmate: Britton said he'd kill again

AMARILLO — A Pampa man testified today that Christopher Chad Britton had planned an escape while he was being held in the Gray County jail last summer after being charged with a capital murder in the shooting death of a Hemphill County deputy sheriff.
Clarence Reed, who is serving seven years in prison for aggravated assault, told jurors today that he shared a cell with Britton last year and heard Britton make threats against law enforcement officers and plan an escape from the Gray County jail.
Britton is on trial for his life in the shooting death of Hemphill County Deputy Jim Bruce Graham.
Britton was found guilty Friday of gunning down Graham on Father's Day, 2001, in Canadian. The trial moved into the punishment phase today. The state is asking the six man and six woman jury for the death penalty. Britton's defense team maintains there are mitigating circumstances concerning Britton's mental health and are asking for life in prison. In a capital case, a life term requires serving 40 years in prison before becoming eligible for parole.
Reed testified today that during the five weeks he shared a cell with Britton and a dozen others in the Gray County jail, Britton told Reed that if Britton got out of jail, Britton would take his revenge on law enforcement authorities.
"He said if he got out," Reed said, "he'd go finish what he started."
Reed also testified that Britton planned an escape from the Gray County jail with another inmate, Michael Moreno.
Reed said that because the jail was understaffed, jailers would take prisoners out of their cells to give them medication. (See TRIAL, Page 3)

Commission checks up on hot check collection

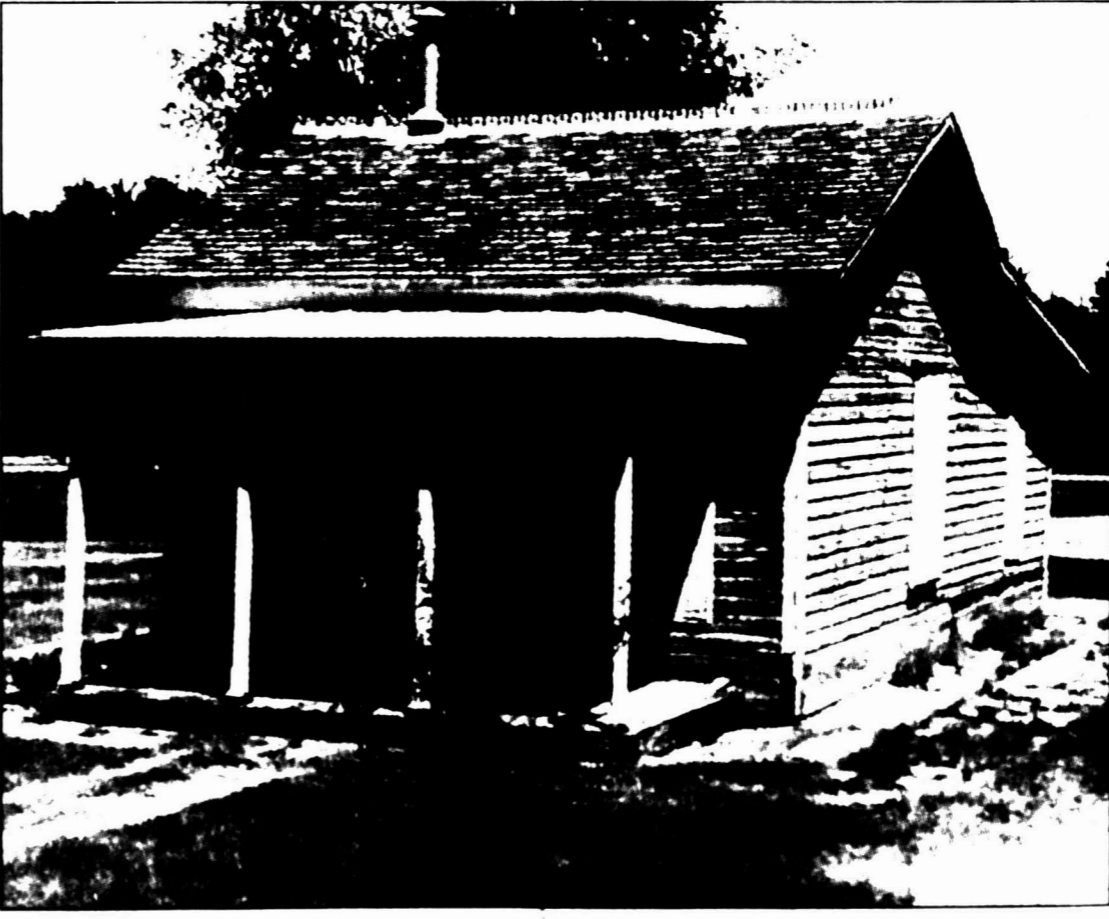

Members of the Gray County Commissioners Court asked County Attorney Todd Alvey Friday afternoon why local merchants are taking their insufficient checks to Justice of the Peace offices in Gray County.
Alvey was called into the all day budget session Friday to answer several questions about the way his office is run as the commissioners were discussing the budget for all offices for the upcoming year.
The County Attorney's office being closed on Friday afternoons was a subject for discussion.
Precinct 1 County Commissioner Joe Wheelley told Alvey he has had complaints from local business owners that they attempted to take checks on a Friday afternoon into Alvey to be filed on and found it closed.
"He came in on Friday afternoon and it was closed," he said. "It upset the business owner and this policy is causing dissension among other county employees."
Alvey told *The Pampa News* this morning that his office is not closed every Friday afternoon.
He said that since he took office nine years ago if everything is caught up he lets his two secretaries go home early on Friday.
"On Friday, there is no set time," he said.

'Pioneer Cottage' to find new home

Pampa's historic "Pioneer Cottage" could have a new home in time for the Gray County Centennial Celebration during the first weekend in October.
A \$5,000 gift from the David D. and Nona S. Payne Foundation, with additional funds up to \$2,000 from the city, will pay for moving and repairing the old structure which now sits in the 600 block of North Starkweather. Iris Ragsdale wrote the successful grant request.
The two-room cabin was built in 1903 by Gray County settlers Wiley Vincent and his wife Katie, according to historical information provided to the City Commission. The structure was purchased in 1920 by then-Pampa Mayor E.S. Carr, and was later donated to the Pampa Genealogical and Historical Society by the Clifford Vincents in 1963. It's now under city auspices.
The cabin was furnished with some period pieces and restored to its original appearance and was recorded as a Texas Historic Landmark in 1970.
Community Services Director Bill Hildebrandt recently gave the City Commission an outline of the plans and said a glitch had developed because representatives for the Schneider House said they'd rather not see the structure placed in the park across the street.

Trial to begin for news anchorman

SAN ANTONIO (AP) — The trial of a news anchorman charged with possessing child pornography was set to begin this week, with pretrial motions scheduled for Monday.

Prosecutors plan to present audiotapes and videotapes that they say depict Gerry Grant talking in graphic terms about having violent sex with children, according to court records.

The documents state that Grant told a prostitute, Heather Powell, that he once paid "extra" to have sex with a girl, 8 or 9 years old, in Mexico and that he molested a lost child in a vacant hospital room, the San Antonio Express-News reported in Monday's editions.

He also told Powell about his desire to lure a "Hispanic girl from the city's West Side" with ice cream, then kidnap and sexually assault her, according to transcripts quoted in the state's notice of intent to introduce evidence, filed last week.

At one point, according to the transcript, after talking about the proposed assault, he wonders aloud, "How do I get away?"

The document is filled with the excerpts from Grant's conversations with Powell that police say they caught on tape as part of an undercover police sting. The conversations took place in a hotel room where Grant met Powell, whom he had been seeing for about nine months, according to records.

Neither prosecutors nor Grant's attorneys would comment about the case. Grant did not return messages left by the newspaper at his home.

Attorneys will meet Monday to discuss several pretrial motions, including an effort by Grant's attorneys to persuade state District Court Judge Juanita Vasquez-Gardner to toss out evidence they deem was obtained illegally.

Jury selection is set to start Tuesday.

The trial has been postponed at least twice after Powell was shot and left partially paralyzed in an unrelated incident.

Grant was arrested Oct. 16, 2000, while he was on his dinner break from KSAT-TV. Police charged him with one count of possession of child pornography, accusing Grant of buying four photographs of children ages 6 to 12 in sexually explicit poses. He currently is out on a \$100,000 bond.

Microsoft moves forward to comply with settlement

WASHINGTON (AP) — Microsoft Corp. is disclosing more technical information about its Windows operating system products in order to comply with a federal antitrust settlement that has yet to be approved by a judge, the company announced Monday.

"Microsoft is obligated as a company to continue to move forward to meet our obligations under the agreement, even as we are waiting for a final decision," Microsoft general counsel Brad Smith said.

The technical information will help software makers write programs that work as well with Windows as Microsoft's own products do.

Some of the technical data will be released online this month for free, while other information — data designed for large "server" computers that run networks — will require a licensing fee.

The disclosures came along with other previously scheduled moves to comply with the settlement. Microsoft will finish work on a new update to Windows this month which will allow computer users to hide some functions of Windows, like the media player, Web browser or mail program.

That concession was made to calm federal concerns that Microsoft's overwhelming market share in the personal computer operating system market allows it to promote its own software more heavily, giving it an unfair advantage over competing software makers like RealNetworks and America Online.

Some critics, such as RealNetworks, AOL and the nine state attorneys general who are still suing Microsoft, say that provision and other portions of the federal deal don't go far enough to keep Microsoft from dominating the industry.

The states want far stricter penalties, including some that would require broader technical disclosure.

Microsoft's Internet Explorer Web browser into the public domain and force Microsoft to let companies translate its Office productivity software to use on other operating systems.

U.S. District Judge Colleen Kollar-Kotelly, the same judge who will decide whether to approve the federal settlement, also has to decide whether to grant the states any or all of their requests. She concluded public hearings on the matter earlier this year, and is expected to make her decision in both cases within the next several months.

The original judge in the antitrust case, Thomas Penfield Jackson, ordered Microsoft broken into two companies as punishment for hurting consumer choice and breaking antitrust law. An appeals court upheld many of the violations but reversed the breakup order and appointed Kollar-Kotelly to determine a new punishment.

Microsoft also said Monday that new Windows license contracts with computer makers go into effect this month. Microsoft had been accused of using its licensing provisions to reward "good partners," while punishing those that did not accede to Microsoft's wishes.

The federal settlement calls for uniform contract licenses for all major computer manufacturers. Some computer makers had complained about the uniform deals when they first went into effect last year, saying they were more restrictive than their previous agreements. The new licenses reflect the computer makers' concerns, Microsoft said.

States that rejected the government's settlement with Microsoft last fall and are pressing for tougher penalties are Iowa, Utah, Massachusetts, Connecticut, California, Kansas, Florida, Minnesota and West Virginia, along with the District of Columbia.

Protesters rally against Houston candidate

HOUSTON (AP) — A councilman running for mayor who voted against a resolution supporting the study of slavery reparations is getting his own form of payback, the unwanted kind.

A group of nearly 30 protesters gathered outside Michael Berry's home Sunday to rally against his mayoral bid because of his vote last week. The Houston City Council voted 8-7 to defeat a resolution sponsored by Mayor Lee Brown.

The demonstrators say

Berry's decision not to support a congressional bill that would establish a commission to recommend remedies for slavery, demonstrates he is against the interests of black Houstonians.

"We are sick and tired of every time you turn around someone is making promises to the black community but no one stands for those promises," said Khalid Greene III, a minister at St. Savior Church.

Michael Berry said he was for black people and wanted us

to keep hope alive, but in one fatal vote he has destroyed the hope," Greene said in Monday's editions of the Houston Chronicle.

The protesters, who held signs and chanted off and on for 35 minutes, came to let Berry know "if he thinks we're going to vote for him as mayor, he needs a checkup," Greene said. Houston police set up barricades around Berry's Westheimer house and about 20 officers stood guard.

ication rather than deliver the medication to the cells.

Britton, Reed said, planned to attack a female jailer with a homemade knife and breakout with Moreno.

"He was going to kill her," Reed said.

Reed said that Britton told him that after he escaped, he would get back at the cops.

Reed testified that he told Britton he wasn't going to let him do that.

Britton also made derisive remarks about his grandfather, Reed said. Dondle Fuller would write his grandson in an effort to reconcile their dif-

ferences, but Britton said he hated his grandfather, Reed testified.

Reed also said that Britton would draw cartoons of a man in a car shooting policemen and cartoons depicting officers with half their faces missing.

While Warren Clark, one of Britton's defense attorneys, insisted that Reed didn't like Britton because of a confrontation when Britton was first put in the Gray County jail, Reed said he wasn't around Britton long enough to dislike him.

Clark also asked if Reed's testimony was part of a plea bargain with the district attorney's office, but Mack Cobb, the prosecutor from the Texas Attorney General's office, said that the statement made by Reed concerning Britton's

actions was made after Reed pleaded guilty to aggravated assault charges.

The state's first witness today, Bonnie Watson of Mobeetie, testified that Britton had grown up in Canadian with Watson's daughter.

"I had problems with him when my daughter was in school," Watson said. "He would verbally abuse her."

Watson said Britton later married her niece, Julie Britton, and that there had been a confrontation between Chad and Julie's family at the Shattuck, Okla., hospital when Britton's son was born because Britton didn't want his mother-in-law there.

"He just didn't like her," Watson said.

Watson also testified that Britton spoke harshly to Julie

and had kicked his dogs several times in anger.

Ben Beasley, Julie Britton's brother, testified that he feared Britton would hit his sister several times and that Britton had once threatened him, but nothing ever came of the threats.

Cathy Stevens, who now lives in Perryton, testified that Britton had told her at a Canadian convenience store in 1994 that "All pigs should die."

She said she understood him to mean police officers.

Later that year, Stevens said, she and her husband, her son and Britton were standing in the Stevens' front yard in Canadian when Hemphill County Deputy Joe Hoard drove by and waved.

Stevens quoted Britton as

saying, "I can't stand pigs."

Under cross examination, however, Stevens agreed with Clark that Britton was immature for his age and often said things to startle people.

While she agreed that Britton engaged in attention getting behavior, she said, "I never heard another kid say, 'All pigs should die.'"

Preliminary autopsy: boy died of heat stroke

MIDLAND (AP) — The 4-year-old Fort Stockton boy who was missing and later found in the trunk of a car a few feet from a relative's home last week died from heat stroke, according to a preliminary autopsy report.

Schyler Lee Fain probably only lived about 30 minutes in the trunk of the 1982 Volkswagen two-door hatchback, physicians said. His body was found in the car's spare tire compartment by search dogs on Friday.

Authorities believed they had searched all the cars, Pecos County Sheriff Cliff Harris said.

The grant request was for locating the cottage in the H.E. and Inez B. McCarley Park in the 100 block of West Atchison, Hildebrandt said. Before another location can be used, Hildebrandt said he will have to clear it with the Payne Foundation.

What's suggested as an alternative is the Santa Fe park on the Southeast corner of Atchison and Cuyler, Hildebrandt said. It, too, is a location that will allow for increased visibility of the cottage. It will provide opportunities for the nearby White Deer Land Museum or other approved offices or organizations to unlock the building occasionally so that interested citizens can see the interior of the 16-foot-by-27-foot cabin.

Mayor Lonny Robbins said he, too, received a request the cottage not be placed in McCarley Park because there is "some concern" by Schneider House residents of park overcrowding and the change in aesthetics that would result. He said the gazebo in the park now is used for activities, including weddings.

The mayor also posed the question: "Can it be moved without falling apart?"

Hildebrandt said the cottage porch "is fragile" but said he believed the building could be moved and said plans call for installing, for \$3,500, new footings for the building. Repairs to the porch, roof and any other damaged features are included in the plan.

According to information given the Commission, Centennial chairman Darlene Birkes has verified that moving the cottage will not terminate nor alter its Texas Historic Landmark status.

taloupe and watermelon. Customers may get a taste of the delicious cantaloupe before they purchase one.

David Smith of Pampa has an appreciation of the fresh vegetables as he makes his purchases from the local vendors.

Ruby Morgan of Pampa has been selling her vegetables for many years at the local market, too. A specialty of hers — homemade hot sauce — is a popular item with the early morning customers.

Travis Trussell of Groom helps his daughter, Kelly Schaffer of Schaffer Farms south of Pampa, by selling her home-grown vegetables at the local Farmers Market. He sells vegetables in

small containers displayed on his table. Also, he offers vegetables for sale by the bushel directly from the farm.

Watermelon, cantaloupe, potatoes, onions, squash, cucumbers, zucchini, okra, peppers, green beans, corn on the cob, tomatoes, and black-eyed peas, are all offered for sale by the vendors. Freshly canned pickles are also available for the customers.

The farmers arrive at their location before 7 a.m. to begin selling for the day. Usually, they say they are gone by noon due to the heat or running out of vegetables to sell.

the staff was there all afternoon.

"Sometimes in the afternoon we don't get out of here until after 5 p.m.," he said.

Wheley also said he has had complaints that the County Attorney's office is not aggressively pursuing hot check writers, and businesses are now taking the checks to Justices of the Peace in Gray County for collection.

He said he knew that the Commissioners Court couldn't make Alvey change the hours of his office because the commission cannot tell another elected official how to run their office. Wheley said the closing by the County Attorney's office on Friday afternoon is causing problems.

According to figures furnished by County Auditor Elaine Morris, the office collected \$10,385 in hot checks last year and \$5,986 so far this year.

Wheley said when the secretarial position was allocated to collect the hot checks under former County Attorney Bob McPherson, it was made clear that the collections were to be enough to meet the salary and fringe benefits.

"That position was carrying itself under McPherson," said Wheley. "It's not now. I understand a lot of business owners are now taking the check to the JP's to be collected."

The hot check secretary makes \$15,600 in salary plus longevity and \$7,786 in fringe benefits, according to Morris.

Alvey said, "There is no way she will collect \$23,000, but I know she is worth it." He added that she could collect \$10,000.

Wheley asked about the procedure which is currently followed in the County Attorney's office when checks are taken to them.

"I would think any check that comes in you should send out a letter," he said.

Alvey said that is what the secretary tries to do. "Sometimes some of the larger businesses will bring in as many as 150 checks at a time. The checks are placed in the stack of hot checks received, and it takes time to get the form letters out to the people and get the information in the computer," said Alvey.

He conceded more could be

done in the area of hot check collections.

"We probably haven't done enough to get checks done," said Alvey. "I can't operate the office with one secretary. I guess I could, but not as effectively." He also said crime is up across the community.

Alvey also said he doesn't think the JPs should be collecting some checks.

"If the checks are over \$50, the JPs shouldn't collect them," he said. "I disagree with them."

Precinct 4 County Commissioner James Hefley asked what the fine is on a check.

Alvey said the fine is \$15 a check. He said the majority of the fees come from court costs. He estimated a \$25 check turned over to his office for collection will cost the check writer approximately

\$250 to \$300.

Wheley said the county is looking at an extremely tight budget and the aggressive prosecution of check writers could generate some revenue.

Precinct 3 County Commissioner Gerald Wright said, "You need to keep the office open on Friday afternoons and get these checks collected."

Alvey responded, "I will not argue with you on that."

County Judge Richard Peet said that while the Commissioners Court does not have control over how an elected official runs their office, the commission does control the purse strings of the county.

He added that it was the responsibility of the commission to see that services should be furnished to the people of the county.

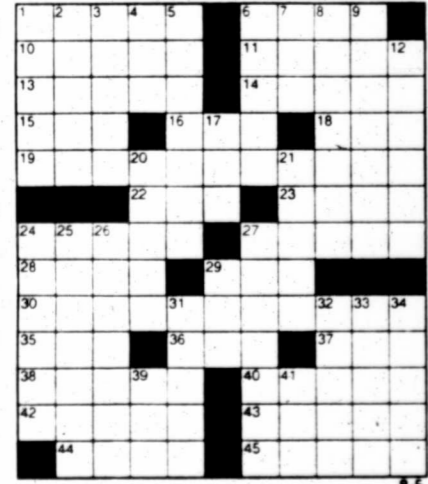

Cowboys, Texans escape heat in cool facilities

In 1954, Bear Bryant took 35 of his Texas A&M players to a preseason training camp in Junction. They practiced in 120-degree temperatures without food or water for eight hours for 10 straight days.

The Dallas Cowboys and Houston Texans continued their NFL training camps Saturday by practicing inside climate-controlled facilities.

As Cowboys owner Jerry Jones said when the Cowboys opened their camp last month in San Antonio's Alamodome, "Bear Bryant would be rolling in his grave."

Training methods and health concerns have changed drastically in the nearly half-century since Bryant's hellish camp, which set the foundation for a championship team two years later.

NFL coaches and trainers are keeping a close watch on their players, determined to avoid a repeat of last August's heatstroke death of Minnesota's Corey Stringer.

And unlike most NFL teams, the Cowboys and Texans have the option to go inside.

DALLAS COWBOYS

Until Friday's workout and scrimmage with the Texans in Houston, the Cowboys hadn't even been outside for training camp.

The Cowboys moved their camp this

year to San Antonio after spending the last four summers in the stifling 100-degree-plus heat of Wichita Falls.

Their plan was to have morning workouts on a temporary grass field set up in the Alamodome parking lot, with afternoon and evening practices inside the climate-controlled building. But the grass field still isn't ready.

All 12 of their San Antonio workouts have been in the Alamodome, but that doesn't concern coach Dave Campo. The Cowboys had offseason workouts outside at their Valley Ranch facility, and will be there nearly two weeks before the Sept. 8 opener at Houston.

Campo contends that his players are working harder, and getting more done inside. And while they are in an air-conditioned building, most players have sweat flowing off their brows as they leave the practice field each day.

"I'm looking at it more as a freshness thing. The general practice tempo, the energy and the mental aspect of things are improved," Campo said. "If we were practicing in 112 degrees, I'd also feel good right now."

Most players remain in shape year-round, so the purpose of training camps has changed over the years. Campo said the majority of camp isn't spent just trying to get players in shape, as happened in decades past.

"We conditioned all offseason and we had hot days for our minicamps and quarterback schools," said defensive end

Greg Ellis. "We will be fine."

Plus, practicing in the heat is no guarantee of being prepared to play in it.

For the 2000 season opener at Texas Stadium, it was 109 degrees — 171 on the artificial turf. The Philadelphia Eagles, who had trained in a cooler location that preseason, won 41-14 and reported only one player with a heat-related problem while several Cowboys struggled with cramps after enduring Wichita Falls.

HOUSTON TEXANS

The expansion Texans have a \$3 million practice bubble at their lush home practice facility, but they haven't used it too often to beat the intense Gulf Coast heat. The Saturday workout was only their second indoors.

Coach Dom Capers wants his players heat-tested for hot-weather games, but that doesn't mean the Texans are ignoring the heat. Team physician Dr. Walter Lowe and the Texans' staff keep close watch on all players.

"The last thing a player does before he goes on the field is get weighed, and the first thing he does when he comes off the field is weigh again," Lowe said. "We watch them at the breaks and see who is starting to get lightheaded and keep pushing water at them."

Lowe doesn't depend on the players to tell the truth when it comes to the heat. "A lot of these guys won't make this team so a lot of them will try to push

through something like the heat," Lowe said. "We watch them closely during practice. If they start to blow, we get them out."

Players who return from workouts with unhealthy weight loss, get a break the next day.

"You'll see some of these big guys lose 12-15 pounds," Lowe said. "We base it on their size. A 175-pound wide receiver might be in trouble, losing 5 or 6 pounds. It's an individual thing."

Lowe thinks the air-conditioned bubble is overrated for coolness.

"It might be worse in there," Lowe said. "There is no breeze and it can have a green house feel."

After working out in the bubble, Houston players don't agree with Lowe's assessment.

"It was really nice," linebacker Keith Mitchell said. "It gave us a chance to get inside and get our legs under us again and slow things down just a little."

Capers has scheduled his workouts so players have a chance to rehydrate between drills. He alternates the times of two-a-day workouts so the players have two meals between each workout.

"We are taking as many precautions as we possibly can to avoid any heat-related problems," Capers said.

An estimated 150 curious Texas Tech fans lined the two practice fields to get a sneak peek of what to expect when Tech and Ohio State meet Aug. 24 in the NACDA Pigskin Classic in Columbus, Ohio.

Leach addressed the team following the afternoon workout and praised the players for their "great attitude and effort" following nearly four months off of organized practice since the April 14 Red-Black game at the conclusion of spring workouts.

"It was a really good first day, a good starting point," Leach said. "It was great to see our players excited about getting cranked up, and it was just as nice to see so many Red Raider fans here to check us out."

"We still have some polishing work on assignments to do, but the effort level is really good," Leach added.

The practice was the first for the varsity, while the newcomers worked through their fifth practice of the preseason.

Kelly's salute to son caps teary NFL ceremony

CANTON, Ohio (AP) — Jim Kelly never tossed a touchdown pass as meaningful or had a moment on the field as sweet.

Just as if he once again were running Buffalo's no-huddle offense, Kelly spread things around Saturday during a moving induction speech into the Pro Football Hall of Fame.

Choking back tears throughout his 10 minutes at the podium, the Buffalo Bills quarterback thanked the teammates, coaches, family and friends who helped him achieve football's highest honor.

Then Kelly looked down at his terminally ill 5-year-old son.

Hunter Kelly, who shares his father's birthday and grit, has Krabbes disease, a rare degenerative disorder of the nervous system that robbed him of motor skills.

"It's been written that the trademark of my career was toughness," Kelly said. "The toughest person I ever met in my life was my son, my hero, Hunter. 'I love you, buddy.'"

Kelly's closing capped an emotional day as he was enshrined along with the late coach George Allen, tight end Dave Casper, defensive lineman Dan Hampton and wide receiver John Stallworth.

On a hot day, a record crowd of 17,700 attended the ceremonies in Fawcett Stadium, a long TD pass from the Hall.

This was the first time the ceremony wasn't held on the Hall's front steps since 1965.

Good thing, too, since Kelly's enshrinement brought thousands of Bills fans — many of them wearing his No. 12 jersey — who made the 240-mile drive to Canton and made Fawcett feel like an October afternoon in Orchard Park, N.Y.

"Is there anyone back in Buffalo today?" said Bills Hall of Fame coach Marv Levy, who presented Kelly for induction.

"I feel like I'm in Buffalo," Bills center Kent Hull said before the ceremony. "Look at this."

People back in western New York undoubtedly were watching the ceremonies on TV to see Kelly, who led the Bills to four straight Super Bowls.

Kelly passed for 35,467 yards and 237 TDs during his 11-year NFL career. He led the Bills to the playoffs eight times, and Levy has no doubt who he would want with the ball and time running out.

"Right there," Levy said, stepping back from the podium to point at Kelly. "Jim Kelly, No. 12. He cared about winning. He cared about his team and his teammates. He cared about his family. His arm was great, but so was his heart."

Beyond his unquestioned physical skills, Kelly's greatest attribute was the way he led — with a swagger.

"If there was a movie made about the life of John Wayne," Levy said. "Jim Kelly ought to play the part."

Kelly was the afternoon's final speaker, and for a moment it seemed like the sea of red, white and blue Bills fans wasn't going to let him get started, drowning out his opening with a rousing ovation.

"Today, I'm joining the greatest team of them all," he said.

Allen, a tireless worker and master motivator, is the only Hall of Famer to have coached for 12 seasons without a losing record.

He helped turn the Los Angeles Rams and Washington Redskins into winners while compiling a 116-47-5 career record.

"The future is now," said Hall of Famer Deacon Jones, opening with one of Allen's best-known phrases. "He was the consummate player's coach. He taught us the harder we worked, the luckier we got. And boy, did we get lucky."

Stallworth was the less spectacular but steadier half of one of the NFL's greatest receiving tandems.

Stallworth and Lynn Swann helped the Pittsburgh Steelers win four Super Bowl titles, and it was Swann's impassioned speech during last year's inductions that helped get his friend elected.

Swann said the "greatest hour of my life is only a half-hour until John Stallworth is here."

Olympic skaters defend their wins

ARLES, France (AP) — Four Olympic champions embroiled in an ice skating scandal denied allegations that the results were fixed to ensure their victories.

French ice dancers Marina Anissina and Gwendal Peizerat and the Russian pairs champions, Elena Berezhnaya and Anton Sikharulidze, on Monday defended themselves against allegations that a Russian mobster arranged a vote-swapping deal to ensure the two couples won their events at the Salt Lake City Games.

Anissina said she knew the Russian man in question, Alimzhan Tokhtakhounov, but did not speak to him during the Olympics. She called the vote-fixing allegations "ridiculous."

"This situation has perturbed me. I am certain it is something that is a complete fabrication," she said.

Anissina said she met Tokhtakhounov in 1999 at a reception and kept in occasional contact with him.

"But I never asked him for anything. It's not true at all," she said. "During the Olympics, I never telephoned him. I am sure that that is not my voice. I don't know who my mother called, but I am sure that she didn't do that either."

Peizerat, wearing a T-shirt with the words "Not Guilty," bristled at suggestions that he could lose his medal. Jacques Rogge, president of the International Olympic Committee, has said he would not rule out changing the figure skating medals if the United States proves its case against Tokhtakhounov.

"You can't take the medal away from us, it's in our hearts," Peizerat said.

Didier Gailhaguet, the president of the French Skating Federation, defended the athletes and said each team "won their medal on the ice."

In a criminal complaint based on wiretaps, U.S. authorities charged Tokhtakhounov with arranging a vote-swapping deal between French and Russian judges in pairs and ice dancing at the Winter Games in February.

Prosecutors contend Tokhtakhounov cut a deal to obtain a visa to return to France. Italian police, who arrested Tokhtakhounov at a resort and are holding him in a Venice jail, said he might have contacted up to six judges to help secure a gold medal for the Russians in the pairs competition in exchange for a victory by the French ice dancing team.

Stallworth, who owns every meaningful Steelers career receiving record, began his speech by saying, "I'm more than happy to complete that hour for him."

Hampton, a fierce run stuffer nicknamed "Danimal," endured 12 knee operations during his 12 seasons with the Chicago Bears. A six-time Pro Bowler, Hampton never dreamed he would wind up in the Hall of Fame.

"Back in college, I was three things you don't want to be as a football player," he said. "Small, slow and friendly."

He was anything but Mr. Nice Guy with the Bears, though.

"Nobody epitomized Monsters of the Midway better than Dan Hampton," said his presenter, former teammate Ed O'Bradovich.

Casper, nicknamed "The Ghost," was very visible as perhaps the league's premier tight end during his 147-game career.

In addition to his impressive stats, Casper will long be remembered for the "Holy Roller" play, when he nudged a fumble into the end zone before falling on it for a game-winning TD.

"He was everything you always wanted in a football player and more," said his former coach and presenter, John Madden. "He's in the Hall of Fame forever because he earned it and he deserved it."

Texans' offensive line ready for first preseason test

CANTON, Ohio (AP) — The Houston Texans' idea for offense was to give David Carr \$46 million to be their quarterback and to pay Tony Boselli \$7.5 million to protect him.

The grand design hasn't quite worked out as planned going into Monday night's preseason opener against the New York Giants in the Hall of Fame game.

Boselli likely will miss the season opener while recovering from shoulder surgery, forcing the Texans to alter their plans.

"People don't expect us to come out and be as good as New England," rookie Chester Pitts said. "They want us to just improve as much as we can. We just have to give our best and work as hard as we can."

Pitts played left tackle at San Diego State and allowed only one sack all last season. He was drafted in the second round by the Texans and was a likely starter at left guard until Boselli's recovery lingered.

Now he and Jimmy Herndon have the critical job of protecting Carr's blind side, and they don't have long to get prepared.

"You never know how fast you're going to progress, but the most important thing is you continue to progress," said coach Dom Capers. "These guys have been working hard, and now they've got to get ready for the Giants."

"We don't have much time to sit around and evaluate this. We have to look forward to the next game."

Pitts expects the Texans line to improve after Friday night's scrimmage against the Dallas Cowboys. They didn't look very good early. David Carr's first pass of the scrimmage was batted back in his face by blitzing Darren Woodson.

"It's a wonderful opportunity," Pitts said. "It means a lot more because I know I'm protecting David Carr. I try not to think about that thought. I just try to do my job."

Herndon, a former University of Houston lineman, expected to back up Boselli. Now he's competing with Pitts for playing time.

"We have a great mix of veterans and youth, a lot of guys with three-four years experience," Herndon said. "In my mind, we should hold up real well. The older guys are bringing the younger guys along."

Neither player expects much playing time at left tackle when Boselli returns.

"They haven't told me anything," Pitts said. "I just want to stay on the field so I'll do what they say but I know it's Tony Boselli's job and I'm filling in right now."

Steve McKinney, who started at left guard four seasons with the Indianapolis Colts, will start at center, although he'd never played the position before. It was homecoming for McKinney, who played college football at Texas A&M.

"It's a dream come true, as a kid I wanted to play for Houston," McKinney said. "I feel

comfortable at center. It's not as new as it was and every day it gets better."

Boselli, a five-time Pro Bowl lineman, has been in the background since start of training camp, but he's been vocal.

"He's back there all the time telling us things," Herndon said. "He'll give us techniques, tips to help us out. Any questions we have about coming to a new offense, he's glad to help out."

As far as when he'll return, Boselli won't say, although he's asked almost daily.

"You can ask me a million different ways and I'll still say I don't know," Boselli said. "I won't put that on myself. I'll return when I'm healthy and not before."

Herndon expects to be a backup on the offensive line, especially when Boselli returns. He can accept that.

"When Houston got a team, it came up on my prayer list that I wanted to be here," Herndon said.

Man on a mission: Tejera wins, goes to get married

teammate Derek Lowe and Oakland's Barry Zito as the AL's only 15-game winners. He allowed just three singles.

Garciaparra went 4-for-4 to lead the Red Sox, who had 19 hits. Shea Hillenbrand and Cliff Floyd, in just his fourth game for Boston, had three hits each.

Every Boston starter had at least one hit.

Garciaparra homered on the next pitch after Trot Nixon hit his 18th homer in the third inning, and the Red Sox led 3-0. Garciaparra's second homer, a two-run shot, capped a five-run fourth and chased Aaron Myette (0-4) with the score 8-0.

Martinez is 8-0 with a 0.98 ERA (seven earned runs over 64 1-3 innings).

Elliott's experience finally prevails at Brickyard 400

INDIANAPOLIS (AP) — Chalk one up for experience.

As the final laps in the Brickyard 400 clicked away, Bill Elliott knew his car was fast enough to win. He just had to be patient.

Elliott waited until 12 laps from the end. He moved underneath leader Rusty Wallace in turn two, raced past him in the backstretch and pulled away for his first victory at the Indianapolis Motor Speedway and his second straight win this season.

"The young guys are going to be a great part of this sport in the near future," the 46-year-old Elliott said. "But I still want to make my mark while I'm here."

Sunday's win was a big achievement for Elliott, whose Dodge took a 1:26.9 second — 15-car-length — victory over the 45-year-old Wallace. The winner led 93 of 160 laps and two of NASCAR's veterans renewed a head-to-head battle.

Wallace, who started 35th in the 43-car field, drove his Ford to second place for the second time in three years and the third time in the nine-year history of the race.

Elliott became the oldest driver to win the Brickyard and added the only missing link to a Winston Cup resume that had included victories in every other major race.

"It's everything, it means everything," Elliott said after kissing the speedway's brick finish line during the post-race celebration.

It was also a big moment for car-owner Ray Evernham.

Elliott was a struggling owner-driver in 2000 when Evernham began putting his

new team together. He bought Elliott's team and took a chance on hiring the driver, who some thought was at the end of his career.

It all paid off Sunday as Elliott, who has 43 career victories, started second and produced his first back-to-back wins since 1992.

For the rest of the field, the day was not nearly as glorious.

Tony Stewart's frustration continued on the 2 1/2-mile oval not far from his hometown of Columbus, Ind.

After winning the pole, battling Elliott for the early lead and still being in contention late, Stewart mysteriously faded to 12th in the closing laps.

Later, Stewart, who has had temper problems in the past, threw several punches at a photographer for The Indianapolis Star. NASCAR said it would review the incident before deciding on disciplinary action.

"It's a bitter disappointment, and I think when you get him in that situation, it is hard for him to even talk," team owner Joe Gibbs said.

One of the series' top young drivers, Kurt Busch, crashed on Lap 35 after getting bumped from behind by Jimmy Spencer. Busch jumped out of the car, waited for Spencer to return, then tapped his chest and waved his arms in disbelief.

The next time Spencer circled the track, Busch bumped his rear end. The two drivers have bumped several times previously and NASCAR officials said neither would be allowed onto the track for the next event until they and their car owners meet with the sanctioning body.

Brazilian officials optimistic about possible bailout

RIO DE JANEIRO, Brazil (AP) — Top Brazilian officials expressed optimism about the possibility of a fiscal bailout package from the International Monetary Fund following a dinner with U.S. Treasury Secretary Paul O'Neill.

O'Neill arrived Sunday evening on a four-day regional tour of South American countries seeking more consistent U.S. support for plans to repair their ailing economies.

Late Sunday, Bush administration officials in Uruguay and Washington announced that an emergency loan of \$1.5 billion would be wired to the crisis-wracked nation Monday. Uruguay shuttered all state and private banks for four days last week but said all but a few of the weakest institutions would be reopening Monday.

The U.S. assistance to Uruguay is to be repaid within days once Uruguay receives a new loan package from the IMF, the World Bank and the Inter-American Development Bank.

Uruguay's four-year economic tailspin has been exacerbated by the unraveling of the Argentine economy next door. The loan marks the first time the Bush administration has provided direct economic support to a country in financial crisis and underscored growing U.S. concern about the widening economic troubles in Latin America.

O'Neill said last week that the administration supported more assistance to Brazil and Uruguay because those countries were pursuing appropriate policies to deal with their economic troubles. He did not include Argentina — still struggling to devise a sustainable plan — in that list.

O'Neill, whose trip includes stops in Uruguay and Argentina, spent three hours dining at the house of Central Bank Governor Arminio Fraga in Rio de Janeiro along with Finance Minister Pedro Malan and the presidential Chief of Staff Pedro Parente.

Brazilian officials are hoping O'Neill's visit will help secure financial support from the IMF in order to avoid a debt crisis and calm financial markets jittery about October presidential elections.

Asked whether O'Neill supported a new accord between the IMF and Brazil, Parente said: "I think it was very positive. I perceived on the part of the secretary a posture that was very favorable, very comprehensive and with a lot of interest about the Brazilian situation."

O'Neill left without speaking to the press.

On Monday, O'Neill meets in Brasilia with President Fernando Henrique Cardoso and early Tuesday will talk with business leaders in Sao Paulo before making a three-hour stop in Uruguay en route to Argentina.

O'Neill's meeting with Cardoso was almost canceled after O'Neill suggested last week that aid money for the South American countries might be diverted to Swiss bank accounts. O'Neill also reiterated wariness about extending big rescue packages to heavily indebted countries like Brazil.

Investors reacted to O'Neill comments by dumping the country's currency and bonds. The Brazilian real then fell to 3.47 to the dollar, the lowest point in its eight-year history.

On Thursday, O'Neill said he favored IMF support for Brazil. He added that the country's economic team "has done a remarkable job of maintaining sound fiscal and monetary policies."

O'Neill's reversal reflected a larger change in the administration of President Bush, which had come to office promising to move away from the big bailouts of the Clinton administration.

McDonald's trying to lure Japan market

TOKYO (AP) — In a nation famous for steep prices, one bargain stands out — the 59 yen hamburger. The special offer, launched Monday by McDonald's Co. Japan, is part of the company's campaign to win back sales devastated by a mad cow scare and other fears about food safety in Japan.

"The cheaper the better," said Ken Inoue, a 32-year-old employee at a computer company, who had two hamburgers, at a cost of about 50 cents each, a teriyaki burger and coffee for lunch at a bustling Golden Arches in Tokyo. "I had two burgers so I'm happy."

Japan has long been notorious for outrageously high prices. But a discount war is intensifying in a wide range of products lately, not only in fast-foods but also in clothing, airplane tickets and household knickknacks, as a long economic slowdown deadens consumer spending.

Hamburger prices in the United States vary from one McDonald's to another, but a burger now costs about \$1 in New York.

McDonald's, which runs nearly 3,900 stores in Japan and attracts roughly 1.2 billion customers a year — including repeats, had scored enormous success with a price-cutting campaign on the burger two years ago to 65 yen (55 cents) each.

But McDonald's raised the burger price back up in February, to 80 yen (67 cents) — just at the wrong time.

Cases of mad cow disease, a brain-destroying illness, which began popping up in Japanese cows last autumn, made beef patties an extremely unappetizing option.

Although McDonald's Japan uses Australian beef, which has not been infected with the disease, sales plunged, dropping about 18 percent some months compared to a year ago.

The aversion to beef was so strong some barbecued beef restaurants collapsed. A series of scandals at other companies over mislabeled meat — including pork and chicken as well as beef — broke out about the same time, setting off deep doubts about food safety and pushing families to eat at home.

Especially worrying is the fact that sales at McDonald's haven't picked up, although overall food fears appeared to be ebbing by springtime, said Seiichiro Samejima, analyst at Ichiyoshi Research Institute in Tokyo.

"People could be getting bored with McDonald's food. And that could mean a crisis for McDonald's," he said.

The price campaign is sure to help a little, but Samejima said it was unlikely to fuel a drastic recovery.

McDonald's Japan Senior Vice President Yutaka Kobayashi acknowledged that low prices alone aren't enough to woo Japanese back to burgers and fries. Marketing research shows people simply aren't happy with the McDonald's menu, he said.

"Basically, McDonald's does not see the 59 yen burger as our only weapon," Kobayashi said. "Customer needs are growing more diversified."

McDonald's has begun offering a new menu of salads and soups at about 2,800 stores to attract calorie-conscious women and a better grade of coffee at 900 outlets to respond to customer complaints, Kobayashi said.

Congress elects U.S.-educated businessman president of Bolivia

LA PAZ, Bolivia (AP) — Gonzalo Sanchez de Lozada, a wealthy businessman who grew up in the United States, has won the presidency of this crisis-wracked South American nation for a second time.

Congress voted the millionaire mining executive back into office Sunday, choosing him over Evo Morales, the rebellious Indian leader of Bolivia's coca growers.

Sanchez de Lozada, who was president from 1992 to 1997, will take the helm of a nation mired in an economic slump as unemployment and rising crime have fueled social unrest. He will also face a contentious opposition, spearheaded by Morales and his Indian-dominated Movement to Socialism congressional bloc of 35 legislators.

The two men topped the voting in a June national election. Sanchez de Lozada officially won with 22.46 percent of the vote and Morales was second with 20.94 percent, but since neither won an outright majority, Congress had to vote.

Sanchez de Lozada, 72, beat Morales 84-43 in the legislative vote. Two congressmen left their votes blank Sunday, while 26 voted for Manfred Reyes Villa, who came in just 714 votes behind Morales in June. Two other legislators were absent.

Morales, 42, the son of Aymara Indian shepherds, gave Bolivia's long-neglected indigenous majority a political

presence not seen before. His group may fight the night for more than 24 hours. All 155 members present gave speeches, with some wearing multicolored Indian clothing and speaking in indigenous languages. Others chewed coca leaf, the base material of cocaine but also an important part of centuries-old

Indian culture in the Andes.

Sanchez de Lozada assured his victory in the legislative vote more than a week ago by securing an alliance with his rival, leftist former President Jaime Paz Zamora.

Morales has led sometimes violent protests against U.S.-backed efforts to eradicate coca

plantations. He has organized regional strikes and highway blockades that have paralyzed parts of the country.

Morales's supporters railed against Sanchez de Lozada during the legislative vote, equating him with centuries of repression and accusing him of "selling the homeland" in a privatization

program during his first presidency.

After the vote, Sanchez de Lozada called for cooperation among Bolivia's often quarrelsome political factions.

"I don't think that everything that's been said, all the zeal and confrontations have been anything other than the expression of democracy in a free country," he said.

Still, he added, "We can't be fighting each other and misunderstanding each other because the country is in crisis."

Known by the nickname "Goni," Sanchez de Lozada was raised in Washington, where his father was a diplomat, and later studied philosophy and English literature at the University of Chicago. He still speaks Spanish with a distinct American accent.

Foundation raises money for pre-Holocaust village in Israel

NEW YORK (AP) — For more than 20 years, Yaffa Eliach has been documenting history. Now she's trying to recreate it.

Eliach and her New York-based Shtetl Foundation hope to break ground as early as this fall on a recreation of a shtetl, or rural Eastern European Jewish village, in central Israel.

Plans call for the shtetl to be constructed on 124 acres in Rishon Le Zion, a suburb of Tel Aviv. It is designed as an interactive museum, with two synagogues, a market square, a library and a fortified castle all available for public use, all remnants of a bygone era.

"There is always a major focus on death and destruction," said Eliach, a professor

of Judaic studies at Brooklyn College. "When people go to Eastern Europe, all they see is concentration camps. I wanted to restore the great Jewish past."

The goal is to recreate daily life in towns that were essentially decimated by the Nazis. Eliach, 65, a scholar in Eastern European history and a Holocaust survivor, said she

worries that memories of a once-vibrant Jewish culture in Poland, Russia and Lithuania have been subsumed by sorrowful images of the Holocaust. She said she hopes her museum could remedy that.

The Shtetl Museum would combine elements of several old European villages, including Eliach's own Lithuanian hometown, Eishyshok. A stone-brick castle would house the shtetl's library and arts center. A market square is expected to feature era-appropriate drugstores, restaurants and barbershops. Visitors would be able to marry in the shtetl's synagogues.

"For Jews of East European heritage, the shtetl does figure symbolically as a cultural home, as a kind of fountainhead of cultural experience," said Jeffrey Shandler, an assistant professor of Jewish Studies at Rutgers

Mother bear, cub self-destruct in house fire

FOREST FALLS, Calif. (AP) — A mother bear and cub died in a fire they started after breaking into a home in a San Bernardino National Forest mountain community to look for food.

A 300-pound black bear and her cub entered the house through an open front window Sunday afternoon while the family was out grocery shopping, fire spokeswoman Tracey Martinez said.

The bears knocked down a living room lamp, sparking the fire, but continued to the kitchen in search of food, Martinez said.

The two were trapped inside the burning home and died. Firefighters discovered the carcasses when they doused the flames, Martinez said.

"It's my understanding that the bears have been kind of terrorizing the neighborhood and broke into several other houses," Martinez said.

About 400 black bears roam the San Bernardino and San Gabriel mountain ranges, according to state Fish and Game wildlife biologist Kevin Brennan.

Forest Falls is about 90 miles east of downtown Los Angeles.
