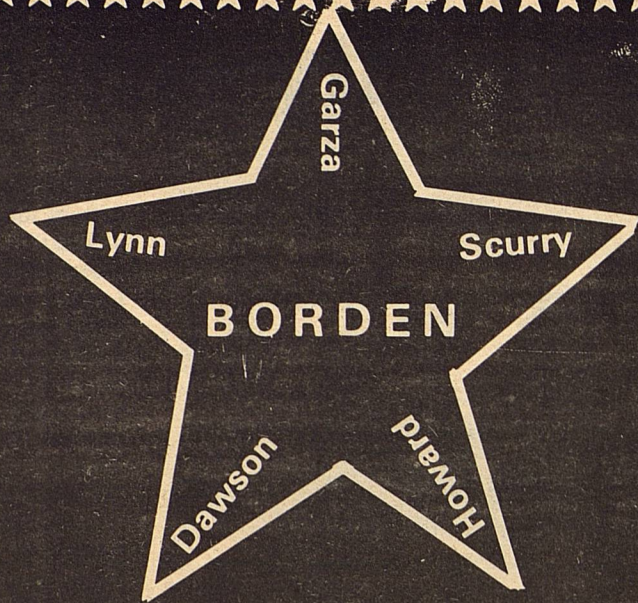

## SECOND DEMOCRATIC PRIMARY ELECTION

Absentee voting for the Second Democratic Primary begins May 23rd, A.D. 1984 in the office of the County Clerk, in the Courthouse in Gail and all other Texas Counties. Absentee voting will continue until the office closes on May 29th, 1984. Office hours are 8:00 A.M. to 12:00 noon and from 1:00 P.M. to 5:00 P.M., Monday through Friday in Borden County.

You are entitled to vote if you are a registered voter and have been registered 30 days before the June 2nd election. You may vote in the Second Democratic

Primary even if you did not vote in the First Primary on May 5th.

There are four very important contests to be decided, stated Dorothy Browne, County Clerk: two Judges of the Court of Criminal Appeals; the 132nd Judicial District Attorney for Scurry and Borden Counties; and the Democratic Nomination for United States Senator. Dorothy Browne said, "Even if you expressed your opinion and voted in the First Primary, you will lose much of your voting right if you do not vote on June 2nd. It is a very important

election. Come by and vote, absentee or make plans to cast your vote on June 2nd, 1984".

The polling places for the June 2nd Primary Election have been combined. All voters in Commissioners' Precinct No. 1 will vote in the Plains Community Center as usual; Commissioner's Precinct 2 voters will vote in the Commissioners' Court Room in the Courthouse; Commissioners' Precinct 3 voters will vote at the 4-H Exhibit Building in Gail. Vote for the candidates of your choice but **BE SURE TO VOTE.**

Although no active land negotiations are currently reported in either Scurry or Borden Counties, the Texas Low-Level Radioactive Waste Disposal Authority has again identified 13 sites in this five county region identified as prime sites for its waste dump facility.

The sites were announced Friday with the release of the authority's Phase II sitting study.

Regarding active land negotiations, Rick Jacobi, general manager of the authority, said Friday morning that the authority is currently talking with landowners in Crosby and Garza Counties.

To date, he said the only legal agreement the authority has reached for a possible land purchase remains in South Texas near Asherton.

The authority was created in 1981 to develop a site for the disposal of low-level radioactive wastes generated in Texas.

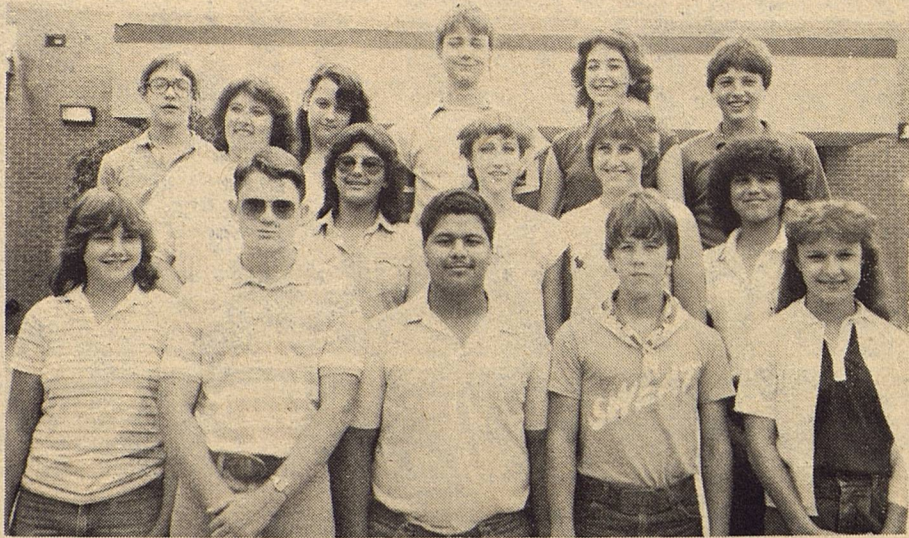
## STATE SPORTSMANSHIP AWARD

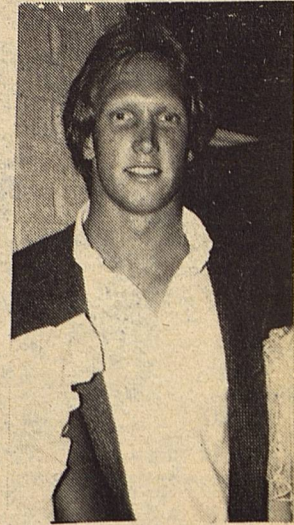

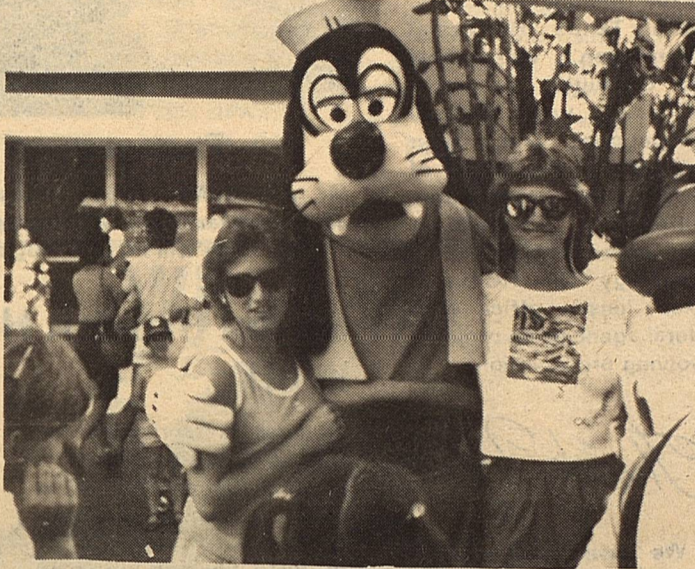

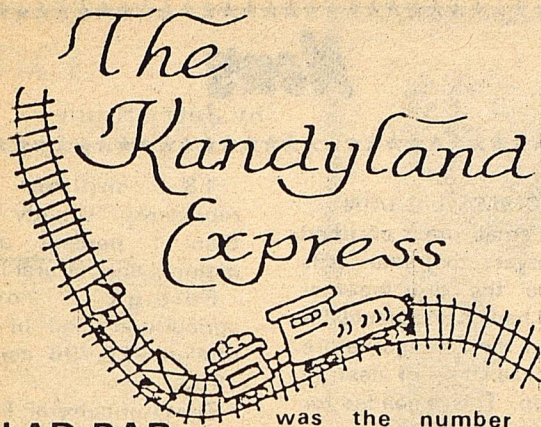

## SALAD BAR

The salad bar is becoming an American institution. They can now be found in every type of restaurant from fast food stores to the finest steak houses.

Of course, restaurants have salad bars because their customers want them. When the magazine Restaurants and Institutions recently asked customers what menu items they are ordering more often, salad

was the number one answer.

People like salad bars for a variety of reasons, most of them having to do with nutrition. Often they will say they eat at the salad bar because it is not fattening, it is nutritious, you can make it any way you want it, you can make a whole meal out of it, and it is good for you even if you are on a special diet.

Salad bars can live up to these nutritional expectations but it is not automatic. Whether your

salad is high in nutrients, low in calories, right for your special diet or adequate for a one-dish meal depends entirely upon the choices you make.

For some people, a salad is a bowl of iceberg lettuce with dressing. That type of salad is high in fiber and low in calories if you do not overdo it on the dressing. But you can do better nutritionally by adding vegetables high in vitamins A and C.

Pale green leaves, such as iceberg lettuce, don't provide much vitamin A and C. But dark green leaves like Romaine lettuce and spinach do.

The typical salad bar also has many other good vitamin A and C sources such as hot red peppers, broccolite, carrots, cauliflower and cole slaw.

Vegetables can not do everything for you, however. So if your salad is supposed to be an entire

meal, you should also include some non-vegetable ingredients like bacon bits, shredded cheese, chopped egg or cottage cheese. These are good sources of protein, calcium and riboflavin.

Some nutrients, like thiamin, iron and niacin, are primarily supplied by foods you do not often see at salad bars, such as meats and grain products.

If you are looking for a low-calorie meal, the salad bar may not necessarily be the best place to find it. By choosing helpings of potato salad, cottage cheese, gelatin and cole slaw along with your vegetables, then topping it with bacon bits and croutons and using a non-diet dressing, you can wind up with more calories than a "regular meal" meal.

To keep you at calorie count down when you go to the salad bar, follow these

suggestions from the American Council on Science and Health:

-Select the plain raw vegetables because they have the lowest calorie counts.

-Do not take too many pickled foods. They are somewhat higher in calories because sugar is added in the pickling process. Pickled beets, for example, have twice as many calories as plain beets.

-Avoid the non-vegetable items such as cottage cheese and the various high-calorie dressings. Cottage cheese and cheese are good sources of calcium, however, so you might want to include them if you are not normally a milk drinker.

-Stay away from prepared salads like cole slaw, potato salad and marinated salads. Prepared salads are higher in calories than plain vegetables because they use high-calorie dressings. For example, cole saalaw contains more than six times the calories of plain cabbage.

-use only a small amount of diet dressing. Some diet dressings have as many as 30 calories per tablespoon and the calories will add up fast if you use a large amount.

## EMERGENCY FEED ASSISTANCE PROGRAM

Due to the continuing drought producers may still come in and sign-up for EFAP corn. Producers interested in signing up for corn should be aware of the following changes which have taken place. The feeding period will be figured at 45 days instead of 30 days. The 45 day feeding period will begin on the day you come in and make application. The percent below normal that rangeland is being figured at has been increased to 80 percent. Another change which has been made is that pasture loss is calculated at 10 pounds instead of 6 pounds per day.

All of the changes mentioned above will increase the amount of corn a producer is eligible for. However, it is important when considering the bushels of corn you wish to buy you keep in mind the following:

1. You must have all corn except a 10 day supply fed by the end of your feeding period.
2. Should we receive a rain and pasture conditions improve and feeding periods are stopped you will have to pay market price for the corn you have remaining in excess of the 10 day supply.

## AVAILABLE HAY

ASCS will again assist livestock producers in locating hay to buy since hay is in such short supply in this area due to the dry weather. We will also assist any producers with excess hay by locating buyers for their hay. A compiled list of available hay from all over the state will be prepared every fourth Monday beginning May 21st and will continue thru October. This list will be available to anyone interested.

## FAILED SMALL GRAIN

Any small grain certified for harvest that later fails due to the dry weather should have a disaster claim filed on the acreage before you graze, bale or destroy the crop. This is needed for history protection.

## HARVEST FOR PIK-WHEAT

With wheat harvest right around the corner, those of you that need to harvest your wheat to satisfy your PIK needs should remember to bring us enough weight tickets to cover your PIK before you sell the grain.

## AGRICULTURAL LAND OWNED BY FOREIGN INVESTORS

Foreign investors reported owning 13.7 million acres of U.S. agricultural land at the end of 1983. Reports indicate foreign owners plan to keep 92 percent of their acreage in agricultural production.

13.7 million acres represents slightly more than 1 percent of the nation's agricultural land.

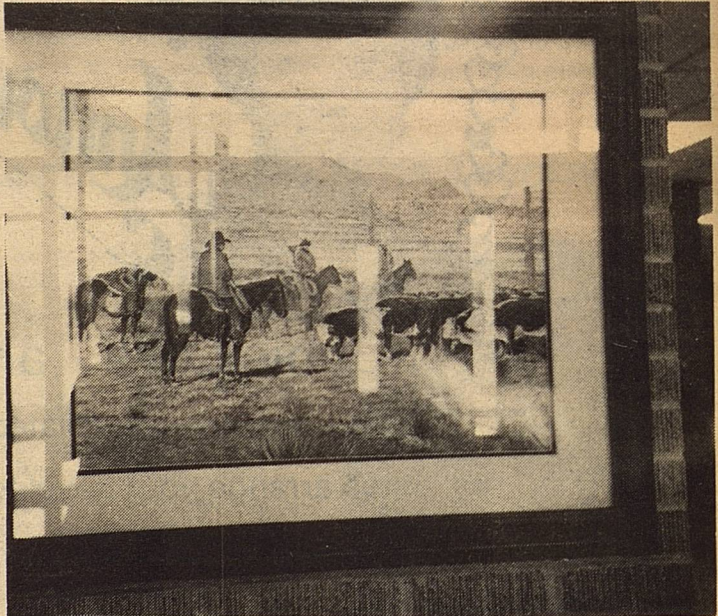
Foreign owned agricultural land in Texas totaled 926,796 acres for 1983.

The Agricultural Foreign Investment Disclosure Act of 1978 requires all foreign owners of U.S. agricultural land to report their holdings, acquisitions, dispositions, leases (10 years or more) and land use changes to the ASCS office.

Foreign owners who fail to report or who are late in reporting face possible penalties. In fiscal 1983 and the first quarter of fiscal 1984, the USDA assessed 174 penalties for late filings, amounting to approximately \$109,500.

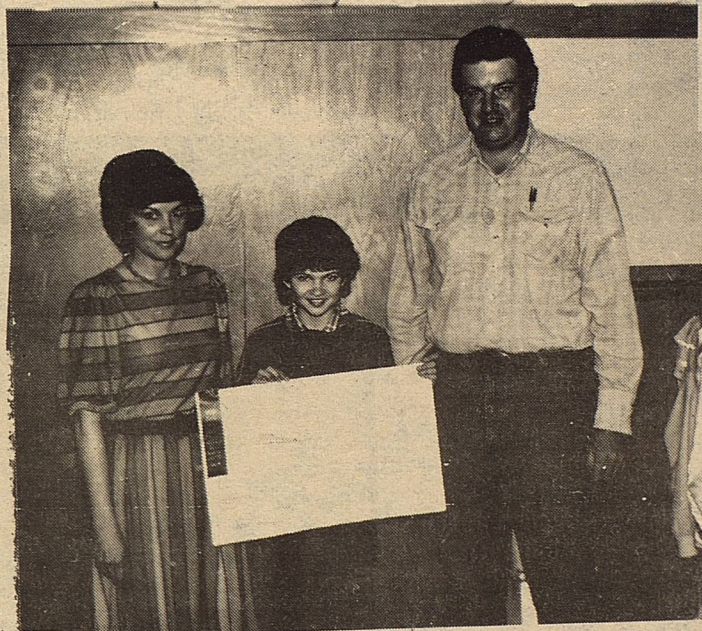

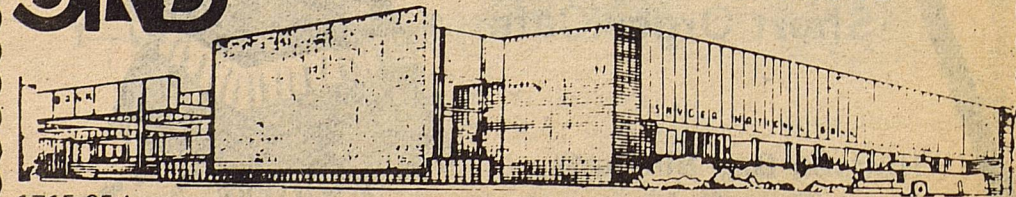
