# December retail sales solid

WASHINGTON (AP) → Retail sales, helped by sizzling activity in auto showrooms, jumped by 1.2 percent in December, providing a solid finish to a year in which sales climbed at the fastest pace since 1999.

The December increase in retail sales pushed total spending for the month to a seasonally adjusted \$349.4 billion, the Commerce Department reported Thursday.

The December gain followed a much smaller 0.1 percent rise in November and reflected the fact that consumers were spending heavily on new cars in response to the return of attractive incentive programs.

Spending on car purchases shot up 4.3 percent last month after having fallen by 1 percent in November.

Excluding autos, consumer spending rose by a more moderate 0.3 percent in December, slightly lower than the 0.4 percent increase excluding autos in November.

Analysts said that spending would have been better last month if it had not been for a big drop of 2 percent in sales at gasoline service stations, a decline that was seen as positive for the economy because it reflected lower gasoline pump prices rather than weaker demand.

For the year, retail sales climbed a solid 8 percent, the best performance since an 8.5 percent rise in 1999 and a performance that

analysts hailed as showing that consumers, who have been the star performers in this recovery, are still willing to spend.

"All this worry about consumer being overwhelmed by debt and threatening to pull back is very much overblown," said Bill Cheney, chief economist at John Hancock Financial Services in Boston. "We have got job growth and people are out spending. We really do have some momentum to the economy.

The 1.2 percent jump in overall sales in December showed that retailers did indeed have a solid Christmas sales season, helped by a surge of shopping just before and after the holiday that helped to alleviate worries about a slow start to the holiday season.

"Households spent a ton in December and it was not just gift cards that they were buying," said Joel Naroff, head of Naroff Economic Advisors.

In a second report, the Labor Department said that the number of Americans filing new claims for unemployment benefits rose by 10,000 last week to a three-month high of 367,000. The four-week moving average, which smooths out weekly fluctuations, rose to a three-month high as well of 344,000.

Analysts cautioned that the jobless figures often produce misleading signals in holiday

# **Baylor suing former seminary** pupil over alleged lewd e-mails

seminary student who lost his scholarship because he is gay is accused of sending lewd e-mails to employees and their families. Baylor filed a lawsuit

Wednesday alleging that beginning last fall, James Matthew Bass sent more than 1,000 e-mails containing pornographic images and messages. Baylor officials also obtained a restraining order Wednesday against Bass, prohibiting him from sending e-mails to Baylor officials and their families.

Bass could not be reached for comment. The action updates a peti-

tion Baylor filed in November against a defendant identified as John Doe. At the time, Baylor's attorney said officials did not know who sent the e-mails to administrators at the world's largest Baptist university. The lawsuit says many e-

mails were sent under the names of Baylor employees or their family members, and one purported to be from an unidentified Baylor employee's child who implored the parent to stop committing sexual abuse.

Some e-mails referred to computer.

WACO, Texas (AP) — A sexual activities by Jesus former Baylor University Christ, and others contained racial epithets, according to the suit.

> One group of e-mails incorrectly reported the death of a faculty member who recently had a stroke, and an obituary for an administrator was sent to news organizations, according to the suit.

Another e-mail, sent in the name of a George W. Truett Theological Seminary administrator, reported to one of Baylor's accrediting agencies that the seminary was involved in a cheating scandal involving faculty and students, according to

Baylor spokesman Larry Brumley said university officials would not comment on the case.

In the lawsuit, Baylor asks for unspecified damages caused by the e-mails and reimbursement for costs incurred from the school's efforts to track and limit the number of e-mails.

The petition also asks the court to require Bass to produce his computer equipment for inspection by Baylor representatives, and to prohibit him from changing any data stored on that

AUSTIN (AP) — The Texas Senate has unveiled a school funding plan it says will pump billions of dollars into schools, but the proposal's fate in the Legislature is far from certain.

The proposal would reduce local property taxes by a third, replacing the lost rev-

enue with a restructured business tax and a variety of other revenue sources such as the sales tax, cigarette tax and motor vehicle tax.

Lt. Gov. David Dewhurst, laid out the plan Wednesday, claiming that all 31 senators have signed on to the proposition.

Dewhurst unveiled the plan the second day of the legislative session, touting a \$6.7 billion increase in new money for schools over the next two-year budget cycle. However, the plan would only generate about \$1.6 billion per year in state funds after accounting for the property tax reduction.

Dewhurst said the plan would close loopholes in Texas' main business tax, forcing all businesses except sole proprietors to

The franchise tax, which five of every six Texas businesses currently avoid paying, would be reduced by more than half. Other money for schools would be generated from a combination of a higher sales tax, motor vehicle tax, cigarette tax and alcohol tax, though details still need to be worked out, the senators said.



In 1962, comedian Ernie Kovacs died in a car crash in west Los Angeles.


In 1966, Robert C. Weaver became the first black Cabinet member as he was appointed Secretary of Housing and Urban Development by President Johnson.


In 1978, former Vice President Hubert H. Humphrey died

# Health care system far from broken

"The Dog and His Bone" is one of Aesop's many instructive fables. It's about a dog carrying a bone in his mouth. Thinking it was another dog with a bigger bone, the greedy dog growled and said to himself, "I'll get that bone, too." When he opened his mouth to take the bone, of health his own bone fell into the water, never to be seen

According to a study by PricewaterhouseCoopers, for every four hours that a physician devotes to caring for a Medicare patient, hospital administrators spend 30 minutes on Medicare paper-

# Military escorts needed in some areas of tsunami-stricken Aceh

BANDA ACEH, Indonesia (AP) Indonesia on Thursday ordered foreign aid workers in tsunamidevastated Aceh province to have military escorts in areas facing violence by insurgents, even as the vice president welcomed a ceasefire offer by the rebels. The total death toll from the disaster rose to more than 157,000.

Relief groups have not reported any security problems in Aceh, where rebels have fought a low-

level separatist war against government troops for three decades, and some worried that the new restrictions could harm their reputation for independence.

"We discourage such actions because it blurs the distinction between humanitarian and military efforts here," said Eileen Burke of Save the Children.

Indonesian military spokesman Col. Ahmad Yani Basuki said in a telephone interview that the army sive spraying campaign starting

considers only the areas around the provincial capital Banda Aceh and the stricken coastal town of Meulaboh safe for foreigners.

"Other areas aside from that are potential trouble spots," he said. Anyone going to the troubled zones must take military escorts. But Basuki warned: "We don't have enough personnel to secure everyone."

Health officials planned a mas-

Friday in Indonesia's disaster zone to head off the threat of malaria, which one expert said could kill up to 100,000 people in the coming months if authorities don't act quickly to kill mosquitoes.

Indonesia's Social Affairs Ministry raised the country's official death toll from the Dec. 26 disaster to 110,229, an increase of nearly 4,000. Sumatra island's Aceh province was worst hit, with the number of people missing there

at more than 12,000, with 703,518 homeless survivors.

Death tolls also went up in India by 345, to 10,672 — and in Sri Lanka — by six, to 30,899. The overall toll across 11 nations stands at 157,642.

Indonesia's restrictions highlight its sensitivity over foreign involvement in the humanitarian effort, especially that of troops from the United States, Australia, Singapore and Japan.

# Jewish groups and lawmakers criticize prince's Nazi costume

LONDON (AP) - Jewish groups and lawmakers criticized Prince Harry on Thursday for wearing a Nazi uniform to a costume party, with one group urging him to visit the Auschwitz death camp, despite an apology from the grandson of Queen Elizabeth II.

The 20-year-old prince apologized Wednesday in a statement after a British newspaper printed a picture of him clutching a cigarette and a drink and wearing a swastika armband.

"I think a lot of people will be disappointed to see that photograph and it will cause a lot of offense," said Michael Howard, leader of Britain's main opposition Conservative Party.

"I think it might be appropriate for him to tell us himself just how contrite he now is," added Howard, who is Jewish.

The Simon Wiesenthal Center in Los Angeles expressed outrage and urged Prince Harry to travel to Poland later this month to commemorate the 60th anniversary of the liberation of the Auschwitz death camp.

"There he will see the results of the hated symbol he so foolishly and brazenly chose to wear," said Rabbi Marvin

Hier, dean and founder of the center. Prime Minister Tony Blair's office was reluctant to get involved. "Clearly an error was made," Blair's official spokesman said. "That has been recognized by Harry, and I think it is better that this matter continues to be dealt with by (Buckingham) Palace."

Jewish groups in Britain were more moderate in their criticism.

"The fact that the palace has issued an apology indicates that this was a mistake by the prince," said Rabbi Jonathan Romain, a spokesman for the Reform Synagogues of Great Britain. "But having being given, the apology should now be accepted."

A spokesman for the Board of Deputies of British Jews said the costume "was clearly in bad taste, especially in the run-up to Holocaust Memorial Day" on Jan. 27. He added: "The board is pleased that he's apologized for the incident."

# Gunmen kill representative of top Shiite cleric in Iraq

BAGHDAD, Iraq (AP) — Gunmen killed a representative of Grand Ayatollah Ali al-Sistani, Iraq's most senior Shiite Muslim cleric, along with the aide's son and four bodyguards in a town south of Baghdad, an official in the cleric's office said Thursday.

Insurgents trying to derail Iraq's Jan. 30 elections appeared to be sending a message to al-Sistani, who strongly supports the vote. Insurgents have targeted electoral workers and candidates.

Gunmen opened fire on a minibus picking up a Turkish businessman from Bakhan Hotel in central Baghdad on Thursday, killing six Iraqis and kidnapping the Turk, who reportedly ran a construction company that worked with U.S.-led occupation authorities.

Sheik Mahmoud Finjan, al-Sistani's representative in the town of Salman Pak, 10 miles southeast of Baghdad, was shot dead Wednesday night as he was returning home from a mosque where he performed the evening prayers, the official said on condition of anonymity.

The aide's son and four bodyguards also were killed,

work. For emergency room care, it's one hour spent on paperwork per one hour spent caring for a patient.

Is Canada better? In her book, Sally Pipes reports the case of 58-year-old Canadian Don Cerniz, who noticed blood in his urine. It took three weeks to get his first test and another month for an MRI, and treatment for his cancer didn't begin until six months later.

According to the Vancouver, British Columbia-based Fraser Institute's yearly survey of medical waiting times, Cerniz was lucky: "The median wait for an MRI across

Canada was 12.6 weeks. Patients in Prince Edward Island experienced the shortest wait for an MRI (six weeks), while Newfoundland residents waited longest (33.5 weeks)." Overall, Canada's total waiting time between referral from a general practitioner to treatment averaged about 18 weeks in 2004.

Americans shouldn't imitate Aesop's dog by looking to Canada's socialized medicine as a solution to our health-care problems and lose what we have. A much smarter move is to repeal previous government-created "solutions" that have marched us nearer to socialism in the provision of medical servic-

In a word or two, get government out of our hospitals and doctor's offices.



# Rockets 124, Mavericks 114

DALLAS (AP) — Tracy McGrady's left big toe was bothering him so much that he took off his shoe during the second quarter and limped to the sideline figuring he was done for the night.

The Dallas Mavericks weren't that lucky.

Halftime treatment and good news from an X-ray got McGrady back onto the court, and he decided to push himself. The result was a tremendous third quarter that carried the Houston Rockets to a 124-114 victory Wednesday night that ended the Mavs' six-game winning streak.

"When I went to the bench, I was going to shut it down," McGrady said. "But at halftime, we put ice on it and more padding in my shoe. It wore off a little bit,

but I was still in pain."

Houston outscored Dallas 37-24 in the third, with McGrady putting up 13 points and eight assists. He added 10 points in the fourth, finishing with 30 points and 11 assists, matching his season high. The Rockets scored their most points of the season for the second straight game while beating the Mavericks for just the second time

"I was in one of those zones," said McGrady, who was 6-of-8 on 3-pointers, making all three he tried in the third. "When I saw daylight, I was confident I was going to knock the shot down."

The Mavericks had won their last six games by at least 14 points, so this was their first tight game since before Christmas

and they didn't have enough offense to keep up. That's right, a team that was averaging 114.3 points in its last seven games couldn't find a consistent scorer, at least not when it mattered most.

Dirk Nowitzki led the Mavericks with 28 points, but had an 18-minute scoreless drought over the middle two periods. Michael Finley, coming off a season-best 33 points, missed nine of his first 10 shots. He finished with 14 thanks to three baskets long after the outcome was settled.

The Rockets took advantage with an 11-2 run early in the third quarter to go ahead for good, then closed the period up nine: They shot 70 percent in the period, down from 72 in the first, and finished at an impressive 61 percent.





# **Inaugural Texas Tour** bike race postponed

LUBBOCK (AP) — The inaugural United Texas Tour, a bicycle stage race that American racing officials had hoped would become a showcase domestic event in a sport concentrated in Europe, has been postponed indefinitely.

Race organizers said Wednesday they were reluctant to ask for sponsorship money at a time the world is sending massive amounts of aid to the relief effort for the devastating tsunami in South Asia.

"We are simply uncomfortable asking companies to fund the race when those dollars could be used for more immediate social concerns," said Eddie Owens, executive director of the United Texas Tour.

Organizers had raised about half of the \$4.5 million needed for the race and would refund money already collected, race spokeswoman Kim Davis said.

Originally scheduled to run Sept. 8-17, the United Texas Tour was to be an 11-stage, 1,138-mile race starting and ending in the Dallas-Fort Worth

area and meandering through western Texas. The title sponsor was to be United Supermarkets Ltd.

"We've all put a lot of blood, sweat and tears into this," Davis said. "Everything was completely on schedule."

Organizers had hoped to attract as many as 20 domestic and international teams to six-time Tour de France champion Lance Armstrong's native state and had just sent out invitations last month. The race was also to have a tie-in with Armstrong's foundation for cancer research and survivorship

"There are many people in cycling who want to visit there, given the legend of Lance," said Sean Petty, chief of staff for USA Cycling.

"We're certainly disappointed. We hope they can get it resurrected," Perry said.

Armstrong was training in California on Wednesday and could not immediately be reached for comment, a spokesman said.

# FDA considering allowing OTC sale of cholesterol drug

WASHINGTON (AP) — The government is considering whether a drug for a serious chronic condition high cholesterol - should sit on drugstore shelves alongside medicines for headaches, allergies and athlete's foot.

Supporters say making a low-dose cholesterol medicine available without a doctor's prescription would help get needed treatment to millions of Americans

who are at risk of heart disease.

"There's a huge treatment gap," said Jerry Hansen, vice president of marketing at Johnson & Johnson-Merck Consumer Pharmaceuticals Co., a joint venture that is asking the Food and **Drug Administration** for permission to sell a low-dose version of Mevacor over the counter.

The drug, he notes, has been on the market for a long time and has proven quite safe.

But opponents say selling directly to the consumer allows patients to skip doctor visits, where they might be told to change their diet and exercise — both crucial in the effort to lower cholesterol.

"This is going to encourage people to take medication rather than alter other parts of their lifestyle," said Dr. Michael Schloss, clinical co-director of the Cholesterol Treatment and Research Center at New York University.

A panel of FDA scientific advisers was considering the request Thursday Friday. The FDA usually folof its advisers.

The FDA turned down a similar request in 2000. In the years since, the drug companies have tested the idea through consumer surveys, focus groups and mock pharmacies, hoping to prove that average patients can figure out for themselves whether they need the drug at all and, if so, if the nonprescription strength is right for them.

But in documents released ahead of the meeting, the FDA detailed numerous flaws with these studies. For instance, the agency said, a study of how well people could understand the label that would be on the drug found that just 1 percent of people who said they could start using Mevacor "right away" were appropriate candidates for the drug. The other 99 percent did not meet the criteria or had a medical condition that made the drug wrong for them.

The drug is only meant for a slice of the population: men 45 and over and women 55 and older whose LDL low-density lipoprotein, or "bad" cholesterol — count is between 130 and 170.

# Judge refuses to hold closed hearing on alleged past abuse

SANTA MARIA, Calif. (AP) — The judge in the Michael Jackson childmolestation case has ruled that a hearing about allegations of past sexual misconduct by the singer will not be held behind closed doors.

The ruling Wednesday by Superior Court Judge Rodney Melville was a victory for the news media and the prosecution, which both opposed a defense motion to hold a hearing on the issue away from reporters.

"I was very pleased that the judge recognized the California Supreme Court ruling that hearings such as admission of evidence be held in open court," media attorney Theodore Boutrous Jr. said.

The judge said he will schedule the arguments after the jury is selected. Jackson's lawyers had contended that holding an open hearing on the alleged prior offenses would influence prospective jurors.

Jackson was not present Wednesday. The 46-year-old pop star is charged with plying a boy with alcohol and molesting him. Jury selection begins Jan. 31.

Pretrial hearings have been set for Jan. 21 and Jan. 27 to consider issues including whether a child-abuse expert can testify, the questionnaire to be given to jurors and other motions on admission of evidence.

The judge has also ordered TV correspondent Martin Bashir to come to California to testify in the trial on March 1. Bashir produced the 2003 TV documentary in which Jackson said that he let children sleep in his bed but that it was not sex-

Bashir is now a correspondent for ABC News, which said Wednesday it will fight

the subpoena. "We feel strongly that the California shield law protects the rights of journalists who cannot be — or be perceived to be — arms of either the prosecution or defense as they pursue the news," ABC News Vice President Jeffrey Schneider said.
