AUSTIN, Texas (AP) ---Amid tense debate over education funding, Texas House members paused to take up a matter dear to school kids everywhere: cuncakes.

Legislators in an unanimous vote Wednesday cleared the way for public school students to once again nibble on the sweet treats -- complete with candy sprinkles - to celebrate their birthdays.

"We have an opportunity to really make the children happy here," said Rep. Jim Dunnam, asking fellow House members to approve the measure requested by his school-age daughter.

Texas Agriculture Commissioner Susan Combs, whose agency oversees the state's school lunch program, imposed new healthy food rules beginning this academic year aimed at limiting or eliminating junk food and food that competes with cafeteria fare.

In August, soon after setting the new rules, Combs issued a "cupcake clarification" stating that cakes and cupcakes could be brought to school for birthdays.

Lawmakers Wednesday couldn't resist making jokes. "If we vote for this, can we all call you 'Cupcake?' " Republican Rep. Peggy Hamric asked Dunnam. "As long as I can call you 'Sugar Plum," Dunnam replied.

Florida fugitive found in vehicle

McDonald found two occupants in the vehicle. Todd Alan Fuller, 22, listed on jail arrest records as homeless from Florida, was arrested and booked into jail at about 10 a.m. vesterday on a charge of unauthorized use of a motor vehicle.

The other occupant of the car was a 15-year-old female who had been reported as a runaway from Bedford. The juvenile was detained and later released to relatives. according to the release.

Fuller is being held for Florida authorities, according to the release.

Trailer carrying immigrants full of dead bodies, witnesses say

HOUSTON (AP) — Piles the Cold Creek Volunteer of half naked bodies. Bloody claw marks. Survivors clinging to life as they experienced violent seizures.

That was the scene those who first responded to the aftermath of the nation's deadliest human smuggling attempt described for jurors on Wednesday.

"I'd never seen that many bodies before in one situation," Rick Streeter, a firefighter and paramedic with Fire Department, said of the scene when he arrived at a truck stop in Victoria where a tractor-trailer filled with dead and dying immigrants had been abandoned. Streeter testified at the

trial of Tyrone Williams, who faces the death penalty if convicted for his role in the deaths of 19 illegal immigrants in the May 2003 smuggling attempt.

Prosecutors say Williams

drove and later abandoned the tractor-trailer after the more than 70 immigrants he was transporting began succumbing to the deadly heat inside. Seventeen people died inside the trailer, and two others died later.

But Williams' defense attorneys say while their client is guilty of transporting the immigrants, he ultimately is not responsible for their deaths because he didn't know they were dying.

The trial continued Thursday with testimony from Eloy Garcia, a convenience store clerk who sold Williams bottled water that the truck driver gave to the immigrants before the trailer was abandoned.

Garcia said that while he was selling water to Fatima Holloway, who was traveling with Williams, a shirtless immigrant came in to his store, said he was thirsty and that a Salvadoran was trying to kill Prosecutors have described that immigrant as delirious. Garcia said he called 911

in front of Holloway, who has pleaded guilty for her role in the smuggling attempt and is expected to testify against Williams. Shortly after the call, Williams and Holloway abandoned the trailer at the truck stop where Garcia worked.

Some of the authorities who first got to the truck stop told jurors they found piles of half naked bodies 4 feet high on the floor of the trailer and bloody claw marks on the doors where the immigrants had tried to get out. They said there was blood and vomit around some of the immigrants having seizures.



"Karami's reinstatement (amounts) to an extension of the crisis and fails to open the door to dialogue," he said from Moscow where he was visiting. "After all, Karami does not control anything. ... The one who controls (the state) is Lahoud and behind him the Syrian intelligence," Jumblatt said in an interview with the Dubai-based Al-

"We are still in the same situation. Anyway, we will see. We will give him a chance. We will see what he will propose," Jumblatt said.

Texas House considers school finance tax bill

AUSTIN (AP) — After approving legislation that would restructure the Texas education system, the Texas House headed Thursday toward debate on a \$10 billion tax bill designed to help fund the measure.

The tax bill — the second part of a school funding overhaul that is the Legislature's top priority for the session offers a slate of consumer taxes and a payroll tax on Texas businesses to replace a one-third cut in school proper-

Several Republican legislators said Thursday morning they expected another revision in the proposed business tax, making the tax more palatable for Texas compa-

Among the new taxes set for debate Thursday: a \$1 increase in the cost of a pack of cigarettes; a 3 percent tax on snacks, such as soft drinks and doughnuts; and an increase in the sales tax from 6.25 percent to 7.25 percent.

On Wednesday, the House narrowly gave tentative approval to an education overhaul, despite criticism that a teacher pay raise is unfunded and \$3 billion in new money is not enough to keep up with inflation or cover new require-

crossed party lines to vote with Democrats.

The bill would add about \$1.5 billion a year to public schools over the next two years. It has been opposed by every major education group in Texas.

Each of the more than 1,030 school districts in Texas would get an average of a 5 percent increase in funds under the proposal.

Republican Rep. Kent Grusendorf, who authored the legislation, called the measure "the most important vote of the legislative session."

reasons. First, it was meant to disguise the true tax imposed, and second, it promises something for nothing - a free lunch, And, when it comes to the promise of a free lunch, employers paying half, gullibility reigns supreme.

There's more deceit and dishonesty. In 1950, I was 14 years old and applied for a work permit for an afterschool job. One of the requirements was to obtain a Social Security card. In bold letters on my Social Security card are the words: "For Social Security Purposes - Not For Identification." According to the Social Security administration website, "This legend was removed as part of the design changes for the 18th version of the card, issued beginning in 1972." That statement assumes that we're idiots. We're asked to believe that the sole purpose of the removal was for design purposes. The fact that our Social Security number was going to become a major identification tool had nothing to do with getting rid of the leg-

There's a moral dimension to Social Security that few have the guts to address. What moral principle, consistent with liberty, justifies forcing a person to set aside a certain portion of his weekly earnings for retirement and jailing him if he fails to comply? Retirement isn't the only important item for which we should budget. How about a congressional mandate that we set aside a certain portion of our weekly earnings for housing, food, entertainment or our children's education? Were Congress to propose a measure that would require each American to set aside a portion of his weekly earnings for these items, most of us would see it as tyranny. Pray tell, what's the difference in principle for a congressional mandate that requires setting aside earnings for retirement versus a mandate setting aside earnings for housing or our children's education?

federal officials like to grandstand by federalizing various crimes. But decreeing the death penalty for certain crimes committed on federal property, for example, or creating mandatory minimum sentences for drug offenses, does little or nothing to make citizens safer.

Terrorist activities, especially with an international dimension, might justifiably be an exception to this general rule of reserving law enforcement for state and local jurisdiction. But it will require mostly dedication, painstaking investigation and wearing out a lot of shoe leather rather than a law of dubious usefulness to cope with them.

Thats why its disheartening to see Gonzales declare such a broad agenda that seems to have more to do with expanding government power than with keeping Americans safe.

Report: American cut more jobs than any other carrier

FORT WORTH, Texas (AP) — American Airlines cut more jobs last year than any other carrier, according to a government



DEAR ABBY: My mother died last year. My 93-year-old father now lives with my sister "Lila" in her apartment back east. I have four brothers and another sister who reside in the same state.

I live in Arizona. Although I'd love for Dad to live here with me, he doesn't want to put such a great distance between himself and the rest of the fam-

Dad gets \$3,000 a month from Social Security. Since Lila doesn't work, she decided that she should be the one to take care of our father. All of us agreed that she should take Dad's Social Security check and use it for his care. Dad also has about \$400,000 put away that is to be split among his children when he passes away.

Recently, Lila took \$21,000 of our father's money, claiming it was a "gift" so she can purchase a co-op. (Dad would buy it; her name would be on the deed.) Someone, I'm not sure who, called Dad's lawyer and reported the withdrawal. The lawyer met with Lila and my brother "Hersch," who has our father's power of attorney. The lawyer told Lila she can either pay back the \$21,000 or it'll be deducted from her inheritance. The lawyer then put Dad's money into a trust fund so it cannot be touched.

Now that she can't have the money as a gift, Lila is very angry and refuses to let anyone speak to Daddy on the phone. We are pretty certain that Lila never informed our father about the withdrawal -- she was trying to steal it. I think she is afraid we might say something about what happened.

DEAR HELP!: There sure is. Pick up the phone and discuss this with your siblings and your father's lawyer. Your sister is attempting to isolate your father, and there is no guarantee that his Social Security check is being spent for his benefit.

If your brothers and sisters do not live close enough to check regularly on Dad's welfare, it may be necessary to hire a social worker or care manager, or move him to an assisted-living facility. Please don't wait. Do it now.





STEROIDS SCANDAL

As baseball fights stars' subpoenas, another hearing focuses on steroids

WASHINGTON (AP) - With Congress and Major League Baseball embroiled in a fight over steroids, the chairman of a House panel said Thursday that all major U.S. sports leagues should work toward a single testing plan.

"Our elite athletic organizations, both professional and amateur, should establish uniform, world-class, drugtesting standards that are as consistent and robust as our criminal laws in this area," said Rep. Cliff Stearns, R-Fla. 'Nothing less should be tolerated."

Stearns' comments came at the opening of a hearing of the House Energy and Commerce subcommittee he chairs. Labor lawyers from Major League Baseball and the National Football League were to testify later.

The panel also was scheduled to hear from Donald Hooton of Plano, Texas, whose son was a steroid user and committed suicide, and Dr. Ralph Hale, chairman of the U.S. Anti-Doping Agency, which oversees drug testing for Olympic sports.

Energy and Commerce Committee

Chairman, Joe Barton, R-Texas, said this could be the first of a series of point subpoenas might be issued for commissioners of the major sports

"The time has come to put an end to this mess and reclaim sports as competition," he said.

Barton said use of performance-

enhancing drugs is tainting sports and its stars, noting that as San Francisco Giants star Barry Bonds pursues the career home run record there are questions about whether he has been aided by steroids.

"With Babe Ruth, people didn't worry about him taking steroids. They worried him eating another hot dog, Barton said.

Another House panel issued subpoenas Wednesday calling for Mark McGwire, Sammy Sosa and five other baseball stars to testify at a March 17 hearing. The House Government Reform Committee also demanded a variety of documents and records of baseball's drug tests.

The move came less than two months after baseball and its players hailed a new, get-tough policy on banned substances and just a week after testing began at spring training.
Baseball balked at the subpoenas.

Stanley Brand, a lawyer for the commissioner's office, said the committee had no jurisdiction, was trying to violate baseball's first amendment privacy rights, and was attempting to satisfy their prurient interest into who may hearings on the issue and that at some and may not have engaged in this activity.

> Reacting to Brand's comments, committee spokesman David Marin said: "Mr. Brand has his facts wrong. He failed to recognize that House rules give this committee the authority to investigate any matter at any time, and

we are authorized to request or compel testimony and document production related to any investigation. It's a shame that Major League Baseball has resorted to hiding behind 'legalese' and inaccurate 'legalese' at that."

The other players subpoenaed to appear next week were Jose Canseco who recently published a book outlining allegations of steroid use by McGwire and others — Jason Giambi, Curt Schilling, Rafael Palmeiro and Frank Thomas. Also called were players' association head Donald Fehr, baseball executive vice presidents Rob Manfred and Sandy Alderson, and San Diego Padres general manager Kevin

Canseco, Fehr and Manfred have agreed to testify, with Manfred appearing on behalf of commissioner Bud Selig. Before the subpoenas were issued, Brand told the committee the other players were declining invitations to appear.

It wasn't immediately clear whether the hearing will take place as sched-

Under pressure from Congress and under the shadow of a grand jury investigation into an alleged steroiddistribution ring, Major League Baseball and its players' association agreed in January to a tougher steroidtesting program. The agreement will suspend first-time offenders for 10 days and randomly test players year-

Counterintelligence to change strategy

WASHINGTON (AP) — The federal government suspects more than 2,000 Chinese companies of operating in the United States to steal secrets and wonders whether more than 300,000 Chinese visitors are really here for study and research.

These concerns about who might be swiping U.S. information extend to several departments — from

Defense to Energy to State — and officials say it underscores the need for pre-emptive action embodied in President Bush's plan for a new, national counterintelligence strategy.

As soon as this month, Bush is expected to direct U.S. intelligence agencies to go on the offensive to prevent the loss of secrets and technology, a policy

consistent with the pre-emptive military strategy the administration developed in 2002.

National Counterintelligence Executive Michelle Van Cleave provided a broad outline of the unclassified strategy — the Seven Pillars of U.S. Counterintelligence — at a conference last weekend in Texas. A leading goal is to shift from reactive counterintelligence operations — finding spies and other sources of leaks after they've done significant damage — to offensive operations.

"No longer will we wait until we have been harmed to act," Van Cleave said.

Intelligence experts say the task will be difficult, given the espionage threats from China, Russia and other countries, as well as terrorist groups and other interests determined to penetrate the United States.

Government officials say there are counterintelligence successes every day that are never made public. Some cases involve suspected

spies who are given "full transactional immunity" for details of their activities — a rare government promise to prosecution in avoid exchange for full disclosure. The individual's career may end, but he or she will avoid jail time.

But some experts say the unfortunate reality is that only one truly major espionage case has ever been unraveled through classic detective work: the case of CIA turncoat Aldrich Ames. He helped devastate U.S. intelligence operations against the Soviets by selling them secrets between 1985 and 1994.

Apartment fire kills at least 10 in New Orleans suburb

MARRERO, La. (AP) — At least 10 members of a family died Thursday in an early morning fire ignited by candles they lit because their new apartment still had no electricity, authorities said.

Four people escaped by jumping out a second-story window, police said. One family member who was believed to be in the house was still unaccounted for.

The dead, all found in the second-floor apartment of a town house, ranged in age from 6 months to 42 years, said Col. Bob Garner of the Jefferson Parish Sheriff's Office. He said the four survivors were not seriously injured.

It was not immediately clear why so many people were sleeping in the apartment, or exactly when they moved in. Garner said the move could have been as recently as the day before.

He said family members had been using candles for light and the candles ignited the bedclothing.

Mark Goldman of the Jefferson Parish Coroner's Office said it appeared that some of the victims died of smoke inhalation and some of burns. Autopsies were to be conducted Thursday.

The apartment, located in lower-to-middle class neighborhood across the Mississippi River from New Orleans, was totally aflame when rescue workers arrived shortly after 5 a.m. The fire was under control less than two hours later.
