Voter fraud is one election-time misdeed that Gray County has not had to deal with, according to County Clerk Susan Winborne and County Tax Assessor-Collector Gaye Whitehead.

"As far as I know, we have never had any voter fraud in Gray County," Winborne said.

"We have never, ever had any

complaints or problems here," Whitehead said.

Texas Attorney General Greg Abbott announced Wednesday that he has launched a statewide initiative to work with law enforcement and prosecutors to combat and prevent voter fraud.

The initiative's first phase, which is planned to be completed before early voting begins for the March primary elections, targets 48 counties that either have a history of voter fraud or a population of over 100,000, according to a news release from Abbott's office.

"Voter fraud has been an epidemic in Texas for years, but it hasn't been treated like one. It's time for that to change," Abbott said in the release. "Trainers from my office are now across the state visiting with prosecutors and law enforcement officers to stop the problem of voter fraud in

its tracks. The integrity of our democratic process must be protected."

The 48 counties include 14 where the Attorney General has previously investigated or prosecuted alleged Election Code violations that were referred by the Secretary of State. The 48 counties contain 78 percent of eligible registered voters in Texas. Four sets of indictments have been

Confusion surrounds new voter registration cards

By MARILYN POWERS Staff Writer

Some Gray County voters may be confused about their new bright yellow voter registration cards, which were mailed in December, according to County Tax Assessor-Collector Gaye Whitehead.

"A lot of people are mailing them back to us," Whitehead said Thursday.

No questions or information is being sent back with many of the cards, she said, leaving county employees to wonder why the cards are being returned in the mail.

"We've gotten back about 1,400 cards. We have about 15,000 total registered voters in Gray County," Whitehead said.

Some voter registration cards are mailed back each time new cards are sent out, she said. The current tally of returned cards is not that unusual.

being put in the wrong precinct," Whitehead said. "Anyone who feels they're in the wrong precinct can

come talk to us." Her office uses the new Panhandle Regional Planning Commission county map and a detailed City of Pampa map in determining which precinct voters live in, she said.

The returned cards mean that the tax assessor-collector's office will end up paying double the usual postage cost for those 1,400 voters to get their voter registration cards.


Some returned cards may represent the approximately 1,000 voters out of the "A lot of people have 15,000 total in Gray County complained that they're who are considered suspended.

> "We cannot find them or verify that they're in the county," Whitehead said.

Voters who have found mistakes on their cards are running out of time to get those mistakes corrected if they want to vote in the March 7 primary.

Deadline for submitting information to get a correct voter registration card is Feb. 6 for the primary,





advanced or caused to be advanced due dates in records on loans belonging to Waller or her family members "that showed the loans to be current or in good standing, when in truth and fact, as the defendant well knew, the loans were delinquent and nonperforming."

Count Three states that on or about June 29, 2001, Waller, as manager of the credit union, granted a loan in the amount of \$12,000 to Cindy Pohnert, "who in turn endorsed the loan proceeds back to the defendant who then deposited the proceeds of the loan into the defendant's Pampa Bank of America account.'

Waller was employed by the Pampa credit union from July 1978 to December 2002, according to information from Pampa attorney Kenneth W. Fields, who responded to a request of the credit union for information.

"The credit union has no information regarding details of any reported indictments against Mrs. Waller at this time. The credit union will cooperate as requested with any appropriate law enforcement authority regarding any investigation or proceeding,

Fields said in a prepared letter.

Deposits at the credit union are insured by the National Credit Union Administration for the maximum available coverage, Fields

"The credit union does not anticipate that these matters will adversely affect the soundness of the institution or its ability to provide services to its membership," he said.

Count One against Waller is a violation of Title 18, Section 657 of the U.S. Code. Counts Two and Three are violations of Title 18. Section 1006.

The maximum penalty for each of the three charges is \$1,000,000 or twice the amount of any pecu-

niary gain by the defendant or pecuniary loss by the victim, whichever is greater, and/or 30 years, followed by at least three years but not more than five years of supervised release.

A mandatory special assessment of \$300 also applies in the case concerning Waller, as does mandatory victim restitution, cited in Title 18, Section 3663A of the U.S. Code. Information from the U.S. District Attorney's Office in Amarillo states that under this act, "in addition to any other sentence imposed, the defendant is required to pay full restitution to the victim(s) of this offense."

Assistant U.S. Attorney Christy Drake, the prosecuting attorney in the case, said this morning that a trial date or plea hearing would probably be scheduled for six to eight weeks from now, in April. She declined to comment on whether additional indictments against Waller or anyone else involved in the incidents was being considered at this time.

The U.S. District Attorney's Office information indicates that an agent of the Federal Bureau of Investigation, Dan Richard, has been involved in the case against Waller, who is being represented by Amarillo attorney Warren Clark. A telephone call to Clark's office had not been returned as of press time today.

handed up since mid-2005 against individuals for voter fraud in Texas.

Earlier this month, two Reeves County women were indicted on charges of illegally possessing and transporting election ballots of several voters.

In December, four indi-

viduals were indicted for illegally possessing and transporting election ballots following a May 2005 Robstown Independent School District election in Nueces County.

In November, Abbott obtained a guilty plea from a Hardeman County commissioner for collecting mail-in ballots while he was a candidate in the 2004 primary and general elections.

In July, Abbott obtained a

County woman accused of voter fraud for mailing an absentee ballot in the name of her mother, who was deceased.

New Orleans could lose 80 percent of black population

city of New Orleans could lose up to 80 percent of its black population if people displaced by Hurricane Katrina are not able to return to damaged neighborhoods, according to an analysis by a Brown University sociologist.

Professor John R. Logan, in findings released Thursday, determined that if the city's returning population was limited to neighborhoods undamaged by Katrina, half of the white population would not return and 80 percent of the black population would not return.

"There's very good reason for people to be concerned that the future New Orleans will not be a place for the peo-

won't be room in New Orleans for large segments of the population that used to call it home," said Logan, who studies urban areas.

The study used maps from the Federal Emergency Management Agency that detailed flood and wind damage and compared them to data from the 2000 U.S. Census to determine who and what areas were affected.

It found the storm-damaged areas had been 75 percent black, compared to 46 percent black in undamaged areas of the city. It also found that 29 percent of the households in damaged areas lived below the poverty line, compared with

More than half of those who lived in the city's damaged neighborhoods were renters, the analysis found.

"The odds of living in a damaged area were clearly much greater for blacks, renters and poor people," the study said. "In these respects the most vulnerable residents turned out also to be at greatest risk.

Elliott Stonecipher, a demographer and political analyst based in Shreveport, La., said the analysis gets to the heart of the debate over how to rebuild New Orleans.

Tool booth scofflaw pleads no contest

DALLAS (AP) — A woman accused of owing about \$76,000 for cruising through toll booths without paying has pleaded no contest to three misdemeanor citations for failure to pay

Evangelina Gonzalez, 41, entered her plea Thursday in a Dallas County courtroom and agreed to pay one-tenth of the total, about \$7,600, in 10 monthly installments.

"It was more than fair," said Gonzalez's attorney, Michael Stephens.

Tollway authorities have said Gonzalez had acquired the highest fees ever owed by a violator in North Texas. Had she used a toll pass, her trips would have cost about \$1,800.

But tollway officials have said she drove through the booths nearly 3,000 times without paying between June 2003 and November 2005, and the \$25 administrative fees for each violation began adding up.

Attorney Marcelle Jones said the tollway authority was "satisfied" with the arrangement.

If Gonzalez meets the agreement's terms, prosecutor may dismiss the citations, with approval from the North Texas Tollway Authority, Jones said.

Jones said that the defendant still faces citations in Collin County stemming the from case.

The doctrine's importance will be underscored next week as elders who lead more than 98,000 congregations worldwide recite a new five-page blood directive from headquarters.

The tightly disciplined sect believes the Bible forbids transfusions, though specifics have gradually been eased over the years. Raymond Franz, a defector from the all-powerful Governing Body that sets policies for the faith, thinks leaders hesitate to go further for fear that total elimination of the ban would expose the organization to millions of dollars in legal liability over past medical cases.

The Witnesses have opposed transfusions of whole blood since 1945. A later pronouncement also barred transfusions

of blood's "primary components," meaning red cells,

white cells, platelets and plasma.

An announcement in 2000 in the official Watchtower magazine, however, said that because of ambiguity in the Bible, individuals are free to decide about therapies using the biological compounds that make up those four blood

Without noting the 2000 change, the new directive tells parents to consider this: "Can any doctor or hospital give complete assurance that blood or blood fractions will not be used in treatment of a minor?"

Aside from the new directive, a footnote in the Witnesses' standard brochure, "How Can Blood Save Your Life?," mentions the 2000 article on fractions — but then omits its contents.

By coincidence, next week's directive follows some heavy criticism of the blood transfusion policy from attorney Kerry Louderback-Wood of Fort Myers, Fla., writing in the Journal of Church and State, published by Baylor University.

Louderback-Wood, who was raised a Witness but now has no religious affiliation, accuses her former faith of giving

"inaccurate and possibly dishonest arguments" to believ-

ers facing crucial medical decisions.

Louderback-Wood complains that many Witnesses and physicians aren't given clear instruction about their faith's See BLOOD, Page 6

PROVIDENCE, R.I. (AP) The president of Providence College, which is run by the Roman Catholic Dominican religious order, has banned a campus performance of "The Vagina Monologues" - a play about female sexuality and violence, saying the work contradicts church teaching.

Written by Eve Ensler, the play debuted a decade ago and is based on the author's interviews with more than 200 women. College officials had permitted performances of the play for four years, while limiting promotion of the show last year, said senior Erica Rioux, who was coordinating this year's production.

prominent Another Catholic school, the University of Notre Dame, also has placed restrictions

on the play's performance.

The new school president at Providence, the Rev. Brian Shanley, wrote in a Jan. 18 letter to students that he particularly objected to one tale that uses religious language to describe a sexual encounter between a woman and a teenage girl.

While the teen narrator describes the episode as "a kind of heaven," Shanley said it's "abusive, exploitative and morally wrong." The church teaches that homosexuality is "intrinsically disordered.'

Shanley also objected to a description of the work as a "new bible" for women, which he said gave the impression that the play attacks "the traditional biblical views that inspires the teaching of the Roman Catholic Church."

Louderback-wood learned that hemoglobin was allowed from the Web site of Associated Jehovah's Witnesses for Reform on Blood, which was founded in 1997 by dissenting local elders, eight of whom served on Hospital Liaison Committees that advise Witnesses and physicians.

The founder of Associated Jehovah's Witnesses, speaking on condition of anonymity to protect his standing in a faith that does not tolerate dissent, says liaison committee members know about the revised teachings, but most Witnesses automatically refuse all forms of blood without consulting the committees. Physicians are often illinformed about Witness beliefs, he

Louderback-Wood thinks the faith is subject to legal liability for misinforming adherents, which to her knowledge is an untested theory in U.S. courts. Related issues arise in a pending lawsuit in Calgary, Alberta, however, over the alleged "wrongful death" of teenage leukemia patient Bethany Hughes.

Witnesses headquarters refused an Associated Press request to interview an expert on blood beliefs. Instead, General Counsel Philip Brumley issued a prepared statement rejecting Louderback-Wood's "analysis and conclusions" in general.

"Any argument challenging the validity of this religious belief inappropriately trespasses into profoundly theological and doctrinal matters," Brumley stated

The Watchtower's 1945 ban said "all

worshippers of Jehovah who seek eternal life in his new world" must obey. Such edicts are regarded as divine law, since the Governing Body uniquely directs true believers. Violators risk

ostracism by family and friends.

A subsequent Watchtower pronouncement forbade storage of a patient's own blood for later transfusion. In all, Associated Jehovah's Witnesses lists 20 shifts and refinements in blood-related rules over the

At the core of their blood beliefs, Witnesses cite Acts 15:29, where Jesus' apostles agreed that Gentile converts should "keep abstaining from things sacrificed to idols and from blood." The Witnesses also cite passages in Genesis and Leviticus.

Judaism and Christianity have always understood these scriptures to ban blood-eating for nourishment. This underlies Judaism's kosher procedures to extract blood from meat, which Witnesses do not follow. Christianity eventually decided the rule was tempo-

Experts assume that Raymond Franz's late uncle, Frederick Franz, who served anonymously as the Witnesses' chief theologian, decided those passages cover blood transfusions. But Raymond Franz raises questions about the blood policy in his book "In Search of Christian Freedom." Among them:

—Why forbid a patient's own stored blood yet permit components derived from large amounts of donated and stored blood?

-Why allow organ transplants, which introduce far more foreign white blood cells than transfusions?

-The Witnesses forbid plasma, which is mostly water, but allow the components in it that provide therapy. So what's the point of banning plasma?

Advances in bloodless surgery have reduced medical dangers for Witnesses in the United States, but Associated Jehovah's Witnesses maintains the blood policy is a life-threatening problem elsewhere.

"Artistic freedom on a Catholic campus cannot mean the complete license to perform or display any work of art regardless of its intellectual or moral content," he said.

Separately, the new president of Notre Dame said Wednesday that the school will scale back its production of "The Vagina Monologues" and a Queer Film Festival held on campus this year. He is also considering whether to cancel the events in the future.

The Rev. John I. Jenkins, who took over July 1, said he would allow "The Vagina Monologues" to be performed on campus this year, but only in a classroom setting and not as a fund-raiser. Last year's event raised about \$15,000 for a women's shelter and other programs.

The three-year-old film festival will continue, but under a new name: Gay & Lesbian Film: Filmmakers, Narratives, Spectatorships. Jenkins said the name change should help clear up any perception that the event is meant to "celebrate and promote homosexual activi-

North Carolina community prays for jobs

LENOIR, N.C. (AP) After years of layoffs at furniture plants, the county with North Carolina's highest unemployment rate held a day of prayer hoping it would help end tough economic times.

About 200 people gathered at the Caldwell County Fairgrounds last Sunday to seek divine intervention for a community coping with a 13.1 percent jobless rate.

"People are down and out," said the Rev. Rodney Raby, who organized the event. "They need some help. They need support."

Despite security, fake Super Bowl tickets persist

DETROIT (AP) — Each Super Bowl ticket

rid of bogus tickets, they show up every year at football's biggest game. With this year's Super Bowl nine days away,

police and NFL security officials say dozens of fans — some desperate to see their team — get ripped off in street sales and over the Internet. Sometimes, even ticket brokers get taken.

"We see some heartbreaking stories every year, great fans of ours that present themselves at the gate who were victimized," Milton E. Ahlerich, a former FBI agent who is the NFL's vice president of security, said Wednesday.

He cautioned against buying tickets on the street or over the Internet, and said counterfeiters often frequent sports bars and the streets around

Last year in Jacksonville, Fla., at least 75 people tried to enter the big game with phony tickets, most not knowing theirs were fake, the NFL said. The Jacksonville Sheriff's Office said it recovered 146 counterfeit Super Bowl tickets and made 27 arrests in connection with the tickets.

In Houston in 2004, 84 bogus tickets were confiscated, the NFL said. At the 2003 Super Bowl in San Diego, 57 were confiscated, but two days before the game, federal officials near Buffalo, N.Y., arrested two men carrying 232 counterfeit

The awards show will be


held Feb. 8 at the Staples Center in Los Angeles. It will air on CBS (8 p.m. EST).

believe it can bully the whole world into doing its bidding.

Right now, the U.S. is banking on getting the International Atomic Energy Agency to refer Iran to the U.N. Security Council. Winning this vote is not a certainty, but even if the U.S. does, Russia or China would likely veto any attempt to apply sanctions on Iran. A high-ranking Chinese official has just publicly announced that Iran is to become China's major trading partner. Russia has a heavy investment in Iran's nuclear facilities. President George W. Bush is about to have his bubble of delusions pricked. We are not the world's only superpower, and there are plenty of people who don't jump when Bush snaps his fingers.

As for the Israelis, they would attack Iran in a New York second – if they had the capability, and I don't believe they do. If they take a northern route, they will need permission from Turkey to use its airspace. They won't get it. If they fly to the south through airspace we control, they would need our permission, and that's not at all certain. Moreover, they don't have the planes capable of taking enough ordnance to

do sufficient damage to fortified, underground installations that are widely dispersed.

Iran, despite its problems, is not without the means to retaliate, whether attacked by Israel or the U.S. One thing the Iranians might do is wreck the oil facilities in Kuwait and Saudi Arabia, as well as closing the valves on their own oil. This would throw the world oil market into chaos, and the world economy would quickly follow.

Bush and Vice President Dick Cheney are far too close to the oil industry to risk that kind of worldwide economic train wreck.

Presumably, we didn't want Israel to have the bomb, but the Israelis built them anyway. Ditto Pakistan, India and North Korea. In the end, despite the hot rhetoric, if the Iranians want a bomb, they will probably end up building it. That might cause the Israelis to lose a little sleep – though not much, as they have 200 nuclear weapons – but it shouldn't bother us in the least.

The Iranians are just as sensible and levelheaded as anyone else. Don't buy the propaganda that they are all a bunch of crazies. They've been around a lot longer than we have. I would trust them with nuclear weapons as much as – perhaps even a hair more than – I trust Bush. Americans must stop allowing politicians and propagandists to scare them into reckless behavior.
