Duncan says school finance bill will be revisited

By DAVID BOWSER Staff Writer

Pampa's state senator said the school finance bill that passed the special session this spring will likely be revisited when the Legislature meets in regular session after the first of the year.

State Sen. Robert Duncan, R-Lubbock, who represents 46 counties from El Dorado to Pampa, told the Pampa Rotary Club Wednesday that the school finance package came basically from a bill introduced by Pampa State Rep. Warren Chisum and recommendations by the governor's tax reform commission.

"Warren Chisum is one of my better friends in the Legislature," Duncan said. "I've known Warren even before I became involved in the legislative process. He's really done you a nice job."

Duncan said the Legislature was

facing a Texas Supreme Court deadline, even though lawmakers had been working on school finance for three years or more.

"This reform required us not only to deal with the structure of how we allocate and appropriate money to public education, but it also required us to totally reform the Texas tax system," Duncan said. "Fortunately, we had debated this issue for three or four years. Those of us that were involved in this issue knew the issue. We didn't have to learn it. We knew where the issues were. We knew where the controversies were and how we could get to a point of some sort of a compromise.'

Duncan said it took a lot of courage for Gov. Rick Perry to appoint a tax reform commission headed by John Sharp, who ran

Funeral protest bill filed as 'the right thing to do' By DAVID BOWSER Staff Writer

Sen. Robert Duncan, who represents Pampa in the Texas Senate, move protesters away from funeral processions because he thought it

was the right thing to do. "We've got so-called church folks not that's a restraint of speech,"

that come out of Kansas that are protesting at our fallen soldiers' funerals,' Duncan said.

He said there have been several such protests in his Senatorial District.

"Not only is it offensive," Duncan said, "I think it's also ripe for some violence."

He said at a funeral in San Antonio, a

biker gang protected the funeral procession because the police were powerless to do so.

"We introduced legislation to basically prohibit folks from protesting at funerals within a certain distance so we keep them away and give law enforcement officials the ability to control those situations and

Duncan said he thinks it's a good piece of legislation and several other states have passed similar legislasaid he introduced legislation to tion, but several groups have announced they're going to challenge it in court.

"We'll soon be hearing whether or

Duncan said. "Quite frankly, I don't think it is because we're not saying you can't speak."

The law simply requires a buffer space between the funeral procession and protesters.

"It's just right to do that," Duncan said. "When somebody dies for the country, or if —Ken Fields your family member Pampa attorney dies for any reason, I think you're entitled to freedom from being

confronted directly with a protest." "Somebody's going to get killed one of these days," Pampa attorney Ken Fields commented.

"You go to a small community like where I grew up," Duncan said, "folks don't take kindly to that kind of disrespect. Some day, it could get out of hand, quite frankly."

officer driving a vehicle that resembles a police car, and he has stopped a woman in Borger twice.

The man is described as a Hispanic male between 5 feet 4 inches and 5 feet 6 inches tall, 150 to 160 pounds, has a mustache and an overbite. He was last seen wearing a light colored uniform, a tan felt cowboy hat, with a gold star-type badge, thin tan jacket, and black gloves. He was armed with a weapon on his left side and claimed to be with DPS.

His vehicle is described as being dark in color and he is using dash type emergency lights and the car has no front license plate. The incident took place on Highway 136, four to five miles west of Borger toward Fritch.

The female victim was stopped two times during a 5-day period, once for speeding and once for a defective tail lamp. Both times he asked for her license, went back to his car and then returned the license to her and let her go.

DPS Trooper Daniel Hawthorne, public information office for DPS in same except their badge is gold in Childress, gave the following infor-

mation for the public concerning being stopped:

DPS troopers do not have facial hair such as mustaches or beards.

DPS troopers wear a gray uniform with a red patch on each shoulder. The patch has a gold star in the center and says Texas Highway Patrol on the top.

The badge DPS Troopers wear is silver. It is round with a picture of the state of Texas in the center and says TEXAS in the center. The trooper's rank is at the bottom.

A DPS supervisor's uniform is the

DPS troopers drive a black and white car or pickup that is black on both sides and white down the middle. The DPS emblem is on both front doors. The front fenders as well as the back of the vehicle will say State Trooper. The car will have overhead lights on it. DPS vehicles will nearly always have a front license plate as well as a rear one. It will be an exempt tag. There could be an off chance situation where a license plate was knocked off the front, but they are usually replaced in short order.

Senate rejects estate tax cut

reject a Republican effort to shrink taxes on inherited estates during this election

GOP leaders had pushed senators to end the tax once and for all. It disappears in 2010, under President Bush's first tax cut, but rears up again a year later.

"This death tax is unfair," said Senate Majority Leader Bill Frist, R-Tenn.

A 57-41 vote fell three votes short of advancing the bill.

Knowing they lacked the votes to eliminate the tax, a small group of senators had hoped to keep the issue alive with an agreement to lift the tax from smaller estates and lessen the hit on larger ones.

Frist gave the negotiators a lift by agreeing to give such a compromise a vote. That didn't give the tax's strongest critics enough

A federal grand jury in Kansas City, Mo.,

Wrestling coach indicted for sexual assault Morris was the owner of The Rock Wrestling Club in Leander.

He also was one of the coaches of Texas USA Wrestling in Fort Worth, which organized the team and sent it to North Dakota. His hometown of Weir is located about 25 miles northeast of Austin.

The indictment delivered Tuesday charges Morriss with unlawfully confining persons who were minors while they were transported across state lines, using a facility of interstate commerce to coerce a minor to engage in illicit sexual activity and traveling across state lines for the purpose of engaging in illicit sexual activity.

American born and yet to be born for decades to come," said Senate Minority Leader Harry Reid, D-Nev.

Frist would still like to deliver a bill to the president reducing the estate tax this summer, before a midterm election where control of Congress is at stake.

Sen. Trent Lott, R-Miss., said he expected the estate tax to find its way into an unrelated bill headed for the president's desk sometime this year.

Under current law this year, the first \$2 million of a person's estate or \$4 million of a couple's, escapes taxation. The remainder can be taxed at rates up to 46 per-

According to the most recent statistics available from the Internal Revenue Service, 1.17 percent of people who died in 2002 left a taxable estate.

Sen. Jon Kyl, R-Ariz., had

the first \$5 million of an individual's estate, or \$10 million of a couple's, from taxation. The size of estates escaping the tax would increase each year to keep pace with inflation.

Estates between \$5 million and \$30 million would be taxed at rates equal to capital gains, and the remainder would be taxed at 30 percent.

"That is a fair way to help the people at the lower end of the spectrum and yet collect the revenue from those very, very wealthy estates that we all agree can pay part of this estate tax," Kyl said.

That effort attracted some of the senators who had been wary of repealing the tax but agreeable to shrinking its impact on heirs, but it did not attract Democrats who had expressed interest in negotiating a deal.

against Perry Lieutenant Governor in 1998.

That commission recommended the overhaul of the state business tax system.

"The system that we had in place at the time, the old franchise system, was not working," Duncan said. "It was unfair. It was discriminatory. It was not generating the revenue necessary. It was allowing most businesses, especially the larger business concerns in this state to avoid taxation, to avoid supporting our public school system."

There was an overreliance on local property taxes to support schools, he said. It required local school districts to rely upon appraisal creep to support public schools.

Under the new law, businesses pay one percent of their gross receipts with deductions for the cost of goods sold or employment costs. Wholesalers and retailers, who traditionally work on a very thin margin, pay only one-half of one percent.

That should bring tax revenues in from large corporations that have not been paying state business taxes.

"These big companies

that have been avoiding this tax will now be paying into the system," Duncan said. "The tax will generate, we hope, enough revenue to compress these local property tax rates down significantly."

Local property taxes, now capped at \$1.50 per \$100 valuation, will come down to \$1.33 in 2007 and \$1.00 in 2008.

"That will achieve significant tax savings for homeowners as well as local businesses," Duncan said.

The new tax law, which becomes effective in 2008, will not go into effect before the Legislature meets in regular session next January.

"This tax will not be implemented until we've had a chance to look at it,' Duncan said.

He said a number of large corporations would be required to file dummy returns based on this year.

"They will not pay any tax on those returns," Duncan said, "but they'll be required to file it so we can examine how this tax is going to play out."

He said the Legislature can go over the dummy returns and look for loopholes or where it may be unfair.

"I think there's going to be some need to go back and revisit some of the issues in that bill," Duncan said, "but fundamentally, I

think it is a very sound concept, and we will have an opportunity to look at potential problems and changes as they may occur with these dummy tax returns."

In addition, Duncan said local school districts have the option of raising local property taxes by four cents.

As part of the school finance package, the Legislature also allocated money for teacher pay rais-

Pampa, he said, will get \$891,415 beginning Sept. 1. "That's almost a million

dollars of new money,' Duncan said. "That's not counting any new money you would get if you raised that four cents.

addition, Legislature created a high school allotment, Duncan

"We're giving schools an additional amount of money to try to provide some improvement in our high schools."

Pampa High School will get \$247,530.

"The goal with this new high school allotment," Duncan said, "is to try to help high schools improve the competency levels of the graduating students to curb dropout rates."

He said he thinks that money will increase in future years.

If you are being stopped and you see something suspicious about the car, or the officer stopping you, call 911. You can ask the dispatcher to confirm if the officer is a police officer, only if you have just cause or a suspicious reason to call. Do not call on every officer just because you are being stopped.

You also may politely ask the officer if they will show you their department credentials. Most officers will not mind this if there are extenuating circumstances such as if you are stopped late at night, on a rural deserted highway, or you are alone.

"Remember, this is very rare to be stopped by a person impersonating a police officer," Hawthorne said. "I personally cannot remem-

ber the last time this happened in the Panhandle."

Regardless of the location this incident took place, Hawthorne said people in Hutchinson County as well as surrounding areas should be on the lookout for this subject.

Thornberry backs refinery bill

WASHINGTON - With the backing of U.S. Rep. Mac Thornberry, the U.S. House of Representatives Wednesday approved legislation to help speed the construction of new oil refineries. H.R. 5254, titled "The Refinery Permit Process Schedule Act" was approved by a 238-179 vote.

"We have neglected our energy needs for too long," Thornberry said. "We must produce more energy of all kinds here at home, and we must get it to consumers."

On an average daily basis, American consumers use more than 21 million barrels of refined products. But, United States refineries produce just 17 million barrels of refined products a day. Relying on imports to cover the shortfall can contribute to wide price swings.

"There are lots of reasons for the higher energy prices for consumers," Thornberry said. "But, even if we produce all of the oil we need, we still have to turn it into gasoline, diesel, and other useable products. Not having enough refineries is one of our biggest weaknesses. We need to encourage the con-

struction of new refineries." Currently, there are 148 refineries operating in the United States, less than half the amount that were active 30 years ago. No new refineries have been built in the United States since 1976. Industry officials say interest in building new refineries is often discouraged by a lengthy permitting process that can last as long as 10 years. Helping drag things out is the fact that proposed refineries must meet the requirements of multiple federal and state regulatory bod-

To streamline the process, H.R. 5254 calls for appointing a federal coordinator to

oversee the permitting process. The coordinator would monitor the efforts of the federal and state regulatory entities involved and help establish a timetable for completing their reviews.

"Hopefully, this coordination will speed up the program. If we can get to where applicants only have to wait a year or two to get a permit, there may be a lot more interest in building the new refineries we need," Thornberry said.

Other highlights of H.R. 5254:

 Makes available to states federal financial and technical assistance during the permitting process.

· Instructs the President to designate at least three closed military installations

as potential sites for new refineries. At least one such site must be designated for refining biomass to produce biofuel.

 Maintains strict environmental standards. The Environmental Protection Agency will be given priority in scheduling coordination. All applications will be subject to environmental laws such as the Clean Air Act, the Clean Water Act. and the Resource Conservation and Recovery

· Does not prevent citizens from using existing legal options to appeal the permitting process.

H.R. 5254 now goes to the Senate for its consideration.



How to keep your desktop uncluttered

The typical office desk never gets dusty. It has so much paper stacked on it, that dust never reaches the wooden surface. The same problem can occur on your Windows desktop. As you install more programs onto your computer, your desktop icon collection grows. Eventually, you can't see the pretty wallpaper on your screen because it's behind all of that iconic garbage.

Maybe you want to remove some (or all) of those pesky icons, but you're afraid of messing something up on your system. Well, fear not. Here's the tried-and-true, totally safe method of deleting, program.

excess icons: First, let's get everything in straight rows. Right click (Click the right mouse button) anywhere on the desktop (but not over an icon). One of your menu options is "Arrange Icons." With your left mouse button click, choose "By Name." This option will sort all of your icons alphabetically. To keep your icons in straight rows from now on, put a checkmark next to the "Auto Arrange" option.

Take a look at your icons. You will notice that some of them have

little white boxes containing black curvy arrows. These icons are short-

cuts. Α shortcut is not a program. It is simply a little pointer giving you quick access to the program. Deleting the pointer (shortcut), just deletes that little file, not the associated

As a very crude analogy, if I were to chop down a highway sign that said, "Las Vegas, 40 miles," I would not be destroying Las Vegas itself, just the sign pointing the way. (I told you it was a crude analogy).

To sum up: You may safely delete shortcut icons with no fear of harming your sys-

Deleting those shortcuts is quite easy. You have a variety of methods available. First, you can simply drag them to the Recycle Bin. Second, you could single-

> icon then hit the "DEL" or "Delete" key on your keyboard. Third, you

click on one

could rightclick on an icon and choose "Delete." You should choose the method easiest for you.

As you've probably noticed, not all of your icons are shortcuts. Can you delete them? Well, it depends. The following icons should be left alone:

My Documents Network Neighborhood My Computer Recycle Bin Internet Explorer (the

blue "e") These are default programs and really don't fall under the "shortcut" description. Windows will complain

if you try to remove them. Once again, remember this: Deleting an icon does not necessarily delete the

associated program. To delete the program, you need to take a different route: Click your START button, then SETTINGS. Choose CONTROL PANEL. Double-click the on "Add/Remove Programs" icon. You will see a list-of

EVERY program installed on your system. Simply single-click on the program you want to remove and hit the "Add/Remove" button at the bottom. Every file, folder, and icon associated with that program will be deleted. This is a great way to free up hard disk space if you're running low.

Another way to clean your desktop revolves around the effective use of folders. Let's say you share your computer with the kids. Their program icons are mixed with yours. Create a folder for each family member and put their

Austin American-Statesman on immigration legislation:

Mel Martinez of Florida is the only immigrant in the U.S. Senate and thus was thrust into a peculiar role as that chamber wrestled with an immigration

Martinez, now a U.S. citizen, trying to steer somewhere near an elusive middle in a most contentious and emotional debate, found his efforts rewarded by 200-plus bricks sent to his office. "Build a wall. Secure the border," messages attached to the bricks urged.

'As long as they're not coming

through the window, I can respect that," Martinez told the San Jose Mercury News last week.

The Senate's handiwork includes something resembling a guest worker program and another provision dividing immigrants into three categories that could become a bureaucratic nightmare. It could also be a dream, depending on whether you have to navigate the system or get a job interpreting it. The Senate envisions offering different options depending on how long illegal immigrants have been in the country.

The details would be relevant only if there were any hope that the Senate version of the immigration bill would emerge intact from conference committee, and that isn't very likely. The gap between House and Senate versions of


the immigration bill is huge enough to make close examination of individual provisions largely a waste of time.

The reason is quite simple: The House bill emphasizes enforcement only and makes no mention of a guest worker program sought by the Senate and White House.

With elections looming, hardliners on either side of the issue are posturing. To add to the political mix, whatever immigration bill emerges might also have an effect on the Mexican presidential elections in July. No Mexican politico ever lost ground pounding yanquis, so this debate is tailor-made for sophists and demagogues on both sides of the border.

DEAR ABBY: I am a 37-year-old married woman with a problem. My mother committed suicide when I was 18, and I have never dealt with my loss. The day after she died, my father bagged up all of her possessions and gave them to charity. I tried talking to him about her, but he told me she was "gone" and I had to move on. I guess I have just put my pain on the back burner all these years. For the last five years or so, I have been sleepwalking and having horrible nightmares about my mother's death. My husband tells me I carry on conversations with him, but that I am not really "there." I also take baths when I'm technically asleep. On one occasion, I woke up behind the wheel of my truck in my garage. I don't know if I went out driving or not, but the thought terrifies me. I am afraid I will hurt myself, or possibly others, in my zombie-like state. Any advice you can give me would be greatly appreciated. - OUT OF IT IN LAS VEGAS

DEAR OUT OF IT: Please accept my deepest sympathy for the tragic loss of your mother. The first thing you must do is ensure that your husband has the keys to your truck at bedtime. Then, contact your physician and ask for a referral to a sleep disorder specialist for an evaluation. Some people experience the symptoms you have described as a side effect from certain sleep-aid medications. However, if you are not taking anything, you may have a treatable sleep disorder. After that, ask your doctor to refer you to a licensed psychotherapist who can help you deal with the emotions you have kept buried all these years since your mother's death. Once your feelings are out in the open, you will be able to deal with them -- and discussing them with a professional will help you more quickly through the process.

DEAR ABBY: I have a good friend, "Cathy," whose 11-year-old son, "Evan," is a friend of my son, "Noah." Evan has always been a name-caller. He constantly uses words like "stupid," "idiot" and "butthead" when talking to my son, but Noah has always laughed it off or told him to cut it out. Today Noah told me he no longer wants to play with Evan because Evan is such a name-caller. Evan's habit apparently doesn't bother Cathy, since Evan constantly calls his baby sister the same names, and Cathy doesn't seem to notice. New Jersey first state to test for high school steroid use

ROBBINSVILLE, N.J. (AP) — New Jersey became the first state to institute a statewide steroid-testing policy for high school athletes.

Athletes who qualify for team or individual state championships may be randomly tested beginning this fall. Athletes who test positive for any of more than 80 banned substances — a list that includes anabolic steroids, some diuretics and other performance-enhancing drugs — will face a one-year loss of eligibility.

I go back to Bonds admitting he used "The Cream" and "The Clear" not knowing what they were at the time. Is that not an admission of guilt to a point?

The legal wrangling aside, if Grimsley was considered a distraction, why is Bonds still playing?

Major League Baseball has a very big problem on its hands and it appears to be getting bigger, if not spinning out of control.

The kind of problem that causes things like sworn documents containing names of players who have wrongfully juiced up to mysteriously disappear.

Understanding your club

This week we are going to take a look at the golf club and how it is designed to be used. Before we get into the actual function

and design of a club, I want to take a stroll down memory lane. Remember the first time you used a hammer? I don't. But I use one often and I imagine you

When you use a hammer do you think about how to hold it? How much to bend your elbow? No. You simply strike the head of the nail with the head of the

Why think differently when it comes to golf? Why perform mental gymnastics before every

swing? Why think keep your head down, keep your left arm straight, lift your left heel, hit down on the ball, hit up on the ball, pronate, supinate, the list goes on and on.

I believe golfers do this because they don't understand how the club should be

club face square to the ball the entire swing.

Most people instinctively try keeping the

While this seems logical, it is incorrect. The club head attaches to the shaft at the hosel. The heel of the club is closest to the hosel, the toe furthest away.

Think of the shaft as the hinges of a door and the toe as the part that has a knob. Imagine the door has nothing to stop it from swinging back and forth.

Keeping the club square to the line is akin to taking a door off its hinges and pushing it through the opening instead of

leaving the hinges attached, opening the door, and slamming it through the opening. Slamming the door produces more force than pushing it just as rotating the club face open to closed produces more force than keeping it square.

Stated differently, imagine you are looking face on at a mirror. Imagine the front of the club face is painted green and the back painted red. Swinging back you should see all green when the club is parallel to the

ground (3 o'clock) and as you swing through to the other side all red when the club is again parallel to the ground (9 o'clock).

This is the beginning of understanding the tool that is a golf club. Remember, the clubface rotates open to closed around the shaft. Until next time Happy Golfing.



DALLAS (AP) — Regrets are a terrible souvenir of the NBA finals, and Shaquille O'Neal had a few after his most recent trip. A decade earlier, so did Pat Riley.

And though they already own seven championship rings between them, the Miami Heat center and his coach were haunted by the ones they weren't wearing. So O'Neal sacrificed salary to improve his supporting cast, and Riley moved from the executive suite to the bench to push this eclectic team to the finals.

"I have three, but I'm not satisfied with three," O'Neal said of his jewelry. "You want more, and I have the opportunity right now to get more. So I'm just going to play

When the Heat take the court in Game 1 tonight against the Dallas Mavericks, many of the players and coaches involved will be new to the NBA's biggest stage. Neither franchise has ever advanced this far, so there's plenty of rafter room for the banner to be won in the

But while Mavericks star Dirk Nowitzki marvels at what he calls "the most exciting time of my life," O'Neal and Riley know all about this familiar pressure on their shoulders. There's no relief unless they make good on their promises of a championship for

"Over time, you know what to do, what not to do, what not to fret about, what counts and what doesn't count," said Riley, who lost the 1994 finals with the Knicks after making seven trips with the

"(You) eliminate all the things that you worry about, and then write down on a notepad ... the basics and specifics of what you have to do to win. And get those in concrete and cement."

Much about O'Neal's 2004 departure from Los Angeles still stings, but the Lakers' embarrassing five-game loss in the finals to Detroit is much worse than his feud with Kobe Bryant and his

subsequent trade. Gary Payton, O'Neal's teammate then and now, can see the hunger in the big man's eyes — and not just because Shaq lost a bunch of weight to be ready

You want more, and I have the opportunity right now to get more. So I'm just going to play hard."

"Me and Gary, we talk about that all the time," O'Neal said of the Lakers' loss. "I was the one that convinced him to come to Miami. I told him it was sort of my fault that we didn't get it done (with Los Angeles). ... We should have done things different, and we didn't. That was just my way to let him know that it won't ever happen again, if you come join me.'

O'Neal, Dwyane Wade and their supporting cast have made all the right moves during the most exciting NBA postseason in recent memory. The Heat have peaked in the playoffs after profound regular-season struggles, while Nowitzki's Mavericks turned their momentum from chasing the San Antonio Spurs into an impressive conference playoff roll.

Not much is similar about these two teams, but fans who have been intrigued by the buildup - five of the conference finals games last week were among the six highestrated shows on cable television should stay by their big screens.

For starters, the sport's two most interesting 7-footers will be on display. Nowitzki, already a household name in Germany and Texas, has reached an elite level with an incredible postseason run with two big highlights: An impossibly dramatic, game-tying three-point play in Game 7 of the second round against San Antonio, followed by a 50-point performance in the conference finals against Phoenix.

Nowitzki seems eager to feel the pressure that emanates from the only stage he hasn't mounted in basketball.

"There's nothing compared to this," Nowitzki said. "I played in the world championships, I played in the European championships, I played in Germany, but this is as big as it gets. I think that the pressure is going to be equal on everybody to perform, so I'm not going to even worry about that. I know once the tip is up, it's still basketball."

Compared to Miami's roster of famed veterans (Payton, Alonzo Mourning, Jason Williams and Antoine Walker) and budding superstar Wade, Nowitzki's supporting cast is largely unknown outside Big D.

But owner Mark Cuban and his fellow fans have no trouble discerning the particular talents of Josh Howard, Josh Powell, Devin Harris, Adrian Griffin and Marquis
