The Pampa City Commission has suspended the effective date of a rate filing by Southwest Public Service for 90 days.

Pampa City Manager John Horst said the city cannot review the 50,000 pages of the filing within the 35-day time period allowed. The

The Pampa Independent School Board of Trustees will hold a public hearing at 6 p.m., June 29, on next year's proposed budget and tax rate.

During a budget report Tuesday night at a special school board meeting, PISD Business Manager Carol Fields told trustees that because the full impact of the school finance legislation passed in Austin last month was still being sorted out, many of the figures she used in preparing the new budget are estimates.

"This is my best guess," she said.

The district is projecting total revenue for 2006-2007 at \$22,620,954 with a tax rate of \$1.435. Revenues for 2005-2006

Houston man victim in NYC subway stabbing

Two people were stabbed, with one left critically injured, in separate incidents on the city's subway system in a roughly 12-hour period, police said.

The latest incident occurred about 4 a.m. Wednesday, when an

unidentified man waiting with a friend on a platform at the Rockefeller Center station in midtown Manhattan was stabbed twice in the stomach, apparently during a robbery, police said. He was hospitalized in stable condition. The stabber fled.

On Tuesday afternoon,

Christopher McCarthy, 21, of Houston, was hospitalized in critical condition after he was stabbed by a man sitting across from him in a subway car on Manhattan's Upper West Side, an attack police said was random and apparently unprovoked.

"We can't put asbestos in our landfill," Horst said. "Each commercial building has to be tested for asbestos."

Targeting abandoned vehicles

The third and last installment of this series on junk cars is about "Abandoned Vehicles." Now this is really different than "Junked Vehicles," but many of the same rules apply.

Officer Brown (as well as all the other officers) deals with this problem too. Sometimes the solution is as simple as the owner having enough time to get a gallon of gas in it, or a mechanic to tow it to their shop, or fix a flat. That is if it is not a danger to the rest of the driving public or it stays there for a couple of weeks without attention.

When we have to impound the vehicle under these conditions, the owners usually come get their cars because it is their mode of transportation. We really try to work with the owners in this situation and give them a reasonable amount of time to get the vehicle running.

Like always, if we are driven to take enforcement action, then we do that without hesitation. When we do take the vehicle we send the required notification to the registered owner and all lien holders. If nobody picks up the car, then the wrecker service will go through the proce-

dure to gain a title to the vehicle so they can recover some of their costs associated with towing and stor-

They would be disturbed at how we have allowed politicians and judges to turn the Constitution into an excuse instead of a restraint. They would be uneasy about the large standing army we have maintained since the end of World War II. And they

If the Founding Fathers would certainly disapprove were to come back, I doubt if of our foreign policy, which can only be described as imperialistic.

The Charley Fathers Reese were suspicious of Columnist government and wary of it.

They recognized that government is always the greatest threat to liberty. George Washington fikened government to fire -"a dangerous servant and a fearful master." The whole purpose of the Constitution they devised was to keep the

government divided and weak.

First, they expected the sovereign states to act as a brake



against any attempt by the federal government usurp their powers defined by the

Constitution. Abraham Lincoln nullified that concept with brute force. Under their original plan, U.S. senators were selected by the state legislatures and were clearly intended to act as ambassadors from the states.

Later generations foolishly eliminated that safeguard by amending the Constitution so that senators are elected by the people.

Clearly, the Founding Fathers did not approve of modern concept, imposed by federal courts, of one man, one vote. They designed the House to represent the people, but each state, regardless of size, was given two senators. When federal courts eliminated the states' ability to follow the example of the Constitution, they shifted political power from the rural areas to the

Sculptor killed in industrial accident while in his studio

HONDO, N.M. (AP) — Luis Jimenez, a successful but often controversial sculptor whose work has been displayed at the Smithsonian and the Museum of Modern Art, died Tuesday in what authorities called an industrial accident.

The Lincoln County Sheriff's Office said part of a sculpture was being moved with a hoist at Jimenez's New Mexico studio when it came loose and struck the artist, pinning him against a steel support. The 65-year-old was taken to the Lincoln County Medical Center, where he was later pro-

The accident remained under investigation late Tuesday. "Luis Jimenez's loss to the United States, to New Mexico, to the Chicano community is great," friend David Hall told Albuquerque TV station KRQE. "He was an icon, he was a very famous and well-respected artist. ... We will dearly miss him."

Jimenez, a native of El Paso, Texas, was known for his large and colorful fiberglass sculptures that depicted fiesta dancers, a mourning Aztec warrior, steelworkers and illegal immigrants. His work often started arguments and spurred

"It is not my job to censor myself," Jimenez once said. "An artist's job is to constantly test the boundaries."

Jimenez's "Vaquero" and "Plaza de Los Lagartos" sculptures have become civic landmarks in El Paso, where he grew up learning to paint and fashion large works out of metal in his father's sign shop.



Former Atlanta mayor CREATE a Beat! sentenced to prison

ATLANTA (AP) — A fed- pay taxes on what prosecutors eral judge said he believed Bill Campbell helped make Atlanta a world-class city but wasn't convinced the former mayor had accepted responsibility for his misdeeds.

Judge Richard Story on Tuesday sentenced Campbell to 2 1/2 years in prison and fined him \$6,300 for tax eva-

Story said he was overcome with a "pall of disappointment" over the breadth misconduct during Campbell's administration. Campbell, 52, was convicted in March.

"Within my heart, I am not sure you have accepted responsibility," he told Campbell.

Campbell was cleared of U.S. Attorney charges he lined his pockets with payoffs as he guided Atlanta during the 1990s, years that included the 1996 Summer Olympics. But he was found guilty of failing to


said were his ill-gotten gains.

Sentencing guidelines had called for 2 1/2 years to 3 years and one month in prison. The judge also ruled that Campbell owed \$62,823 in back taxes.

Campbell, who was ordered to voluntarily surrender to police at a later date, said he was confident he would prevail on appeal.

"What we saw today was an attempt, unfortunately, to undo the jury's verdict," Campbell said. "This is not justice. I never betrayed the public trust."

Campbell's defense team argued that his two decades of public service were grounds for leniency. But Assistant Russell Vineyard said that if the former mayor "seeks credit for the good things that happened on his watch, he must also take credit for the bad."

LOS ANGELES (AP) -An appellate court tossed out a \$3.75 million default judgment against "Golden McClanahan because the plaintiff's lawyer served her agent with the complaint rather than her attor-

The 2nd District Court of Appeal unanimously ruled Monday in favor of

McClanahan, who had been sued for slander by former documentary filmmaker Dirk Summers. There had apparently been a dispute over a \$200,000 loan the actress, a former Oklahoma resident, made to Summers.

Although Summers' complaint eventually got to McClanahan's lawyer, the three-judge panel conclud-ed the circuitous delivery method was improper.

"Accepting Summers' rationale would constitute a judicial repeal of California's statutory law governing service of process and the adoption of only one rule: 'A summons may be served on anyone, anywhere, by any means which results in actual notice of the action in time to defend," Justice Earl Johnson wrote. Justices Fred Woods and Laurie D. Zelon joined in the opinion.

Summers filed suit in 2003 claiming he had been unable to obtain work because of McClanahan's defamatory statements about him after a failed business project. He sought \$1.7 million in damages for past and future lost earnings, \$1 million for damage to his reputation and \$1 million in punitive dam-

Summers' Eugene Paolino, left a copy of the complaint at the office of McClanahan agent Barbara Lawrence and he mailed the agent another

The agent sent a copy of the complaint to McClanahan attorney John C. Edwards, but the lawyer didn't answer the complaint because he believed it was improperly served.





Wade, plagued by foul trouble and slowed by a sore left knee, scored 42 points - 15 in the fourth quarter - to rally the Miami Heat to a 98-96 win over the Mavericks on Tuesday night in

Showing off his full offensive arsenal in the biggest game of his young career, Wade singlehandedly saved Miam's season. Despite picking up his fifth personal foul with 10:56 to play, Wade kept himself on the floor and kept the

Heat in the series. "As a team, we just came out and said this could be the season if they win this game," Wade said. "We came out, ran our offense to the crisp, locked down on defense and came back and won this game."

Dallas still had plenty of chances late, but Dirk Nowitzki missed one of two free throws with 3.4 seconds to go and the Mavericks couldn't convert on an inbounds play in the final second, thanks to Wade.

"I had a chance to tie it, I just missed the free throw," Nowitzki said. "That's just a free throw I usually make. I don't know what happened. I just shot it a little strong."

When the final horn sounded, Heat fans simultaneously exhausted and exhilarated, tossed their "White Hot" white T-shirts and seat covers into the air, a celebration that seemed unimaginable just a few minutes earlier.

Now, after watching Wade's heroics, Shaquille O'Neal and Udonis Haslem make four crucial free throws in the final two minutes and the second-largest fourth-quarter rally in NBA finals history, they're coming back for Game 4 on Thursday.

"We had 2 1/2 horrible games and now we can use this momentum and pick it up and just try to win four," said O'Neal, who had 16 points and 11 rebounds, atoning for a miserable five-point performance in Game 2.

Miami was down and almost done after Jason Terry's basket made it 89-76 with 6:34

Tha"s when Wade, conjuring memories of Michael Jordan's playoff miracles, took over.

First, he banked in a 14-foot jumper. Then he completed a three-point play and drilled a 17footer to bring the Heat within five. Then, after a miss by Nowitzki, Wade drove the baseline, hung in the air for what seemed like an eternity, adjusted the ball in flight and hit a floater to make it 91-88 with 3:36 to go.

Dallas, meanwhile, which had shown so much poise through 3 1/2 quarters, was coming

apart. They rushed shots, missed others and blew a game they may later regret giving away.

"This is a team that detests losing," Dallas coach Avery Johnson said. "We don't like losing anything.'

Nowitzki's two free throws slowed Miami for a moment, but O'Neal, whose abysmal foul shooting had contributed to Miami's 0-2 deficit in the series, calmly spun in Guard, Miami Heat two attempts to pull the Heat within 93-90.

What was he thinking?

"Make 'em," he said Wade's 20-foot jumper got Miami within a point, and Haslem came up with perhaps the play of the game not made by Wade, picking off a pass intended for Nowitzki. Haslem, playing with a badly bruised shoulder suffered in Game 2, was fouled and the Heat's toughest player made both attempts after firing bricks on his first four tries.

"It was tough just to get my arm over my head," Haslem said.

"He stepped up," Wade said.

Nowitzki, who finished with 30 points, was fouled trying to answer Payton's shot with a drive to the hoop. At that point, he was 25-of-27 from the line in the series, but could only make the first. When he misfired on the second, he triggered a roar inside AmericanAirlines Arena that could be heard back in Dallas.

The Mavericks appeared on their way when they outscored the Heat 34-16 in the third quarter to open a 77-68 lead entering the final 12 minutes.

Josh Howard scored 21 points for Dallas, which came in 25-0 in games in which he scores at least 20. Erick Dampier added 14 points and Jerry Stackhouse, who had 19 in Game 2, managed just four points on 1-of-9 shooting.


"We definitely feel like we gave this game away," Stackhouse said.

Athletes and their motorcycles just aren't a good combination

(AP) - The list is startling, mainly because it is so long.

Jason Williams may never play in the NBA again because he couldn't stay off his motorcycle. A ride on his bike in a parking lot cost Kellen Winslow Jr. \$3 million and nearly his career with the Cleveland Browns.

Dennis Rodman wrecked his twice, the second time in front of a strip club for added effect.

And now Ben Roethlisberger is in a Pittsburgh hospital recovering after seven hours of surgery for a broken jaw, nose and who knows what else after his bike hit a car.

Not just any bike. He was riding the fastest street-legal motorcycle you can

Without a helmet.

Not the brightest thing to do. So dumb, in fact, that even fellow Suzuki Hayabusa riders were shaking their heads.

"Wear a helmet on the field, but not on a bike? Makes no sense to me," one wrote on a 'Busa message board.

Doesn't make much sense to anyone, especially the Pittsburgh Steelers, who lectured their young quarterback to no avail about his motorcycle habits. Of course, had the Steelers shown some backbone and put a clause in Roethlisberger's contract prohibiting motorcycle riding, he might not be in the hospital today.

Just what is it about these men and their machines? More to the point, what is it that makes Roethlisberger want to drive the Pittsburgh streets with his hair flowing in the wind on a motorcycle that reaches 139 mph in the quarter mile?

Taking hits from Ray Lewis can ruin your day. Taking them from a Chrysler New Yorker can ruin your life.

when asked about his quarterback riding motorcycles.

"What I say about motorcycles is that concrete is undefeated," Porter

Unfortunately, there're a lot of athletes who can't seem to figure that out. Roethlisberger was one of those, insisting on riding his bike even after Winslow crashed his last year and was hurt so badly that his young career was in jeopardy.

Steelers coach Bill Cowher used the Winslow accident to caution his quarterback, apparently to no avail. Maybe he should have tacked up a list of athletes injured in motorcycle crashes above Roethlisberger's locker to get his attention.

Topping that list would be Williams who, like Roethlisberger, had the world at his feet after a fine rookie season with the Chicago Bulls. Shortly after the season ended, Williams crashed his new motorcycle into a light pole, fractured his pelvis, tore knee ligaments and damaged nerves in his left

The Bulls released him, and the former No. 2 draft pick hasn't played in the NBA since.

The list goes on, littered with names and lost careers. Even the Herminator wasn't immune, breaking both legs in a 2001 wreck and nearly losing one. Olympic skier Hermann Maier was told he would never walk again, though he came back to win two medals this year at the Turin Games.

Whether Roethlisberger can come back won't be known for months, maybe years. His mother cried as she entered the hospital Monday, and most of Pittsburgh was crying along with her at the possible loss of the quarterback who helped win them win the Super Bowl.

At the age of 24, Roethlisberger seemed to have everything. He was Joey Porter had it right last year rich, loved by Steelers fans and

already had one Super Bowl ring on his finger.

Though there's no evidence Roethlisberger was speeding, the urge to ride and the feeling that you're indestructible can be a bad combination. Athletes by their very nature tend to

be risk takers. Some get their rush on motorcycles, others turn to alcohol and drugs. Still others - John Daly and Charles Barkley come to mind - get their kicks by betting millions of dollars in casinos.

Tiger Woods went bungee jumping recently, and drove a race car.

Hurricane assistance spent in variety of ways

WASHINGTON (AP) — Houston divorce lawyer Mark Lipkin says he can't recall anyone paying for his

services with a FEMA debit card, but congressional investigators say one of his

clients did just that. The \$1,000 payment was just one example cited in an audit that concluded that up to \$1.4 billion — perhaps as much as 16 percent of the billions of dollars in assistance expended after Hurricanes Katrina and Rita - was spent for bogus rea-

The Federal Emergency Management Agency also was hoodwinked to pay for season football tickets, a tropical vacation and a sex change operation, the audit found.

Prison inmates, a supposed victim who used a New Orleans cemetery for a home address and a person who spent 70 days at a Hawaiian hotel all were able to get taxpayer help, according to evidence that gives a new black eye to the nation's disaster relief agency.

"I do Katrina victims all the time," Lipkin, the divorce attorney, told The Associated Press. "I didn't know anybody did that with me. I don't think it's right, obviously."

Government Accountability Office officials were testifying before a House committee Wednesday on their find-

Rep. Michael McCaul, R-Texas, chairman of the subcommittee overseeing an investigation of post-hurricane aid, called the bogus spending "an assault on the American taxpayer."

"Prosecutors from the federal level down should be looking at prosecuting these crimes and putting the criminals who committed them in need of our assistance."

jail for a long time," he said. To dramatize the problem, investigators provided lawmakers with a copy of a \$2,358 U.S. Treasury check for rental assistance that an undercover agent received using a bogus address.

The money was paid even after FEMA learned from its inspector that the undercover applicant did not live at the

FEMA spokesman Aaron Walker said Tuesday that the agency, already criticized for a poor response to Katrina, makes its highest priority during a disaster "to get help quickly to those in desperate

"Even as we put victims first, we take very seriously our responsibility to be outstanding stewards of taxpayer dollars, and we are careful to make sure that funds are distributed appropriately," Walker said.

Report takes aim at nation's ERs

WASHINGTON (AP) — Half a million times a year - about once every minute — an ambulance carrying a sick patient is turned away from a full emergency room and sent to another one farther away.

It's a sobering symptom of how the nation's emergency-care system is overcrowded and overwhelmed, "at its breaking point," concludes a major investigation by the influential Institute of Medicine.

That crisis comes from just day-to-day emergencies. Emergency rooms are far from ready to handle the mass casualties that a bird flu epidemic or terrorist strike would bring, the institute warned Wednesday in a three-volume report.

"If you can barely get through the night's 911 calls, how on earth can you handle a disaster?" asked report coauthor Arthur Kellerman, Emory University's emergency medicine chief.

That ERs are overburdened isn't new. But the probe by the IOM, an independent scientific group that advises the government, provides an unprecedented look at the scope of the problems - and recommends urgent steps for health organizations and local and federal officials to start fixing it.

Topping that list is a call for coordinating care so that ambulances don't waste potentially lifesaving minutes wandering from hospital to hospital in search of an ER with room. The idea is to

set up regionalized systems that manage the flow much like airports direct flight traffic. That also should direct patients not just to the nearest ER but to the one best equipped to treat their particular condition - making sure stroke victims go to stroke centers, for example.

Other recommendations: -Congress should establish a pool of \$50 million to reimburse hospitals for the unpaid emergency care they provide to the poor and uninsured.

-Congress should ensure that more of the nation's disaster-preparedness funding goes to the hospitals and emergency workers who will provide that care. Typical government grants to hospitals for bioterrorism preparation are \$5,000 to \$10,000 — not enough to equip one critical-care room. When it comes to getting ready for a bird flu outbreak, few hospitals even have the ventilation equipment needed to isolate patients. And emergency medical services received only 4 percent of the \$3 billion distributed by Department

Homeland Security in 2002 and 2003 for emergency preparedness.
