Proposed budget increase over last fiscal year

> By DAVID BOWSER Staff Writer

Preliminary figures put Pampa's general fund budget at slightly over \$9 million for the next fiscal year.

"Sales tax receipts are up which helps us immensely," said Pampa City Manager John Horst.

The \$9,118,058 proposed budget for the 2006-2007 fiscal year is an increase over this year's \$9,032,623.

"That does not include capital expenditures," said Horst.

At a budget work session Tuesday night, the city staff presented the new budget proposal. Once the commission has reviewed it, they must hold a public hearing on the budget and vote twice, once each in two different meetings, to adopt it. Under state law, the budget has to be adopted by the beginning of the new fiscal year, which for Pampa would

The commission reviewed both the general fund operating budget and capital expenditure budget at Tuesday's work session. Horst said the commission will continue its work on the budget next week during their regular session at 4 p.m. Tuesday in the City Commission Chambers in City Hall.

"There's really no big changes in next year's projected general fund budget than what we've got this year," Horst said. "We're planning on providing the same services. Of course, energy costs are up. Fuel costs are up which hits us

Money budgeted for the mayor and city commission operations along with administrative services are both down.

Financial services budget is up. Robin Bailey, the city's financial director, said the financial services department had gained additional duties during the past year and that the cost of audits had gone up.

Municipal Court and police department services are up.

Horst said an increased caseload and

County officials vote to take payment services online

Property owners in Gray County will soon be able to pay their property taxes online in much the same way that they may renew vehicle registrations online.

County commissioners at their Tuesday morning meeting approved a contract with Certified Payments to provide the service, which would be accessible through a link on the county's Web page.

Credit and debit cards must be used to pay online, said County Tax Assessor-Collector Gaye Whitehead at the meeting. A convenience fee of 2.75 percent of total tax paid will be charged by Certified Payments to provide the service.

The county will receive the tax amount paid online, with the convenience fee going to the service provider. Minimum fee is

"We will get the tax payments within two days of the day they are paid," Whitehead told commissioners. "There is no set term

FEMA urge evacuees to meet deadline

HOUSTON (AP) - Evacuees who fled to Texas to escape hurricanes Katrina and Rita have 90 days to recertify for federal housing aid, a deadline that officials warn may not be extended.

The Federal Emergency Management Agency has been helping thousands of displaced residents pay for temporary housing and utilities. When the storms hit last August and September, most of the evacuees — about 150,000 retreated to Houston.

About 16,000 families in Texas still eligible for assistance must recertify with FEMA by Oct. 31. They would receive aid until the end of February.

Another 4,000 evacuees now determined to be ineligible for more federal aid have until Aug. 31 to begin paying for their own housing.



raises accounted for the increase. Pampa Police Chief

Trevlyn Pitner told the commission that the increase request for his department centered on the city's upgrading of communications and computers in patrol cars and increases in salary for police personnel. He also pointed out that the city's contract with Gray County for jail services had increased from \$50,000 a year to \$75,000 a year.

The police department was also one of the city departments hit hard by increased fuel costs.

The emergency medical services budget is up slight-

Horst said the city pays the ambulance service a subsidy of \$80,400 plus utilities and maintenance on their building, a former fire station. Gray County also pays them \$80,400.

Fire prevention services

Pampa Fire Chief Kim Powell said that when the new Fire Marshal was

appointed, he would have taken a cut in pay from his captain's position, so his pay remained the same, pushing up the budget in that category. The city is also paying to bring the Fire Marshal's certifications up to date. Powell said there has also been an increase in calls over the past year that is being reflected in next year's proposed budget.

"Everything else is about the same," she said.

Planning and engineering department costs have increased.

Richard Morris, the city's public works director, said the 4.8 percent increase is mostly due to wages and fuel costs.

Streets and parks budgets are both down.

Morris said that was in part due to the retirement of a senior employee. Another part of the lower budget number was the result of stored materials for street maintenance, but he warned that was coming to an end and new material costs are rising.

Horst pointed out that electrical costs for streets lights have gone up about \$25,000 a year. He said the city's active program of

Both new locations have ample parking and are ADA accessible, Winborne said.





Dems are not true friends of state of Israel

Ten years ago, on April 18, 1996, Israel attacked Hezbollah in Lebanon for 16 days in an operation called Grapes of Wrath. The global condemnation of Israel was fierce, especially when it bombed a U.N. refugee camp, killing 107 people, an attack that Tel Aviv said was a mistake.

At the time, the United States did nothing to stop the tide from turning against Israel and President Clinton said, "I think it is important that we do everything we can to bring an end to the violence."

In private, Clinton seethed at the Israeli attack, saying he had discussed with Israeli Prime Minister Shimon Peres the possibility

of concluding a military defense treaty with his nation, pledging U.S. aid in the event of an attack.

"They really want this guarantee from us," Clinton told me. "I would have given them the commitment, too, but now I can't because of the uproar over the refugee camp bombing."

No such treaty was ever

Clinton's willingness to use American power to force a cease-fire on Israel before it had fully eradicated Hezbollah stands in stark and sharp contrast to George Bush's insistence on letting Israel proceed with its attacks until the terrorist group is neutralized.





Matthews smacks grand slam in Rangers' 9-0 win over Twins

MINNEAPOLIS (AP) -Gary Matthews Jr. hit his second grand slam this season to highlight an eight-run fourth inning, and Adam Eaton pitched the Texas Rangers past the Minnesota Twins 9-0 Tuesday night.

Michael Young also homered for Texas, which won for only the second time in nine games.

Making his second start since having surgery on the middle finger of his pitching hand, Eaton (1-1) threw six impressive innings for his first win with the Rangers.

After missing Sunday's scheduled start because of food poisoning, Eaton allowed four hits, walked four and struck out four. C.J. Wilson and Scott Feldman

finished the five-hitter, the Texas' sixth shutout this

The Twins were blanked for the ninth time.

The closest Minnesota came to scoring against Eaton was a two-out triple by Joe Mauer in the first, but Michael Cuddyer hit a soft liner to first to end the inning.

Scott Baker (3-7) did not help his chances to remain Minnesota's fifth starter, allowing a career-high seven earned runs in 3 1-3 innings. In three starts since his recall from Triple-A Rochester, Baker has allowed 16 earned runs in 14 2-3 innings for a 9.82 ERA.

Baker gave up one hit in three innings before Texas broke loose in the fourth with some help Minnesota's defense.

With one out, a single by Hank Blalock scored Carlos Lee, who doubled off the right-field baggie to start the inning. Ian Kinsler followed with a single before Matt Stairs hit a grounder to Nick Punto at third.

Punto double-pumped, then threw wide of Luis Castillo at second base, allowing Blalock to score on

error and moving Kinsler to third. Rod Barajas was hit by a pitch to load the bases before Brad Wilkerson hit an RBI single for a 3-0 Texas lead.

Matthews worked the count full before hitting a 426-foot shot to right that landed about 10 rows into the upper deck.

Young followed with an opposite-filed homer, also on a 3-2 pitch, to end Baker's night.

Mark Teixeira added an RBI single in the ninth.

Pat Neshek struck out a career-high four in 2 2-3 hitless innings out of the Minnesota bullpen.

Notes: Minnesota manager Ron Gardenhire missed his second straight game with flulike symptoms. A team doctor wasn't sure if Gardenhire would back for Wednesday's game. ... Texas recalled Feldman from Triple-A Oklahoma and optioned pitcher John Rheinecker to RedHawks. ... Barajas threw out Castillo and Punto trying to steal second base three pitches apart in the third inning. Barajas entered the game with a 30.6 percent success rate.

Astros 1, Padres 0

SAN DIEGO (AP) -Andy Pettitte outpitched Jake Peavy in his first game in San Diego since the 1998 World Series, and Morgan Ensberg returned from the disabled list to help spark the Houston Astros to a 1-0 win over the San Diego Padres on Tuesday night.

Pettitte and Peavy went head-to-head for the third time since 2004, and the Houston lefty now has a 2-1 advantage over the Padres' righty.

Pettitte (10-11) was impressive in his first start in San Diego since winning Game 4 of the 1998 World Series at Qualcomm Stadium, which completed the New York Yankees' sweep of the Padres.

Pitching for the first time at Petco Park, he held San Diego to five hits in six

innings, struck out eight and escaped two jams. Pettitte walked two and got the only run he needed on Adam Everett's sacrifice fly in the fourth.

He hasn't returned to the eastern Iowa town since its famous cornstalks resurrected Shoeless Joe Jackson and other long-dead ballplayers on the big screen 17 years ago.

But now comes word that Costner will

The star will appear Aug. 11 at the baseball field in Dyersville as part of a "Rolling Roadshow" tour, in which 10 classic movies are being shown at the sites of their filming.

Netflix, an online movie rental service that organized the tour, confirmed this week that Costner will make an appearance before the movie is shown on a 30-foot inflatable screen in the outfield.

Costner will play a free concert with his unnamed rock band, followed by the movie.

"Field of Dreams" was an Academy Award nominee and featured one of the most famous movie lines ever: "If you build it, they will come."

"Returning to the 'Field of Dreams' location to play a concert ... has special meaning for me," Costner said in a news release. "The movie was significant in my career, and the band is an important part of my future."

LOS ANGELES (AP) — A pilot faced reckless flying and other charges for landing a helicopter on a public street to pick up Tommy Lee and take him to a concert, prosecutors said.

David Keith Martz, 49, landed the helicopter July 7 outside a home in the Hollywood Hills to give the 43-year-old rocker a 50-mile flight to a Nine Inch Nails concert in Irvine, said Frank Mateljan, a spokesman for the City Attorney's Office.

Martz was charged with one count each of reckless flying, landing an aircraft on a public road and landing an aircraft without a permit, Mateljan said. Martz was to be arraigned in Hollywood on Wednesday.

Each charge carries a maximum penalty of six months in jail and a \$1,000 fine.

Martz, who lives in the La Jolla area of San Diego County, has an unlisted telephone number and couldn't be reached. Mateljan said the city attorney's office didn't know the name of his lawyer.

Lee publicist Dvora Vener Englefield said Tuesday that Lee would have no comment.
