

"You have got to stop the flow of illegal immigrants," said George Lingenfelder, a business owner from the Houston suburb of Katy. "We need to stop the free education, stop the free health care, stop the housing subsidies. I do not believe in amnesty.'

The Rev. Kevin Collins, pastor at Immaculate Conception Catholic Church in Houston, said he believed Wednesday's hearing was being held to spread misinformation about immigrants.


"We want to fix the system that is broken," he said. "But we feel these hearings are not doing anything to fix the system. They are painting pictures of immigrants as criminals."

Inside the courthouse, a U.S. House subcommittee began one of about two dozen hearings around the country this month on how to fix the laws on illegal immigration.

The subcommittee, chaired by U.S. Rep. Michael McCaul, R-Austin, was to discuss criminal activity and violence along the U.S.-Mexico border.

The 2006-2007 school year is upon us again. One of the issues we face every year is what to do when we see a school bus picking up children. I want to remind everyone of the correct procedures when you encounter a bus.

build a new junior high school and move the current administration offices to the old junior high school.

The discussion centered on the merits of creating a new Pampa Junior High School and the possible locations for such a project. The decision to create a new PJHS would, Haenisch said, require a bond issue in the fall. The board has two weeks to decide.

At the instigation of two reports, the board established a PISD Facilities Committee, consisting of 51 community members, in November 2005.

Both the Texas Association of School Administrators and the engineering firm of Parkhill, Smith and Cooper recommended in separate findremodeling the junior high and high schools.

"The first group evaluated how adequate the facilities were for learning, and the second group looked at the facilities from a structural point of, view," Haenisch said.

"Both came up with the same basic concept," he noted. "Everything was adequate or better, but the junior high and high school were both in the lower ranges of adequate.'

Haenisch said the proposed rebuild and renovations are the "only way to meet the needs both the studies identified at a cost acceptable to the board."

Parkhill, Smith and Cooper also recommended replacing the bus barn and both central administration buildings currently in use by the district.

At the last meeting, the board was trying to put together a long range pro-

ings, Haenisch said, replacing or posal. At this time, Haenisch said, the board is favoring a site for the proposed new junior high that is large enough to accomodate an additional campus should Pampa High School require rebuilding at some point in the future.

PHS, Haenisch said, was built in 1941. Officials hope to eke out another 30 to 50 years from the campus and anticipate the proposed remodeling will extend the life of the school dramatical-

"Some of the remodeling would take care of electricity but not plumbing and other significant structural issues that might develop over time - certainly not all of them," the superintendent said.


The location of the next meeting has not yet been finalized, Haenisch said. He believes the time will be 6 p.m. and expects the board will continue its debate on whether or not to raise a bond issue for the public to vote on.

ST. LOUIS (AP) - The former chief executive of online gambling company BetOnSports was freed on \$1 million bond Wednesday after spending nearly a month behind bars following his arrest on racketeering and fraud charges.

David Carruthers, 48, was released after a hearing before U.S. District Judge Mary Ann Medler. He had been expected to be freed as early as Monday but it took days to work out technical details. Among those details: A dedicated phone line had to be installed at the residence where he will stay.

Carruthers must remain in the St. Louis area until his trial. According to the terms of his bond, Carruthers will live at a hotel in the suburb Clayton. He will not be allowed to leave the hotel except for court appearances, meetings with his attorney or medical emergencies.

During the hearing, Carruthers asked the judge if the home-incarceration was 24 hours a day. She said it was.

The charges against Carruthers are part of a 22count indictment against London-based BetOnSports PLC being prosecuted by U.S. Attorney Catherine Hanaway in St. Louis. Carruthers was chief executive of the company until he was fired shortly after his arrest last month at Worth Dallas-Fort International Airport.





In 2004, Brewster County District Attorney Frank Brown indicted two members of the Alpine City Council. Brown determined that a series of emails among the council members discussing beyond public view the hiring of a water engineer constituted a violation of the Open Meetings Act.

The indictments were later dropped. And that should have been the end of the story.

But one of those council members, along with a third who received immunity in the original case, filed the lawsuit in Pecos charging that the Texas Open Meetings Act is vague and unconstitutionally stifles free speech.

A ruling in favor of the plaintiffs by U.S. District Judge Robert Junell would erase a substantial record of progress toward local government accountability. Democrats and Republicans have championed the Open Meetings Act, with former Texas Attorney General and current Sen. John Cornyn among its most ardent advocates.

And a ruling against the statute in a federal court would call into question the ability of any state legislature to compel transparency in local government.

That's a high price to assuage the hurt feelings of a few council members in Alpine. And it's one the state of Texas shouldn't be forced to pay.



CANYON (AP) - West Texas A&M

coach Bob Schneider retired Tuesday, clos-

ing out a career that included more than

he had been contemplating retirement for about a week.

"I talked to the players this morning, and I told them there's never a good time to retire," Schneider said at a news conference. "I've always kind of felt that way."

"I just feel like this is the time for me," he said. "It's one of those situations where you really don't think about it that much, but then all of a sudden you wake up in the morning, and you begin to think about some other things. I think that's where I am at this time."

He said he had considered retirement before.

"You have great relationships with your players, your coaches, the community and the administration, so you say, 'Well, I want to go one mc z year. I've done this, or I'm looking forward to this', and the years just keep rolling on. Hopefully the wheels don't fall off."

West Texas A&M went 28-4 last season and won the Lone Star Conference title, Schneider's ninth in 25 years with the Lady Buffs. The team advanced to the NCAA Division II quarterfinals.

Schneider's West Texas A&M teams compiled a 585-163 record. The 1988 team went 33-1 and was the national runner-up.

Overall, Schneider compiled a record of 1,045-293. In addition to West Texas A&M, he coached at Texas Woman's University and at three high schools in Texas and New Mexico.

He led Canyon High School to five state championships and the state championship game 10 straight seasons while compiling a 350-59 record from 1966 to 1978.

The school planned to begin its search for a successor on Wednesday. Athletic director Michael McBroom said the search committee will narrow the search to three candidates.

The Amarillo Globe-News reported in its Wednesday editions that Schneider had recommended his son, Brett, for the job. Brett Schneider is an assistant at West Texas A&M. See in the second

Cubs 8, Astros 6, 18 innings

HOUSTON (AP) - Fighting fatigue at the end of a long night, Matt Murton found the energy for another big hit.

Murton hit a tying homer in the ninth inning and a two-run single in the 18th, sending the Chicago Cubs to an 8-6 victory over the Houston Astros on Tuesday in the longest regular-season game in the 6-year history of Minute Maid Park.

"I was a little tired," Murton said. "That's just part of the game. You have to find a way to get over it. It was a great night in the sense we were able to win a game like that."

Cubs manager Dusty Baker said he's never managed a longer game. By the end, he was down to his last pitcher - and player Rich Hill, who's scheduled to start Wednesday. Thanks to Murton, Hill (3-5) only had to throw 28 pitches, shutting out the Astros in the 17th and 18th.

The teams used 18 pitchers in all, tying an NL record. Hill finally ended it after 5 hours, 36 minutes, by striking out Morgan Ensberg at 12:41 a.m. CDT on the game's 542nd pitch. That came about 45 minutes before another 18-inning game ended Tuesday night - the Arizona Diamondbacks won 2-1 at Colorado. It was the first time in major league history two games on the same day lasted as long as 18 innings, according to the Elias Sports Bureau.

The Cubs and Astros won't get much sleep, either. The finale of their three-game series starts at 1:05 p.m. CDT today.

It was Houston's third 18-inning game in 10 months. The Astros outlasted Atlanta 7-6 in a home playoff game last October to advance to the NL championship series, and lost 8-7 in 18 innings at Pittsburgh on May 27.

"We normally win 18-inning games here," Houston manager Phil Garner said. 'We played hard and had great pitching performances. It was just a tough one to lose."

Murton sent this one to extra innings with a leadoff homer in the ninth off Astros closer Brad Lidge, who blew a save in a game Roger Clemens started for the second time in a month.


