Board members present were Randy Adcock, Scott Clayton, Joel Dennis, Kenny Hensley, D.M. Parks, Jack McPhaul, and Tom Ed Vestal.

Superintendent, Jimmy Thomas was present.

John Harris was the only visitor present.

- 1. Call To Order: The meeting was called to order by Board President, Jack McPhaul.
- 2. Community Input: There was no Community Input.
- 3. Approval Of Minutes: A motion was made by Joel Dennis and seconded by D.M. Parks to approve the minutes of the October 21, 1991 Meeting. The motion carried unanimously.
- 4. Approval Of Bills: The November bills were reviewed. A motion was made by Randy Adcock and seconded by Scott Clayton to approve the November bills. The motion carried unanimously.
- Take Action To Approve Gasoline/Diesel Bid: Bids submitted for gasoline and diesel were reviewed. A motion was made by Kenny Hensley and seconded by Randy Adcock to accept the bid submitted by Franks Oil Company of Lamesa. The motion carried unanimously.
- Take Action To Approve Propane Bid:
 Bids submitted for propane were reviewed. A motion was made by D.M.
 Parks and seconded by Joel Dennis to accept the bid submitted by Eddins-Walcher Company. The motion carried unanimously.
- Take Action To Approve Food Service Bid: Bids submitted for food service items were reviewed. A motion was made by Scott Clayton and seconded by Tom Ed Vestal to accept the bids submitted by Ben E. Keith and White Swan on a per item basis. The motion carried unanimously.
- 8. Take Action To Enter Contract For New Scoreboards: The offer presented by Refreshments Vending Inc. to provide new scoreboards for the Borden County School was reviewed. A motion was made by Randy Adcock and seconded by Scott Clayton to enter the contract with Refreshments Vending Inc. to provide scoreboards for the Borden County School. The motion carried unanimously.
- 9. Adopt Policy Concerning Transportation Of Students Living In Hazardous Areas: The requirement to have Board Policy concerning transportation of students living within a 2 mile area of the school that live in hazardous areas was discussed. A motion was made by Joel Dennis and seconded by D.M. Parks to adopt Board Policy to allow transportation of students living in hazardous areas and less than two miles from the school for state funding purposes. The motion carried unanimously.
- 10. Sale Of Old School Vehicles: The school vehicle fleet was discussed in relation older vehicles that were no longer needed by the District. A motion was made by D.M. Parks and seconded by Randy Adcock to sell a 1974 GMC Pickup and a 1976 Ford Bus at public auction. The motion carried unanimously.
- 11. Academic Excellence Indicator System Report: The 1990-91 Academic Excellence Indicator System Report was reviewed.
- 12. <u>Superintendent's Report:</u>
 a. Financial Report A year to date financial report was given for the 1991-92 school year.
 - b. Attendance Report It was reported that 151 students were enrolled in grades K-12 as of November 18, 1991.
 - c. Failure Report A six weeks failure report was presented for the conclusion of the second six weeks.
 - d. Poka Lambro Equipment Reduction Agreement A report was given concerning final reduction of charges from Poka Lambro relating to the purchase of phone equipment. The Board was also informed that Poka Lambro installed a pay telephone free of charge for the District's convenience.



(the "Utility") intends to change rates for electric utility service effective November 27, 1991, or as soon thereafter as may be permitted by law. The Utility has not had a general rate increase since 1986. Based upon a test year ending December 31, 1990, the increase requested over actual test year revenues is \$1,518,446 or 15.75%. Of this amount, \$482,193, or approximately 5%, is attributable to an increase in the cost of wholesale power purchased by the Utility from Texas Utilities Electric Company which the Utility already has authority to charge to its customers. The increase requested over test year revenues adjusted for annualization of this test year wholesale power increase is \$1,036,253 or 10.3%. The changes are applicable to all areas, all customer classes, and all customers served by the Utility.

Implementation of the proposed changes is subject to approval by the appropriate regulatory authority. A statement of intent including the proposed revisions of tariff and schedules and a statement specifying in detail each proposed change is available at the general office of the Utility located at U. S. Highway 180 West, P. O. Box 518, Roby, Texas 79543.



Now is the time to let us know of any changes in your farm and ranch operations for 1991. If you have leased a new farm or ranch, dropped a lease, rented, purchased, or sold a place, please let us know so we can update our records.

Remember, if a farm is determined to be Highly Erodible, that HEL status stays with the farm, regardless of who is the owner or operator.

HIGHLY ERODIBLE/SODBUSTER CONSERVATION COMPLIANCE

Owners and operators farming highly erodible land are reminded that they must be applying a farm conservation plan in order to remain eligible for ASCS benefits. If you are unsure if you have highly erodible land or if you have any question, contact either the ASCS or Soil Conservation

Farms will be spot-checked for compliance with the conservation plans. Producers who are found not to be following their approved conservation plans will lose benefits on all farms for that year.

FAILED COTTON ACRES (attention farm operators)


Prior to destroying any failed cotton acres you need to come by the ASCS office and file a Failed Acreage Report, form (ASA-574). You will also need to provide us a copy of the FCIC appraisal work sheet.

Note: We need the FCIC appraisal worksheet before we go to the field.

We will make a field visit to each farm with failed acres. After we make our visit we will notify you in writting.

Destroying failed cotton acres prior to ASCS's review will cause you to lose program benefits on that farm.

Eligibility for participating in all programs administered by ASCS is established under law without regard to race, color, religion, sex, handicap, national origin or marital status.



Cow conditions at Calving Time

calving time is the single most important factor in determining how soon that cow will cycle and rebreed after

For this reason, it important that calves be weaned early enough in the fall for the cows to regain body flesh condition and before winter. that are thin at calving have slower and lower reproductive rates.

The cow's body flesh should be such that the cows are not overly fat or excessively thin.

The body condition of cows is scored on a range of 1 to 9. One represents extremely thin cows and 9 repreextremely cows. Each body condition score represents approximately 85 pounds of body weight.

Body fat on COWS also is a reserve energy source that can be depleted to various extents once the cow calves ahead of lush forage.

Cows in normal body condition, 5 or 6, can be maintained on a 7 percent protein ration. Cows that are in condition scores 1 to 4 require 8 percent or 9 percent protein ration. They also need additional energy to gain body weight and raise the body condition to the desired score of 5 or

NOTICE OF INTENTION TO CONDUCT WEATHER MODIFICATION OPERATIONS IN THE STATE OF TEXAS

Date of the first of three weekly publications of this Notice: NOVEMBER 27, 1991

- 1. Notice is hereby given that the Colorado River Municipal Water District has filed an application with the Texas Water Commission for a State permit to conduct weather modification operations to change or attempt to change the natural development of clouds for the purpose, objective, period, and by the method summarized hereinbelow.
- 2. The Colorado River Municipal Water District has a valid Texas weather modification license. The initial license was issued on December 18, 1974, and was renewed in 1976, 1977, 1978, 1979, 1980, 1981, 1982, 1983, 1984, 1985, 1986, 1987, 1988, 1989, 1990, and 1991.
- 3. The purpose of the weather modification operation is to increase rainfall to affect water resources. The period of the permit is March 1 through November 30 during the years 1992, 1993, 1994, and 1995.
- 4. The proposed weather modification operation is to be conducted for and on behalf of the Colorado River Municipal Water District, P.O. Box 869, Big Spring, Texas 79721-0869.
- 5. The proposed weather modification operation is to be carried out in both an "operational area" and a "target area" to cause the intended effects to occur only in the target area. The operational area is that area described as being the area between an outer boundary which is defined by a line that encompasses the block of counties of Lynn, Garza, Kent, Fisher, Nolan, Runnels, Coke, Sterling, Glasscock, Martin and Dawson, and an inner boundary which is that of the target area.
- The area to be affected by the proposed weather modification operation is the target area. The target area is that area described as bounded by a line beginning at a point of origin at Big Spring, Texas, and running along Highway 87 in a northwesterly direction to Lamesa; thence, north-northeast on Highway 87 to the north border of Dawson County; thence, east along the northern boundary lines of Dawson, Borden, and Scurry Counties to Highway 84; thence, southeast along Highway 84 to Roscoe, in Nolan County; thence, south-southeast to Maryneal; thence, east to the Nolan-Taylor County border; thence, south along the eastern Nolan County line to the Runnels County border; thence, east along the northern Runnels County line; thence, south along the eastern Runnels County line; thence, west along the southern Runnels County line; thence. north along the western Runnels County line to a point where the southern Coke County line meets Runnels County; thence, west along the southern Coke County line to a point 13 miles south of Robert Lee in Coke County: thence, north to Robert Lee; thence, west to Highway 87 at a point approximately 13 miles northwest of Sterling City; thence, northwesterly along Highway 87 to the point of origin at Big Spring, Texas.
- 7. The methods and materials to be used in conducting this operation are summarized herein: A licensed meteorologist will select cumuliform clouds for cloud-seeding using a weather radar display, standard meteorological analyses, forecast techniques, observations, and pilot reports to direct an aircraft equipped to dispense the seeding particles, silver iodide crystals, into the updraft air at cloud base.
- 8. Persons interested in knowing more about the technical aspects of the proposed operation should contact the applicant or the Weather & Climate Section of the Commission.
- 9. A public hearing on this application may be called by mailing a petition that requests a hearing to the Executive Director, Texas Water Commission, P.O. Box 13087, Capitol Station, Austin, Texas 78711. The petition must contain (1) the signature, full name, address, and phone number of each person requesting; (2) a statement that each person is at least 18 years of age and resides or owns property in the operational area; and, (3) a description of each person's interest and how that interest would be adversely affected. Requests for hearing must be received by the Commission within 30 days of the date of the first publication of this notice. More information on calling a hearing can be obtained through the Legal Division of the Commission.
