# No one at tax hearing; employees get pay raise

#### **By MARILYN POWERS** Staff Writer

No county residents attended or participated this morning in the second of two public hearings concerning Gray County's proposed tax rate.

A county tax rate of .445623 per \$100 valuation is being considered. The current rate for fiscal 2006 is .488926 per \$100 valuation.

The proposed rate is higher than the effective rate, which is the amount required to generate the same amount of tax revenue as was collected the previous fiscal year, because it will generate more income that the previous year's rate due to

increased property values. Increases in some county property values and in mineral values have resulted in an increase in the total taxable property value taxed by the county.

Current taxable property values subject to county tax total \$1.377,369,900, an increase from last year's \$1,175,561,634.

The proposed county tax rate would garner \$9,348,303 for fiscal year 2007. The 2006 county budget was \$9,127,934, and the proposed 2007 budget totals \$10,078,024, reflecting increased operating costs of various county departments, said County Judge Richard Peet.

The \$729,721 difference between the proposed budget and proposed tax rate collection total could be taken from the county's projected \$2.1 million which will be left over after this fiscal year ends Sept. 30, Peet said.

Commissioners approved a cost of living pay raise of approximately \$100 per month for full-time county employees and elected county officials. Part-time county employees will receive a raise prorated according to their salary.

The pay raise does not affect the court reporter's or county auditor's offices because the district judges set.

those salaries.

Any increase in pay for elected county officials must be voted on at least 10 days prior to any vote on the proposed fiscal year 2007 budget and tax rate.

The next meeting, on Sept. 15, will include voting on the proposed budget, followed by a vote on the proposed tax rate.

# Gray grand jury hands up 17 indictments

A Gray County grand jury handed up 17 indictments Wednesday in 223rd District court, including two first-degree felonies and three second-degree felonies.

Carlos Lemonte Fisher Jr., 38, was indicted for possession of a controlled substance with intent to deliver and aggravated assault against a public servant. Bond on each of the first-degree felonies was set at \$15,000, for total bond of \$30,000.

On Feb. 16, 2004, Fisher allegedly possessed with intent to deliver 400 grams or more of cocaine. Also on that date, Fisher allegedly caused bodily injury to Jason Henderson, a trooper with the Texas Department of Public Safety, by hitting him on the back of the head and choking him, causing Henderson injury by rolling down an embankment, all

while Henderson was attempting to arrest Fisher.

James Clyde Benson Jr., 37, was indicted for assault on a public servant, enhanced. Bond on the seconddegree felony was set at \$10,000.

On Oct. 22, 2003, Benson allegedly caused bodily injury to Jason Henderson, a trooper with the Texas Department of Public Safety, by hitting him while Henderson was attempting to arrest Benson. On May 17, 1988, Benson was convicted in Superior Court of Los Angeles, Calif., of the felony offense of robbery 2nd.

Joshua Luke Mitchell, 28, was indicted for failure to register as a sex offender, enhanced. Bond on the second-degree felony was set at \$8,500.

On Jan. 17, Mitchell allegedly failed to register with Pampa Police Department as a sex offender. On Feb. 3, 2003, Mitchell was convicted in the Court of Common Pleas of \$10,000. Jackson County, Ohio, of failure to register.

Michael Anthony Tidwell, 47, was indicted for aggravated assault. Bond on the second-degree felony was set at \$20,000.

On June 7, Tidwell allegedly broke a person's nose by striking the person with his fists.

Robert Allemand, 33, was indicted for making a false statement to obtain property or credit. Bond on the third-degree felony was set at \$5,000.

On July 21, 2004, Allemand allegedly made a false or misleading written statement to Jana Albracht by signing the name of Melinda Birkeland on a retail installment contract with the intent to obtain a 2004 Dodge Durango for himself.

Kimberly Dawn Crawford, 34, was indicted for fraud. Bond on the third-degree felony was set at

On May 16, Crawford allegedly attempted to obtain an increased quantity of hydrocodone, a controlled substance, by removing it from a secure medication distribution system.

Jane Derie Dedriek, 33, was indicted for tampering with physical evidence. Bond on the third-degree felony was set at \$5,000.

Dedriek was also indicted for theft of \$1,500 or more but less than \$20,000. Bond on the state jail felony was set at \$3,000.

On July 18, Dedriek allegedly unlawfully took three laptop computers from Gene Brock, their owner, and concealed the computers with intent to impair their availability as evidence in an investigation of stolen property.





# Shuttle scrubbed, Saturday only day left

CAPE CANAVERAL, Fla. (AP) --NASA scrubbed today's launch of the space shuttle Atlantis again, this time because of a problem that has bedeviled the space agency before: a faulty fuel tank sensor.

The launch was rescheduled for 11:15 a.m. EDT on Saturday, when NASA will try a fifth time to get Atlantis off the ground and send it to the international space station to resume construction on the orbiting outpost, which has been on hold since the Columbia tragedy 3 1/2 years ago.

Saturday is the last time NASA has to launch Atlantis before it has to go to the back of the line, behind a Russian Soyuz capsule that is slated for liftoff Sept. 18 on a flight to the space station. Both Atlantis and the Soyuz cannot be at the space station at the same time.

If Atlantis cannot lift off on Saturday, it will have to wait at least until late September - and even then, only if NASA waives a post-Sept. 11 rule that says launches must be con-

ducted in daylight so that the spaceship can be photographed for signs of damage

Previous launch attempts over the past 12 days were dashed by a lightning bolt that struck the launch pad, Tropical Storm Ernesto and a fuel cell coolant pump that gave an erratic reading.

This time, a sensor in the hydrogen fuel tank gave an abnormal reading during a test as the shuttle was being fueled early today.

Atlantis had been fueled with more than 500,000 gallons of supercold liquid hydrogen and oxygen, the six astronauts had donned their orange flightsuits and strapped themselves in, and the hatch to the shuttle had been closed, when NASA decided to postpone the launch with just 45 minutes to go until liftoff.

'We had a lot of discussion. ... We follow the rules," said launch director Mike Leinbach. "Ought to feel good that we did that."

Atlantis commander Brent Jett responded, "We understand. We concur 100 percent."

The fuel gauges are designed to prevent the main engines from running too long or not long enough during the climb to space. An engine shutdown at the wrong time could prove catastrophic, forcing the astronauts to attempt a risky emergency landing overseas, or leading to a ruptured engine.

Earlier this year, the launch of Discovery was delayed by almost two months so four hydrogen fuel tank sensors could be replaced after one was found to be faulty. A similar problem briefly delayed last summer's launch of Discovery on the first shuttle flight since the Columbia disaster in 2003.

Despite four delays, Atlantis is far from the record for NASA's most snakebit shuttle. In 1986 and 1995, NASA scrubbed the launch of Columbia six times after fueling the shuttle.

The Bush administration, stepping up the pressure on Tehran, moved today to sever a big Iranian stateowned bank from the U.S. financial system.

Stuart Levey, the Treasury Department's under secretary for terrorism and financial intelligence, said the government's action is against Bank Saderat, which the United States contends is used by Iran to transfer money to terrorist groups, including Hezbollah.

While Iranian financial institutions are barred from directly accessing the U.S. financial system, they are permitted to do so indirectly through a bank in another country. The United States is closing down that avenue for Bank Saderat, a U.S. Treasury official explained. The action, which involved a

change in regulations, doesn't apply to other Iranian banks, the official said.

"Today we have cut off one of the largest Iranian state-owned banks, Bank Saderat, from the U.S. financial system," Levey said.


It marked the administration's latest effort to turn up the heat on Iran.

The United States wants the U.N. to impose sanctions against Iran unless the country stops enriching uranium, a key step in making nuclear weapons.

Friday's action also is the latest step to financially clamp down on Hezbollah, which the United States says is bankrolled in large part by Iran.

The U.S. calls Lebanonbased Hezbollah a terrorist group that is suspected of involvement in terrorist attacks worldwide.







Most people know they should increase their activity level by walking or aerobics classes. In fact, many of you probably made a New Year's resolution this year to start on Jan. 1.

Changing any habit requires several tries and a great deal of effort for most people. Increasing your activity level can have a great impact on your health both now and later in life.

Everyone knows regular exercise greatly improves health. Getting started is not easy. To help people get started and establish a habit of regular exercise, "Walk Across Texas" (WAT) was created in 1996 by Texas Cooperative Extension.

Walk Across Texas uses friendly competition and group support to help people not only start exercising regularly, but also to continue exercising long after Walk

Across Texas is over. Walk Across Texas is a free program. All participants need is a pair of comfortable walking shoes.

Regular walking has a great impact on health problems like diabetes, high blood pressure, cholesterol, gall bladder disease, falls and fractures, osteoporosis, depression, stress, obesity and even the risk of hospitalizations.

Regular walking at a moderate intensity level boosts immunity, too. A recent national study showed walking 30 minutes 4-5 times weekly and loss of 7 percent of body weight significantly lowered one's risk for developing diabetes.

Walk Across Texas is a free, fun, group physical activity program. All you need is a group of eight friends, family members, or co-workers who want to keep track of the amount they walk for eight weeks. You can encourage one another to keep going

park hung over, eat 12 hot dogs and wash them down with six bottles of pop, then waddle out to the plate, his big belly emphasized by his spindly legs, and hit home runs. He had phenomenal eyesight, unusual depth perception, extremely good hand-eye coordination and lightning reflexes. Every one of those was a natural gift. You either have them or you don't.

The real solution to the drug problem starts with childhood. Americans have to get over this obsession that winning is everything. Children should be taught that there are things more important than winning, such as good behavior, honesty and the satisfaction of playing the game. Parents should teach children to be gracious in both victory and defeat. It is the obsession with winning that often drives young athletes to steroids

and other drugs, and nine times out of 10 that obsession comes from demanding parents.

Winning is everything in a gunfight, but sports are just games to be played for enjoyment. It doesn't really matter who wins as long as both sides have a good time. The old Buddhist saying - do your best, but don't worry about the outcome - applies to sports as well as to life in general.

When I covered high-school sports, I had an extremely low opinion of most coaches. They acted like drill instructors and were obsessed with winning. I wouldn't put up with their abusive barking for one second. One man, however, at a small Catholic high school made sure that every boy who wanted to play football made the team. He made sure everybody got a chance to play. The school had a poor record of wins, but he got my vote as outstanding coach of the year. He alone had the right priorities.


That would prove to be Pampa's last score of the game.

#### Cowboys won't release drawings

ARLINGTON, Texas Dallas (AP) — The Cowboys, citing security and business concerns, have not released drawings of their publicly funded stadium under construction.

Black tarp covers the chain-link fence surrounding the site, preventing members of the public from looking at the 50-foot deep stadium bowl.

The plans should remain confidential under the Texas Homeland Security Act, Cowboys attorneys argue, because releasing them would disclose the stadium's vulnerability to terrorist attacks. Citing Public the Information Act, the Fort Worth Star-Telegram requested the plans from the city of Arlington. After the Cowboys declined to release them, the city sent the request to Attorney General Greg Abbott.

"At this time, we believe it's premature to release the documents because of proprietary business practice information as well as issues with security," Cowboys spokesman Brett Daniels said.

The stadium is expected to cost \$650 million.

# Swoopes misses exhibition after suffering back spasms

# **Baylor's new offense gets test**

#### WACO, Texas (AP) -Baylor coach Guy Morriss didn't have a problem with his new offensive coordinator's play-calling in the first game with a pass-oriented system. The penalties and turnovers were what hurt.

"I'm kind of surprised and upset with the breakdowns that we had," Morriss said. "The times that we have 11 guys executing and there are not penalties, we move the football. That's the way it's supposed to work."

The Bears (0-1) get another chance in their new offense Saturday night when they play Division I-AA Northwestern State (0-1).

In its season-opening 17-7 loss to No. 23 TCU, Baylor had turnovers inside the 20 on consecutive drives in the third quarter. Another scoring chance got erased by back-to-back false start penalties on third down right before a missed 47-yard field goal attempt.

Offensive coordinator Lee Hays admittedly was somewhat conservative, not wanting to chance creating a turnover "just for the sake of pushing the ball down the field." Besides, it was the first game in the new scheme and the Bears defense was playing well.

"We moved the ball well. It is just a matter of getting the ball in the end zone," said quarterback Shawn Bell, who completed 31 of 47 passes for 286 yards. "Coach Hayes has told us so many times that this is an offense that sometimes lays low, and then all of sudden hangs 70 (points) on a team. We knew that coming it. We know it is just a matter of execution.'

Maybe this is the week for a breakout performance.

Northwestern State is coming off a 49-18 loss at Kansas during which the youthful Demons had their share of mistakes, primarily on special teams. Of the 53 players who got in the game for the Louisiana-based Demons, 27 made their debuts. There are only seven seniors.

The Jayhawks led 28-6 by halftime after an 89-yard kickoff return set up a touchdown, a 70-yard punt return for a score and a blocked punt that set up another. Kansas had a 15yard TD pass on the first play after the Demons fumbled a snap.

"We basically served up 28 points on a platter to them," coach Scott Stoker said. "You'd never tell it by the scoreboard, but we were pretty good defensively for all but the last 8-10 minutes, when we got some fresh faces in there for their first taste of college football."

Northwestern State won an overtime game at TCU in 2001.



"This is all about trust of a highly publicized, competitively successful gym," said Frank Branson, the girl's attorney. "WOGA knew or should have known this pedophile was there."

The lawsuit does not seek a specific amount of money from the academy owners, Valeri Liukin and Yevgeny Marchenko, and doesn't accuse them of abuse.

Branson said the girl, who is not being identified because she is an alleged sex assault victim, has been left with severe emotional and psychological scars.

Wagoner, who coached at the academy before the 2004 Olympics, and his attorney declined to comment on the case.

A lawyer for the academy declined to discuss details of the case.

"The management of the gym was shocked and saddened to hear of the allegations of injury to this former student," lawyer Bill Boyd said. "We are committed to get to the bottom of these charges and develop all the facts."

According to the criminal case, Wagoner sexually assaulted the girl numerous times at his apartment and at the academy's two gyms.


