# City provides some funds for welcome signs

**By DAVID BOWSER** Staff Writer

Everybody agreed it is a good thing, but nobody wants to pay for it.

When Chuck White first appeared before the Pampa City Commission in January with a proposal that the Pampa Rotary Club would put attractive signs on the five approaches to the city welcoming people to Pampa, he estimated the cost to be \$125,000 to \$150,000.

He wanted to use the \$6,000 that the city got from an insurance company when a trucker plowed up the

Park where U.S. Highway 60 enters the city on the west side of town and \$5,000 that was left over from the Rotary Club's Super Playground project.

He asked that the city chip in \$25,000 and said the Rotary Club would figure out how to raise the money for the rest.

White said he thought the Rotary Club could erect five signs at entrances to Pampa without the endbureaucratic red tape that the city has gone through for the past decade. It

Returning to the Pampa City Commission Tuesday afternoon, White had good news and bad news.

The good news was that the estimated price of the project had come down from \$150,000 to \$53,000.







### Georgia fire flares up

WAYCROSS, Ga. (AP) posed a threat to homes. - Dozens of residents evacuated their homes for several hours early today after a wildfire jumped a road and spread toward two small communities.

"It looked like it was snowing with all the ash falling. You could feel the heat," said Darryl Cribbs, 44, who packed up his family in Braganza after sheriff's deputies came to their door around 1 a.m. "They said as soon as we left they were going to bring in tanker trucks and try to save the house."

The wildfire spread rapidly Tuesday night and early Wednesday near the Okefenokee Swamp Park, fueled by dense and dry trees and brush.

"They're not out of the woods yet," said Eric Mosley, a spokesman for the

Georgia Forestry Commission. "There's still a possibility there could be some danger."

Over the past nine days, wildfires have burned about 67 square miles of forest parched by drought in southeast Georgia and destroyed 18 homes.

More than 1,000 Ware County residents have been forced to evacuate, and 5,000 others have been urged to leave because of health risks associated with the smoke.

A top concern this morning was a blaze that crossed state Route 177 and was threatening Braganza and Astoria, Smith said. Waycross, a city of about 15,300 resident three miles to the north, was not in immediate danger, though thick smoke blanketed the city, she said.

# **Border twister fatal to 7**

EAGLE PASS, Texas (AP) - Rescue and recoverv efforts resumed early today after a tornado tore through the edge of this Mexican border city, killing at least seven people, injuring more than 70, destroying more than 20 homes and leaving several mobile homes missing, officials said.

Five of those killed were inside a mobile home when the twister slammed it into a school in a rural area Tuesday night, Eagle Pass City Councilman Ramsey English Cantu said. They were a girl between the ages of 4 and 6, her parents, and two other adult relatives, he said

Debris from the shattered mobile home was indistinguishable from the wreckage of Rosita Valley Elementary School early today. Bricks from caved in walls were scattered around the campus, broken water pipes were spewing water and the metal roof was twisted violently.

"It's the worst I've seen," said resident Ricardo Tijerina, who rode out the storm in a house near the school with his six children. Tijerina, 38, said he watched as the storm destroyed a mobile home across the street.

"It was pretty scary; I saw the trailer when it blew apart," said Tijerina, who said all the mobile home residents survived.

One of those killed in the storm died in a house, but few details were available on the circumstances, Cantu

was taken to a San Antonio hospital died today, according to Maverick County Judge Jose Aranda. Officials across the border reported three deaths in Mexico.

About 150 rescue workers were searching the Eagle Pass area for survivors today, including members of the National Guard and Border Patrol. Rescuers went door to door, and some were using search dogs.

# How gun-control laws kill innocent victims

Thirty-two fine young men and women are dead and that is a huge tragedy. It is also, however, a tragedy that the death toll could have been substantially lower if it were not for an absurd law that kept the students and faculty from exercising their Constitutional right to protect themselves and others by bearing arms on campus.

Thanks to that law a madman was able to confront the men and women at Virginia Tech secure in the knowledge that he was armed while his victims were unarmed and defenseless.

One of those victims used the only weapon he had to protect his students. Liviu Librescu, a man who survived both the Nazi Holocaust and Communist tyranny in his native Romania, used his body as a defensive weapon against the madman's assault, putting his shoulder to the door to keep the killer from getting into the classroom while his students fled though the windows.

Tragically, that frail body was no match for the rapidfiring Glock 19 in the hands of a crazed Cho Seung-Hui. He paid with his life for being the body-in-between, as the Secret Service puts their role in protecting the president.


"My father blocked the doorway with his body and asked the students to flee," Joe Librescu told the Associated Press in a telephone interview from his home outside of Tel Aviv. "Students started opening windows and jumping out."

defeat the proposal - none other than Virginia Tech spokesman and Vice President Larry Hincker, who told the Times: "I'm sure the university community is appreciative of the General Assembly's actions because this will help par-

ents, students, faculty and visitors feel safe on our campus."

In the aftermath of the killings on his campus, I wonder if Mr. Hincker still believes his students and faculty who were so cruelly slain - most had multiple wounds - remain safe on campus thanks to the legislature's ill-advised action that denied them the right of selfprotection.

In Virginia, any adult who has a lawfully issued permit to carry concealed weapons anywhere in the state remains prohibited from protecting himself while on a state campus thanks to the defeat of the proposed law that would have allowed them the same rights they had off-campus while oncampus.

The very fact that the state considers a person capable of carrying a concealed handgun by their very act of granting a permit should demonstrate that the state believes that the permit holder can be trusted to use that handgun only for selfprotection.

It is patently absurd to judge sane, normal people as being incompetent and untrustworthy to bear arms while blithely ignoring the obvious truth of the old saying that when good people are legally disarmed, only bad people will have guns.

Had just one student or faculty member on the Virginia Tech campus under assault by the killer been armed, the death toll would



Every child born in this world comes into it with a blank slate. Every child has to be taught what is right and what is wrong. That includes not only matters of race, but also behavior and matters like

patriotism.

The transmission of good values from one generation to the next is one of the most important factors in human civilization. Unfortunately, it seems to be broken down in

our society. Part of that cause is the fact that parents must not only compete with their children's peers, but also with a morally corrupt entertainment industry that reaches children through television, movies, the Internet and advertising. Not to be excluded is a public-education bureaucracy that teaches some of the worst ideas to come down the pike.

Another part of our problem is that both black and white journalists and politicians are often afraid to condemn bad behavior if is committed by a minority. Years ago, I interviewed an idealistic young man from

Armies of politicians, professional commentators, policy analysts and concerned citizens give the president candid advice every day. The more prominent and widely heard this advice, the better the advisers like it. Apart from matters of national security, the only reason to keep candid advice secret is if the advice is wrongheaded or contrary to the public interest and therefore likely to embarrass the adviser and the president.

The next skirmish between Congress and the executive branch occurs Tuesday, when U.S. Attorney General

Alberto Gonzales will testify before the Senate Judiciary Committee. There he will be asked to explain his contradictory and false statements regarding the fired prosecutors.

In a written opening statement released in advance, Gonzales says, "I know that I did not would not ask for the resignation of any U.S. attorney for an improper reason" and that he had no basis to believe anyone else did. Unfortunately, the wording betrays his doubt. Were the attorney general more certain, he would likely have written, "I did nothing improper, and neither did anyone else."

To make his case, Gonzales has only to tell Congress and the American peo-

"He swings at the first pitch a lot, but for some reason he's been taking and I just laid one in there and he hit a ball through the 6hole (at shortstop)," Maholm said.

## **Griffey passes Reggie on HR list**

Ken Griffey Jr. moved up on the career home runs list with another of his familiar sweet swings, swatting Reggie Jackson out of the top 10.

"To pass him, sometimes it's mindboggling because I didn't think when I started playing this game 19 years ago that I'd be anywhere close to where I am now," Griffey said.

Griffey moved into sole possession of 10th place with his first homer of the season, and 564th of his career, helping the Reds to a 10-3 victory over the St. Louis Cardinals on Tuesday night. Jackson made a congratulatory telephone call last fall when Griffey tied him, and Griffey expected another call soon.

Big Unit was outpitched in his season debut by fellow 43-year-old counterpart David Wells in San Diego's 10-5 victory. It was the oldest matchup of left-handers in major league history.

"I thought everything went pretty well," said Johnson, who struck out seven. "It's not the way I would have written things up.
