## High speed chase ends in arrest of Pampa man

A vehicle chase that led first south, then north across Pampa Thursday morning ended in an arrest after a Pampa man reportedly fled in his car from officers who were attempting to make a traffic stop.

Pampa Police Department Officer Neal Gardner attempted to stop Brian Lane Sealman, 24, in the 1100 block of North Sumner at 10:29 a.m. for running a stop sign. Gardner noticed Sealman driving erratically, according to Assistant Chief Dennis Burton.

Sealman did not stop but instead accelerated and headed south through residential streets between Kentucky Avenue and Rham Street, reaching speeds of up to 60 mph and at one point nearly sliding into a utility pole as he turned a corner, according to police reports.

Officers pursuing Sealman reported that he began throwing items out of

the car in the 700 block of North Wells. Sealman turned east on Rham Street and then headed north once he reached Hobart Street, according to the police report.

Sealman drove north on Hobart Street at speeds reported to have been up to 75 mph before being boxed in and stopped by law enforcement officers at 10:33 a.m. at the intersection of Randy Matson and Hobart streets.

Sealman, the only occupant of the vehicle he was driving, was arrested and booked into Gray County Jail on a charge of evading arrest or detention with a vehicle, a felony offense. He had not been arraigned as of late Thursday afternoon.

Officers returned to the location where Sealman had reportedly tossed items out the vehicle's window during the pursuit. Some marijuana and pills were recovered, according to Burton.

## Pampa police using latest laser technology on speeders

Pampa Police officers are making the city's streets a safer place thanks to new technology.

Due to complaints from residents about speeding and unsafe drivers, the department decided to upgrade their traffic control equipment to the latest laser technology.

Police Chief Trevlyn Pitner said the department has purchased two "Lidar" laser technology devices and soon will purchase an additional two.

"These new tools are used for traffic enforcement and to measure distances in the case of vehicle accidents and crime scenes," Pitner said. "This equipment is very accurate because the officer looks through a scope and a laser beam shoots out and hits a vehicle or object with a red dot, so there isn't any question which car is being clocked."

The speed the vehicle is traveling and the distance from the officer show up on the display. Pitner said this is very helpful when officers are patrolling school zones.

"The officer will stand at a point past the school zone and shoot the beam to the sign telling people the speed limit has changed to a slower speed so he or she know exactly where the school zone starts," Pitner said. "Then when the car is hit with the beam and the information displayed, the officer knows,

without a doubt, if the car was inside the school zone or not in it yet."

The main use for this new equipment is in high traffic areas where there are multiple lanes and a high number of cars, and of course school zones. Pitner said this is not being used to catch more people or give more tickets, but instead to make the streets of Pampa safer for everyone.

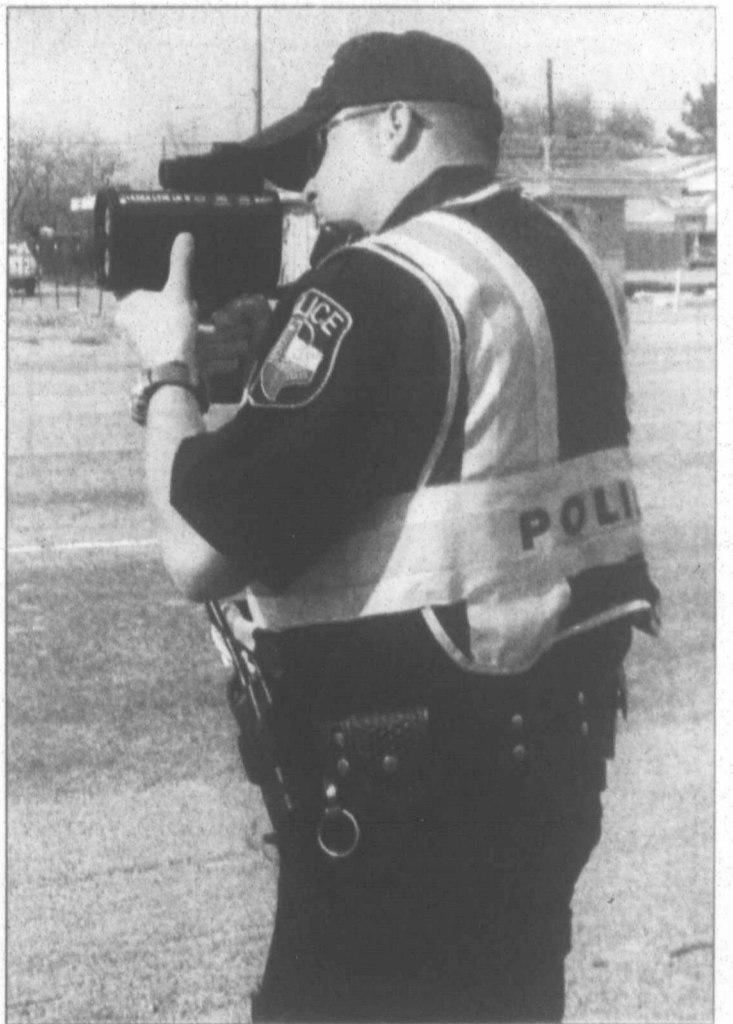
This new technology makes it possible to check the speed of the car in the back of the pack instead of the front vehicle.

In the case of crime scenes or vehicle accidents, the officers use this to measure distances. Pitner said this is much more accurate than using a tape measure.

"The officer can stand at the vehicle that was involved in a wreck and shoot the beam to several landmarks or buildings to see exactly how far the car is from those points," Pitner said. "In the past, they've had to use those rolling tape measures and they are not exact. This equipment can measure distances as short as two or three inches, so it is very versatile."

Pitner said radar detectors cannot detect this type of speed control device so residents should not bother running out and buying one.

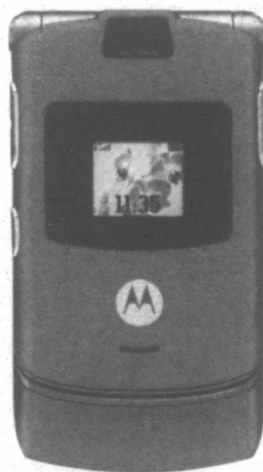

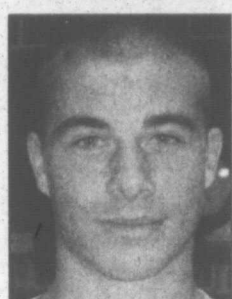

## Pet food maker, ingredient supplier searched in fed probe

WASHINGTON (AP) — Federal agents searched facilities of a pet food manufacturer and one of its suppliers as part of an investigation into the widening recall of products made with ingredients contaminated by an industrial chemical, the firms disclosed today.

Food and Drug Administration officials searched an Emporia, Kan., pet food plant operated by Menu Foods and the Las Vegas offices of ChemNutra Inc., the supplier of one of two ingredients sus-

pected in the contamination of millions of cans of recalled dog and cat food, according to the companies.

Menu Foods also said the U.S. Attorney's offices in Kansas and the western district of Missouri have targeted the company as part of misdemeanor investigations into whether it violated the federal Food, Drug & Cosmetic Act. The sale of adulterated or contaminated food is a misdemeanor. A Justice Department spokeswoman had no immediate comment.

"Menu Foods has been doing everything it can to cooperate with the FDA," company chief executive officer Paul Henderson said in a statement. "Even before commencement of this investigation we have given the FDA full access to our plant and our records, have answered questions and provided documents to them any time they have asked."

FDA spokeswoman Julie Zawisza would not confirm or deny that a search warrant was executed. "We have a strict policy of not dis-

cussing activities of our Office of Criminal Investigations," she said.

ChemNutra said it had been informed the company could be held accountable because it imported the melamine-adulterated wheat gluten used in the tainted pet food even though the company had no knowledge that its Chinese supplier had introduced melamine into the product.

"We have cooperated and complied fully with FDA investigators both prior to and since being served with today's search warrant, and

will continue to do so," Steve Miller, chief executive officer of ChemNutra, said in a statement. "We keep very good records, which has made it relatively easy for the investigators to retrieve what they needed."

ChemNutra spokesman Steve Stern said FDA agents arrived at the company's offices in the late afternoon and stayed until late in the evening. They copied computer hard drives, Stern said, adding, "we complied completely with the FDA."

## Storms, high wind destroy homes in Midwest

LAPORTE, Ind. (AP) — Storms packing winds strong enough to toss a police cruiser over a fence spawned apparent tornadoes that leveled houses and downed power lines in several states.

The storms buffeted parts of Indiana, Tennessee, Illinois and Ohio on Thursday. Tornadoes apparently touched down in Tennessee and

Illinois, officials in those states said.

Debris injured at least seven people in the northeastern Tennessee town of New Tazewell. At least six homes were destroyed, and as many as 400 homes — about one in every five homes in Claiborne County — lost power, officials said.

Jason Ellis said his family fled their mobile home when the wind started

rocking it back and forth.

"It felt like the top of the house was fixing to come off. I just didn't want to chance it," he said.

By this morning, electricity was restored to all but about two dozen homes, and roads had already been cleared of fallen limbs, said David Breeding, the county's deputy emergency management director.

## FDA rejects Vioxx successor Arcoxia

TRENTON, N.J. (AP) — The Food and Drug Administration rejected Merck & Co.'s request to market a successor to its withdrawn arthritis drug Vioxx in the United States, the drugmaker said today.

The move was widely expected, after a panel of FDA advisers two weeks ago voted 20-1 against approving the drug, Arcoxia.

Arcoxia is the class of anti-inflammatory drugs called Cox-2 inhibitors, which are touted as less likely to cause stomach bleeding and other dangers but have been linked to cardiac risks. That's the same class of drugs as Vioxx, which has become a poster child for drug safety problems.

Merck pulled Vioxx from the market in September 2004 after research showed it doubled risk of heart attacks and strokes. That triggered an avalanche of lawsuits — more than 27,000 so far — and a nosedive for Merck's stock price, which has since bounced back.

Despite the safety concerns in the United States, Arcoxia is on sale in 63 other countries, and Merck officials said as recently as Tuesday that they intended to keep working to get it on the U.S. market.

Merck spokesman Ron Rogers said the company would not discuss whether it now will drop efforts to get Arcoxia approved here, saying the company's strategy is pro-

prietary information.

Analyst Steve Brozak of WBB Securities said he believed Merck officials were "just going through the motions" with the FDA approval on Arcoxia.

"This is it. Put a fork in it and it's done," he said.

Merck said in a statement that FDA had sent it what is called a "non-approvable letter" that stated the company "would need to provide additional data in support of the benefit-to-risk profile for the proposed doses of Arcoxia in order to gain approval."

Arcoxia had been poised for approval until Vioxx was pulled from the market. Two months later, the FDA issued an "approvable" letter, saying it could approve Arcoxia, but only if Merck provided further safety and efficacy information for the drug.

Merck has since produced results from further studies of Arcoxia, but doctors questioned those results because Merck compared Arcoxia in its tests to another, older anti-inflammatory drug, diclofenac — widely used elsewhere, but not in this country — that has elevated risk of heart attacks and strokes. Merck said the two drugs have similar cardiovascular risk. However, Arcoxia causes high blood pressure in more patients than diclofenac.

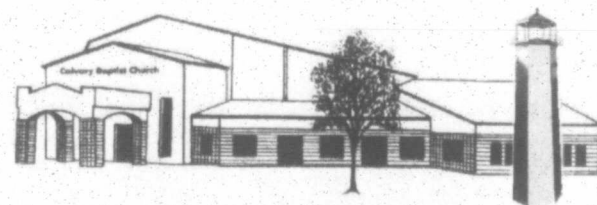

## None dare call Dems posturing sabotage

Under the guise of responding to the will of those voters who gave them control of the House of Representatives, Democrats are busy trying to undermine the war effort and bash the president to improve their chances of winning the 2008 elections.

One of them, Rep. Dennis Kucinich — the perennial presidential candidate from Ohio — is wandering into cloud cuckoo-land by introducing articles of impeachment against Vice President Dick Cheney and calling for the impeachment of President Bush ... a couple of dandy ideas when the nation is involved in a war.

He was allegedly looking into the death of Pat Tillman and the capture and rescue of Private Jessica Lynch. Shamefully, he is using these two Americans to advance his agenda of retreat and defeat.

Just what was he hoping to find? That Pat Tillman was killed by friendly fire? We've known that for a long

time. That the military may have made a mistake — that somebody might have not told the truth? We already knew that, too.

## Pols have created too many military missions

I've never been a supporter of the all-volunteer Army, primarily because it relieves the populace as a whole of any responsibility for the common defense.

Another reason to oppose it is that it enables politicians to involve more easily the nation in unnecessary wars. With less than 1 percent of the population involved in the wars in Iraq and Afghanistan, politicians felt no need to have a real debate about the wars before they were started. Even now, Democrats routinely refer to using military power for this or that reason.

War, as Ernest

Hemingway said, is itself a crime against humanity. It should never be employed except in extreme circumstances that threaten national survival.

And when it is employed, the whole country should participate in one way or another.

The Marine Corps, which has always been made up of volunteers, is our equivalent of the French Foreign Legion. It should remain voluntary. The rest of the services, however, should

ideally rely on universal military training or, as a second-best, a military draft without exemptions.

Proponents of the all-volunteer force make the claim that new weapons systems are so sophisticated that special people are required. Of course, the Defense Department has itself put the lie to that claim. Now that its recruitment and retention are under pressure, it has lowered standards and is luring in high-school dropouts and

even kids with criminal records.

The truth is that firing a rifle, a tank gun or an artillery piece is the same, no matter how complex the weapon is. The fact that the modern tank has computer-controlled guns doesn't mean the gunner needs to know anything about computers. In fact, the Army has a genius for training its soldiers to do what they have to do with a minimum of knowledge.

I will never forget a lecture I heard when I was in armor school on setting the

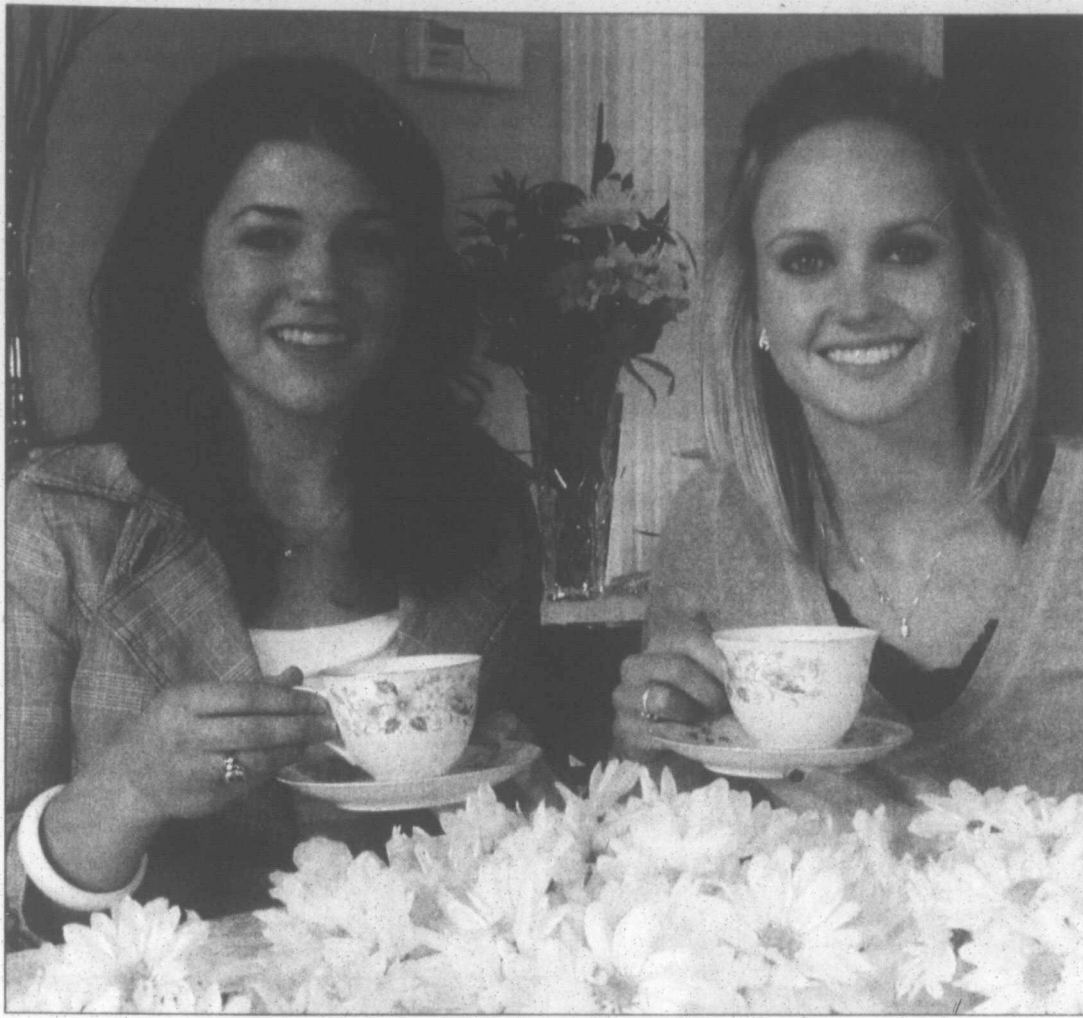

grave to do it.

headspace of the .30- and .50-caliber machine guns. Headspace is the distance between the bolt, when it is closed, and the barrel. The Army's headspace gauge was a small metal tool, obviously larger at one end than at the other and stamped "Go" and "No Go." The lecture consisted of one sentence, "You screw in the barrel until the go goes and the no-go don't go." I'm sure that same basic strategy is employed at least in the combat arms.

Another problem with the all-volunteer force is that it's too expensive. It's recently been reported that the cost of bonuses to lure enlistees and to retain soldiers has approached \$1 billion. Military pay must also necessarily be higher. A consequence of this has been the development of a "security industry" where civilians do the jobs once done by military people. They have to do this because they have so relatively few military people.

It's fashionable to say in Washington these days that our "Army is broken," but "inadequate" would be a more accurate word. The politicians have created too many missions while being unwilling to fund the necessary forces. Like corporate cheapskates, the politicians, instead of reducing the number of missions, are demanding more work from their soldiers and sailors.

The products of war are always the same — death, injury, debt, taxes and destruction. Any American who is unwilling to send his own sons and daughters to war should have the decency not to ask that others do so.

If we had had a draft or universal military training, President George W. Bush never would have been re-elected. As it is, for most Americans, the war is something they see on television for a minute or two and otherwise ignore. It must be jarring to the soldiers to come home and discover that everybody else has been living their normal, comfortable lives while they were enduring the hell of combat.

Judging of consumer items and oral reasons will take place prior to the viewing of class placings which will begin at 2:15 p.m. The participants and winners will be recognized at an awards program beginning at 2:45 p.m.

Prior to the contest, youth studied a select group of items in their Consumer Life Skills

project at the county level. Junior youth, ages 8-10, studied athletic shoes, insect repellent, sun screen, printing digital photos and pedometers.

Intermediates, ages 11-13, and seniors, ages 14 to 19, studied the same items in addition to emergency radios and gift cards. Intermediate and senior contestants are required to give oral reasons whereas juniors are given the option of presenting reasons to judges.

Youth may participate as individuals or teams of three to four members. The top three senior teams will advance to state competition at Texas A&M University in June.

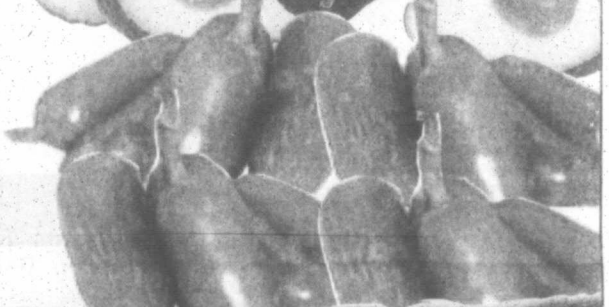

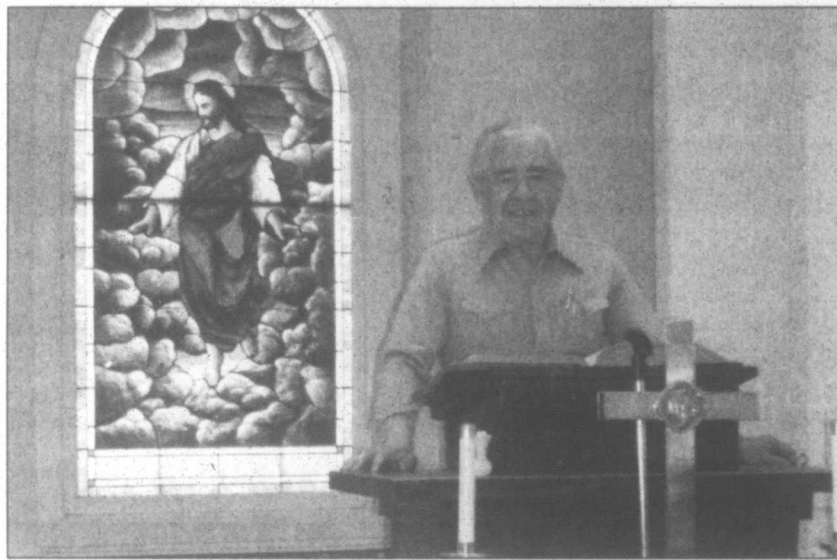

## Minister's Musing: How big is *your* God?

Are you familiar with Ephesians 3:20-21? "Now to him who is able to do immeasurably more than all we ask or imagine, according to his power that is at work within us, to him be glory in the church and in Christ Jesus throughout all generations, for ever and ever! Amen."

Do you believe that verse? Have you ever had that verse put to the test? Gina did. And God came through in flying colors, just like He always does.

In a previous article, I told you about when I first met Gina. Basically she lived a life which was full of every kind of violent, illegal sin imaginable. That lifestyle landed her in prison and at an earlier age cost her a son.

One day, after she had begun to really grow in the Lord, I asked her a question that stopped her in her tracks.

"Gina, what is the greatest thing that you could ever hope that God would do for you?"

She froze and didn't say a word. Usually when people do that they are thinking through a list of things. But I could tell that she wasn't thinking of a list; she knew exactly what she hoped for. She was silent and motionless because she just couldn't get the words out. Then the tears came.

She told me, "Mike, years ago I had to give up my son because of how I was living. I haven't seen him since. I know it is probably too much to hope for, but I pray to God regularly and ask Him if I could just see him once before I die. I don't ever expect to be with him, but if I could just see him once, I'd be the happiest mom in the world."

By then I was crying, too. Several of us who were her friends began to make that a regular matter of prayer.

**Life** began to drastically improve for Gina. God blessed her so much at her job that she was promoted to manager and then offered a management position in the Panhandle area and then offered a bigger management position over several stores in Arizona. The day she moved we all cried. The Lord blessed her in Arizona, too. Before long, she had met a man and got married. I was so happy for her.

Then one day I got a call. Gina was crying on the other end. She had written several

letters over the years to a neutral person who (she hoped) sent them on to her son.

"Mike, my son just turned 18, and he wrote me, and wants to meet me. I never dreamed that this could ever happen."

## A dedicated life brings abundant life

"I beseech you, therefore, brethren, by the mercies of God, that ye present your bodies a living sacrifice, holy, acceptable unto God, which is your reasonable service." (Romans 12:1)

"Salvation available in Jesus Christ" is universally recognized as the theme of Paul's epistle to the church at Rome. In this letter, he discusses all aspects of salvation — God's grace which initiated it; its availability to all; faith in Jesus Christ as the sole condition for receiving it; and God's forgiveness which brings us into righteousness.

To Paul, the basic doctrines of our faith and their practical consequences in daily living cannot be separated.

"The mercies of God" is the theme of Paul's first 11 chapters. It is "mercies" Paul emphasizes, rather than the power or authority of God, as the motivating force in dedication. God's mercy, not man's merit, made salvation possible.

Even as God's mercy is the foundation of our faith, so it is His mercy which is the dynamic of our consecration to Him. Because we

have received His mercy, we must live out the purpose for which we have been saved.

We did not work for our salvation, but we work because of it, and from it.

"The mercies of God" bring us to God and move us to dedicate ourselves to Him.

The character of dedication:

—Dedication is voluntary. The word "present" carries the meaning of "give" or "yield," which is an act of one's own free choice.

—Dedication is complete, involving the whole man. Paul uses the term "bodies" to refer to the total personality — spirit, mind and physical body.

—Dedication is sacrificial. Paul compares the dedication of the Christian with the Old Testament sacrifices of consecration. Where the Jew offered dead animals, the Christian brings an active living personality to place on the altar of God's will.

Herein is the sacrifice or

offering — the giving of our lives to God's service rather than to self-centered materialistic purposes. God does not require we give up things for Him. He desires we give

our total personalities to Him, if we are to realize the full joy of our salvation.

Dedication is pure. The sins, along with the blind-spots of prejudice, hate and envy, must be confessed and put out of our lives. To be acceptable to God, we must come to the altar of dedication with clean lives. The Christian lives his life "unto God" and not to please men. What pleases God is the principle desire of the dedicated believer.

—Dedication is practical. Always the fruit or outcome of dedication is work. Our relationship to God determines our attitude toward Him, and our attitude toward Him determines our action. A husband may expound loudly of his love for his wife and family, but unless that love proves itself by

working for their support and comfort, then there is reason to doubt his proclaimed love. A dedicated life results in a life of service to God.

—Dedication is rational. Dedication of the loving total personality is contrasted with the unintelligent offering of the animal in the Jewish sacrifices. The word "reasonable" may be translated "logical," referring to an act of the mind. The logical result of what God has so graciously done for us is the dedication of our total personalities to Him. It is logical that the attitude of one who receives such mercy would be one of service toward the giver of that mercy.

Salvation (what God freely gives us); justification (what God's grace makes us); consecration (what we do with our lives in thanksgiving for the mercy that made us free): This, says the Apostle Paul, is the plan of God. Only as we do our part can Christ's character and conduct be reproduced in us to bring to realization the abundant life.

At the end of the season, I still got invited to the team pizza party, and was still awarded for my efforts with a shiny trophy.

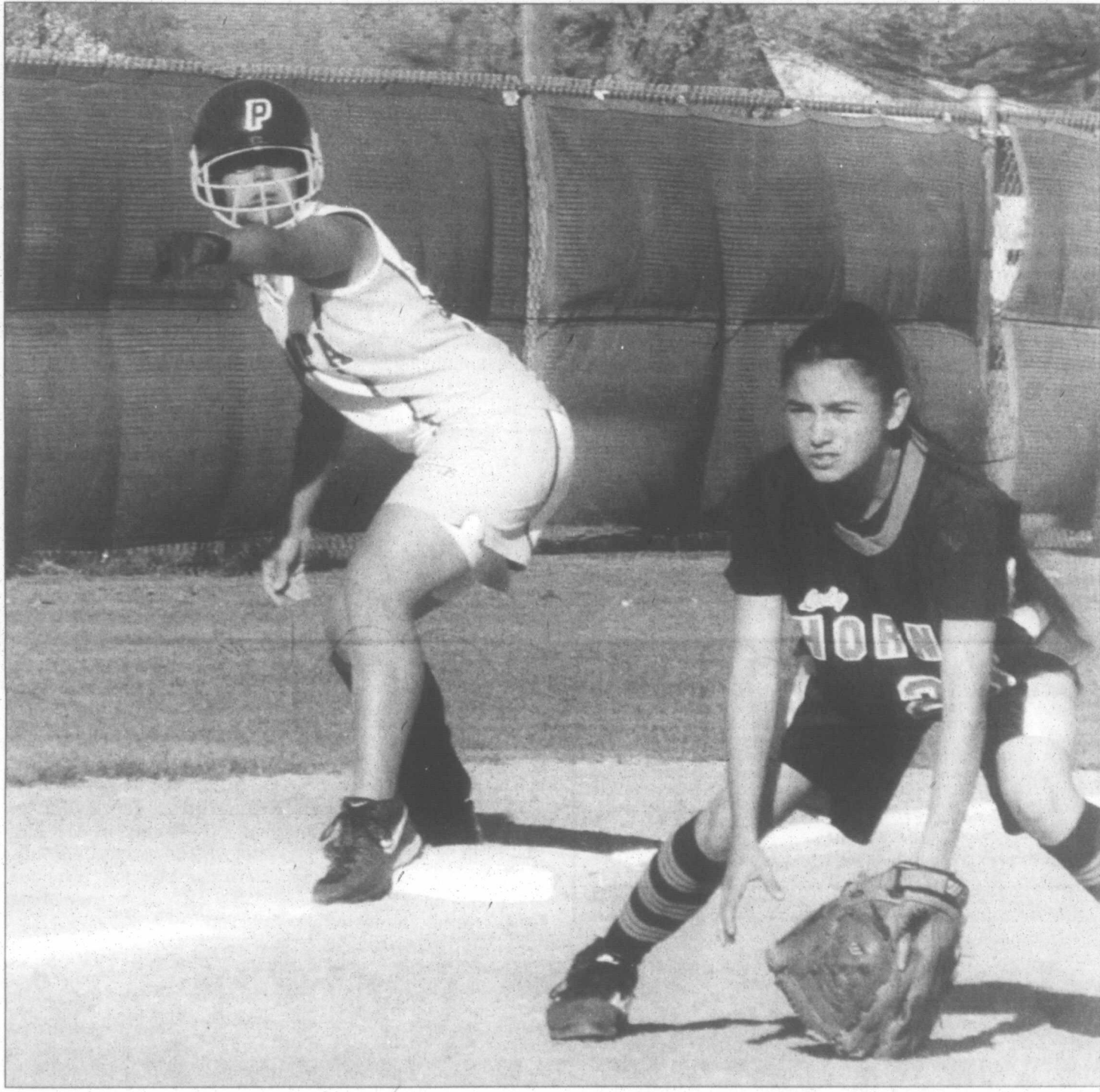
Needless to say, it was the last shiny trophy I got for playing baseball, but I've come to find over the years that the memories of how bad I was are far more valuable.

## Baseball, softball hits the road today

The softball girls wrapped up district play earlier this week with a perfect record, but the baseball boys still have one game to go before they head into the post-season.

At 1 this afternoon, the Harvesters (20-7-1, 7-2) will travel to Randall to take on the No. 1 seeded Raiders (9-0) in the last game of the dis-

trict season.

The Lady Harvesters will also be hitting the road tonight to play in a practice game at 5:30 p.m. in Perryton.

Because they earned the No. 1 seed in the district, the girls got a first round bye in the playoffs and will face a team from El Paso to start the playoffs next week.

## Player wounded in shooting sues Duquesne

PITTSBURGH (AP) — One of five Duquesne basketball players shot on campus last year has sued the university, alleging it failed to provide adequate security at a dance.

The lawsuit, filed late Wednesday in Allegheny County Common Pleas Court, says university officials didn't take action once they knew of potential criminal activity. A doorman let two armed men into the dance even after their friend asked if the men would be frisked, according to the lawsuit.

"Rather than alerting the campus police who were present inside the ballroom about (the frisking inquiry), or taking other similar reasonable steps, the doorman simply responded that they would not be frisked," and allowed the men to enter, the lawsuit states.

The player who filed suit, Stuard Baldonado, was one of five shot early Sept. 17 as they walked back from the dance. Also wounded were Aaron Jackson, Shawn James, Kojo Mensah and Sam Ashaolu, who was shot twice in the head.

Baldonado, a junior trans-

fer from Miami-Dade Community College in Florida, was shot in the arm. The bullet, according to the lawsuit, hit an artery and then continued through his chest, missing his spine by a centimeter.

Two alleged gunmen and two women who allegedly helped facilitate the shooting are awaiting trial. Each has pleaded not guilty.

The school will not discuss the lawsuit, but is committed to its students' safety, spokeswoman Bridget Fare said.

"The university has a long-standing, proven record of providing a safe living and learning environment," Fare said. The shooting, she said, "was a totally unprecedented event for Duquesne."

Baldonado remains a scholarship player and works out with his teammates, after taking a medical redshirt last season because of his injuries, said Teresa Toriseva, his attorney.

The bullet damaged Baldonado's elbow and back "preventing him from doing the full range of things he did as a basketball player," Toriseva said.

## Nelson fines Baron, Jackson as Warriors work on keeping cool

OAKLAND, Calif. (AP) — Though the Bay Area is abuzz with excitement for the Golden State Warriors' first home playoff game in 13 years, the Warriors are getting a few remedial lessons in keeping their cool.

Warriors coach Don Nelson said Thursday he will fine Baron Davis and Stephen Jackson for being ejected from Golden State's 112-99 loss in Game 2 of the club's first-round playoff series against the Dallas Mavericks.

Davis and Jackson put on a taunting, preening display that dampened an otherwise successful trip for the eighth-seeded Warriors, who stole Game 1 from the heavily favored Mavs and headed back to the West Coast with homecourt advantage in the series, starting with Game 3 on Friday night.

"It doesn't make any sense to me, as hard as we worked to get to the playoffs, to all of a sudden get there and not be able to play because of ejections and not controlling our emotions," Nelson said before a brief workout at the Warriors' downtown training complex.

"I want to play with passion. I want to play with emotions, (but) have respect for authority out there. The referees are the authority, and just like when I make a decision, I expect the respect to be there for me. ... Things don't always go your way, and you've got to control your emotions."

The NBA hasn't announced any potential discipline against Davis, who apparently was thrown out for sarcastically applauding the officials late in the third quarter, or Jackson, who left the court in a contentious, roundabout manner after getting his second technical foul in the final minutes.

But on what should have been a celebratory day before hoops-crazy Oakland's first taste of the postseason since 1994, Davis and Jackson spent the day avoiding direct comment on a dressing-down from their veteran coach. Nelson didn't announce the amount of his fines, only saying, "it will be substantial."

Neither player betrayed any particular anger about the fines — perhaps a testament to Nelson's control of

the club in his first season back in town. The Warriors spoke mostly about improving their defense and harnessing the energy of their sellout crowd Friday night after splitting the first two games.

"That's in the past," said Davis, who had just 13 points Wednesday night after scoring 33 in the series opener. "I'm not even going to talk about that, not even a little bit. It doesn't have even a little relevance."

Davis kept clapping for the officials while standing at the bench, even when Nelson asked him to stop. Davis defended his clapping a bit, saying, "I was stopping."

Jackson still could face a suspension for the very definition of failing to leave the court in a timely manner. He took time to shout at officials and spar with fans on the long walk back to the locker room, but the swingman was cool again Thursday.


"I love basketball," Jackson said. "I'm going to continue to play with a lot of emotion. Obviously, I've got to police myself. It's obvious, and I will continue to do

that, but my passion for the game will never change."

The Mavericks already learned last year about remaining calm in the playoff cauldron. Their path to the NBA finals was littered with misbehavior — Jason Terry's one-game suspension for punching San Antonio's Michael Finley below the belt; D.J. Mbenga's five-game suspension for going into the stands; Jerry Stackhouse's one-game ban in the NBA finals for a hard foul on Shaquille O'Neal.

"Guys can get suspended, so we kept our cool (in Game 2)," Dallas forward Josh Howard said. "That's something that comes with experience."

But that cool didn't slow down a series that's become more competitive and exciting than most 1-8 matchups in an average year. Dallas' win in Game 2 snapped Golden State's six-game winning streak against the NBA's best regular-season team — and it might have awakened the Mavs' competitive spirit as well after they were outfoxed by Nelson and Davis in the opener.

# O'Hair leads after first round of Nelson

IRVING, Texas (AP) — Sean O'Hair wants to be known for his game, not how he was pushed into the professional ranks while still in high school by an overbearing father.

With the way O'Hair is playing these days, his past is becoming less of the story, though it's disturbing.

O'Hair shot a season-best 5-under 65 on Thursday in the EDS Byron Nelson Championship to take a one-stroke lead over defending champion Brett Wetterich and Anders Hansen after the tournament's first round without its namesake.

"You don't want to be known for other stuff," the 24-year-old O'Hair said. "My life is in a great spot. I've got two beautiful kids I

love to death and I've got a beautiful wife who does nothing but support me. ... I'm very fortunate to be in the situation that I'm in."

That wasn't always the case for O'Hair, who was pushed relentlessly by his father to be a star. He used to have to run a mile for every bogey and turned pro at age 17, a year before he finished high school.

Wetterich's 66 included an eagle 3 on the 554-yard 16th hole when he hit his approach within 7 feet of the pin. His 20-foot birdie attempt for a share of the lead at the closing 440-yard hole at the TPC Four Seasons course slid just left of the cup.

One of the things Wetterich treasured about his

only PGA Tour victory was the personal congratulation he got from Nelson at the 18th green after the final round. Wetterich was the last winner to have that privilege.

Nelson, the champion golfer known as "Lord Byron" and in 1968 the first to have a PGA Tour event named after him, died Sept. 26. He was 94.

"It is a little sad to not see Byron there. I really miss him," Phil Mickelson said after his round of 69. "But I don't think he's very far away from us. We still have all the great memories he's provided."

Luke Donald, with his ninth consecutive Nelson round in the 60s, and Scott Verplank were among five

players tied for fourth at 67. Another dozen players posted 68s.

When O'Hair was the Nelson runner-up to Ted Purdy as a PGA Tour rookie two years ago, O'Hair's story became well-publicized. But by then, he had already severed ties with his father.

"I kind of had my life in order. ... Once the media kind of got involved in that situation, it made it a little bit more difficult for me," O'Hair said. "That stuff is long gone, and it's been long gone for a long time."

O'Hair said he now talks to his father "once in a while." While he politely described their relationship as a "good situation," he didn't elaborate.

# Ochoa 1 stroke back in homeland debut as No. 1

MORELIA, Mexico (AP) — Lorena Ochoa shot a 5-under 68 on Thursday in the Mexican star's first round as the No. 1 player in the world, leaving the defending champion a stroke behind leader Stacy Prammanasudh in the Corona Morelia Championship.

Ochoa, who took the top spot in the rankings from Annika Sorenstam on Monday, had two eagles, five birdies and four bogeys in windy conditions on the Tres Marias course, the Jack Nicklaus-designed layout that sits 6,300 feet above sea level.

After playing the back nine first, the 10-time LPGA Tour winner eagled the par-5 fifth and eighth holes, hitting a 7-wood from 216 yards to 21 feet on No. 5 and a 9-iron from 160 yards to 27 feet on No. 8.

"It was a day of ups and downs. I was very pleased with the eagles and the bogeys come with the emotion of playing a little aggressively," said Ochoa, followed by a swarm of fans giving hearty applause on almost every swing.

"We planned to get 5 under each day so I'm very tranquil and happy. It's going

according to plan and we hope that will carry on over the following days."

Prammanasudh had four birdies and an eagle en route to her 67.

"I knew you had to make birdies out there, just with how soft the greens are and you can be really aggressive with your putts," the Oklahoman said. "Luckily, I didn't have any mistakes out there and just made some birdies when I had to."

South Korea's Na On Min matched Ochoa with a 68. The South Korean rookie had eight birdies, a bogey and a double bogey.

Ochoa topped the world rankings Monday with 12.84 points, 0.14 points ahead of Sorenstam. Sorenstam had led the list since the rankings began in February 2006, but has been sidelined by a ruptured disk in her back.

The news was greeted with euphoria south of the border, being splashed across the front of Mexican newspapers and President Felipe Calderon even made a congratulatory call to Ochoa. Rivals such as Prammanasudh say it can be tough playing against Ochoa with such support in her homeland.

# Red Bulls continue shutout streak over FC Dallas

FRISCO, Texas (AP) — Hunter Freeman scored in the 79th minute and the New York Red Bulls became the first team in Major League Soccer to start a season with

four consecutive shutouts, beating FC Dallas 1-0 on Thursday night.

The Red Bulls (3-0-1) beat the record of three set by FC Dallas' predecessor,

the Dallas Burn, in 1999, when the Burn didn't allow a goal in their first 343 minutes of the season.

Freeman fired a right-footed shot into the left corner of the net from the top right corner of the penalty box for his first goal of the year. Dave van den Bergh set up the score with a crossing pass from outside the penalty box. Jozy Altidore also had an assist on the score.

FC Dallas (2-2-1) managed only nine shots to the Red Bulls' 13.

New York goalie Ronald Waterreus made four saves for his third shutout of the

season. He made a sliding save of a shot from inside 10 yards by Kenny Cooper in the 76th minute. It was FC Dallas' first shot in more than 30 minutes.

Jeff Parke almost scored for the Red Bulls in the 74th minute when he fired a shot from about 6 yards, but FC Dallas goalie Shaka Hislop made a leaping save. Hislop finished with four saves.

FC Dallas forward Carlos Ruiz had an excellent scoring opportunity in first-half stoppage time, but Red Bulls defender Carlos Mendez deflected his shot from about 12 yards.

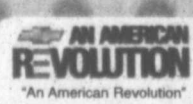
