

Upper Colorado SWCD Windbreak Tree Program

Colder weather and West Texas winds will be here before you know it. It's time to be thinking about purchasing windbreak trees.

The Upper Colorado Soil and Water Conservation District is ready to take orders for the 1998-99 windbreak program.

A properly installed and maintained windbreak goes a long way toward lowering utility bills, and making life easier on both people and animals. Don't be fooled by the name, these trees do more than block the wind. Properly sited and spaced, they work well as sound privacy barriers and/or screens. Wildlife benefit from food and cover provided by windbreaks. Studies have shown that by softening rainfall, blocking high winds, and holding soil in place windbreak plantings reduce erosion by as much as 25%.

Evergreen and hard-wood varieties are offered again this year, along with four wildlife packets. Evergreen species again include Afghanistan Pine, Austrian Pine, Eastern Redcedar, and Pinyon Pine. Ponderosa Pine is offered, for the first time, this year.

Evergreen seedlings are shipped in tar paper tubes and are prices at \$2.00 each. Larger containerized trees may be available later on in the season.

hardwood The regular includes: selection again Desert Willow, Catalpa, Green Ash, Shumard Oak (Red Oak), Hackberry, Russian Little Walnut. Olive, Lacebark Elm, and Sumac. New Aromatic additions this year are:

Cherry, Fourwing Sandy Saltbush, Flameleaf Sumac, Nanking cherry, Sand (Native) Plum, and Amur Honeysuckle. Hardwoods are bare-root seedlings and are \$1.00 each. Amur Honeysuckle is in very short supply, so if you are please interested, place your order soon.

Wildlife packets contain a total of 100 bare-rooted hardwood seedlings (25 each of 4 varieties) individually tailored for quail/ pheasant, deer, turkey and squirrel. Wildlife packets are \$67.00 each.

Here's looking Ah-choo! It's time for your flu shot

Now is the time to get your flu shot, especially if you're older than 65. The ideal time to get the inoculation is from October through November to give your body time to build up antibodies to the virus which usually strikes Texas around Christmas and lasts until February.

Preliminary reports say that this season's outbreak is expected to be more severe than in previous years, according to the Center for Disease Control in Atlanta, Ga.

"The shots may help prevent you from getting influenza, or at least may minimize your symptoms if you do catch it. In other words, you can still get the flu, but typically, it will be a milder case," said John Carpenter, M.D., Scott & White physician specializing in treating infectious diseases.

"If you wait until the end of December to get our flu shot, it may be too late. The vaccine needs about two to three weeks to take effect," Carpenter said. "The month of October is the best time because it allows your body time to build antibodies (natural defenses) to the virus before you are exposed. The shot helps prevent influenza in 70 to percent of the population and minimizes

With just 1:27 left in the game, the Coyotes had a chance to increase the


margin, as Fernando Baeza out-raced the Panthers to the 13 yard line. The Coyote had time to run two plays before time ran






