Cross Country Runners State Bound!

The Borden County high school girls team and Trent Pepper have qualified for the State Cross Country Meet based on their performances at the Region I meet in Lubbock on Saturday.

The high school girls placed second behind Nazareth to earn a state cross country meet berth. Out of one hundred eighty-six finishers, medalist Lindsey Smith placed tenth with a

time of 13:00. Lindsey qualified for state as both an individual and with the team. Holly Thomas followed closely behind, placing fifteenth in 13:18. Julie Mayes finished forty-seventh in a time of 13:46, Valerie Wootan placed fifty-sixth in 14:00, and Crystal Dye finished fifty-seventh in 14:01. Hailey Adcock placed sixty-first in a time of 14:05, and Bekah Hensley finished sixty-fifth in 14:07. The girls look to improve on last year's ninth place state finish.

Gold medalist Trent Pepper led the boys to a seventh place team finish. Trent cruised to victory with a time of 16:41, finishing forty-five seconds ahead of the second-place finisher. T.C. Stipe placed thirty-fifth among the one hundred forty-three runners in 18:52. Robert Stamper was close behind, finishing thirty-eighth in 19:03. Colt McCook placed seventy-eighth with a time of 20:27, and Fernando Baeza finished seventy-ninth in 20:28.

Kevin Pinkerton placed one hundred third in 21:45, and Ramon Griffin finished one hundred ninth in 22:03.

The State Cross Country Meet will be held in Round Rock on Saturday, November 14. The girls will run at 10:00 a.m., and Trent will run at 10:20 a.m.

Coyotes Clinch Play-Off Spot

The Borden County Coyote football team clinched a play-off spot Friday night as they defeated the Hermleigh Cardinals by a score of 56-6. The victory makes the Coyotes the runner-up in district 6-A, with a 4-1 district record, and a 9-1 record overall.

The host team got on the board first. As the Cardinals were forced to punt, a Coyote fumbled the punt right back to them. On the next play the Cards completed a pass into the end zone from 7 yards out. The PAT failed, and the Cards took an early 6-0 lead.

The Coyotes did not panic and set in to do the rest of the scoring for the evening. With 7:07 left in the first period Fernando Baeza carried the ball 29 yards for the Coyotes' opening touchdown. The PAT kick was missed tying the score at 6-6.

The Coyote defense quickly gave the ball back to the offense, and with 6:07 left Ed Rodriguez rambled 35 yards to the end zone. The PAT kick was missed, and the score was 12-0.

The Coyotes' third touchdown came with only a :01 tick left on the clock in the first period as Baeza bolted loose from the Cardinal defense. On fourth down and 3 to go from 53 yards out, the Coyote offense went for it as Baeza followed good blocking up front, made a Cardinal miss a tackle, and out ran the defense for the touchdown. McCook kicked the PAT good, and the score was 20-6.

Early in the second period, the Coyotes got on the board again with a 35 yard run from Ryan Grant. The PAT failed, and the score read 26-6 with 6:54 on the clock.

With 3:32 left in the second period, the Coyotes were once again bargaining for six. They got it as Kevin Pinkerton took the ball from 12 yards out for the score.

The PAT was kicked good by McCook, and the lead was extended to 34-6.

With 1:32 left in the first half, McCook hit Baeza with a pass for 8 yards and a touchdown. McCook kicked the PAT good, and the score was 42-6.

The Coyote defense again gave the ball right back to the offense and made short order of the next six points. With 1:00 left in the half, Baeza hit Rodriguez with a pass from 12 yards out for the touchdown. The point after was kicked good by McCook, and at the half the Coyotes led by 44 points, 50-6.

On the Coyote first possession of the third quarter, a 34-yard field goal attempt to end the game was missed on a fourth and four-yard situation. The Cards were soon stopped by the Coyote defense, and on the next play McCook hit Rodriguez in the end zone from 34 yards out to end the game. With 3:09 left in the third period the score read 56-6.

Fernando Baeza had 7 carries for 130 yards and two touchdowns. He caught two passes for 24 yards and a touchdown. He threw a pass for 12 yards and a touchdown, and he led the defense with 11 stops. Baeza has 99 carries for 1010 rushing yards and 22 touchdowns through ten games. Baeza has also caught 22 passes for 361 yards and 6 touchdowns for the season.

Ed Rodriguez had 2 carries for 40 yards. He caught 3 passes for 54 yards and 2 touchdowns. He had 7 tackles, one fumble recovery, and one interception. Through ten games Rodriguez has 64 carries for 736 yards and 11 touchdowns. He has also caught 8 passes for 183 yards and 5 touchdowns on the season.

Ryan Grant had 2 carries for 40 yards. He caught a pass for 4 yards; and had 5 stops and one QB hurry

on defense.

Kevin Pinkerton had one carry for 12 yards and a touchdown. He caught a pass for 29 yards and had 5 tackles on defense. Pinkerton has caught 16 passes for 322 yards and 5 touchdowns so far this season.

Colt Miller caught a pass for 10 yards. He had 6 tackles and one fumble recovery on defense. Miller has caught 16 passes for 271 yards and 7 touchdowns in the last 10 games.

Colt McCook completed 7 of 9 passes for 109 yards and 3 touchdowns. McCook caught an interception on defense and broke up several other Cardinal passes. McCook has completed 71 of 122 passes for 1297 yards, 6 interceptions, and 23 touchdowns for the 10 game season.

Lee Pepper carried the ball 3 times for 17 yards, and he had a tackle on the kick-off team.

Dale Grant had 2 carries for 3 yards, and he had a tackle on the kick-off team.

Cesar Mujica played on the extra-point team and saw some action at offensive end.

Robert Stamper played some QB and some safety, and played on the kick-off team where he recorded a tackle.

John Harding is a regular on the extra-point team and he saw action at offensive end.

Justin Lawrence played offensive and defensive end where he had two tackles and a quarterback hurry.

Nick Flanigan saw action at offensive end and defensive cornerback.

Ramon Griffin blocked well for the Coyote offense at center and had one tackle on defense.

Preston Sharp played on the defensive line where he had a QB hurry. Sharp also plays on the special teams.

yards total and held the Cards to only 96 yards on the night. The Coyote runners only had 18 carries for 243 yards, and completed 8 of 11 passes for 121 yards. The Cards had 4 turnovers, two fumbles and two interceptions. The Coyotes only gave up one fumble.

The Coyotes are now ready to begin post-district play. Their first opponent will be the Wellman-Union Wildcats. They are a very worthy opponent as they are big up front and have four quick backs that they rotate in

and out of the game. One of them is one of the best track hurdlers in the state, Jeremy Webb. They were hurt early and had 3 losses to their record. They have since healed and rolled through their district with 7 straight wins. They will be hungry to upset the Coyotes and keep up their winning streak. We will have to be at our best. The game will be played Friday night, November 13, at 7:30 PM, in Klondike. Everyone come out and root the Coyotes to a Bi-district championship.

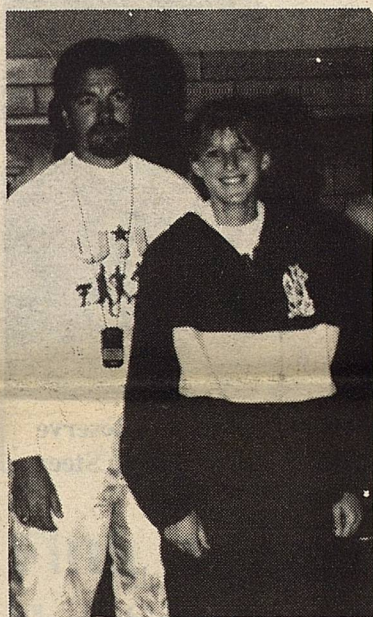
Applicants must have participated in athletics at BHS and must have at least 30 college hours with a minimum GPA of 2.75 on a 4.0 system. Previous

FSA NEWS

ECP Drought Funds

The ongoing drought has caused severe damage in Borden and Garza Counties. Farms and ranches suffering severe damage may be eligible for assistance under the Emergency Conservation Program (ECP) if the damage:

- *will be so costly to rehabilitate that Federal assistance will be needed to return the land to productive use;
- *is unusual and is not the type that would recur frequently in the same area;
- *will affect the productive capacity of the farmland;
- *will impair or endanger the land.

Producers who have suffered a loss from a natural disaster may contact the Garza-Borden FSA office and request assistance from November 9 through Dec. 8, 1998.

To be eligible for assistance, practices must not be started until:

- *an application for cost-share assistance has been filed;
- *the local FSA Committee or its representative has conducted an onsite inspection of the damage area;
- *NRCS has made a needs determination, which may include cubic yards of earth-moving, feet or pipeline, etc.;
- *FSA Committee has

issued approval.

Land Located in Non-designated ECP Counties

Land eligible for ECP C/S assistance shall include an farm-land physically located in an ECP designated county, but which is administratively located in a non-designated ECP county.

Sign-up continues through December 8, 1998. Call 806/495-2801 (extension 2) for an appointment.

Poor Early Quail Hunting Season Predicted

Deer season will be good this year, but quail season will not. The drought kept quail from reproducing this year, so there will not be many to hunt. Extension wildlife specialist Dr. Don Steinback predicts the first half of the season is lost. He says the only bright spot is that quail tend to

next a second time if they fail the first time. Steinbach says that's the case in South Texas, but the birds will not be big enough to be hunted until January. A cold snap in November or December could wipe out that population too. Steinbach says the rains this fall brought on weed growth

that till provide seeds for the quail to eat, but when they're very young they require insects for protein. as the weather cools, that insect populations will dwindle.

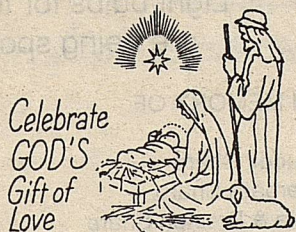

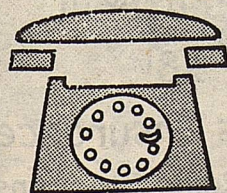

How can an old buck beat you?

He eats at night. Legal and ethical hunting ends at dark. This buck can do all his doings at night when everything is quiet.

He lives in thick cover. He will spend his days in the thickest most inaccessible bushes there is. He will not run out of it when you go in there either. He holds tight or circles around and lays back down. He is slick.

He will not eat at a deer feeder. No way, Jose.

He does not chase does. He lets the young foolish bucks stand out in the open fields chasing does.

You can find his shed rack in April and say "Wow! Look at this antler!" If you followed his antlers you would see the size of the antlers decrease in his later years. The teeth wear out on old bucks and does. When their teeth are worn from chewing their food they get in poor physical condition. They become easy prey for coyotes. They die from disease as they lose their immunity.

Hunting for me if fun and exciting. It is a challenge to outwit the deer on their own turf. I enjoy collecting the racks and eating the venison. My heart beats fast when I shoot. I still get "Buck Fever". I do not enjoy the death of the animal. I do believe that it is more humane than a coyote. I have prayed that when my time comes that the Good Lord would take me quickly. I would not want to go with a long battle.

Enough of that. We are in the midst of a great deer season. Spend some-time outdoors. There is real peace to be found out there?

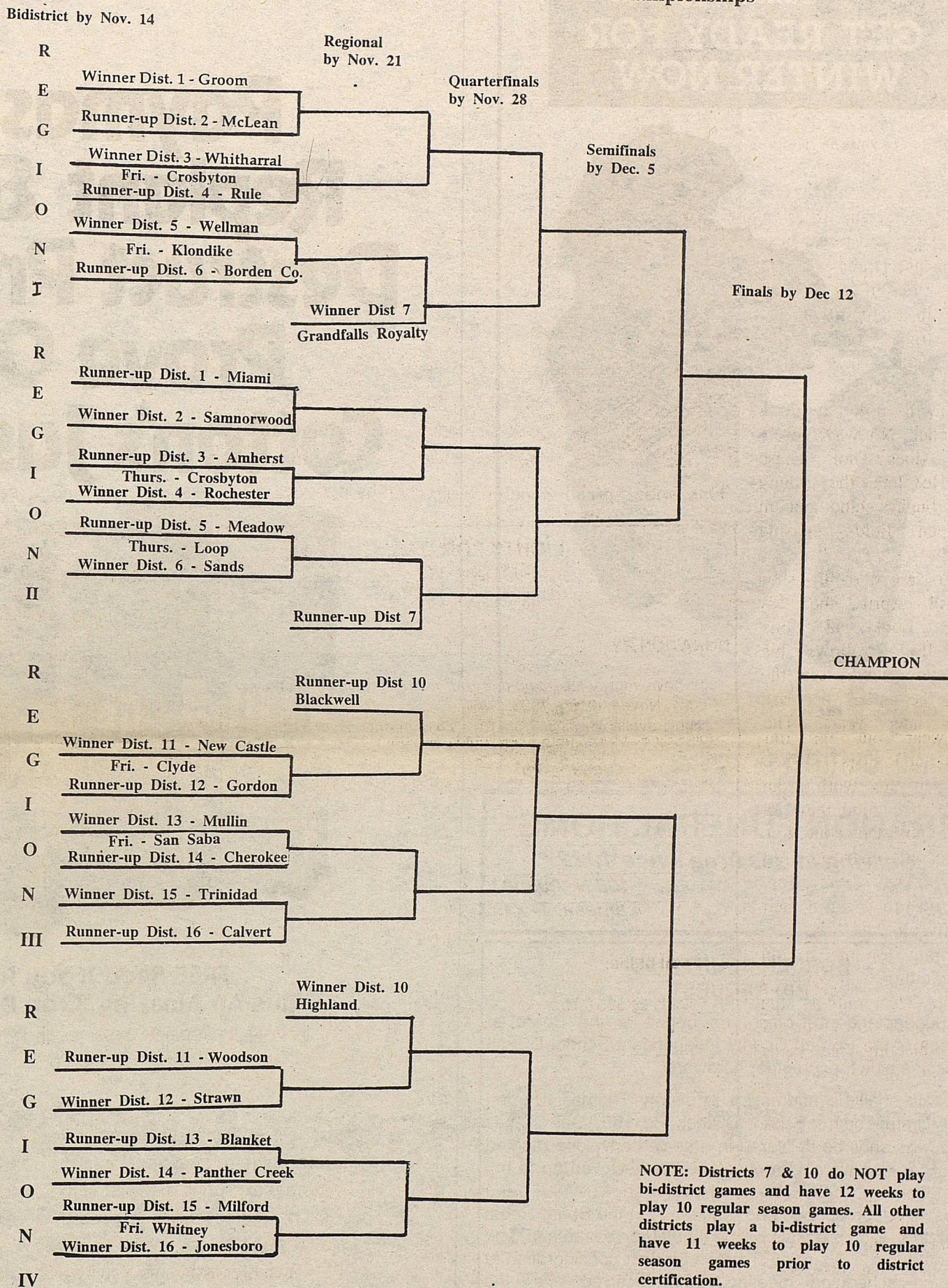
