Officials plan 'Smoke Test' for sewers

The City of Pampa Wastewater Collection Department will be conducting a smoke test of its sanitary sewer system beginning Aug. 4.

The "Smoke Test" survey will assist inspection crews in locating breaks and defects in Pampa's sewer system. The smoke that can be seen coming from vent stacks on houses or holes in the ground is non-toxic, non-staining, has no odor, is white to gray in color and creates no fire hazard, local officials say.

The smoke should not enter a home unless it has defective plumbing or dried up drain traps.

The City of Pampa's Wastewater Collection Superintendant Wayne Terry advises home owners to pour a gallon of water into each floor drain prior to the testing. According to the press release, if smoke enters your home there is good reason to assume that dangerous sewer gases may also be entering your home or business

If there is any individual in your home or business who has respiratory problems and is immobile it is important to notify the department prior to testing.

Anyone who sees smoke in their home or business should evacuate immediately and notify the department's work crews. If you are not home and discover smoke when you return, call 669-5706 or 898-8072.

Landfill, water issues strain budget

The good news is that Pampa's economy is good. The bad news is that Pampa's economy is good and could get better.

Pampa Manager Trevlyn Pitner said that with the community growing there is more need for expanding infrastructure and added expense in maintaining the infrastructure that exists.

The problem is that fuel prices are up, steel is up and unemployment is down.

During slow economic times, Pitner said, a number of people come to work for the city. With highpaying jobs in the oil patch, he said it is more difficult to recruit and retain city employees.

As the city works on fiscal year, Pitner said new landfill cell

that expenses are going to be up.

"My greatest concern right now," Pitner said, "is our landfill issue."

When the city opened its regional landfill, the first cell cost about \$800,000. That cost has swelled and as Pampa begins work on its next cell this fall, the cost has skyrocketed to over \$3 million.

The excavation costs have doubled. The cost of fuel has doubled.

The city has been putting money aside for the project, but much of the cost has increased within the past few months and the money that has been set aside won't fully cover the costs.

"A year ago," Pitner come in under budget."

lion. By June, those costs had increased to \$3.4 million.

Since the landfill serves a number of cities, Pitner said that some of that cost could be defrayed. He said in talking with member cities that use the Pampa landfill, they all expect fee increas-

The base fee right now is \$27.50 a ton.

The problem is figuring out how much to go up without pricing the Pampa landfill out the market. Anything that can't be passed on to member cities will have to be borne by Pampa residents.

"The landfill is not profitable," Pitner said, "but it is stable." Richard Morris,

"We may have to borrow," he said.

"We better hope that sale tax revenues increase," said Pampa City Commissioner Robert Dixon. "We can't continue to go into debt."

The city already has debt of about \$14.5 million.

In addition to the landfill, Pampa is faced with developing new municipal water wells. Pampa is one of two members of the Canadian River Water public works, said the Authority cities that has its own well field. Amarillo is the other.



Texas inmate executed for slaying mom, child HUNTSVILLE, relatives of his victims watch-Texas nothing in the seconds before

(AP) — Seventeen years after a suburban Houston woman and her 2-year-old son were attacked and killed at their apartment, the man convicted of their slayings was put to

Derrick Sonnier, 40, said

his lethal injection Wednesday evening, shaking his head once from side to side when asked by a warden if he had any final statement. He nodded to a friend and cousin who watched through a window but never acknowledged five

ing through an adjacent window.

Eight minutes later, he was pronounced dead.

"Justice can never be done," Tameka Traylor, whose mother, Melody Flowers, 27, and brother, Patrick, 2, were killed in 1991. "After 17 years, it can never be done.

"What hurts the most is not about justice. It's not about him dying. That doesn't change anything. It's the many nights I had to stay up and cry and want her as a child... Taking his life, that doesn't give any kind of comfort, no type of comfort for what he took from us."

Traylor, who watched Sonnier die, was 8 when the murders occurred.

"This world is a mean place," she said. "A lot of people are full of so much hate. The bad thing is our family isn't going to be the last family to have to go through this."

Sonnier made a similar trip to the death house seven weeks ago but was spared when the Texas Court of Criminal Appeals stopped his scheduled punishment about 90 minutes before he could have been executed.

There was no reprieve this

Lawyers then - on June 3

— raised questions about the legality of Texas' lethal injection procedures. That appeal, however, subsequently was rejected and no new legal efforts were attempted to save him from becoming the third Texas inmate to die this year.





Child Sex-Indictments

AUSTIN (AP) — An Austin man accused of sexually assaulting as many as six children, and videotaping them, has been indicted by a Travis County grand jury.

Billy Dan Carroll was indicted late Tuesday for aggravated sexual assault of a child, indecency with a child by contact and indecency with a child by exposure, according to the Austin American-Statesman.

Police said a videotape taken from Carroll's home in northwest Austin shows him having sex with children as young as age 2. They say the suspect used a hidden camera to videotape a 13-year-old. Authorities say Carroll also drugged a slushy in order to assault a victim.

Sgt. Brian Loyd of the child abuse investigation unit told the newspaper on Wednesday that police still have one victim they hope to identify from a videotape, but they are uncertain she can be found since they have no way to find her.

State District Judge Melissa Goodwin had declined to appoint a lawyer for Carroll and instead asked him to give her certain documents, including income tax statements. Carroll had not done so at a recent hearing. He had owned a courtreporting business in Austin and San Antonio but said he did not have the financial means to pay for an attorney, because his assets had been frozen.

Police said they have finished their investigation of

Carroll whose next court hearing is Aug. 8.

Emergency Landing-Probe

HOUSTON (AP) — The Federal Aviation Administration has started investigating the emergency landing in New Orleans of a Continental Airlines Boeing 737 carrying former presidential candidate Ron Paul and six other members of Congress,

officials said.

Les Dorr, an FAA spokesman, said the plane, from Houston enroute to Washington D.C., was being inspected in New Orleans, where Continental Flight 458 landed late Tuesday. After a loss in cabin pressure, the pilot declared a mid-air emergency and oxygen masks dropped from overhead com-

Four of Pampa's 11 water wells are down. Morris noted that the newest Pampa water well was drilled back in the 1950s.

A new well is estimated to cost about \$750,000.

The costs of water from CRMWA are expected to rise as the authority shifts more production to its well field in Roberts County and away from Lake Meredith. The water level at Lake Meredith is near historic lows and CRMWA's electric bill for pumping in Roberts County in June was near \$900,000, which was up from over \$600,000 in May. Those costs are shared by CRMWA's member cities.

While some projects might be put on hold, Pitner said the city might not have a choice when it comes to the water wells and landfill issues.

With the city expected to grow over the next few years with oil and gas activity as well as the potential growth of the wind energy industry here, Pitner said the city needs to be preparing for construction of more housing and businesses.

That means extending such things as water and sewer lines. Those fees will likely have to be raised, and that doesn't include solid waste costs.

Pitner said the city needs to build a new lift station to serve the north end of Pampa, particularly if the area around the new junior high school is annexed and developed.

Pampa Independent School District is already planning a lift station for the junior high school.

As the city works through its budgeting process this summer, Pitner told the Pampa City Commission this week that he wants to keep them updated on future projects and potential problems.

The biggest problems the city faces are rising costs of fuel and material, just like most citizens of the communi-

While all the projected income for the city isn't in yet, many of the projected expens-

Pitner said he doesn't have the revenue estimates from the tax appraisal district yet, but sales tax revenues continue to be strong, which is a positive for the next fiscal year.

He said he and the department directors are pouring over budget requests and trying to pare them down.

Pitner said there are about \$4 million in capital expenditures in the developing budg-


"Some of those are funded from previous bond issues," Pitner said.


He estimated that about half of the capital expenditures are already funded.

Pitner said that over the next few weeks, some difficult decisions are going to have to be made to reach a balanced budget.

As the budgeting process continues, he said he'd try to bring in better numbers.

"While in a foreign country," the State Department Web site states rather unequivocally, "a U.S. citi-

zen is subject to that country's laws and regulations, which sometimes differ significantly from those in the United States and may not afford the protections available to the individual under U.S. law. The trial process in Mexico is

> different from the trial process in United States (surprise, surprise!), and

procedures may vary from state to state. Penalties for breaking the law can be more severe than in the United States for similar offenses. Persons violating even Mexican laws, unknowingly, may be expelled, arrested or imprisoned."

The United States cautions ITS citizens to abide by the rules of the land or suffer the full legal ramifications of engaging in criminal activity if apprehended, irrespective of nation of locale.

Wow. What a shocking position for the government to take, right?

I guess Mexican authorities disagree with the State Department in regard to Mexican citizens. Mexico does not expect its residents to adhere to the laws and legal procedures of other nations when they are sans country?

What is this, guilt by international disdain? Americans must play by the rules while traveling abroad,

but America's legal system is a smorgasbord for all non-Americans?

This is what the State Department Web site had to impart on the state of incarceration in Mexico: "Prison conditions in Mexico can be extremely poor. In many facilities food is insufficient in both quantity and quality, and prisoners must pay for adequate nutrition from their own funds. Most Mexican prisons provide poor medical care, and even prisoners with urgent medical conditions receive only a minimum of attention. U.S. citizens who are incarcerated in Mexico are sometimes forced to pay hundreds and even thousands of dollars in

On July 24, 1858, Republican senatorial candidate Abraham Lincoln formally challenged Democrat Stephen A. Douglas to a series of political debates; the result was seven face-to-face encounters.

On this date:

In 1783, Latin American revolutionary Simon Bolivar was born in Caracas, Venezuela.

In 1847, Mormon leader Brigham Young and his followers arrived in the Great Salt Lake Valley in present-day Utah.

> In 1862, the eighth president of the United States, Martin Van Buren, died in Kinderhook, N.Y.

In 1866, Tennessee became the first state to be readmitted to the Union after the Civil War.

President In 1929, Hoover proclaimed the Kellogg-Briand Pact, which renounced war as an instrument of foreign policy.

In 1937, the state of Alabama dropped charges against four of the nine young black men accused of raping two white women in the "Scottsboro Case."

In 1948, Henry A. Wallace accepted the presidential nomination of the Progressive Party

Philadelphia.

In 1959, during a visit to Moscow, Vice President Richard M. Nixon engaged in his famous "Kitchen Debate" with Soviet leader Nikita Khrushchev.

In 1967, French President Charles de Gaulle stirred controversy during a visit to Montreal, Canada, when he declared, "Vive le Quebec libre!" (Long live free Quebec!)

In 1974, the Supreme Court unanimously ruled that President Nixon had to turn over subpoenaed White House tape recordings to the Watergate special prosecutor.

Ten years ago: A gunman burst into the U.S. Capitol, opening fire and killing two police officers before being shot and captured. (The accused shooter, Russell Eugene Weston Jr., is being held in a federal mental facility.) The motion picture "Saving Private Ryan," starring Tom Hanks and directed by Steven Spielberg, was released.

Five years ago: The House and Senate intelligence committees issued their final report on the attacks of Sept. 11, 2001, citing countless blunders, oversights and miscalculations that prevented authorities from stopping the attackers.

Let's start at the very beginning. A "network" is simply two or more computers connected together so that they can communicate. On a typical network, information and printers can be shared by any of the connected computers.

Two basic types of networks exist: "Peer-to-peer" and "client/server." A peer-

I know I wasn't too specific on the "how to's", but each operating system comes with instructions on the actual implementation of the network. As homeowners buy multiple computers, more and more non-business peer-to-peer networks are popping up all over the place.

Client/server networks are for larger organizations. If your company has four or more computers that need to be connected, you might

All I can say is, thank heavens!



peer-to-peer network grows beyond three computers, much of your mission-critical information begins to migrate to one PC. It just makes sense. You want all of your important information on one PC so that everyone can find it and so that it can be backed up much easier. Well, if you have three, four or six machines all trying to access one PC, that poor PC will slow down to unusable levels. Enter, the server!

The server is a normal computer with special software (server software, to be exact). This software makes it easy and efficient for numerous PCs to simultaneously access the information on the server. A server usually sits in a closet somewhere. No one actually sits down and types on it since that would slow it down for everyone else. A server's job is to simply divvy out information to all the other PCs, (known

If you are interested in setting up a client/server system in your office, you might want to contract the work out. Configuring server software is not for the technologically timid. Usually, you will have three choices in server software: Windows Server (http://www.microsoft.com/server), Novell Netware (http://www.novell.com), and Linux (http://www.linux.org). I listed them in order of "ease of use." If you want to try your hand at administering your network, go with Microsoft. Only computer gurus should attempt to use Linux.

Three other terms you need to know: LAN, WAN and MAN. All three are acronyms. LAN is short for "Local Area Network." Whenever a computer is connected to a network that consists of computers in one office or building, they are said to be on the LAN. WAN is short for "Wide Area Network." WANs typically connect LANs over long distances. For instance, XYZ Corp. has offices in Los Angeles, New York and Amarillo. Each office has their own LAN. These LANs are connected to each other to create a WAN.

The term, MAN, is relatively new. It stands for "Metropolitan Area Network." Typically installed by large cities, MANs connect multiple businesses in an area to foster electronic commerce. MANs are usually funded by tax

dollars and administered by city employees. That leaves us with the last three terms you've probably heard bandied about: Internet, Intranet, and the newest one, Extranet. We've all heard of the Internet. Essentially, the Internet is the largest public WAN on the planet. Anyone can

connect to it. Today, most companies have set up Intranets. A company Intranet operates just like it's older brother, but is only accessible by employees of the company. Large corporations are putting employee handbooks, policy manuals and other resources on their Intranets, instead of printing them.

An Extranet is simply a multi-company Intranet. Certain vendors and suppliers might set up extranets with their customers to facilitate product ordering. Off-limits to you and I, these networks exist on the Internet, but are only accessible

by certain companies. Over the next few years, networks will change. Look for data to merge with video and voice. Your computer, telephone and television may someday be the same device ...

One final note: All of the vocabulary terms you saw mentioned in this article are clearly defined at one of my favorite Web sites: WhatIs? (http://www.whatis.com).

N.M. cavers chart unique 'snowy' river of crystals

beneath Earth's surface, a few seasoned cave explorers venture where no human has set foot. Their headlamps illuminate mud-covered walls, gypsum crystals and mineral deposits.

The real attraction, though, is under their shoes. A massive formation that resembles a white river spans the cave's floor. A closer examination reveals that the odd formation is an intricate crust of tiny calcite crystals.

The explorers have reached Snowy River — thought to be the longest continuous cave formation in the world.

"I think Snowy River is one of the primo places underground in the world and there's still so much left that we haven't discovered. ... We don't even know how big it is," said Jim Goodbar, a cave specialist with the federal Bureau of Land Management.

The survey expedition by members of the Fort Stanton Cave Study Project in early July added several thousand feet to the measurement of the spectacular formation, which is at least four miles long. The explorers who have been following the passage under the rolling hills of southeastern New Mexico say there's still more of Snowy River to be discov-

The few who have walked on the formation say they've seen nothing else like it. Early studies point to its uniqueness: Already, some three dozen species of microbes previously unknown to science have been uncovered.

New Mexico's two U.S. senators are pushing for Congress to designate Fort Stanton Cave and Snowy River as a national conservation area. The designation would protect the area from such activities as mining that threaten the water flows that created the cave. It also might generate funding for scientific research.

"It's certainly a national treasure and very well worth protecting in its own right, even without Snowy River. With Snowy River, it puts it in the class of world-class caves," said

Bale asks for privacy after assault allegations

(AP) — Batman star Christian Bale asked for privacy Thursday in his first comments since allegations he assaulted his mother and sister at a London hotel, saying the incident was person-

The Welsh-born actor brushed off questions about the alleged family dispute, saying he preferred to focus on the blockbuster movie "The Dark Knight," which had its premiere in Spain on Wednesday.

"It's a deeply personal matter," Bale told The Associated Press at a news conference at a luxury hotel in Barcelona. "I would ask you to respect my privacy in the matter.

The 34-year-old actor spent four hours talking to British police Tuesday following allegations he assaulted his mother and one of his three sisters in his suite at London's Dorchester Hotel two days earlier. He was released on bail, but not charged.

Bale has said through his lawyers that the assault allegations were false.

British media reported that Bale's mother and sister told police he assaulted them at the hotel a day before attending the European premiere of "The Dark Knight." The Sun newspaper said the complaint was filed by sister Sharon Bale and mother Jenny Bale.

The drama unfolded even as the movie broke records Paul Haven reported from and was met with critical Madrid.

"It was an iconic portrayal of The Joker," Bale said, adding Ledger's character had embodied "an agent of chaos.


Bale said he tried to add an edge to his portrayal of Batman as well, inspired by the superhero's complex and mysterious character.

In Portland, parking laws include police

 Portland police are not above the parking laws, even if they're hungry.

Officer Chadd Stensgaard, who parked his patrol car illegally while making a dinner-break stop at a Japanese restaurant, must pay a \$35 fine, Traffic Court Judge Terry Hannon ruled Wednesday.

The infraction came to light thanks to Eric Bryant, who was at the restaurant friends when Stensgaard parked in a curbside no-parking zone. Bryant, an attorney, filed a citizen complaint against the officer in March.

About five minutes after the officer arrived, Bryant walked up to him and told him he was parked illegally. "He told me he was allowed to do so," Bryant testified. "I responded, 'No, you're not.' I told him he was an officer of the law. He's not supposed to break the law. He's

PORTLAND, Ore. (AP) supposed to enforce the

Oregon law allows emer-

gency responders to park in no-parking zones when responding to emergencies or chasing suspects. The law says nothing about sushi. Stensgaard testified that

he needed to park his car close by in case he had to respond to an emergency call. He declined to comment after his defeat.

Portland police leaders say they plan to ask city commissioners to make it legal for officers to park in no-parking zones when ordering food or stopping for a restroom break.

Bryant, meanwhile, saw the ruling as a victory for those who don't carry a

badge. "I tried to represent the interests best Oregonians," Bryant said. "And I believe that Oregonians believe police don't get to ignore the law."
