Fifty Years Later, A rematch with **Dell City**

The school colors were different. The team was known as the Gail Covotes rather than BHS. And, the game was played in Pyote instead of Pecos.

What remains the same is that the 2006 version of Coyote football will once again meet Dell City in an important football gameone that will determine who advances in the state six-man playoffs.

On November 28, 1957 (Thanksgiving Day), Borden County and Dell City met for what would be the ultimate trophy for that time: the Region 2B Six-Man football championship.

Gail, as the team was called, reached the final with a 26-6 win over Sterling City. Dell City earned their spot with a 62-24 win over Pyote.

Pyote, though, would get to host the big championship

It was a town with some rich history, thanks to the Army Air Corps Rattlesnake Bomber Base.

According to the Handbook of Texas Online, the base closed down after WWII and many bombers and fighter planes were sent to Pyote to be melted into scrap metal.

Among the planes stored there were the Enola Gay of Hiroshima fame and General MacArthur's plane, the Swoose. (Those planes were rescued by the Smithsonian).

With a neutral site at Pyote set, the Coyotes set their sights on their first region crown under Coach Eddie SWEET VICTORY

Coyotes broke a 30-30 tie in the third quarter and then romped to a 64-42 win over Dell City.

Borden County Coyote football team won its first post season football. game last Friday night in seven years. The Coyotes defeated the Grandfalls-Royalty Cowboys by a 2 point extra point kick, 48 to

The Coyotes took the ball first and failed to move the ball at all and turned the ball over to the Cowboys on downs at mid-field. The Cowboys had a long run that looked like it would score when Quentin Shafer knocked the ball from the Cowboy runner and Michael Bullinger recovered it on the 2 yard line. On the next play Bullinger broke a couple of tackles and returned the ball 78 yards for a touchdown. The PAT kick was missed and the Coyotes took the lead with 7:26 left in the first 6-0

With 2:09 left in the first period the Cowboys scored their first touchdown and kicked their extra points good to take the lead 8 to 6.

The Coyotes scored next with 9:10 in the second period as they capped off a drive when Bullinger ran the ball over from the one yard line. The PAT kick failed and the Coyotes regained the lead 12 to 8.

With 7:49 left in the second the Cowboy tailback ran into the end zone from 2 yards out, their PAT kick was good and the Cowboys took the lead 16 to 12.

The Cowboys scored again taking a 10 point lead on the Coyotes as the Coyotes blocked their extra point kick. The Cowboys extended their lead 22 to 12.

With 0:48 seconds left in the first half the Bullinger carried the ball over from the 5 yard line. Bullinger kicked the PAT good to bring the Coyotes back to with 2 points 22 to 20.

In the third period each team took turns with the ball before the Coyotes scored with 5:48 left when Clint Chapman hit Michael Bullinger on a perfect strike for a 59 yard catch and run in to the end zone. Bullinger kicked the PAT good and the Coyotes took the lead 28 to

On the Coyotes next play the Coyotes decided to check out the Clint Chapman to Shafer combination and on a similar play these two connected again on first down for a 45 yard touchdown reception. With 1:16 left in the third period the PAT kick failed and the score was 42 to 34.

teams would exchange the ball before the Cowboys would score with 3:26 left in the fourth period on a 5 yard pass completion. and the Coyotes led 42 to 40.

With 1:58 left in the game on 4th and 14 from around mid-field the Coyote Quarterback Clint Chapman hit Bullinger on a swing pass for a catch and run from 46 yards out. The Coyotes made the decision to go for one point to go up 9 points instead of kicking the ball to go up two. The decision did not pay off as we were tackled short of the goal line and the Coyotes led by only 8 points with less than two minutes left. The Cowboys could score and kick the extra point over and send this game into overtime.

It looked as if the Coyotes would stop the Cowboys with out a first down, but on 4th a 15 from around mid-Cowboys again via Quentin field the Cowboys dumped Shafer's twelfth interception the ball off to their back with a cast on one arm and he was hit by three Coyotes and it looked like he would be short. A very benevolent spot by the official gave the Cowboys new life and a first down. With just 0:27 seconds left in the game the Cowboys would score on a 5 yard pass reception. It was now all up to the kick: the snap was high the kicker refused to kick it so they rolled out, pitched it, and attempted to run it over for one point which would not be enough to win. The attempt was short as they were tackled out of bounds at the two yard line. All the Coyotes had to do was recover the on-side kick and the game would be over.

The on-side provided a bit of drama as well as the kick was punched over to our weak side and the kicker was first to get to it, he rolled over on the ball but it came lose as he was tackled by Flynn Chapman. The ball seemed to lay there for hours Their kick failed on the PAT but it was probably just a

second before Rodriguez was there to cover it. All the Coyotes had to do now was kneel the ball one time, the clock would run out and the game would be HISTORY.

Zane Williamson caught 5 passes for 57 yards, and he had 8 tackles on defense and broke up one pass.

Flynn Chapman caught 4 passes for 41 yards and he had 8 tackles and one hurry on defense.

Michael Cooley had 6 tackles on defense had one hurry and one quarterback sack as he wreaked havoc on the Cowboy quarterback.

Asa Rutherford had 6 tackles on defense as he played safety in the Coyotes cover two.

Miller Valentine saw time in the game as the deep snapper for the extra point team and the punting team.

"The Coyotes totaled 450 yards of offense, 350 of it through the air completing 19 of 26 passes with no interceptions. We did pick off one of theirs and they lost a fumble and we did not. We won the penalty category with 9 flags called against us for 85 yards and several calling back touchdowns. There were 3 penalties against the Cowboys for 20 yards. We punted the ball 3 times for an average of 20 yards and the Cowboys punted once for 39 yards. The Cowboys rushed for 262 yards and completed 15 of 32 passes for 191 yards for a total of 453 yards of offense.

It was a pretty even game, sometimes it is better to more lucky than good but the kids fought hard and never let up as they battled the Cowboys to the bitter end and came out with a two point victory. What a game.




