Information Items That Pertain To The 2000-2001 School Year Are as Follows:

1. High school students and new students will be allowed to continue early registration from now until the end of the day on Friday, August 11th. Early registration hours will be from 9:00 a.m. to 5:00 p.m. each day at the school principal's office.

2. Classes will begin at 8:05 a.m. and dismiss at 3:33 p.m. each day. Please note that students are not to arrive at school prior to 7:50 a.m. unless arrangements have been made with the school principal.

3. Buses will run according to the above schedule. Bus transportation will be provided for students living east of Highway 669 and south of Highway 180 for students living within the 2 mile radius of the Borden County School. Bus routes will be modified or not traveled when weather conditions warrant or the safety of a child has the potential to be compromised according to the discretion of the school administration or bus driver. Buses will not arrive at school prior to 7:50 a.m. unless circumstances create a situation that causes a bus to arrive earlier than this specified time.

4. Season tickets for home athletic events may be beginning August 15, 2000, in the purchased superintendent's office or at the first home football game. The price for season tickets will be \$20.00.

5. School annuals may be purchased in the superintendent's office for \$20.00.

6. An official school calendar, a tentative class schedule for grades K-12, and a list of recommended school supplies for grades K-5 are listed in this week's paper. You will be notified of changes in the school calendar during the school year as a result of inclement weather or other unforeseen circumstances.

7. Delays in the start of school, early dismissals, and school cancellations that take place as a result of inclement weather will be reported as early as possible to the following area televisions and radio stations: KAMC TV Channel 28 in Lubbock, KLBK TV-Channel 13 in Lubbock, KCBD TV Channel 11 in Lubbock, KBYG Radio Station-1400 AM in Big Spring, KPET Radio Station-690 in Lamesa, KSNY Radio Station-1450 AM and FM in Snyder, KVOP Radio Station-107.3 FM,107.3, KLLL Radio Station-590 AM and 96.3 FM in Lubbock.

8. Breakfast service will begin at 7:50 a.m. each morning. It also needs to be emphasized that all students and families will need to return the free and reduced lunch application with the proper information completed. We are revising our cafeteria program, and the federal rules require a response from every family and/or child. Therefore, everyone will need to return these applications as appropriate. If you are not interested in obtaining free and reduced lunches simply write your name on the form, write "NO", and return the form to the principal's office. In addition, please do not send any money for your child's meals during the first two weeks of school. We will need to complete our enrollment period prior to determining meal prices.

The Borden County Independent School District offers a choice of healthy meals each school day. Children may buy lunch for \$1.00 and \$1.25 and breakfast for 50 cents. Children who qualify under U. S. Dept. of Agriculture guidelines may get meals free or at a reduced-price of 40 cents for lunch and 25 cents for breakfast. All meals served must meet nutrition standards established by the U. S. Department of Agriculture. If a child has a disability, as determined by a doctor, and the disability prevents the child from eating the regular school meal, the school will make substitutions prescribed by the doctor If a substitution is needed, there will be no extra charge for the meal. Please note, however, that the school is not required to make a substitution for a food allergy, unless it meets the definition of disability. Please call the school for further information; telephone number 806-756-4313.

Your children can get free school meals if you get food stamps or Temporary Assistance for Needy Families (TANF). Depending on your income, your children may be eligible for free or reduced-price meals.


