

Helping kids deal with the tragedy of terrorism

In the wake of terrorist attacks on the United States, Americans are struggling with feelings of shock, fear and helplessness.

Children are most vulnerable during this time to the effects of the violent images they see on television. It is important for parents to pull themselves away from the new coverage, turn the television off, and talk to their families, according to Dr. Steven Pierrel, a psychologist and an associate • professor with the department of family and community medicine at Baylor College of Medicine.

"W need to listen to the concerns of our children and learn what meaning they are attaching to these events."

Pierrel said. "It is our responsibility to talk with them, share our perspective and provide a place of comfort and security as they come to grips with these tragic events.'

There are several ways parents and others who care for children can help alleviate the emotional consequences of trauma, including the following tips provided by the American Psychological Association.

Spend more time with children and let them be more dependent on your the during months following the trauma for example, allowing your child to cling to you more often than usual. Physical affection is very

comforting to children who have experienced trauma.

- Provide play experiences to help relieve tension. Younger children in particular may find it easier to share their ideals and feelings about the event through non-verbal activities drawing.
- Encourage older children to speak with you, and with one another, about their thoughts feelings. This helps reduce their confusion and anxiety related to the trauma. Reasons questions in terms they comprehend. Reassure them repeatedly

Waving the flag

Thousands of flags were sold this past week as Americans rushed to show their national pride in the aftermath of the terrorist attacks. From homemade flag pins to flags hanging over porches and out windows, every American is relearning an important civics lesson: how to display the American flag.



To hang a flag in mourning, hoist the flag to the peak of the pole for a moment and the lower it to half staff. When lowering the flag, raise it to its peak briefly before lowering it completely.



If you display the flag against a wall (like hanging it flat outside a window), the union stars should be on the flag's right or the observer's left side.



If the American flag is flown with other flags of states or localities, the American flag should always be at the center and highest point.



When the flag is displayed on a car, the staff should be attached to the right fender.



- To display the flag over the middle of a street, it should be suspended vertically with the union to the north in an east-west street or to the east on a north-south street
- Never hang a flag with the union down, except as a signal of dire distress or danger to life.
- The flag should not touch anything beneath it, such as the ground, water or floor.



individual When an representing a charity knocks on the door, sends emails or calls on the phone pleading for a charitable donation to help victims, Texans should take the time to ask a few questions before offering a donation. Here are a few tips to avoid falling victim to email scams:

- Well known national organizations do not send unsolicited emails requesting donations unless the person has had contact with the organization in the past. Be wary of these kinds of requests. If a solicitation seems suspect, do not donate. Forward the email to the Attorney General's Protection Consumer Office at the address listed above.
- When clicking on a link to allow for a donation, look at the organization's URL I the browser window. If the domain name of the URL is hidden, is unfamiliar or is not the same as the link's text, the request is likely a scam.
- Verify the charity's identity by phone before donating online. Many phony charities imitate the name and style of a well-known charity in order to con people.
- Be wary of appeals that

are long on emotion and . short on descriptions about providing help to those in need;

- Be alert to questionable charities using names that closely resemble those of well-known charities;
- If the charity the person represents is not recognizable, it could be a fraud. Verify the organization he or represents by asking for credentials, including exact name and phone number of the organization, particularly if the charity is unfamiliar;
- Find out the planned uses for the money to be donated. Will proceeds directly benefit those in need? What portion of the contribution will toward the charitable purpose to be supported?
- Call the charity and confirm that the solicitor is connected to it;
- legitimate charity A background welcomes checks on their operations. Don't succumb to high-pressure tactics and demands for an immediate decision;

- Never give credit card or social security numbers to a telephone solicitor;
- Never give cash. Write a check in the name of the charity, not the individual doing the asking, and get a receipt.

The Attorney General's Office also cautions concerned citizens wishing to do their part by raising funds for disaster relief. Certain legal requirements for fund raising efforts should be followed, including the registration of public safety groups like firefighters' organization.






