Micah, currently a junior at Borden High School, won three of four journalism events this ,past Saturday at the Red Raider UIL Invitational Meet held at Texas Tech.

And, it was at Texas Tech that her cousin Laura, 1996 BHS grad completed a journalism degree two years ago.

Now both cousins are being rewarded for using their writing talents.

Micah's accomplishment Saturday was noteworthy in that she not only won first place in news writing, editorial writing, and headline writing, but she also finished $2^{\text {nd }}$ in feature writing, competing against AA and AAA schools.

Her performance earned her the high-point individual trophy for the entire meet, accounting for 57 of Borden High School's 85 points*

Laura, too, participated in UIL journalism in high
feature and news writing, advancing to regional in both events multiple times in high school.

She spent some time working in the summers for The Borden Star, served as an editor for Tech's University Daily, and now is employed as a staff writer for The BryanCollege Station Eagle.

This past October, Laura, the professional journalist of the family, experienced an early-career highlight as well.

Her feature story, "The Sport of Kings," was one of only three nominated (in its circulation category of 25,000 ) by the Press Club of Dallas, who annually hands out the Katie Awards for excellence in journalism.

These awards are not restricted to Texas either but encompass a five-state regional market from which nominations are pulled.

Laura was invited to attend the November 10 banquet at the Fairmont Hotel in downtown Dallas.

Ironically, her feature was a follow-up to a story Laura had done about girls trying to break into the high school six-man football ranks.

She interviewed girls and women who actually
have played football, including the first woman to have ever played in the United States.

Though Laura did not win this year's Katie Award, she no doubt has established herself as a talented journalist in this genre.

## Comptroller Rylander Expands Online Sales Tax Filing to all Texas Businesses

Making good on a promise she made when she launched her e-Texas initiative, Texas Comptroller Carole Keeton Rylander announced that all Texas businesses may now file sales tax returns onlilne, using the Comptroller's WebFile system.
"If all Texas businesses paid their sales tax online, the paper alone that we would save would reach seven times the distance from the floor of the Capitol rotunda to the top of the dome," Comptroller Rylander said.
"When I announced my eTexas initiative, I vowed to expand the use of technology to cut costs and improve the quality of service to
taxpayers. WebFile makes it easier for businesses to file tax returns and saves the state time and money," Comptroller Rylander said.
To use WebFile, a taxpayer completes an online sales tax return, and the computer checks the electronic form for errors and calculates the amount of tax due. The taxpayer has two options to submit his payment: pay the tax with a Discover or American Express credit card, along with a credit card service fee, or have the payment deducted electronically from his bank. If he uses electronic funds transfer, the taxpayer can select a date, on or before the due date, for
the sales tax to be automatically paid.
"With WebFile, there' no check to write, no papers to fill out, no trip to the post office or concern about mail delivery," Comptroller Rylander said. "WebFile is quick, convenient and secure, and I urge every sales taxpayer to take advantage of electronic tax filing."
Each year, the Comptroller's office processes about 2.6 million sales tax returns filed by more than 615,000 businesses. More than 100,000 businesses already use electronic tax filing.

## Season Record Now at 22-5 Playoff-Bound Lady Coyotes Down Grady, Ira to go 6-0

With a win over Sands this week, the Borden High School Lady Coyotes will clinch yet another district title.

After last week's decisive wins over Grady, 50-37, and Ira, 61-32, the Lady Coyotes are primed for a run at another playoff season.

A determined Grady team kept it close in the first quarter, trailing BHS by only one, $8-7$.

Coach Bobby Avery's troops were doing fundamental -things well, but cold shooting prevented a larger lead. BHS was 3 -of- 13 from the field in the first quarter.

The visitors kept at the Lady. Coyotes in the second quarter, beating BHS on transition plays to pull ahead at the $5: 42$ mark, 12-11.

Junior Bobbie Kempf came out after a time out with 2:00 remaining in the half to hit two baskets, one of those on a textbook give-and-go assist from Micah Hensley to make it a 23-18 Lady Coyotes lead.

Bobbie's sister, Dalene, scored on a similar pass from her twin at the start of play in the second half, pushing the lead to 25-18.

Junior Kylia Culp would get in on the action by scoring her first points of the night on a drive to the bucket at the $6: 43$ mark to put BHS up 2718.

What turned out to be an important $8-0$ run was completed when Bobbie hit two more shots to increase the margin to $31-18$ with $4: 32$ remaining in the third quarter.

The biggest lead of the night would come at the buzzer to end the third

## Physical inactivity, bad diets harm kids

An epidemic is taking years, even decades, off the lives of Texas' children. It is largely preventable, yet statistics show each year the nemesis is winning, and kids are losing.
The epidemic is an unhealthy combination of physical inactivity, obesity, poor diet, and unhealthy cholesterol levels, and it is threatening kids' health and making them vulnerable to diseases more commonly associated with adults. Inactivity
As many as one-quarter of Texas elementary school students are clinically overweight, and for many it's a result of unhealthy lifestyles. The problem begins with physical inaetivity. Research shows millions of children aged 8 to 16 watch at least 2 hours of television every day. Habits like watching television or playing a computer game occupy time that kids could otherwise spend running, playing, and being physically active-burning calories instead of just burning time. U.S. Surgeon General David

Satcher reports nearly half of the young people aged 12 to 21 are not regularly vigorously active.

## Obesity

There is $s$ correlation between being a "couch potato" and having health problems. Studies show the more time children spend watching television, the greater the number of kids who are obese. This is a growing trend, as the percentage of overweight children has nearly doubled in the past 20 years. And while that number continues to grow each year, so does another threat. Temple cardiologist Jim Rohack, MD, sees a relationship between diet, inactivity, and cholesterol levels. "For children who are living in western cultures where things are 'supersized' and activity is less, cholesterol levels are increasing."

## What's Cholesterol?

Cholesterol is a substance found in the fats carried in the bloodstream. It performs necessary functions, bu8t can be harmful when it concentrates at excessive

levels. The two most common types of cholesterol are HDL and LDL. HDL (high-density lipoprotein) is considered beneficial because it id believed to carry clogging cholesterol away from arteries, to be eliminated from the body. LDL (low-density lipoprotein) is often considered "bad" cholesterol because too much of it can begin to build up in the body's arterial walls and combine with other substances to crate "plaque," a thick deposit that can clog arteries. That clogging is called "artherosclerosis," or a term some have associated with illness in older people, "hardening of the arteries." Recent studies, however, have found artherosclerosis in children.
Since atherosclerosis is known to lead to heart attacks and strokes in adults, that's a threat for children as well. This summer a south-central Texas youth died of a heart attack after football practice, which Dr. Rohack sees as a warning. "This early

## An Intelligent Pet Owl

Harry Potter is not the only one with a pet owl. Ron George had on when he was growing up around Commerce.
"It was a barred owl," says Ron. "Most remarkable."
Unlike Harry Potter's owl named Hedwig, Ron called his owl Tex.
Ron says this was before the hawk and owl protection act went into effect in 1965 . Ron knows about things like that. He's deputy director of the Texas Parks and Wildlife Department.
"My brother got Tex out of a nest before it could fly. He brought it to the house and put it on a perch outside the kitchen window."
The owl certainly became a member of the family in a big hurry.
"It would sit on that perch quietly during the day, then in the evening when it got hungry it would call a real soft feeding call two or three times."

Ron can make the sound of the call. I can only describe it as the sound of a hungry owl.
"If somebody didn't come out to feed it, it would fly over and land on the screen window. It would land at the bottom of the window and walk up the screen flapping its wings. Then it would fly back to its perch."

His mother was pretty quick to get out there with the owl food after that.
"That owl lived in the yard and flew around the property. It didn't know how to hunt. Didn't need to, since we fed it. Onetime it caught a small snake about a foot long and brought it to its perch by the kitchen window. Tex was real proud of it and showed it
off. He carried it around for a day or two before he actually ate it."
Ron milked cows in those days and would walk up to the barn early in the morning. He didn't carry a flashlight, since he knew the trail by heart.
"I was walking up that trail one morning way before daylight and the owl flew up behind me and got directly over my head. I didn't have any idea it was there. Owls are totally silent on the wing. Then it came out with a piercing, loud call that really scared me. I threw my hands up in the air and the milk bucket went flying off and I reached up, touched some owl feathers and then felt something land on top of my straw hat. I put my hand up there and it was a cold, wet piece of liver. It was the owl's food from the night before. He hadn't eaten it. I. guess owls, have a sense of humor."

Tex didn't have anything to do with strangers. When somebody would come, he would leave. But he had a
fetish for steering wheels.
"One day we had a plumber who did some work, then went to his pickup to leave. He came running back to the house telling us there was an owl sitting on his steering wheel. We told Tex to get off and he did."
When Ron's wife started coming around, Tex didn't take to her at first. "He swooped down at her a couple of times. Tex got in her face-once, then she whacked him with her hat and it didn't bother he any more after that.'
Tex stayed around the George house for ten years.

## Say good-bye to dry skin this season

When winter temperatures leave you singing the dry jkin blues, small changes in your daily routine can make a jig difference.
"Dry skin is a problem for nany people during the winter months," said Dr. Ida Jrengo, an associate proessor of dermatology at Baylor College of Medicine n Houston. "When humidity lecreases, the air becomes trier, which can cause skin to secome dry and flaky."
Lotions typically fall into one of three categories liquid, cream and ointment. All help the skin to retain moisture. When choosing moisturizers, lotions are good for use over the entire body since they are easier to apply and don't stain clothing as nuch as creams. Creams are jetter for localized areas such is the hands, feet and face jecause they last longer on he skin. Since ointments are thicker and greasier, they are nost appropriate for excepionally dry areas and are best to apply at night to avoid soiling clothes.
"The best time to moisturize is right after your shower because the skin is more receptive to moisture since the pores are opened up," Oregon said.
Oregon offers the following tips for beating dry skin:

- Take lukewarm showers that last no longer than five minutes. Long, hot showers can strip the skin of natural oils.
- Avoid using pure soap. Instead, opt for one with a moisturizer or use a soap substitute.
- Minimize the use of soap. Use soap under the arms, in the groin and on the feet. Running warm water over the arms, chest and back are enough to clean these areas.
- Soak in a medicated bath such as an oatmeal bath for fifteen minutes. This helps to control itching that results from dry skin and helps to moisturize.
- Use a moisturizer two to three times per day if necessary. People who work closely with the public and have to wash their hands several times
per day should re-apply lotion after every washing.
Try not to stress. Controlling stress is essential for maintaining healthy skin.
"It is important to follow a good diet to avoid drying out the skin," Oregon said. Low fat diets can sometimes cause a person to lose essential fatty acids that help to moisturize skin."

The WebFile program began in 1998. At first, it was available only to businesses that collect no sales tax during a reporting period In October 2000, WebFile became available to short form sales tax filers - mainly businesses that have only one location.
Now, the expansion of the program is complete, and all businesses that report sales tax are eligible to use WebFile, no matter which paper form they currently
use.
"Every business that collects sales tax, from the ice cream vendor in the park all the way up to the big department store chains, can now use WebFile to report and pay sales tax 24 hours a day, 7 days a week." Comptroller Rylander said.
Sales taxpayers can access WebFile through the Comptroller's Web site www.window.state.tx.us or through the state services Web site www.texasonline.com.

evidence of plaque formation just highlights the concerns of having high cholesterol levels, having early plaque being formed, now having 14 year-old kids dying of heart attacks while participating in sports. If you don't pay attention to the storm clouds that are coming, you're going to get wet," he said.

- Total cholesterol levels less than 200 milligrams per deciliter
- LDL of less than 130 $\mathrm{mb} / \mathrm{dL}$
- HDL greater than 35 $\mathrm{mg} / \mathrm{dL}$

Exercise not only helps reduce excessive weight, it also helps increase the HDL (good cholesterol) level in most people, and higher HDL levels seem to help protect against heart attack and stroke, while high LDL (bad) levels are associated with increased risk, of those diseases.

What you can do
The physicians of the Texas Medical Association want you to know that it is very important to have a good relationship with your family physician or pediatrician, who can help monitor your child's weight and cholesterol levels. If your child is physically inactive, gaining weight, and his or her cholesterol level is high, he or she is at risk of developing more serious health problems later in life. To help, TMA developed a public-awareness program called Project WATCH, an abbreviation for the major factors that influence the risk of heart attack and stroke, Weight,

Activity,
Cholesterol, and High blood pressure. TMA also endorses CATCH, or Coordinated Approach to Child Health, an innovative and proven program which coordinated school-wide efforts to provide nutrition and fitness education, as well as healthier eating and exercise habits in the lunchroom and at home.

Start early by encouraging your child to exercise and be physically active, eat a healthy diet, and monitor hís or her cholesterol and weight, and you will be building a healthy foundation for a lifetime.

## COLORADO RIVER MUNICIPAL WATER DISTRICT RULES AND REGULATIONS AS ADOPTED BY THE BOARD OF DIRECTORS DEC. 12, 2001

The Board of Directors of the District shall have the power to adopt and promulgate all reasonable regulations to secure, maintain and preserve the sanitary condition of all water in and to flow into any reservoir owned by the District, to prevent waste of water or the unauthorized use thereof, to regulate residence, hunting, fishing, boating, and camping, and all recreational and business privileges, along or around any such reservoir and the Colorado River and its tributaries, or, any body of land, or easement owned or controlled by the District.
An Ordinance enacted by the Board of Directors of the Colorado River Municipal Water District adopting Rules and Regulations under the powers and provisions of Chapter 12, Title 128 (Article 8280-137) of the Laws of the State of Texas and Chapter 51, Title 4 (Texas Water Code, Section 51.127 et seq.) providing for and to:
Regulating toilets and sewage disposal; regulating industries upstream from the lakes and reservoirs; regulating garbage and trash disposal; requiring permit for any construction on lands bordering on the lakes and reservoirs owned by the District and covered by flowage easements held by the District.
Requiring certain standards of safety, size, construction, equipment, and occupancy of boats; providing for the removal of boats in violation of applicable provisions; providing certain sanitary standards for boats having overnight accommodations; defining certain types of boats and docks; providing that the Texas Boat Safety Laws apply to the lakes or reservoirs.
Requiring permit for operation of commercial activities on waters of District owned lakes and reservoirs or lands owned by District and providing for concession areas.
Providing for the inspection of boats and other floating devices on the District owned lakes and reservoirs for sanitation and safety; providing for certain recreation permits and fees to be charged by the District for access to boating, fishing, skiing, surfboarding, camping and picnicking on the lakes and reservoirs or in designated recreation areas adjoining the lakes and reservoirs; providing for certain exemptions.
Regulating the use of firearms, fireworks, and pellet and BB guns on District owned land, lakes, and reservoirs.
Providing that State Laws regulating fishing in Borden, Coke, Coleman, Concho, Howard, Mitchell, Runnels, and Scurry Counties shall apply to District owned lakes or reservoirs located therein.
Providing for the establishment of code enforcement officers and defining the powers of such officers.
Regulating the construction of piers and wharves, floats, and boathouses.
Regulating the anchoring of rafts and floats.
Prohibiting the anchoring of boats, trot lines, and other apparatus to buoys, floats, and boathouses owned by the District.
Prohibiting the discarding of cans, bottles, and rubbish into or on the waters of District owned land, lakes, and reservoirs.
Providing a time limit for camping in public areas.
Providing certain penalties for violation of the terms of this Ordinance said penalties shall not exceed fines of Two Hundred (\$200) Dollars or imprisonment of more than thirty (30) days.
Providing for structures to be built on areas covered by a flood easement granted to the District: (a) Lake J.B. Thomas between Elevations 2258.00 and 2265.00 mean sea level; (b) E.V. Spence Reservoir between Elevations 1900.00 and 1912.00 mean sea level; and (c) O.H. Ivie Reseryoir between Elevations 1555.00 and 1567.00 mean sea level. Providing for pumping of water for personal and private use.
Providing for pumping of water for commercial use.
Providing for the changing the water line of District owned land and water.
Providing for impounding abandoned property on District owned land, lake, or reservoir areas.
Providing for speed limits on District owned lands, lakes, and reservoirs, and the prohibition of ATV use by the general public on District property.
Prohibiting the entry onto private lands to fish, camp, and picnic.
Providing for the repeal of conflicting Ordinances.
Providing a severability clause.
Providing for the lawful publication of this Ordinance, and fixing of the time at which this Ordinance will be in full force and effect.
Providing for rules and regulations governing public access to O.H. Ivie Reservoir Wildlife Management Areas (WMA).
Requiring permits for WMA limited use activities by the general public and providing for fees thereof.
Requiring permits for WMA public hunting and providing for fees thereof.
BE IT ENACTED AND ORDAINED BY THE BOARD OF DIRECTORS OF THE COLORADO RIVER MUNICIPAL WATER DISTRICT.
