It's been a few years since any debate team from Borden High School has earned the trip to Austin for the UIL State Meet, but Billy Roper and John Wilson have changed that.


The two freshmen will be in Austin March 11 to compete, having won the District 11-A meet with a perfect 6-0 record.

Roper, the son of Juna and William Roper, and Wilson, son of Carol and Tim Wilson, are the first BHS students in over a decade to qualify in an event for which Borden High School has a rich tradition.

During the 1970's, BHS, under the tutelage of Huddleston, enjoyed years of success.

The team of Jim McLeroy and Catherine Jackson brought home the bronze medal in 1975 while Glynda Burkett and Janna Love advanced in 1979 as juniors to win what was then the Class B State Championship.

Junior Bobbie Kempf also named the district' Most Valuable Player for the 2001-2002 school year.



# **Environmental Qualify Incentives Program (EQIP) Colorado Headwaters Geographical Priority Area**

The Colorado Headwaters reduction Geographical Priority Area increased water yields to (GPA) has met with positive reservoirs and permanent conservation results for private landowners. Producers in Borden, Scurry, Mitchell, Howard, Nolan and Dawson counties have taken an interest in the EOIP program since the GPA was developed in 1999. Participating produces have utilized the conservation technical assistance and program cost-share through the USDA-Natural Resources Conservation service (RNCS) and The Upper Colorado soil and Water conservation District to carry conservation measures on their land.

The primary resource concerns are aimed at 3. Treating 40 percent of the improving water quantity and water quality. The program criteria has enabled the GPA producers to conservation applications impacting 127,696 acres. Some of the conservation measures completed have been through the use of brush management, range seeding, and prescribed grazing. By establishing these practices, producers have made accomplishments in sediment

reservoirs, vegetation. Water erosion has been addressed through the use of conservation cropping systems, permanent vegetation and terracing.

GPA goals are specified:

- 1. Reduce excessive erosion on 70 percent of the cropland and 50 percent of the rangeland in the watershed.
- 2. Positively impact the storage capabilities of Lake J.B. Thomas, Lake Colorado City, and Lake Champion by extending their useful life expectancy by the reduction of sedimentation entering the structure.
- rangeland by establishing high quality grass cover.
- achieve 4. Installing water erosion control measures on 70 percent of the cropland in the watershed.
  - 5. Reduce nutrient loading by 50 percent.

Eligible cost-share practices are all structural vegetative practices that will **NRCS** technical meet

standards and specifications. EQIP contracts range from 5 to 10 years. All practices will be eligible for a maximum of 75 percent of the established average cost of the practice. The allocation for 2002 will \$420,632.00. Local SWCD directors for Borden County are Max Jones and John Anderson.
