In a state well known for large families, Tawnie Allridge of Lindon, Utah, has the bragging rights earned by birthing 18 youngsters - at once. Tawnie is a Labrador retriever.

All but one of her huge litter has survived.

Research indicates the only dog who has given birth to a larger litter is a Saint Bernard in England, who gave birth to 24. Several of those puppies died.

## Lack of search warrant gets drug charge dropped

Two charges — one drug-related and one firearm-related against Lionel Ray Attaway were

droppped Wednesday in 287th District Court.

The drug-related charge, possession of methamphetamine, was dropped because the court ruled that investigating officers did not secure a search warrant when they

should have.

The other charge, felon in possession of a firearm, was dropped because Attaway's friend, Shane Fuller of Clovis, testified that the gun found during a May 13 traffic stop on American Boulevard belonged to him, not Attaway.

The action came during a pretrial hearing on a motion by Attaway's attorney to suppress evidence found during a second

examination of items found in the vehicle Attaway was driving.

Judge Gordon Green ruled that the initial traffic stop — based on a tip called in from Lamb County regarding a possibly intoxicated driver — was acceptable even though the local officers followed Attaway's pickup for some time without observing any erratic driv-

He also accepted an initial search

of the pickup cab by Bailey County Sheriff Coy Plott and an inventory of items in the pickup, which followed the policy of the sheriff's department.

The inventory uncovered no evidence of drugs in the vehicle, but while Attaway was being booked officers found an electronic scale and a notebook in one of the

# Board sets bond issue at \$3.4 million

The Muleshoe Area Hospital District board of directors voted Thursday to approve the issuance of \$3.4 million in bonds to finance construction of a new nursing home in Mule-

The motion to set the amount at that level was made by board secretary Arline Phelps and seconded by board member Mike Miller.


The amount is somewhat higher than recently anticipated, partly because the recommended construction bid is slightly higher than the \$2.5 million that had been planned.

The bid recommended by district administrator Jim Bone was submitted by G. Greenstreet Inc. of Lubbock for \$2.61 million, which jumps to \$2.8 million with the addition of architect's fees, Bone said.

The bid includes a connection for a sprinkler system but not the system itself, nor does it include landscaping.

The board decided to go ahead and issue bonds to cover more than just building costs — including about \$300,000 to go into a fund to cover the first year's payback — after Bone said he estimated the difference in cost to amount to about one patient per month over the life of the bonds.

A groundbreaking date for the new facility has not been

## District 3 six-man all-district list out

The District 3 six-man all-district team ended up like many of the season's games — a shootout among Three Way, Whitharral and Cotton

Lazbuddie managed to fill three slots on the honor team, while Three Way hogged 10.

Lazbuddie did also manage to produce an offensive star, though senior Jeffery Seaton, a first-team all-district running back, amassed 1,273 yards and 16 touchdowns rushing. He also was the Longhorns' extra-point kicker; Coach Mark Scisson said Seaton's point total for the season was 162.

"After Landon (Parham) got injured, Jeff was one of the few players

we had with varsity experience, and he really came through for us," Scisson said.

Also for Lazbuddie, senior Laramie Wood made the first team on defense as a safety.

Wood played only on defense, Scisson said, and had four interceptions and "knocked down a lot of passes." He added that Wood's ability is all the more remarkable because of a childhood accident that left him with only one eye.

Jason Jesko is Lazbuddie's other all-district representative — as a running back on the second-team offensive honor roll.

"Jason was a pleasant surprise," Scisson said. "He was a running back at the start of the season and switched to fullback. I think Jason

did some things he didn't realize he could do."

Jesko ended the season with 613 yards rushing and 11 touchdowns.

While Lazbuddie's season included some tough breaks that kept the record from acquiring its usual luster, he said the enthusiasm is still there.

"Expectations are so high here, and we want to keep it that way," he said.

At Three Way, Coach Jimmy James barely knows where to begin bragging about his Eagles and their improvement over the past four sea-

"Three Way made the playoffs for the first time since 1985," he said.

## Hope Chest aiming for joyous noel

While there's a good feeling to be found in helping the less fortunate at any time of year, the gratification just seems to run deeper during the Christmas season.

Under the auspices of the Bailey County Ministerial Association, organizers of Muleshoe's Hope Chest hope to mobilize community support to help citizens who might "fall through the cracks" of traditional organizations.

A typical case is "Family A." With six children ages 6 to 16, the family has had some rough times.

The mother said she was touched that someone was concerned enough about the family to refer them to Hope Chest, but she said all they really need is jeans for the 6-year-old — "the rest of us are OK."

Another example is "Miss B," an 80-year-old who lives alone with no relatives in Muleshoe and has no income besides Social Security.

"After paying rent, there's not much left to go around," she said — but she's



making it.

She suggested that if someone wants to help her, they might consider getting her some new jeans and a new shirt but especially some warm socks.

And finally, "Mr. C" is a World War II veteran whose wife died about two years ago. Then he lost his home and car in a fire.

"New clothes would be wonderful,"

### Y2K update: Phones should be fine

A coalition of Texas agencies known as Readiness 2000 has provided the city of Muleshoe with pertinent information about many of the issues that concern citizens as the new year approaches.

No. 4 — Telephone service will be available, but the volume of calls could slow the process.

If a caller has trouble getting a dial tone or getting a call to go through during the New Year's holiday, it's not necessarily Y2K-related: New Year's is the third-highest volume day of the year for telephone companies.

Telephone company officials predict that at midnight on New Year's, enough people will pick up the phone to wish friends and family a "happy new millennium" to make that day the secondhighest volume day of the

Because of all the Y2K publicity, it is also expected that a huge number of people will simply pick up their phone receiver at that time to see if it still works.

The anticipated volume of calls could cause a delayed dial tone. If callers pick up the phone and hear nothing, they should wait at least 30 seconds for a dial tone.

suspect's vest pockets.

That led Plott to reconsider his earlier decision not to call in a drug-sniffing dog from Clovis.

It was at that point, Green ruled, that the sheriff's department overstepped its bounds.

"I take full responsibility for that," Plott said Thursday. "I thought once the dog walked around the vehicle and hit on the drugs, we would be OK. We all learned from this."

The dog found methamphetamine in the truck's camper, inside a toy contained in a plastic grocery sack full of trash.

Defense attorney Kathryn Gurley of Friona had asked that the entire traffic stop be disallowed.

She argued that the initial tip was not sufficient grounds for stopping the vehicle 15 or 20 miles farther down the road. She also argued that officers' observation of furtive motions in the cab of the pickup during the stop did not provide ample cause for the stop.

She established that there was no field sobriety test administered to tie the stop to the initial call about an intoxicated driver. She also established that ownership of the gun was not established at the time.

District Attorney Johnny Actkinson tried to shake Fuller's testimony that the .380 semi-automatic weapon belonged to him.

Actkinson asked Fuller to describe any identifying markings on the gun. and Fuller described something similar to "SS" that was inscribed on the gun. Actkinson said the mark was similar to markings found in Attaway's notebook and in tattoo's on Attaway's body, but Fuller said he had not noticed Attaway's tattoos.

Actkinson asked Fuller where the marking appeared on the gun, and Fuller said it was on the handle. Actkinson then held up the gun and showed that the marking was near the tip of the gun.

Actkinson suggested that Fuller didn't know where the marking was because "you've never seen that gun before," but Fuller insisted that he had just acquired the gun when it was confiscated, so he wasn't that familiar with it.

Plott had earlier been ad-

monished by the judge when the sheriff said he had been told the SS or lightning-like marking was a symbol of the Aryan Brotherhood, a white supremacist group with strong membership in some prisons.

In his ruling, Green said that while the discovery of the electronic scales (a type reportedly often used by drug dealers) made it reasonable to go back and search the pickup again, officers were legally bound to secure a search warrant at that point in order to have the right to conduct the further search.

## Arraignments held for those previously indicted

Arraignments were held Wednesday in 287th District Court for several of the people indicted by a grandjury the week before.

Those for whom not-guilty pleas were entered and who were given four more weeks (until Jan. 5) to hire an attorney were:

- · Cynthia Ann Reyna, accused of fraudulent use of a credit card belonging to Celso Gonzales and also forging a check on an account belonging to Israel Reyna Jr.;





ond-team offense as a tight end — "He's one of those kids that got better every day," James said. "He's got great work habits and did a great job blocking."







### NOTICE OF WATER QUALITY APPLICATION **PERMIT NO. 02548**

APPLICATION. Southwestern Public Service Company, P. O. Box 1261, Amarillo, Texas 79170 has applied to the Texas Natural Resource Conservation Commission (TNRCC) for a renewal of Permit No. 02548, which authorizes the disposal of cooling tower blowdown at a daily average flow not to exceed 1,358,000 gallons per day, metal cleaning wastes at a flow of 160,000 gallons per occurrence, low volume wastes and limestone sludge at a flow variable rate, and coal pile runoff at a flow variable rate via evaporation. The applicant operates the Roy Tolk Steam Electric Station. This permit will not authorize a discharge of pollutants into waters in the State.

The facility and disposal area are located on Farm-to-Market Road 2910 approximately three miles south of State Highway 70 and approximately nine and one-half miles east of the City of Muleshoe, Lamb County, Texas. The plant site and disposal area are located in the drainage basin of Blackwater Draw, in Segment No. 1241, of the Double Mountain Fork Brazos River.

The Executive Director of the TNRCC has prepared a draft permit which, if approved, would establish the conditions under which the facility must operate.

PUBLIC COMMENT/PUBLIC MEETING. Written public comments and requests for public meetings may be submitted to the Office of Chief Clerk, at the address provided in the information section below, within 30 days of the date of newspaper publication of the notice. A public meeting is intended for the taking of public comment, and is not a contested case hearing. A public meeting will be held if the Executive director determines that there is a significant degree of public interest in the application.

CONTESTED CASE HEARING. The TNRCC may grant a contested case hearing on this application if a written hearing request is filed within 30 days after newspaper publication of this notice. The Executive Director may approve the application unless a written request for a contested case hearing is filed within 30 days after newspaper sublication of this notice.

To request a hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number, and fax number, if any; (2) the applicant's name and permit number; (3) the statement "[I/we] request a public hearing"; (4) a brief and specific description of how you would be affected by the application in a way not common to the general public; and (5) the location of your property relative to the proposed activity. Requests for a contested case hearing must be submitted in writing to the TNRCC Office of the Chief Clerk at the address provided in the information section below. You must also submit your proposed adjustments to the application/permit which would satisfy your concerns.

If a hearing request is filed, the Executive Director will not issue the permit and will forward the application and hearing request to the TNRCC Commissioners for their consideration at a scheduled Commission meeting.
