6-Man Rarity-Gicklhorn Kicks Field Goal **Another Win for JV Coyotes**

football program is known for its fundamentals, and those fundamentals made the difference Thursday night as the Coyotes used special teams, offense, and defense to win their second game in as many weeks.

The 20-14 victory featured a J. Ryan Gicklhorn field goal-which accounts for four points in six-man football—a 167-yard rushing performance by Garrett Thomas, and some headhunting special teams play by Caden Nowlain, Aaron Pigford, Austin Tarleton, Derek Gwinn, Andrew Lamming, and Gicklhorn.

The Coyotes' first drive stopped by interception, but the defense stepped up to stop Ropesville short in their first possession, too.

Lamming and Thomas stopped the first down play followed by Billy Roper's solo tackle to force a third and long situation.

Tackles by Trey Soto and Gicklhorn up the middle came before Tyler Wallace's sack which led to a nine-yard loss.

Soto pulled a block for Thomas as the Coyotes took over on downs.

On second and ten, quarterback Ben Griffin bootlegged and found Wallace for an 11-yard strike and a first down.

Though the drive stalled inside the ten-yard line, Gicklhorn nailed a 25-yard field goal to give BHS the 4-0 lead with 3:06 remaining in the first quarter.

Nowlain played his trailing position perfectly on the kickoff, making the tackle on the Eagles at their 38-yard

Again, solid defense gave the ball back to BHS as John Wilson and Wallace made big plays in this series to force a Ropes' punt, which Griffin returned for good yardage.

After a Coyote fumble,

With Griffin and Gicklhorn leading the way, Thomas rushed three times in the next drive for over 36 yards, but another interception gave the their own 17-yard line.

It would be Wilson's killer hit on the Eagles' runner with 3:05 left before halftime which led to a Wallace fumble recovery on the 25yard line.

As any coach knows, converting after a turnover is important, especially before halftime, and the Coyotes did just that.

Thomas's 25-yard touchdown run pushed the lead to 10-0, and then Pigford held the ball as Gicklhorn found the middle of the uprights once again for a 14-0 lead.

Facing 4th and 18, Griffin launched a pass that would have given the Coyotes a first down, but it fell incomplete and Ropes took over.

When the Eagles lined up offensively, once again they faced the wrath of the Coyote defense.

Pigford, who had made a touchdown-saving tackle on the previous play, teamed up with Nowlain to stop the next rushing play.

Griffin played off his blocks and made two consecutive tackles, one a sack that led to a six-yard loss and gave the Coyotes possession with 1:10 left in the third period.

Thomas this time took the ball and produced a 48-yard run that showcased his agility and cutback moves and put Coyotes on scoreboard once again.

Gicklhorn's kick was good again as BHS moved out to an 18-6 lead.

Tarleton's pass coverage forced an incompletion in the series while Wilson provided a solo stop as well as an open-field tackle as time expired in the third quarter.

Giffin's tackle on fourth down gave BHS the ball at midfield, but the next offensive drive was halted by fumbled snaps and a penalty.

With just less than four minutes in the game, the Eagles took possession and scored with :38 remaining in the game to cut the margin to 20-14.

Gicklhorn fell on the Eagles' onside kick attempt, and Gwinn did a good job of protecting the ball on the final rushes of the game to run out the clock. finished with 17 yards on the two carries.



Make it two in a row as Coyotes 'STORM' past Ropesville, 57-12

With 405 yards of total offense and six fumble recoveries, the Borden High School Coyotes rode the weather out to take their second convincing win of the young season.

Against Ropesville, BHS used all its weapons to take the win and up its record to 2-0.

Weapon number offense. The Coyotes took their opening drive 72 yards in nine plays, scoring on a 10-yard pass from Brionne Jackson to T.J. Sharp. The PAT kick was good as Sharp made it an 8-0 Coyote lead.

The Eagles would answer, however, on their first possession. The score came on a 37-yard pass play.

BHS did manage to block the PAT and keep the lead, 8-6, with 2:56 remaining in the opening period.

Two more offensive possessions by the Covotes came up short, leaving Ropes with an opportunity to gain momentum.

The defense, though, rose to the occasion when Raul Rodriguez and Adam Carter put a hit on the Eagle runner who fumbled. Andy Lozano fell on the loose ball, but again the Coyotes could not get a drive going.

With 9:23 left in the half, play was suspended due to inclement weather.

Forty-five minutes later, Ropes returned to the field and in less than two minutes had snatched the lead on a three-yard touchdown run.

Trailing 12-8, the Coyotes faced further adversity on the first play from scrimmage after the kickoff.

The Eagles drove down to the Coyote seven-yard line and were facing a 4th and goal with 5:16 left in the finish off the scoring as he second quarter.

The crossroads to the game came—a Ropesville score would have given them a larger lead and more play in the half, Sharp nails a importantly, momentum after solo tackle to force the ball the long delay.

Rodriguez was tackled at the one-yard line, so Jackson handed off to Sharp to finish off the drive at 3:36, pushing the Coyotes ahead by the score of 14-12.

D-E-F-E-N-S-E—a Coyote specialty—made things tough for Ropes in their final drive before halftime.

The Rodriguez brothers and Sharp harassed the Eagles' quarterback, forcing a 3rd and 23 situation from the visitors' 14-yard line.

Ropesville punted, and the Coyotes began one more drive, attempting to score before intermission.

Jackson found Sharp for a 21-yard gain through the air, and Sharp followed with a 30-yard rush down to the four-yard line.

Coyotes back, but a Raul Rodriguez rush and a swing pass from Jackson to Sharp moved BHS down to the 9yard line with :10 remaining.

A dropped pass in the endzone left the Coyotes just short of another score, but it would not matter as the second half saw BHS return with even more intensity.

Raul and Derek collaborated once again as Ropes was forced to punt in their first drive after halftime.

Derek blocked the punt, which Raul recovered, so the Coyotes found themselves once again in great field position.

However, the weather's soggy conditions led to a Coyote fumble, and Ropes retained possession.

Sharp came through again with some great defense as his tackle stopped the Ropes' drive on a 3rd down and 11 next drive. play.

The visitors had to punt once again, and it was a good one for 41 yards, pushing BHS back to their own sixyard line.

No sweat for a Coyote as blocks were made when took Tarleton's handoff to scamper 71 yards for a touchdown.

Even on the PAT, things went well, as the kick was missed, but Kyle Pinkerton made a key block freeing Jackson to find Talin Pepper in the endzone for the extra point.

Pinkerton, playing in his first game since recovering from last year's knee surgery, booted the kickoffs in the second half.

The left-footer booted them in to the endzone to prevent any return, and the Coyote defense went to work again.

Sharp and Raul Rodriguez each regard a sack in this Eagle drive, and Raul recovered yet another fumble, his second of the evening.

With 3:07 left in the third quarter, Jackson handled some heavy pressure to find Raul on a 22-yard pass play.

Facing 4th and goal with 1:51 left, Sharp took the handoff from Jackson and passed to Pepper in the endzone for the 11-yard touchdown strike.

Jackson wasted no time as he found Pepper once again in the endzone for another touchdown.

Sharp's PAT kick was good, pushing the BHS margin to 43-12.

Ropesville went to a spread offense in hopes of moving the ball, but Pinkerton saw to it that the strategy would not

Jackson would do what he had done well all evening on Coyotes' ensuing possession.

It took just two plays, but both passes resulted in big gains and led to another Coyote touchdown.

Jackson first went to Lozano for a 16-yard pickup, and then followed with a 10yard touchdown strike to Sharp.

And worth mentioning, the PAT kick by Sharp was good. Pinkerton kicked off and then made the tackle, too. But, he wasn't finished as he




Though the offense had a temporary setback, defense went right to work.

NOVEMBER 5, 2002

HJR 2 would amend the constitution to allow the commissioners court of a county to

declare the office of constable dormant if that office has been vacant for at least seven consecutive years. The records of a constable office that is declared dormant will be

transferred to the county clerk. If the office is declared dormant, the previous office-holder does not continue to hold the office. The office may not be filled by election or appointment unless the commissioners court votes to reinstate the office or a majority of votes cast in an election held on the issue favor reinstatement. The reinstatement

election may be held if the commissioners court on its own motion orders such an elec-tion, or the reinstatement election must be held if the commissioners court receives a

Amber's Legacy

KAY BAILEY HUTCHISON

"My child has been taken." The most terrifying nightmare a parent can endure has just begun. This was the crushing truth facing Donna Hagerman, now Donna Norris, the mother of a nine year old girl named Amber, who was kidnapped while riding her bicycle near her home in Arlington in 1996. Four days later, Amber was found

Amber's death had such an impact on the community that local law enforcement and area broadcasters developed what is now known as AMBER Alert (America's Missing: Broadcast Emergency Response). An AMBER Alert is activated by law enforcement to find a child, when a child has been abducted. An alert triggers highway notification and broadcast messages throughout the area where the abduction occurred. To date, 57 cities, regions and states have established AMBER Alerts, which have enforcement is successful in tracking down many of these been credited with the safe recovery of 31 abducted chil- children, but evidence shows a few hours time can make

The kidnappings that have captured our country's attention this summer remind us why it is more critical than successful in helping locate missing children, nationwide.

the Senate in unprecedented time, to establish a national AMBER network. The legislation helps fill the gaps that

exist in the current patchwork of AMBER systems. It also provides much needed resources for states and communities to build their own systems and spread vital information to surrounding jurisdictions with a single phone call.

This summer the abduction of an Abilene infant brought this issue home to many Texans. A woman abducted one-month-old Nancy Crystal Chavez from a car in a Wal-Mart parking lot. Because a surveillance camera caught the incident on tape, law enforcement in North Texas were able to alert the public of the make and model of the kidnapper's vehicle through the AMBER Alert system. The following day, the alleged kidnapper was stopped by highway patrol after receiving a tip from a

When a child is lost, the whole community grieves along with the family. An AMBER Alert helps them channel their concern into action. Recent child kidnappings in California, Utah, Virginia, Texas and other states have brought the issue home to many communities and tips from average citizens have resulted in the safe and rapid recovery of many children.

We must be able to spread the word about abducted children across county and state lines and take away the predators' hiding places. It must happen quickly, before the kidnappers have the chance to cover their tracks and get too far away. According to a 1990 U.S. Department of Justice study, roughly 4,500 children in the United States are abducted by non-family members every year. Law the difference in a safe recovery. An AMBER Alert gives these children, and their families, a fighting chance.

In memory of Amber Hagerman, and for every family ever that we take the AMBER program, which has been so ravaged by the searing tragedy of child abduction, my colleagues and I moved swiftly to pass this legislation in My colleague from California, Senator Dianne the Senate. Our goal is to have President Bush sign this bill Feinstein, and I introduced and were able to pass a bill in into law this fall. Soon more states will join the national AMBER network and all families will benefit from the dedication and vision of Donna Hagerman Norris.
