Hornets Sting the Coyotes in Their Final Non-District Game

The Borden County Coyotes hoping to ride the momentum that the Borden County Junior High and Junior Varsity created from two solid victories on Thursday night found themselves in a familiar setting as an early deficit coupled with early mistakes resulted in a very long night.

After forcing the visiting Asperment Hornets to methodically drive the ball the length of the field to pay dirt, the Coyotes allowed them to travel a much shorter distance less than a minute later as the Hornets quickly turned a fumbled center quarterback exchange on their own 15 yard line into a touchdown one play later and a quick 14 to 0 lead.

The Coyotes took the ensuing kick-off and managed to put together a nice drive as they moved inside of the Hornet 20 yard line only to have yet another miscue result in another fumble recovery for the visitors.

With 25 seconds remaining in the opening stanza, the Aspermont Hornets built a very comfortable 22 to 0 lead over the home town Coyotes.

On the next Coyote's offensive possession, they could not muster any offensive success and were forced to punt the ball back to the Hornets. The Hornets for the 4th consecutive possession managed to reach the end zone and a comfortable 30 to 0 lead. On the Coyotes next possession, they managed to eliminate any mistakes and used the tough running of sophomore Flynn Chapman along with a nice throw from sophomore quarterback Brendan Tarleton to freshman end John Hensley that covered 37 yards to setup a scoring opportunity for the Coyotes.

Flynn Chapman strolled into the end zone from 1 yard out behind nice blocks from Carlos Hernandez, Logan Howard, John Hensley and Quentin Shafer to cut the lead to 30 to 6.

The Hornets answered back as they turned what looked like a great defensive play into a successful play of their own as Quentin Shafer and Miles Valentine covered the Hornets pre-season all-state receiver only to have the Hornet quarterback dump the ball off just as it appeared Logan Howard was going to sack him and he turned it into a 44 yard scoring play and regain their 30 point lead at 36 to 6.

The Coyotes had another drive stall, but just as it seemed that the Hornets would blow

this game completely open a nice defensive stand by the Coyotes gave them the ball back and one last chance to score before halftime.

The Coyotes managed to string a couple of first downs together and apparently moved inside of the 20 yard line only to have a penalty called and as a result the Coyote drive would

The Borden County Pups wasted little time in deciding the outcome of their final non-district football game in Aspermont against the home team hornets, as Tanner Richey returned the opening Kick-off 65 yards to pay dirt to set the tone for the 1st quarter fireworks.

On the ensuing kick-off, a nice hit by Richey jarred the ball loose from the Hornet return man. Blake Turner was Johnny on the spot for the recovery and two plays later Richey crossed the goal line again for the Pups and a quick 12 to 0 lead.

Behind the nice blocking of the 2nd team offense, Steven Howard added the extra-point to boost the lead to 13 to 0.

After successfully hanging on to the kick-off the Hornets were not as lucky on their first offensive play as Richey stripped the ball from the home town runner and then managed to fall on the loose ball to give the Pups the ball once again.

It took the Pups three plays this time as Richey scored for the 3rd time on a nice 45 yard run to increase the lead to 19 to 0.

The Pups held the Hornets on downs the next series and on the very first play after stopping the home team, Austin Fields got into the scoring act as he took a screen pass from Blake Turner and turned it into a 41 yard touchdown reception and a very convincing 25 to 0 lead for the visiting Pups with 2:32 remaining in the opening period.

The Pups used their second team defense for the remainder of the game and that group of Chris Teel, Riley Smith, Troy Copeland, Luis Andrade, Luke Burkett, Valerio Hernandez, coupled with a couple of first team players, Blake Turner, Chance Taylor and Steven Howard only gave up two touchdowns during the entire contest.

Their solid defensive play included a nice goal line stand and some very nice individual defensive plays from Riley Smith, Chance Taylor and Chris Teel.

The Pups also used their 2nd team offense for most of the game, but after surrendering a touchdown in the 2nd quarter, the 1st team of Austin Tyler, Matt Roberson, Steven Howard, Blake Turner, Tanner Richey and Austin Fields came back in to regain the 4 touchdown lead as Austin Fields scampered 25 yards after having an earlier 50 yard run called back because of a Pup penalty.

After the touchdown, Richey carried the ball into the end zone when Fields pitched the low snap to Tanner who was trying to kick the extra-point but sauntered across the goal line instead to give the visiting pups a 32 to 6 halftime lead.

The 2nd half was a defensive battle until the Hornets broke thru to cut the Pups lead to 32 to 13 late in the 3rd period, but the Pups quickly responded as Austin Fields rumbled 35 yards for his third touchdown behind a nice block by Austin Tyler and Matthew Roberson.

Another low snap on the extra-pt try resulted in Richey hitting Turner for the extra-pt and a 39 to 13 advantage. The 2nd team defense came up with one more stop to end the game and give the Borden Pups their 4th victory of the season.

The Pups will take the week off before they resume their quest for another junior high district championship and another undefeated season. The Pups will play host to the Loraine Bulldogs on October 18th and this should be a very difficult challenge.

stall as the half would end with the Coyotes trailing 36 to 6.

The Coyotes took the opening kick-off of the half and drove inside the Hornet 30 yard line, but a nice 1st down run by John Hensley ended with a violently hit that jarred the ball loose from the freshman and another Coyote turnover. The Hornets would score moments later to extend their lead to 44 to 6.

Following the kick-off, as had been the case most of the evening, the Coyotes would mount another drive that got inside the Hornet 30 yard line again only to have a big penalty for the Coyotes to put the ball in the air and as a result the Hornets picked off an errant pass to thwart yet another promising drive.

Texas 4-H Turns 100!

JACKSBORO - On an ordinary day about a century ago, Jack County Agent Tom Marks got together with 25 young farm boys to discuss how to grow corn. Marks wanted to bring the latest science-based farming techniques to the newest generation of farmers.

Because he hadn't had much luck convincing long-time farmers to try new methods, his hopes were that the boys would take these techniques to their own families farms and convince their parents to use them too.

Jacks and those first 25 members had no way of knowing how wildly successful their efforts would be.

That first corn club became the roots of today's Texas 4-H, which still teaches innovative, science-based methods of farming and much more. Because todays 4-Hers come from both rural communities and urban neighborhoods, the program offers such projects as photography, public speaking, technology and consumer decision-making in addition to its time-honored crop and animal projects.

Participation has expanded just a bit too. According to the Texas 4-H Web site (http://texas4-h.tamu.edu/), current membership in Texas 4-H clubs is more than 65,000 and another 850,000 young Texans are involved in 4-H projects through their schools, after-school programs and neighborhood or wouth centers

According to the Web site, the four Hs stand for: Head, which represents clearer thinking and decision-making; Heart, for greater loyalty, strong personal values, positive self-concept and concern for others; Hands, for larger service, workforce preparedness, useful

skills, and science and technology literacy; and health, for better living and healthy lifestyles.

No matter what the size of their neighborhoods or the diversity of their projects, all 4-Hers are guided by the pledge: I pledge my head to clearer thinking, my heart to greater loyalty, my hands to larger service, my health to better living for my club, my community, my country and my world.

First written by Otis Hall of Kansas, the pledge was approved in 1927 at the first National 4-H Club in Washington, D.C., according to the Web site. The only change to the pledge in the past 80 years was the addition of the phrase my world in 1973.

To officially open the 100th anniversary year of Texas 4-H - which will be celebrated from September 2007 through August 2008 - Jacksboro and Jack County hosted a celebration on Oct. 9. Festivities included a display of current 4-H projects and Share-the-Fun performances, dinner and entertainment, and a corn recipe contest in honor of the first corn club.

Children attending were given samples of corn seed to take home and plant.

Attendees could also visit the Jack County Museum, which is located in the house where Tom Marks lived. The room dedicated to 4-H exhibits is reported to be the room where the original corn club met. Museum visitors could also see the 4-H centennial quilt, which was made by volunteers from Childress County in honor of the occasion. The double-sized quilt, which has been described as part applique, part monogram, is made of blocks that form the 4-H centennial circle, a design created especially for the 100th anniversary of Texas 4-H.

Throughout its first 100 years, the goal of Texas 4-H has been reflected in its motto: To make the best better.

No matter what changes in size and project topics Texas 4-H has in the future, that goal will remain the same.

Reeder, Mayes Inducted Into Synder High School Athletic Hall of Honor

1964 Borden High School graduate Pam (Stephens) Reeder and current Sixth Grade Teacher Sue Jane Mayes were inducted October 5 into the Snyder High School Athletic Hall of Honor.

The two were members of Snyder's first athletic state championship team, having won the 1972 State 3AAA Championship by defeating Gregory-Portland in the final match, April 22, 1972, on the University of Texas campus in Austin.

Reeder, in her first head coaching job, led the Lady Tigers to a 17-7 record that year as a rookie 25-year-old coach. Mayes, a sophomore, was the starting setter for a team.

The Lady Tigers never got to defend their title as Snyder's enrollment increased that year, pushing Snyder into the state's largest class at that time (4A). The next year Snyder finished second in a district with Abilene High, Abilene Cooper, Midland High, Midland Lee, Odessa High, Odessa Permian, and Big Spring. At that time, only the first place team advanced in the playoffs.

Mrs. Reeder, now living in Fort Sumner, New Mexico, left Snyder in 1973 to begin her family. Her daughter Shayne is a 1992 BHS graduate while son Kurt graduated in 1995 from Borden County.

Big Spring's Foremost Animal Lover

When Melanie Gambrell was growing up in a small town in Iowa, she spent a lot of time on her aunt and uncle's pig farm. She'd sing to the pigs and feed them apples. Her uncle raised ducks and she would get in rotten duck egg fights with neighbor kids.

"When those rotten duck eggs hit you, they explode all over you," says Melanie. "I had to ride in the back of the pickup a lot because I stunk."

She used to pick up garter snakes and put them in her pocket.

"My mother never could figure out how those snakes kept getting in the house," says Melanie, who now has as many animals as some small zoos.

"People just drop them off or they call me to take care of them." Growing up in town, she never had all the pets she wanted.

Now she does. Her place east of Big Spring is a menagerie. "I have a pet steer named Spot that lived in the house with us for three months. I have a llama named Brock. We've got two barbado sheep named Barbie and Doe, I have a fainting goat, a meat goat, two horses, rabbits, birds, seven of my own dogs, six of my own cats, two bobcat kittens, a possum, some chickens and roosters and a husband."

She has made a business of taking care of animals. She grooms and boards them, trains them, uses them as therapy for people in nursing homes, teaches people how to be better pet owners through her weekly radio program (Pet Talk) and puts some orphaned animals up for adoption.

"I'm pretty particular about who gets my animals," she says. "I want to make sure they get good homes. When they do, I get a real satisfied feeling."

Her business is called All Creatures Sanctuary and Rescue. She is licensed to examine animals to see if they've been abused. People bring her injured wild animals and she helps them get better so they can return to the wild.

By the way, she says you shouldn't put feed out for stray cats. "It'll bring colonies of feral cats, skunks and raccoons and becomes a breeding ground and a place for disease."

Melanie got a new dog the other day and named him Bob Barker. She did have a pet mule deer that rode in her car.

"We raised her from a baby. When she was about a year old she started visiting the neighbors, which were a mile away. They would call and tell me that Big Girl was on their place. I'd drive over there and she would come to the car, get in and we would drive off."

Her pet steer Spot slept on a comforter in her house and had his own blanket. "Have you ever bought Depends for a steer? That's no bull."
