In our country, the Fourth of July is a happy holiday, one that we have grown to view with relaxation and fun.

Our forefathers would be pleased beyond measure that we have the freedom still to do such things.

Thomas Jefferson, though, might also like to know that at some time during the backyard cookout, conversation might be about more than just the Rangers' losing streak or the need for more beer and ice in the cooler.

Jefferson was the primary writer of the Declaration of Independence, which was formally adopted on July 4, 1776.

In 17 days, Jefferson wrote-not typed-the document that is at the heart of why we celebrate the Fourth.

"the eloquently stated unalienable rights of life, liberty, and the pursuit of

happiness." Family reunions celebrate life.

Gatherings in a park or a church or in a neighborhood with friends represent liberty.

And happiness is....well, happiness is sitting in the lawn chairs, looking into the sky, and listening to small children "ooh and aah" after some beautiful displays of pyrotechnics.

This holiday was created to remember the written document, not the battles that were to come afterwards.

Our country's independence day stems not just from a revolutionary war but from a letter written to a king thousands of miles across the ocean.

The first shots had already been fired in 1775, and the Revolutionary War would rage for several more years.

Even after we won independence, the struggle continued when our newlyformed United States faltered with the Articles of Confederation.

It would not be until 1788 We celebrate because that after the ratification of another written document, the Constitution, that we actually came to be the united country we are today.

So why was July 4th set aside instead of a decisive date or battle the Constitution's ratification?

On this day over 225 years ago, a few men did not take a leap of faith-they knew exactly what they were

doing. And they did it with pen and paper by signing their names to an essay of which TAKS graders would be proud.

The Fourth of July is about essay: a strong an introduction, body paragraphs that provide support for the actions taken, and a conclusion that leaves readers inspired and determined: "we mutually pledge to each other our Lives, our Fortunes, and our sacred Honor."

Today, we are a country polarized often by political agendas and parties-that's been a normal progression and one that even Jefferson would understand.

He and a guy named Alexander Hamilton did not like each other and that





Texas Announces Largest July 4th Holiday Crackdown Stepped Up Law Enforcement

Aimed at Drunk Drivers

ABILENE, TX – State officials have a stern warning for motorists who 4th of July holiday plans include alcohol: Drink, Drive, go to Jail.

Brenda Mitchell, Abilene district traffic safety coordithe Texas nator for Department of Transportation (TxDOT), said today that State troopers and local law enforcement statewide will step up enforcement of the state's DWI laws between June 27th and July 13th. Thousands of officers, including many in the 13county Abilene district, will be out in force during the 17day period, which coincides with the long Independence holiday day weekend, Mitchell said.

Texas is part of a massive nationwide effort aimed at getting impaired drivers off the nation's streets and highways. The mobilization is being spearheaded by the national highway Traffic Safety Administration (NHTSA) in an effort to reduce alcohol-related crashes this summer.

"Our message to all drivers is simple and direct: If you drink and drive, you will go to jail," says Carlos Lopez, TxDOT Director of Traffic Operations. "There are 60,000 law enforcement officers in Texas who can arrest drunk drivers. Safe alternatives to getting behind the wheel is you've had

anything to drink are to designate a sober driver before drinking begins, call a taxi or just stay where you are until you can drive home safely."

Starting today, TxDOT will air new television and radio announcement in English and Spanish with *Drink*, *Drive*, *go to Jail* message. The ads will run during programs typically viewed or heard by men between the ages of 21 and 34. According to Mitchell, research shows this age group is more likely to drive impaired than any other group.

Texas leads the nation in alcohol-related fatalities. The Texas Transportation Institute reports that 1,193 people were killed in drunk driving crashes in Texas in 2000. There were 10,083 crashes in which the driver was impaired by alcohol or drugs. The legal limit for intoxication in Texas is .08 blood alcohol concentration (BAC). Penalties for a first DWI offense include \$2000 in fines, 72 hours to 6 months in jail and driver's license suspension from 90 days to a year.

Stenholm Announces Implementation of the National "Do Not Call" Registry

Washing, DC Charlie Congressman Stenholm proudly announced the implementation of the national "Do Not Call" registry. Beginning June 127, 2003, consumers in states west of the Mississippi, including Texas, may register via telephone by calling 1-800-382-1222. Furthermore, consumers can register via by visiting computer www.donotcall.gov. Using this telephone method, the number to be protected and email address for an confirmation purposes must be provided.

"I was proud to vote for the legislation that made this registry possible. The objective of this new law is to hold telemarketers accountable for calling folks listed on the Do Not Call registry, making them subject to penalties for the violation," noted Stenholm. "We must monitor the effectiveness of this registry closely as coordinating the efforts of the federal trade Commission, the Federal Communications. Commission and state authorities into one national system will be challenging."

The Texas Cowboy Reunion got it's start back in the early days of the Great Depression when a group of thirteen Stamford businessmen met to discuss establishing some type of local celebration in order to boost morale during some pretty tough times.

Stamford was central to several large ranches and the founders decided a rodeo would be an appropriate celebration.

The founders named it the Texas Cowboy Reunion and dedicated it to preserving the heritage of the typical West Texas cowboy.

That first year was a success in every way, with 98 cowboys participating in foru events.

Calf roping was the most popular, but was followed closely by wild-cow milking, steer riding, and bronc riding

Back in those days, a total of 12, 000 people attended the rodeo during a three-day period.

In the following years, the event grew and, by 1937, crowds totaling 70,000

AMERICA'S PROTECTORS U.S. Troops Safer—In Surprising Ways

(NAPS)—One reason many of America's defenders may have lighter hearts these days is that they have lighter equipment.

Thanks to today's technology, some of the most sophisticated gear U.S. troops have is also easy to carry. For example, the new M4 carbine has a retractive plastic butt stock and a shorter barrel with plastic hand grips-making it more lightweight and maneuverable for added mobility in close quarters. A carbine, or short-barreled rifle, the M-4 fires the same small, high-velocity ammunition as the old M-16. It can also be easily reconfigured into a grenade launcher, a laser or an illuminator to help guide bombs.

Today's soldier has a helmet made of a lightweight plastic composite that can be stronger than older helmets to protect the temples, ears and neck.

Lightweight night vision equipment can be individual binoculars or goggles and the more heavyduty-thermal imaging equipment. These devices convert light particles called photons into electrons. The photons strike a special plate in the lenses and an electrical pattern is established. This signal is amplified and sent to a video screen.



More than ever, American troops are protected by highstrength, lightweight plastics.

Our military has chemical defense equipment that consists of a vinyl protective suit and a gas mask with an airtight seal. To make it easy to carry when it's not being worn, the suit folds compactly into a backpack when not in use. The backpack is modular with removable components and pockets so troops can tailor their packs to shorter or longer missions.

In addition, a soldier's flak jacket and interceptor body armor are both made of plastic to protect against shrapnel and gun fire.

Lightweight, durable materials such as plastics give troops added mobility and added survivability on the battlefield.


