Entomologist Advises Bailey Sorghum Growers

Dr. Don Rummel, area entomologist for the Agricultural Extension Service, assisted local farmers Wednesday by going to the grain sorghum fields with County Agents of Lamb and Bailey counties to get an accurate picture of the midge damage situation.

In making the test, Rummel placed the grain sorghum heads inside a wide-mouth jar, shaking it vigorously. The head was then removed and a close look revealed the midge among the blooms in the bottom of the jar.

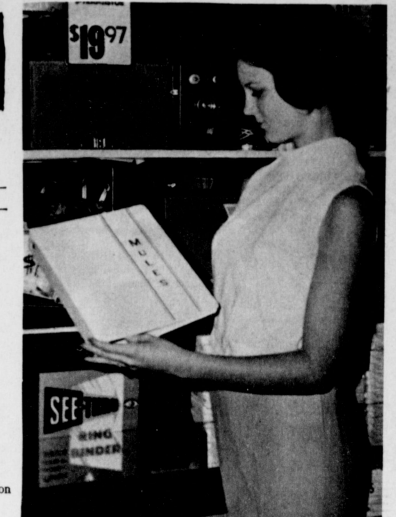

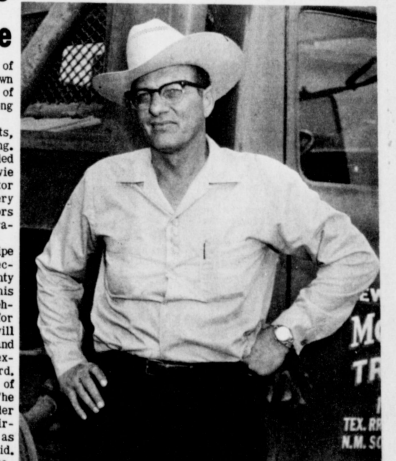

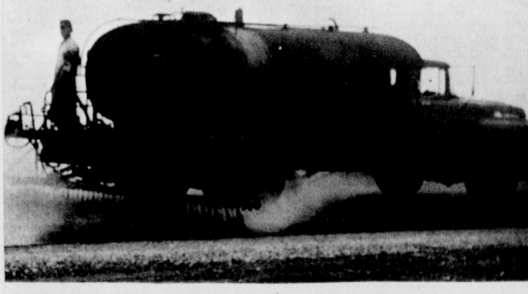

General admission will be \$1.50 for adults; 75¢ for students at the gate and pregame students tickets will be 50¢.

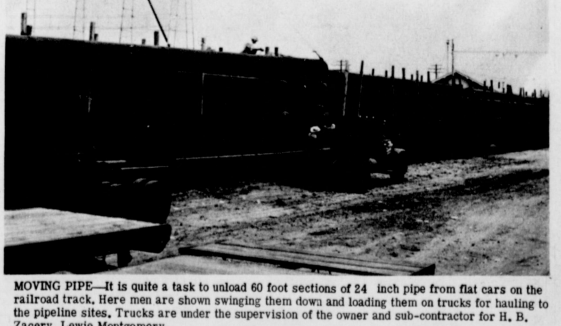

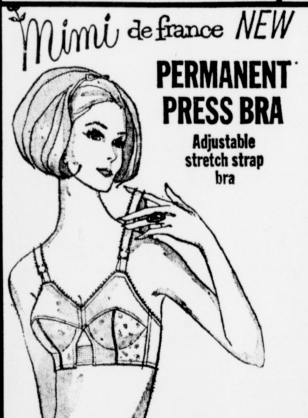

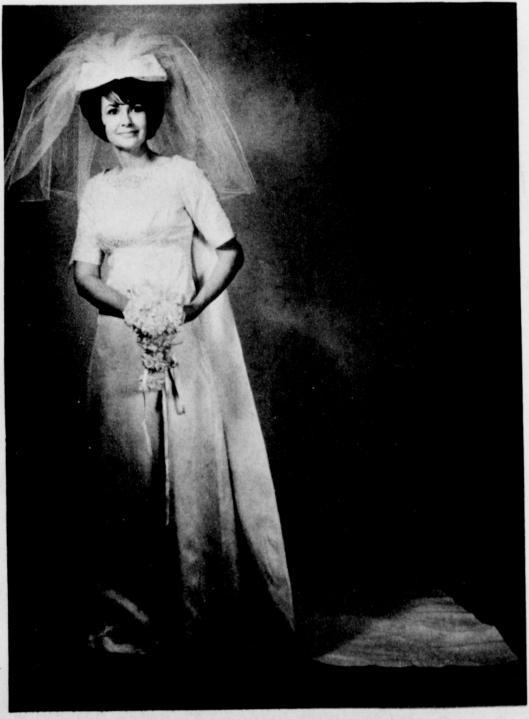

New Feature Added to Field Day Program

A new feature has been added to the Annual Field Day program of the High Plains Research Foundation to be held September 14. The various commodity committees of the Board of Trustees will have special displays of products and plants of the items under present and possible future research at the Foundation.

The oilseed research committee will have on display plants and products of soybeans, sunflower, sesame and rapeseed. The fruits for this program will be the oilseed committee headed by Bervyn Tillson. Members of his committee will be on duty at the display during the afternoon.

The oilseed display will be located in front of the greenhouse next to the laboratory in the southwest part of the Killgore Building. So many products are made from soybeans that the yearly increase in acreage has been met with increase demand and usage for a number of years. Research is devoted to production of higher oil and protein content and profitable yields. Varieties that do not shatter nor lodge (fall down) are also desired by producers. Sunflower research includes the search for high yield, combine height, moth and disease resistant varieties. Short growing season and lower water requirement make this crop desirable for the area. The future of sesame lies in the production of a higher yielding non-shattering combine variety. The research on rapeseed is very new. Finding insect resistant varieties is the immediate need. Dates of planting, fertilizer and irrigation response also needs to be determined.

The grain and forage sorghum commodity committee will display products, uses and some varieties of grain and forage sorghum at the Eleventh Annual Field Day. This display will be located at the south end of the seed production laboratory.

Elbert Harp, Bill Nelson and members of the commodity committee from the Board of Trustees will be hosts for this exhibit during the afternoon of Field Day.

Undergraduates Must Request Service Deferral

AUSTIN—A new draft form on which undergraduates college students can request deferment has been furnished draft boards, Colonel Morris S. Schwartz, state Selective Service director, said Friday.

Undergraduates must request deferment under the new Military Selective Service Act of 1967 after the date of its enactment, June 30, in order to be deferred.

The form, titled "Request for Undergraduate Student Deferral (SSS Form 104)", reproduces pertinent provisions of law printed on the form, states he is pursuing a full-time college course, a d asks for deferment in Class II-S, then signs the form. The blank forms may be secured from local boards.

Colonel Schwartz said that requests for deferment could be made by ordinary letter, too. "The form is for the convenience of students," he observed, "it will help them understand what the law provides."

Deferment of undergraduates in Class II-S is mandatory if they are full time and satisfactory, under 24 years old, and request deferment. To be satisfactory, a student must make normal progress toward his baccalaureate degree. For example, in a four-year course, he will be expected to earn 25% of his credits in the 12 months following the beginning of each year.

Board of Insurance put the new driver penalty point system into effect on August 1. By levying \$6,439,362 in penalties on drivers who had wrecks or serious traffic offenses during the year just ended, the Board was able to cut average rates by one percent.

Texas Employment Commission reports that a total of \$8,200,000 in unemployment insurance benefits was paid to eligible claimants in Texas during the April-June quarter.

PRICE-FIXING SUIT—State of Texas has filed a price-fixing suit against five big drug firms. Suit, entered in federal court at Dallas by Atty. Gen Crawford C. Martin, seeks triple damages totaling about \$12,000,000 from the producers of au-

romycin, terramycin and tetracycline products. Drugs involved are used to treat both human and animal diseases and as animal feed supplements.

According to Martin, the defendant suit pending against the same firms: Charles Pfizer and Co., Inc.; American Cyanamid Co.; Bristol-Myers Co.; Olin Mathliessen Chemical Corp.; and the Upjohn Co.

Martin alleges that the drug manufacturers charged state and local governments "unreasonably high prices for retail antibiotics through a conspiracy to limit their manufacture and sale.

Furthermore, the attorney general contends, the firms' actions inflated prices to retail druggists, wholesalers, private hospitals and the consumer. Martin estimated more than \$3,000,000 has been spent by state and local governments available between November, 1953, and November, 1966, to buy antibiotics for use in public-supported hospitals, schools and other institutions and health or welfare programs.

The attorney general is contemplating similar suits, Martin said, and state attorneys general will discuss the case at their conference in Portland, Ore. On August 29, HEALTH GRANTS SOUGHT -- Seventy eight health facilities have applied for federal Hill-Burton construction grants of more than \$34,500,000, about twice as much as is expected to be available for Texas.

New 1968 Texas State Plan for Construction and Modernization of Hospitals and Related Medical Facilities now is available for review at the State Department of Health.

Hill - Burton Act provides funds to help finance construction and modernization of general hospitals and long-term facilities, diagnostic and treatment centers, rehabilitation facilities, tuberculosis hospitals and public health centers.

Dr. J.E. Peavy, State Commissioner of Health, said the 1968 plan indicates ever-increasing use of health facilities.

Ben Atwell of Dallas, W. C. Sherman of Fort Worth and Hudson Moyer of Amarillo to the House Concurrent Committee on State and Local Tax Policy; and Reps. Charles Jungmichel of La Grange, Dean Neugent of Texas City and Gus Mutscher of Brenham to the Interim Committee for the Study of Land Uses and Environment Control.

State Finance Commission appointed Francis A. Miskell, Regulatory Loan Commissioner, to serve as Consumer Credit Commissioner, effective October 1. Post was created to administer the Consumer Credit Code passed by the 60th Legislature.

The conference was held in conjunction with the implementation of Title XIX, commonly referred to as Medicaid, of the Social Security Act in Texas.

The one-day meeting, sponsored by the Texas Nursing Home Association, State Department of Health was based on the theme, "Meet The Challenge Of Change," and dealt with the responsibilities of the nursing home and state employees under this new program.

Title XIX, which implemented in Texas starting September 1st will replace the current Kerr-Mills welfare programs which have been functioning in Texas since 1962. This new, joint federal-state program, will initially provide the following services to the certain categories of the medically indigent welfare recipients: physician services, in-patient hospital services, outpatient hospital services, skilled nursing home services, and other laboratory and x-ray services. These services will be available to the eligible blind, aged, and totally and permanently disabled and families of dependent children.

Medicaid was the companion legislation to medicare passed by Congress in 1965 as part of Public Law 89-97. Since medicare is a joint federal-state program, while medicare is

strictly a federal program, each state legislature had to pass legislation enabling the state to participate in the program. Senate Bill 2, passed by the Texas Legislature and signed by Governor John Connally on May 11, 1967, was Texas' enabling legislation.

Conference speakers included Dr. David Wade, Assistant Commissioner for Medical Administration, State Department of Public Welfare; Arthur B. Taylor, President, Texas Nursing Home Association; L.C. Rouse, Director, XIX, commonly referred to as Medicaid, of the Social Security Act in Texas; Dr. R.C. Jordan, Chief, Medical Care Administrative Services Section, Texas State Department of Health; Bee Grissom, Director of Finance, State Department of Public Welfare; and John M. Crawford, Executive Director, Texas Nursing Home Association.

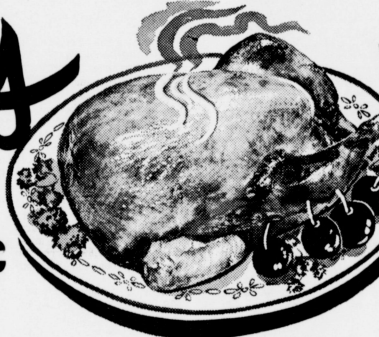
