10 tips for Parents to Establish a Strong Parent-Teacher Partnership.

1. The first meeting with a teacher sets the tone for building trust. It's important to be worm, friendly, and professional. Approach a teacher as you would a professional colleague. (After all she is a professional colleague in your child's education.) When you contact the teacher

briefly by phone, a note, e-mail or faceto-face meeting in the first week of school, you make a connection when neither of you has a problem or complaint.

2. Provide helpful information about your child as soon as possible, but keep in mind that your child's teacher has a classroom full of students with their own special learning styles, needs

and personalities.
Follow-up your first contact with any pertinent information about your child's learning history, home situation, special abilities and challenges that the teacher might need, but try not to overwhelm the teacher

with information.

3. Let the teacher know that you are a partner in the learning process. Find out the teacher's home-work expectations, and ask for age-appropriate ways to help your child. Ask about other home support you can pro-vide, including tools such as reference books and computer programs. Read to your child

every day.

4. Provide detailed contact information.

Give the teacher all of your telephone numbers (home, work and cell) as well as your e-mail addresses.

Let the teacher know if you are going to be out of town for prolonged period of time or when changes in the home environ-

ment might affect your child's attitude at school. Invite the teacher to contact you at the firs sign of any problem. Be sure to find out how and when the teacher prefers to be contacted by parents. (Many parents assume morning that the hours before school are the most convenient time to talk to teachers. In actuality, this is often the teacher's busiest time."

- Find a way to get involved at school. Volunteer to assist in the classroom, sign up for field trips, donate supplies or offer to do special tasks. If the requirements of your career do not allow you to be available during the school day, offer to completer special projects for the classroom in the evening. Attend Parent's Club meetings, parent orientations and school events. Read school newsletter, and visit its Web site. Parents who involved gain insight and consideration from teachers.
- 6. Ask for clarification if you don't understand. A teacher may use the language of education. You should ask for definitions or explanations when you don't understand terms. This ensures that you get all the messages you need to help your child the most.
- 7. Remember that the

endraid sees issues you have with your child's teacher should be addressed with the teacher. Avoid playground gossip with other parents. Get teacher's version of the facts before you react. Go to the teacher first about a problem, not to the principal or to other parents.

8. Prepare

- parent-teacher conference as if it were a business meeting. Write down the questions you would like to ask. You may even start this list at the beginning of the school year. A sheet of paper posted on the refrigerator is ideal for jotting notes as things come up that you want to discuss. Bringing your list of questions to the conference will help you learn the most information in the shortest amount of time and it will ensure that you do not forget anything. Be sure to ask: What is my child learning? How do you know that he or she is learning? In what areas does my child need improvement? How can I help my child improve? How is my child's social development? Be on time, and be open to listening.
- 9. Always send a follow-up note after any conference or telephone call. Thank the teacher for her time, and summarize what you think you heard the teacher say

- about your child.
  Detail any action
  steps or goals that you
  or the teacher agreed
  to take.
- 10. After six weeks, contact the teacher again by telephone, a personal note or email. Even if everything is going well, ask for suggestions to help your child develop. Be respectful of the teacher's time, but be sure that you remain an active partner in your child's education.






These observances have given opportunity for interaction between teens and senior adults, and have done much to bridge the generation gap between these groups. Each group has gown in its appreciation of the other.

### A Safe Ride

About 55 percent, more than 23 million, of all kids ride a school bus every day. According to the National Safety Council, school buses travel about 4.3 billion miles each year. With all those miles and children, it's important that you and your friends take some responsibility to leep safe.

#### Going to the bus stop ...

- Whenever possible, walk with friends and others from your school.
- Do not walk in the street. Use sidewalks if they are there; otherwise, walk on the grass next to the street. If you have to walk in the street, walk as close to the curb as possible.
- Be alertand avoid any signs of danger.
- · Obey traffic lights and signals.
- When you are crossing the street, cross only at the corner and use crosswalks where possible. Look both ways before crossing.

#### While you wait for the bus . .

- · Make sure you dress right for the weather.
- Be aware that drawstrings, ties, straps and backpacks can get caught in bus doors, railings or aisles, so be extra careful when getting on or off the bus. You may want to consider shortening or removing those items.
- Arrive at the bus stop on time.

#### Boarding the school bus . . .

- Do not approach the bus until it stops completely.
  Wait for the driver's signal to board.
- Enter the bus in single file. Do not push

#### Riding the bus ...

- \* Always obey the school bus rules.
- Remain seated throughout the ride.
- Keep your arms, hands and head inside the bus.
- Help keep the bus neat and clean.
- Do not put any belongings in the aisle, and keep them away from emergency exits.
- Eating and drinking are not allowed on the bus.
- Be courteous to the driver and other riders.
   Listen to any directions the driver gives you.
- Do not make noises or gestures that could distract
- the driver or annoy other passengers.

#### Leaving the bus . .

- Do not stand up until the bus comes to a complete stop.
- + Use the handrail when leaving the bus
- Never walk behind the school bus.
- If you cannot see the bus driver, the driver probably cannot see you. Take five giant steps away from the bus, then you should be able to see the driver, and the driver should be able to see you.
- Never crawl under a bus. Do not bend down near or under the bus.
- If you have to cross the street, wait for the driver to signal, then cross the street in front of the bus.
- Look both ways before crossing the street.
- Never run back to the bus, even if you have forgotten something.
