

Even for those who aren't necessarily football fans, night's Friday contest between Borden High School and Ropesville provided all the elements of a good story.

There was the setting: a beautiful, crisp autumn evening in September with a West Texas sunset.

There were the characters: a dazzling passer for the opponents and a bunch of young Coyotes led by three determined seniors not to mention their "old" coach.

And, there was the plot: the conflict between two opponents who were going to go to the air to settle the score.

The game had plenty of action, which always makes for a good story. Coyote fans even went home happily ever after--at least until the next football game.

Against Ropes, the Coyote cast of characters were in need of a win. The young team fell to Meadow last week in their season opener.

From the outset when Ropes decided to onside kick the opening boot, the Coyotes hinted they were ready to play.

Kyle Pinkerton fell on the ball, and the Coyotes were in business on their own 32yard line.

Pinkerton's boot made it a 16-6 Coyote lead.

Ropes' defense returned the favor, however, and the Eagles' offense scored soon thereafter on a 41-yard pass play. Their PAT kick was true--the game now stood at 16-14 with the Coyotes ready to regroup.

A fumble on the next offensive possession for BHS thwarted the regrouping. Heck, it even stopped it.

Less than two minutes later, the host team scored again to take the lead with 1:38 left before halftime.

And they weren't through.

The Coyotes received the kickoff but immediately turned it over again on a deflected pass interception.

With :18 in the half, the Eagles found the end zone again in the air, this time a 12-vard strike. A converted PAT kick stunned the Coyotes as they now were down 28-16 in just a matter of minutes.

Not content to take a knee and run out the half, Pinkerton scooped the onside kick and took it 17 yards before being brought down on the Eagles' 25- yard line.

Carter picked up 12 yards to give the Coyotes some breathing room, but two incomplete passes set up a 4th and short situation.

Once again, Pinkerton got the reverse call and rushed downfield for the needed five yards and a first down to keep this drive going.

It didn't last long, though,

as the Coyotes were unable to move the ball and were forced to punt after a delay of game penalty.

Pinkerton--who by now was in contention to be named the main character of the game--got off a 56-yard

Not only that, the Eagles fumbled the punt, and Tarleton fell on it inside the five-yard line.

Here's where you may think you can put the book down and figure out the ending.

Keep reading because the Coyotes were unable to punch it in from only five yards out. The third quarter-which had seen BHS take all the momentum away, also saw them give it right back to the Eagles as they could not convert on the turnover.

Oh, but don't give up on them just yet because just as Ropes thought they could get back in the game, Wilson and Carter decided to thicken the

The duo combined for a hit and fumble recovery with 9:45 left in the game. This time the Coyotes would convert the turnover into points as Tarleton tossed his fourth touchdown pass of the evening to Pinkerton on a 21yard scoring strike.

Rodriguez bulled into the end zone on the PAT to give the Coyotes a 37-28 lead with 9:22 on the clock.

Lozano got down field in a hurry, as usual, and made the solo tackle on the kickoff as Ropes took over on their own 21-yard line.

# JV Battles to Take Hard-Fought Win Over Ropesville

After the first quarter, the 2-0 score was indicative of the tough game that lay ahead.

The jr. varsity Coyotes pulled off a safety with 3:28 to play in the opening quarter when Statton Keith sacked the Ropes runner.

The defensive points came after the Coyote offense had stalled on the 14-yard line on their opening drive.

The free kick gave the ball back to BHS, and it appeared the Coyotes would convert on the golden opportunity.

Quarterback Austin Tarleton teamed up with Andrew Lamming for a 22yard gain on a pass play.

Michael Bullinger did his part on the ground, churning out 42 yards on the drive.

However, a fumble on the 2-yard line gave Ropes possession with :49 in the first quarter.

A facemask penalty gave the Eagles better field position, but Keith hammered the opponent's runner and Trey Soto picked up the loose ball on the 7-yard line.

With 7:40 remaining in the half, the Coyotes were in position again to capitalize on great field position.

Once again, however, it was not to be.

A deflected pass, a sack, and a rush for short yardage set up a 4<sup>th</sup> and goal for BHS. The Eagles held.

Ropes went to work deep in their end of the field, but it wasn't easy.

Clint Chapman stripped the ball but the Eagles were able to recover their own fumble.

Bullinger made a touchdown saving tackle on Ropes' next rushing play followed by Keith's rush and deflection.

Regrouping, the visitors then went to the air and scored on a 31-yard touchdown pass with 2:41 left in the half. The PAT made it an 8-2 game.

Keith returned the kickoff 23 yards to the Eagle 37-yard line.

Taking Tarleton's handoff, Keith then used the option to find Zane Williamson downfield for 28 yards.

Lamming moved the ball two more yards up the middle, but an incomplete pass and a sack forced the Coyotes to call a time-out with :53 to play in the half, facing 4<sup>th</sup> and goal.

After offsetting penalties gave the Coyotes a second chance on the 4<sup>th</sup> down play, Keith found Trey Soto in the end zone for six points.

The PAT run by Bullinger was good to make it a 9-8 game at halftime.

A long, sustained drive by the Eagles to open the second half kept the ball out of Coyote possession and resulted in a score for Ropes.

The score, at the 3:43 mark of the third quarter, put Ropes up 14-9.

Bullinger went to work and found holes in the Eagle defense not only on his 22yard kickoff return but on a 43-yard scamper downfield for a touchdown.

However, a block in the back call negated the touchdown, as the Coyotes had to return to the line of scrimmage and try again.

The next effort—with rushing efforts by Bullinger and Keith—was successful as Keith scored on a 10-yard rush with 2:11 left in the quarter.

The Coyotes were back on top at this point, 15-14.

Lamming's solo shot on the kickoff return kept the Eagles at bay on their own 20-yard line.

Bullinger got through the line and forced a 5-yard sack and Keith added a solo shot to put the Eagles in a 4<sup>th</sup> down situation.

With only 30 second left in the third period, Ropesville was able to convert and move the ball downfield, stopped short of the goal line by Bullinger's tackle.

On the next play, the back and forth momentum continued as Chapman sacked the Eagle runner for a seven-yard loss.

Facing 2<sup>nd</sup> and goal from their 25-yard line, Ropesville continued to be harassed by Coyote defenders as Chapman's rush forced an incomplete pass.

The Coyotes had dodged a bullet but could not capitalize on their next offensive possession.

Ropes came back to score midway through the final period and regain the lead, 20-15.

Not to be outdone, the Coyotes quickly answered with a scoring drive. Bulling made good yardage on the kickoff return and then scored on a 15-yard sweep with 1:55 left in the game. BHS led 21-20 but the game still wasn't over.

A shanked kick gave the Eagles good field position as they began their drive on their 34-yard line with less than two minutes to play.

Soto provided some stellar defensive play that included a sack and a heavy rush on 4<sup>th</sup> and 17, which led to an incomplete pass.

The Coyotes had held and with :39 to go in the game, Keith took it in for an 18-yard touchdown.

Tarleton completed a PAT pass to Dore Rodriguez to make it a 28-20 lead.


Tarleton's interception ended the Eagles' final chance to knot the score as the Coyote jv claimed their first win of the season.

Next action will be in Ira following the jr. high game Thursday.



yards after eluding the Eagles in the backfield with a slick change of direction.

The PAT kick gave the Coyotes a 45-28 lead with 7:32 remaining.

That lead would appear comfortable except for the fact that this story takes place in six-man land and the opposing quarterback had already thrown for 148 yards in the first half alone.

Like any good story, irony is a key element. Remember when something happens that isn't expected.

The unexpected led to a score for Ropes--they caught everyone off guard by not throwing the ball on their next possession.

They ran it--all the way to the end zone, scoring on a the game.

Their two-point conversion narrowed the margin to 45-36 with plenty of time left for both teams to pull off a win.

Thomas did his part on the kickoff with a 31-yard return to the Coyotes' 35-yard line.

Thanks to key blocks by Wallace and Roper, Thomas picked up 10 yards on the first play from scrimmage, moving the ball into Eagle territory.

At this point, BHS tried to use up the clock, running the ball but facing a 4th and six on the 36.

Lozano came through with a 16-yard run to get the first down and at least four more downs for BHS.

Tarleton waited patiently in the pocket on an option play and found Pinkerton for some yardage, but another rush resulted in a loss of yardage.

Ropes called a time out with 3:05 left in the game with the ball resting on the Eagles' 18-yard line and the Coyotes looking at a 4th and

In what was perhaps the final turning point in the contest, Pinkerton found Carter racing downfield and

placed the ball perfectly in for a 18-yard stride touchdown play.

Once again, Pinkerton-who was involved in all scoring possessions except one--split the uprights as the Coyotes scored their 23rd point of the quarter.

Leading 53-36, Coyotes knew that Ropes would have to score three more times in less than three minutes to win. The Coyotes -also knew that stranger things have happened in six-man football.

So they continued to apply heavy pressure, courtesy of Wallace and Lozano, on the Eagles' next-to-last possession. Their presence in the Ropes' backfield gave Pinkerton the opportunity to two-yard run with 7:08 left in do one of the few things he hadn't done on the evening: intercept a pass thrown hurriedly by a frazzled Eagle quarterback.

Lozano also recovered a fumble in the final few seconds after the Coyotes fumbled the ball away one more time.


Well, that concludes the story. It was a dandy and if it were a movie, some accolades would have to go to the three seniors for stepping it up when the troops were down 28-16.

The next story hits the stands Friday night as the Ira Bulldogs bring their game to town--look for another bestseller as the Coyotes hope to take their record to 2-




Adam Carter #10: Making holes for the Coyotes.

Pinkerton's 70-yard kickoff return in the third quarter brought some life back to the Pups, but the second-half scores to deny the Pups a comeback.


Midway through quarter, BJH fourth threatened to score, moving the ball down to Ropes' seven-yard line.

But the Eagles held and sealed the victory with a touchdown run of their own.


