Last year BHS was the State Champion speech team and Lindsay finished second.

Junior Rachel Wilson closed out the point scoring for BHS with a sixth place medal in Current Issues and Events.

The CI&E team also competed this year at the State Meet. Along with Wilson, team members were Clary, Reynaldo Hernandez, and Karl Lamming.

Joining Dobyns in Austin was the 2006-2007 Spelling team: sophomore Katherine and freshmen Froman Chellsie Pigford and Brendan Tarleton.

Four sponsors accompanied the eleven statequalifying students: Darrin Ard, Sue Jane Mayes, Cindy Herridge, and Charla Soto.

Herridge and Soto will be assuming UIL responsibilities next year upon Mayes's retirement from UIL coaching.

Coyotes Slide Into Final

Borden The County Coyotes played their final 4 baseball games of the season over the final 8 days of the regular season. The Coyotes ended that eight day stretch just like they started district play, by winning 3 of the 4 games played. The Coyotes started district play with 3 wins and 1 loss and they ended district play with that identical record of 3 wins and 1 loss. The only problem though, was that they were 0 and 6 in the middle of the district season.

Coyotes The actually played the 2nd ranked Hamlin Pied Pipers to a very competitive contest prior to the final game, which was better than any team in district had done with the state ranked Pipers throughout district play. This meant that the Coyotes actually played great baseball over the final 5 games of the season. They lost to Hamlin 9 to 3 before playing the final 4 games during that 8 day stretch.

The Coyotes matched up with Hermleigh for the first time and immediately took care of business in this contest as they built a quick 2 to 0 lead on their way to a .13 to 2 victory.

Leading the way for the Coyotes in this contest was winning pitcher Quentin Shafer who pitched 4 innings and gave up only 1 run on 6 hits. Quentin had 1 walk and 5 strikeouts as he improved to 2 wins and 1 loss on the season.

Hitting stars in this contest were Clint Chapman who was 1 of 2 and scored 3 runs, Quentin was 3 of 4 with 2 runs and 3 RBI's, Zane Williamson pitched 1 inning giving up 1 run on no hits and struck out 2 and he also

and 2 RBI's with a double and a triple.

Flynn Chapman was 3 of 3 with 2 doubles, scored 2 runs and 3 RBI's, Jacob Froman was 1 of 4 with a run scored, Miller Valentine scored a run and had an RBI on a perfectly executed squeeze play. Karl Lamming added 2 of 3 with a triple and 2 RBI's and Michael Cooley rounded out the hitting with a 1 of 2 day and a run and an RBI.

The Coyotes would next play Roby for the 2nd time this season. This game was rain shortened, but was filled with History in it's short Flynn Chapman time. became the first ever Coyote pitcher to throw a no-hitter. In fact, this game could have been a perfect game if not for back to back hitters that reached base on a dropped strike, because of this, Flynn had to get 5 outs in the 2nd inning. Flynn had 7 strikeouts in the 5 inning shortened contest due to rain. The Coyotes bats did not fair much better, but they did put together 2 good solid hits that were enough to give them their 5th district victory of the year and a sweep of the Lions.

Flynn Chapman led off the 2nd inning with a double and then stole 3rd base. A fouled off attempt at a squeeze play forced Miller Valentine to battle and have to hit away. That is just what he did as he lined a shot down the 3rd base line that drove in the only run of the game. When the rains came, the game was called after 4 1/2 innings and a legal game which gave Flynn the no-hitter and the Coyotes a victory.

The Coyotes next traveled to Ira to take on the 2nd place

was 3 of 4 with 2 runs scored Ira Bulldogs. They jumped out to an early 3 run lead as they put together a single by Michael Cooley, a walk by Clint Chapman, Quentin was hit by a pitch and then a perfectly executed squeeze play for a bunt single by Michael Bullinger to give the Coyotes a 1 to 0 lead. After Flynn struck out for only the 3rd time of the season, Zane Williamson hit a 2 out double up the middle to drive in 2 more runs and a 3 to 0 lead The Covotes would leave runners on 2nd and 3rd, but felt good about their chances. But however, in the bottom of the inning, the Bulldogs were given some help by the Coyote defense as they committed 4 errors in the inning along with an untimely balk that led to 8 unearned runs for the home team Bulldogs and chased starter Clint Chapman from the game. Clint pitched great, he just was unfortunately the recipient of poor defense behind him in that 3rd inning **Softball** recipient of poor defense which resulted in an 8 to 3 lead for the Bulldogs.

> In the 5th inning, the Coyotes got another run as Clint Chapman walked and By Coach Avery then stole 2nd. Quentin Shafer singled up the middle to drive in Clint. Quentin was later thrown out at home when a pick-off attempt got away from the Bulldogs, but when Quentin tried to go from 2nd home he was thrown out on a super play by the Bulldogs. The Coyotes never really threatened the rest of the game. Quentin pitched the remainder of the contest when he took over for Clint in the 3rd inning as he gave up no hits while striking out 5 Bulldogs. The final score was 8 to 4 in favor of the home town Bulldogs. Clint Chapman was 1 of 2 with 2 runs scored, Quentin was 1

of 3 with a run and an RBI. Michael Bullinger was 1 of 3 with a squeeze RBI. Zane Williamson was 1 of 2 with 2 RBI's, Michael Cooley was 1 of 2 with 1 run.

The Covotes would come back to this same field because of rain to play the Hermleigh Cardinals in the final game of the Coyotes actual baseball season. The weather forced this game to be moved from Snyder to Ira. in order to get the game in due to the wet conditions. The Coyotes were able to play every Coyote baseball player in this contest and were able to pound out 15 game called by the 10 run rule.

With this victory the Coyotes improved to 9 wins and 8 loses on the season and 6 wins and 8 loses in district.

Ouentin Shafer again was the winning pitcher in this contest as he came a dribbler . away from pitching a nohitter. 








Above - Deja vú... Kate Wallace receiving her second consecutive gold medal in Persuasive Speaking from UIL State Speech Director Jana Riggins.





Poisonous Plants in Borden Co.


surrounding counties have been experiencing some poisonous plants have been identified. Two of the most commonly found poisonous plants that have been identified in our area are Woolly Loco weed and Threadleaf Groundsel.

Woolly loco is a stout perennial legume. The leaves have 19-29 ovateoblong leaflets which are densely hairy. It usually grows in localized patches commonly in flooded draws, but is frequently associated with buffalo and blue grama grassland. Horses are partisheep and goats may develop loco poisoning as well. Animals poisoned from loco are extremely nervous. The most common signs are slow, staggering gait, rough coat, staring look, emaciation and muscle incoordination. The signs of locoism may not be apparent when the animal remains quite, but when subjected to strenuous muscular exertion signs of locoism appear. Complete recovery rarely occurs.

The stems have leaves on them except at the base and also have variable hairiness. Yellow flowers are produced throughout mild winters and the blooms are abundant following summer rains. Threadleaf groundsel is a native weed or half-shrub, usually growing in association with native grasses. On Texas ranges cattle are most often poisoned. The advanced stage of the disease is characterized by continuous walking, the sudden appearance of nervous disturbances and frequent voiding of small cularly susceptible but cattle, amounts of liquid, bilestained feces. In the advanced stage, the poisoned animals are likely to attack any moving object that may be near. Death soon follows the appearance of the advanced stage of disease.

Sometimes due to over grazing livestock will often graze on these poisonous weeds and will become deathly ill. If these weeds are present in your pasture the best thing to do is to Threadleaf groundsel is a rotate pastures and try to Also if
