> During the one and a half subpoenaed as witnesses by the cont estants. More than 130 of the subpoenaed witnesses were sworn in a mass swearing at the Tuesday morning opening. Judge Boone gave instructions to the sworn witnesses and released the majority of witnesses with orders to return to the courtroom on Wednesday morning.

> During the first day of testimony, only seven witnesses were called to the stand. The first witnesses were Dr. Jerry Gleason and County Attorney Roger Gorrell. They were followed by former hospital district board member and secretary Don Harmon who testified for approximately four and one half hours. Harmon was followed on Tuesday by Mrs. Bernard Phelps, board secretary; Neal Dillman and Sam Damron, board members; and Dr. Charles G. Lewis, hospital

in effect paid taxes. The contestants failed to prove that any of the witnesses were "illegal voters" as each of the witnesses testified that they owned or leased property subject to taxation. This made them eligible to vote under the United States Supreme Court ruling in the case of City of Phoenix, Arizona et al vs Kolodziekski.

Mrs. Rudolf Moraw, who was a presiding judge at the Needmore voting box, testified Wednesday morning. She explained the facilities at Needmore where the election was held. When asked by Attorney Crawford as to the number of polling places in Muleshoe School District elections, she testified 'one at Junior High in Muleshoe". She further testified that it had been the custom to have only one voting box in the school district elections since she had been in the district and that some voters travelled at least thirty miles to vote in school

district elections. County Clerk Hazel Gilbreath, in her twelfth year of office, was questioned at length on records of the County Commissioner's Court regarding all past county elections. She testified that "in normal elections there were seven voting boxes and four in County Commissioner's precinct elections since 1918 and in the January,

1970, redistricting precincts". She further stated that if the county is combined into two districts, Muleshoe and Needmore were about equal in distance and distribution to properly divide the county.

She further testified "It has been the custom until this election, I think, for commissioner's court to set up (establish placing of) voting boxes but was left to the hospital board they appointed, on this matter (election)"

Despite the harrassment and inconvenience caused more than 130 people who were summarily subpoenaed into District Court, with most of them wondering why they received a subpoena in the first place, only approximately 25 people had to take the witness stand in the suit.

More than 100 more people, most of them working people, had to lose time and wages waiting to see if they would have to testify.

Many Bailey County residents, qualified voters, who have been property owning taxpayers for years, were listed as 'illegal voters' in the suit and are highly upset. Several have indicated they would like to have a public apology from the contestants as they feel their personal integrity, as well as their right to vote, has been questioned.

It is very apparent that both parties have had their day in court and given an opportunity to be fully heard. A fair and impartial decision has been rendered by the court after hearing all the facts.

Bailey County desperately needs the time and energy of all its citizens to solve other pressing problems. Bailey County cannot afford the luxury of wasted energies and talents over issues which should be finalized.


