Seed Certification Change

College Station --- Texas producers shopping for certified planting seed for the 1977 season will see a change in the certification label accompanying each bag of seed. Starting next year, seed will be certified for genetic identity only. Although the new certifica-

tion label assures that the seed is the variety stated on the label, the big change is the fact that it does not relate to any seed quality factors such as purity, inert matter, other crop seed, weed seed, noxious weed seed and germination. The Texas seed law, however, still requires that this information be truthfully stated on the analysis label accompanying the seed.

"The change in seed certification which becomes effective Jan. 1, 1977, means that producers will have to pay particu lar attention to the labels on the seed bag," emphasizes Dr. Robert B. Metzer, cotton specialist for the Texas Agricultural Extension Service. "The certification label will tell them what variety the seed is, and the analyses label will provide information on quality factors."

Both labels tell the complete story about the seed, but keep in mind that quality factors can vary even though the seed is certified," notes Metzer. SEED CERT. CONT.

Certification for genetic identity means that seed has been produced and processed under standards and procedures estab-lished by the Texas Seed and Plant Board and enforced by the Texas Department of Agriculture to assure that the variety is as represented by the certification label accompanying the seed.

"Reading the label has always been of importance in purchasing seed, but the new standards will place even greater responsibility on the producer to carefully read both labels to determine if the seed meets his quality requirements." points out Metzer.

SECTION 1: That an election shall be held on the 14th day of August, 1976, in the Borden County Independent School District for the purpose of submitting to the resident qualified electors of said District the following propositions: That an election shall be held on the 14th

A friend of hers took this recipe and used it to develop the candy now known as "Millionaires" and "Turtles". This recipe makes about 60 pieces.

1 c. brown sugar 1 c. dark Karo 2 tsp. vanilla 1/2 lb. heavy cream 1/2 lb. real butter 2 c. heavy cream 1 lb. (4 c.) broken pecans

1 c. white sugar

Place in a saucepan sugars, Karo, butter, 1c. cream. Mix well. Bring to a boil (rolling) and add second c. of cream. Bring to boil again. Turn heat low, stir often to prevent scorching and cook and cook and cook. The mixture will appear so thin one will feel sure it could never thicken to a soft ball, and just keep cooking. Dropping a bit in cold water at first does no good because the mixture separates, but later it will form a

soft ball. Cook to the firm ball stage and remove from fire. Add vanilla anf cool for 10 minutes. Add pecans and beat. (Have buttered pan 2' deep prepared to pour candy to 1). Continue to beat until mixture takes on thick, creamy appearance and pour into prepared pan. Chill overnight or place in freezer for 3 hrs. Cut in squares of desired size. (Mrs. Clayton cut hers in 1' X 2' squares but smaller squares are easier to dip and the candy is very rich.) Dipping:

1 double size pkg. chocolate chips 3/4 bar shaved paraffin

Place chocolate and paraffin in double boiler to melt. Use ice pick or toothpick to dip. Place on waxed paper to cool.





FORT WORTH--Henceforth the supplies for the army posts of suppries for the army posts of the West, hundreds and thou-sands of tons of freight, will be shipped from the "City of Heights." Yesterday, Major Strang, quartermaster of the U-nited States Army, arrived here, in obedience to orders from the War Department and established headquarters here.

SAN ANTONIO-An example will yet have to be made of the drivers of vehicles in this city, for leaving a horse, or horses, standing alone in the streets while they go into houses, generally barrooms. They thus cause runaways dangerous to the lives and property of citizens generally. We demand of the city authorities that they punish every such case to the fullest extent the ordinances allow, except where there is a valid ex-

HOUSTON- The great railroad feat of changing the guage from broad to standard on the Houston and Texas Central began atdaylight this morning. The change is necessary because almost all of the other major roads in the state are built at the narrower guage, necessitating transfer of all passengers and freights going to Houston. Preparations for the change, including new, narrower cars have been in progress for some time. With two teams working, it is expected that the job will be finished by tomorrow morning.

AUSTIN-On July 31, the Legislature rescinded the motion to adjourn sine die on that date and agreed to stay in session until the important pending legislation is finished. The action was initiated by the Senate, and a message from the governor urging the House to concur was sent in the afternoon. After heated debate and controversial parliamentary maneuvers the House agreed. One effect is to give the Texas and Pacific Railroad the extra three weeks it requires to fulfill the requirements of its charter and avoid forfeiture of its lands.
