Dr. Marvin L. Baker, president of South Plains College, Levelland, Texas, will bring the Commencement Address at the High School Graduation exercises on Thursday, May 18 at 8:00 P.M.

Dr. Baker is a native Texan. He was born in Avery, Texas, November 8, 1926. After graduation from high school in 1944, he served in the United States Navy for two years receiving his discharge in 1946. Dr. Baker and his wife, Mildred, have a daughter, Barbara, and a son, Tommy.

Dr. Baker received his Bachelor of Science and Master of Science from East Texas State College in Commerce, Texas. He received his Doctor of Philosophy from the University of Texas in Austin in 1956.

Encumbents Over 50% of eligible voters unopposed. Other of

County

Over 50% of eligible voters in Borden County went to the polls Saturday to cast their votes in the Democratic and Republican primaries.

In the two locally contested races, both incumbents were defeated. County Clerk Doris Rudd lost to Dorothy Browne by a narrow margin. The final tally was Rudd - 191, Browne - 206.

Mrs. Rudd has held the office of County Clerk in Borden Co. for 22 years, defeating five opponents in that time.

Ed Rinehart defeated County Commissioner Van York by an even narrower margin of 70 to 59. This vote was tied in the absentee box of precinct 4, 7 to 7. Rinehart carried the other two boxes, North Gail and Snellings by a small majority.

County Judge Jim Burkett ran

County Follows State Lead

Borden County followed the state lead in the U.S. Senatorial race between Joe Christie and Bob Krueger by giving Krueger a large majority of 201 to Christie's 136. Krueger will be opposed by Republican Senator John Tower in the general election.

Dusty Rhodes carried the county handily in the U.S. Representative race in the 17th District with 178 votes. Following the district trend, the second contender in this 7 man race was Stenholm with 75, followed by Baum 67, Godfrey 24, Sharp 12, Snowden 6 and Mc-Cullough 4. Although Rhodes carried the district, he did not have a majority. This forces a run-off between Rhodes and

Opposes Referendum

Both referendums on the Democratic ballot failed to pass statewide as well as in Borden County.

Failing to pass by a large majority was the referendum proposed by some legislators to increase small loan interest rates. Not one in thirty-one West Texas counties voted FOR this referendum. Unofficially it failed to pass state-wide by approximately 10 to 1. Borden County vote was 20 for, 324 against.

In the non-binding referendum to permit pari-mutual betting in Texas, the county return was 169 for, 184 against. This is close to the margin held state wide.

Lack of an overwhelming defeat may imply prospects for a future victory, according to the Texas Horse Racing Assoc.







Proclamation Signed

The United States' annual loss of five million acres of rural land to non-agricultural use was a special concern during this year's celebration of Soil Stewardship Week April 30-May 7, W. L. Wilson, Jr., chairman of the Upper Colorado Soil and Water Conservation District announced today.

This year's Soil Stewardship Week theme, "Compelling Ventures," also stressed the importance of controlling water pollution caused by run- off from unprotected farms, racches, roadsides, and construction sites Wilson added.

Soil Stewardship Week is a nationwide observance which emphasizes man's responsibility to protect and conserve soil, water, and other natural Traditionally, resources. churches and local citizen's groups participate.

"Nearly 3,000 conservation districts throughout the U.S. focussed their attention upon conserving and preserving America's best farmlands during this 24th annual observance of Soil Stewardship Week," Wilson said. "The U.S. Department of Agriculture estimates that of the five million acres annually lost to agriculture, nearly one million acres are classed as 'prime' land --the best and most productive land we have. We are encouraging the preservation of these top-quality farmlands for farming rather than their indiscrimminate use for housing developments, highways, shop-ping centers, and the like." The county was one of a minority to ally themselves with Governor Dolph Briscoe, defending the Governorship against Attorney General John Hill. Briscoe received 182 votes as opposed to Hill's 164. Former Governor Preston Smith ran a weak third with 33 votes. State wide, Hill defeated Briscoe by more than 150,000 votes.

In the state Senate race for the 28th District Don Workman carried Borden County by a large majority with 204 votes. Closest to Workman in the field of five was former Senator E.L. Short with 80 votes in the county. The margin was narrowed in this race throughout the district, necessitating a run-off in June.

State Representative Mike Ezell ran unopposed as did James Binion, member of State Board of Education.


