McMeans, High School Principal; and Ben Jarrett, Elementary Principal. The meeting was called to order by President Ralph Miller.

Minutes of the last meeting were reviewed and approved. There were no visitors. The school board reviewed the February bills and moved to pay the bills. A school board election

was called for April 5, 1980.

A year-to-date financial report was presented. It was reported that the enrollment in high school was 77 and in elementary 151 for a total of 228 students.

Superintendent McLeroy recommended to the School Board that the contracts of the high school and elementary principals be extended through the 1981-1982 school year. Principals Mickey McMeans and Ben Jarrett were commended by the Superintendent and School Board for a job well done. The contracts were renewed and extended unanimously.

The Board was presented a special printing of House Bill No. 621 (relating to ad valorem taxation of property) for their information and consideration.

There being no further business, the meeting was adjourned. **Coyote Boys Finish Season** 

The Borden County boys basketball team finished their season with a 9-14 season record. In a season that saw many high points and many low points the Coyotes managed to always perform with enthusiasm, hustle, and desire. #### **Take Giant Step Toward State**

Coach Larry Steele and the Borden County Lady Coyotes made a giant step toward a place in the state playoffs by defeating the Klondike Cougarettes for district 9-B the Championship. This is the first championship for the Borden County girls since 1967.

Using a tenacious defense and showing great poise in crucial situations, the Lady Coyotes crushed the Cougarettes 54-45. After jumping out to a 6-0 lead, the Coyotes then led at the quarter 10-7. Again during the second quarter the Coyotes built up a 24-17 lead only to see the score at halftime 24-23. After a dismal 23 percent shooting in the first quarter, the Lady Coyotes hit on 60 percent of their shots in the second quarter.

After halftime, Borden displayed the poise and patience of a champion and outscored the Cougarettes 30-22 the last half. The Coyotes hit on 50 percent of their 3rd quarter attempts and 61 percent in the fourth quarter.

Late in the game, the Cougarettes made a futile attempt to full court press and the result was a spree of 8 unanswered points by the Covotes.

Jana Edwards led the Lady Coyotes in scoring with 19 points and 5 rebounds. Gayla Newton hit for 10 points, 5 rebounds, and 7 stolen balls along with 6 assists. Karen Williams scored 9 points, Talley Griffin 7, Janna Love 5, and Glynda Burkett

The Lady Coyotes are now 29-2 and will play Westbrook Tuesday night,

February 19 in Big Spring for Bi-District. Should the Coyotes win Tuesday they will play in the Regional Tournament in Levelland Friday at 2:30 p.m. -s- LM



Con't from P. 1 with government-funded consumer groups, government-funded anti-beef nutrition groups, and others who threaten our

industry. Yes, there are some individual farm and ranch organizations who make some effort to promote beef and protect the interests of cattlemen as best they can. But no single group now in existence has enough money to do the job that needs to be done. The Beef Board, created by passage of the Beeferendum, will have enough money to expand foreign markets, promote the nutritional value of beef, combat beef substitutes, fight anti-beef propaganda and counter the extreme highs and lows

in the cattle cycle. The Beef Board will be made up of cattlemen, and they'll have the kind of power it takes to meet the opposition head-on.

Whether you think the Beeferendum is government or not doesn't really matter. The important thing is to recognize that cattlemen don't have enough force now to influence factors that affect them. It's important that they take advantage of this opportunity to put some power behind their punch. If the Beeferendum fails, cattlemen will have to admit that they were too scared of power to grab hold of some when it was offered to them.

I'm tellin' ya, now, the jock exploiters are running the world but it's the athletes who are the pawns. The unfairness in the treatment of college athletes has become more and more obvious. But what has really ticked me off is the way the Taiwanese were discriminated against last week at Lake Placid.

The athletes from Taiwan asked to be excused from the Winter Olympics because the IOC refused to allow them to march and participate under the flag of the Republic of China. Since red China is now most favored (People's Republic), the Taiwanese are just written off---there is no such thing as a flag of the Republic of China---no national anthem--- they are simply people without a nationality. Oh yes, the Taiwanese were begged to participate---and a flag would be given them. They could march in under the Olympic flag, learn a new anthem, pledge allegiance to the IOC, if you will. The United States even ingragiatingly offered the Tai the privilege of marching in with the U.S. participants, under Old Glory. I guess that's our way of ridding US of a guilty conscience - after all, we are the ones who took away Taiwan's national status.

Anyway, Taiwan said no thanks,--- 'The mere suggestion that we have to accept any flag but our national flag is a downright insult". But that isn't the end. Taiwan asked to "be excused" rather than march under a substitute name and different colors. Here's the catch; they made it plain that they were asking to be excused from the games rather than withdrawing. You see, there are severe penalties for withdrawing. How about that, sports fans? You are penalized for withdrawing from games you aren't allowed to participate in under your own flag---makes sense doesn't it?

Just about as much sense as the IOC saying they are not political. Can you tell me anything less political then the Taiwanese situation? It has absolutely nothing to do with eligibility or athletic prowess. But it has 100 percent to do with politics.

And isn't it strange that while Russia is committing an aggressive act of war upon a relatively free nation, their athletes are allowed entrance to the games? In fact, an inorginate amount of TV time was devoted to the Bears as they paraded around the stadium carrying the symbolically deadly hammer and sickle.

Another funny thing--the U.S. representative to IOC mutters that Cyrus Vance jeopardized the United States' position by asking that summer games be removed from Moscow. So in a snit, the IOC voted to continue plan A-games in Mescow-as scheduled. Can you tell me why our representative didn't withdraw our name right then in support of duty, honor and country? I tell you, I am fed up with athletics which have become nothing but mercenary exploitation of the physically gifted.

Correlated the Olympics with the scandals you are reading about in college athletics and you see a dirty game being played. The winners are the unprincipled exploiters, the losers are the poor sweaty jocks.

teacher Bev Copeland with awe. Tammy also said of her aunt Jean "Wow, Jean can do two things, she's a hair do-er and a dancer.


Even tho they claimed to be nervous, it looked like the couples were having as Much fun performing as the audience was watching them.

1979 Crop Deficiency Payments - Cotton

No deficiency payment will be made for the 1979 crop of Upland cotton. The weighted average market price received by farmers during the entire calendar year (1979), has exceeded the target price of 57.7 cents per lb.

Producers already participating in the program, should continue to report changes in livestock numbers and turn in all feed receipts, signed by the seller.



retirement we wonder if the renovation of the court house, working in all that noise and dirt at this time has figured in her decision. She assured us it d.d not.





Cotton farmers from O'Donnell, Garden City, Tahoka and Fluvanna were on hand for a Cotton Production Meeting at the Plains Community Center last Friday. Dr. James Supak, Area Agronomist, spoke with the farmers on Cotton Production. He covered subjects such as weed control, furrow diking, catton varieties and production practice. Dr. Supak emphasised the importance of planting depth (2 inches) and planting date (when soil temperature is 60 degrees F. at 8 inches for 10 consecutive days.)

Marvin Sarun, Area Economist Management, was also on hand to visit with local farmers. After discussing cotton prices and marketing tools, Marvin related what he felt farming would be like in 1990. He stressed that with the profit margin getting narrower and narrower that management skills, especially financial management, will be a must.

Another production meeting is scheduled in April at Fluvanna. It will put a little more emphasis on insect control and soil fertility so be watching for it.






