# **No Place but Texas!**

"No place but Texas!"-it costs less to live! a family resource management specialist says.

In other states, families need \$20,517 to maintain an "intermediate level" of living, but in Texas, they need less, Nancy Granovsky reports.

Mrs. Granovsky, on the home economics staff of the Texas Agricultural Extension Service, The Texas A&M University System, cites recent family-budget-figures released by the Bureau of Labor Statistics for the "latest-Texas-brag" material.

This brag is no joke, either, she says.

According to the report, Dallas families can buy that same "intermediate level" of living for \$18,301, and Houston families can get it for \$19,025.

These budget figures are derived from what it would cost an urban family of four -- that is, an age 38 husband, employed full-time, a non-employed wife, a boy age 13, and a girl age 8 -- to buy specific goods and services for a whole year at autumn, 1979 prices.

Dallas and Houston are the only two areas in Texas for which specific data were collected.

There's even more "brag"

to the report: Texas costs less a lower and at higher-budget levels, too.

At the lower-budget level, families in other states would have to spend \$12,585.

However, Dallas families would pay only \$11,687, and Houston families would spend only \$12,100 to maintain the same level of living. On the "high side," families in other states needed \$30,317 to stay in that living standard. Dallas families who wanted to live at these higher-budget levels only had to spend \$27,004, and Houston families needed \$27,686. Why?

We would like to see a 100 percent voter turn out in Borden County. The voice of rural America must be heard loud enough to become a reckoning factor in the *change* of the federal government.

# McLeroy crowned Most Beautiful






A discussion was held concerning the fruit sale project. The fruit sales began October 21st and will continue until November 3.

# **Coyotes Beat Hermleigh**

The Coyotes beat Hermleigh last Friday 50-38 to bring their season record to 5-2 and loop record, 2-1.

The Coyotes scored first as Sam Williams carried the ball over from one yard out with 3:12 left in the first quarter. Junior Benavidez kicked the two point conversion, giving the Coyotes an 8-0 lead.

Kenny Riley received a pass from Kevin Roemisch and ran 18 yards to put the Cardinals on the board with 27 seconds left in the first quarter. Hermleigh followed 8-6.

Sammy Williams scored again in the second quarter on a 20 yard run. The kick was no good. Soon after, Mike Peterson raced over from 6 yards out with 6:40 left before halftime, enlarging the Coyotes advantage 20-6.

A minute later, Jones ran for 27 yards to score for the Cardinals. Mike Nachlinger kicked the P.A.T. The score was 20-14, Coyotes.

Sam Williams made his third touchdown of the night on a 52 yard run and Junior Benavidez kicked the P.A.T. Roemisch passed to Ted Olsen for an 18 yard TD pass. The conversion try was no good.

Early in the third quarter, quarterback Jym Rinehart took the opening kickoff and raced 65 yards to score. Benavidez's kick made it 36-20.

Rinehart continued to pace the Coyote third period effort as he recovered a Cardinal fumble at the Borden County 23-yard line, then passed to Troy King for 35 yards to set up shop on the Hermleigh 2 yard line. Peterson ran over on the next play and with 4:15 left in the quarter, Gail led 42-20.

With 2:50 left, Riley ran another Hermleigh touchdown. King blocked the PAT. Roemisch threw to Olsen soon after for another TD.

The Coyotes clinched the victory with 6:10 left to play in the game as Rinehart tossed to Bart McMeans. Benavidez kicked the P.A.T. Riley made his third


touchdown of the evening for Hermleigh, but the time soon ran out on the clock and Borden County had another win in their pocket.

Now that you have been thoroughly indoctrinated as to how to vote, the next task is getting you to the polls. The apathy of those registered to vote (and that figure is pitiful) is mind boggling. It is estimated that less than half of those registered will actually pull the lever-that some 75 million who are voting age will not bother.

Why--why, for goodness sake don't people exercise their privilege of helping direct the coarse of history? There have been lots of second guessing and high falutin sociological theories

falutin sociological theories voiced explaining the reasons for the nation's indiference and maliaise. Some say folks just don't care--that their vote doesn't matter--that they tried it once and it didn't make a dent in the way things turned out. Some say they don't trust the system--or that they are just little, plain people and aren't a part of the system.

There are many who have worked their telephone ears off and walked their feet to nubs only to lose the good fight. This year they are embittered and believe it impossible to elect a conservative. And then there are those who simply don't know what is at stake--they don't understand nor have they been told the real issues by the candidates. The campaign has been a scurroulous one. Reagan was put on the defensive immediately and has had

little opportunity to do anything but wipe mud out of his eyes. Carter has meanly continued to ask questions implying, "Are you still beating your wife?" David Lawrence of U.S.

News asked some years ago: "Irrespective of who is elected, the real question is: On what course will the ship of state sail in the next several years? How will the next Administration answer, for instance, these

question:" He then listed 6 questions which he felt the voters deserved to have answered but that had been glossed over in the game of party politics. That was in 1964---the year of the really big smear---the year Goldwater was thrown in a mud hole early on and never was able to climb out. That was the year a lot of us became disillusioned.

But Lawrence's questions that went unanswered then carry more pertinence today---and they still go unanswered. We listen to the innuendos and accusations and some of us try to ferret out the course the nation will take. A lot of us realize what is at stake. Yet 25 percent have yet to unravel the campaign rhetoric and are still undecided. This election will be decided by that undecided vote--and most likely right here in Texas. But more important are those who have lost interest, given up and won't vote. Some say, "Well they deserve what they get!"---that may be but I don't deserve what they will get. You and I who have gone to the trouble of stuydying platforms and voting records don't deserve what the apathetic are apt to foist upon us. So what to do---get out the vote---the future of US is at stake in 1980.

But what if you aren't part of a four-member urban family? Other report figures the

same story. For example, single people (under age 35) trying

to maintain an intermediate level of living in Dallas would pay \$6,405. In Houston, they would pay \$6,659.

However, in any other state it would cost \$7,180. A one-parent family with

A one-parent family with two children trying to maintain the lower level of living would have to spend \$8,882 in Dallas -- and \$9,196 in Houston. But in any other state it would cost \$9,564.

What do these "made-up" budgets really tell us, though?-- and what do they not tell us?

Mrs. Granovsky says they do not tell us what it really costs people in Texas to live. Instead, they say what a "standard" marketbasket of goods and services costs in two areas of Texas and in other regions of the United States. This marketbasket includes items ranging from food and housing to toothpaste and taxes, but it certainly does not cover everything Texas residents or those of other states really buy, the specialist adds.

However, the "made-up" budgets do provide one thing: a way to compare budget costs across the United States, and, no matter how they do it, the answer is still the same It costs less to live in Texas.






Plan ahead for Christmas gift giving to save time, money and frustration.

TEXAS CROP AND LIVESTOCK REPORT

From mid-November to early January, many Texas farmers and ranchers will receive a crop or livestock questionaire from the Texas Crop and Livestock Reporting Service or will be personally interviewed by the Service's field staff. All of the estimates published by the Texas Crop and Livestock Reporting Service are based on the data provided by Texas farmers and ranchers, County Extension Agents, ASCS offices, and many others in agriculture. This cooperation provides the necessary data which is, in turn, returned to farmers and ranchers and others in the form of accurate estimates, which are so essential in making the wisest production and murketing decisions. Each farmer or rancher receiving a questionnaire is urged to fill it our carefully and return it promptly to the Agricultural Statistician in Austin. Individual reports are confidential and used only for state and county estimates.

**1981 NCA NOTICES** 

1981 crop year normal crop acreage (NCA) notices will be mailed October 28, 1980. Producers are requested to plan their NCA requirements now for the 1981 crop year. As in the past, any producer on the farm may request the county committee to reconsider any entry on the form he-she believes is incorrect or inequitable.

The request must be in writing and delivered to the County Office within 15 days of the mailing date shown. This will give producers in Borden County until November 12, 1980 to file request for additional NCA acreage.

The County Committee has a limited reserve, however the State Committee has held in reserve an acreage that will be available to meet bonafied needs, based upon the producer's written appeal, where a change in farming operations has occured.

EMERGENCY FEED PROGRAM

Livestock producers that have not applied for assistance under the program are still offered an Overwhelmingly endorsed by 82% of the Texas lawyers.


# Vote to Keep Judge Will Garwood on the Texas Supreme Court

opportunity to apply. To be eligible, the producer must be feeding his livestock in quantities above normal. He **must not** have sufficient feed for his eligible livestock and have suffered at least a 40 percent loss in feed and pasture production.

#### CROP DISASTER

Remember you must file your application for disaster credit **before** plowing, grazing, or making other use of the failed crop acreage. If the crop is harvested, then you must file within 15 days after harvest is complete for the crop in question.

It is very important that requests are filed timely as you could lose your disaster payments.

DROUGHT DISASTER LOANS

The Small Business Administrations's (SBA) declaration No.1900 for drought has brought much needed assistance to the agriculture industry in Texas.

The disaster victim is eligible for crop losses sustained during the 1980 growing season providing the crop was in the groun during the incident period of the declaration, regardless of the harvest date. Partial crop losses will be computed only after harvest and determination of actual yield.

The following formula will be used to compute eligible loss:

Acres planted x established yield x percentage of loss x market price (less insurance received, less ASCS low yield payment and other recoveries) equal eligible loss.

Farmers and ranchers have until February 12, 1981 to file their physical loss applications under this declaration. Agriculture-related businesses have until May 12, 1981 to file for Economic Injury Disaster Loans. Producers in Borden County are eligible for losses during the period 5-30-80 through 8-5-80 due to drought conditions.

1981 FARM PROGRAM Disaster provisions have been extended and will cover the 1981 crops.

Eligibility for participation in all programs administered by ASCS is established under law without regard to race, color, religion, sex, or National origin.




