The winner of this years beef were Mr. and Mrs. Jim Smith of Gail. Processing of the 1000 lb animal was

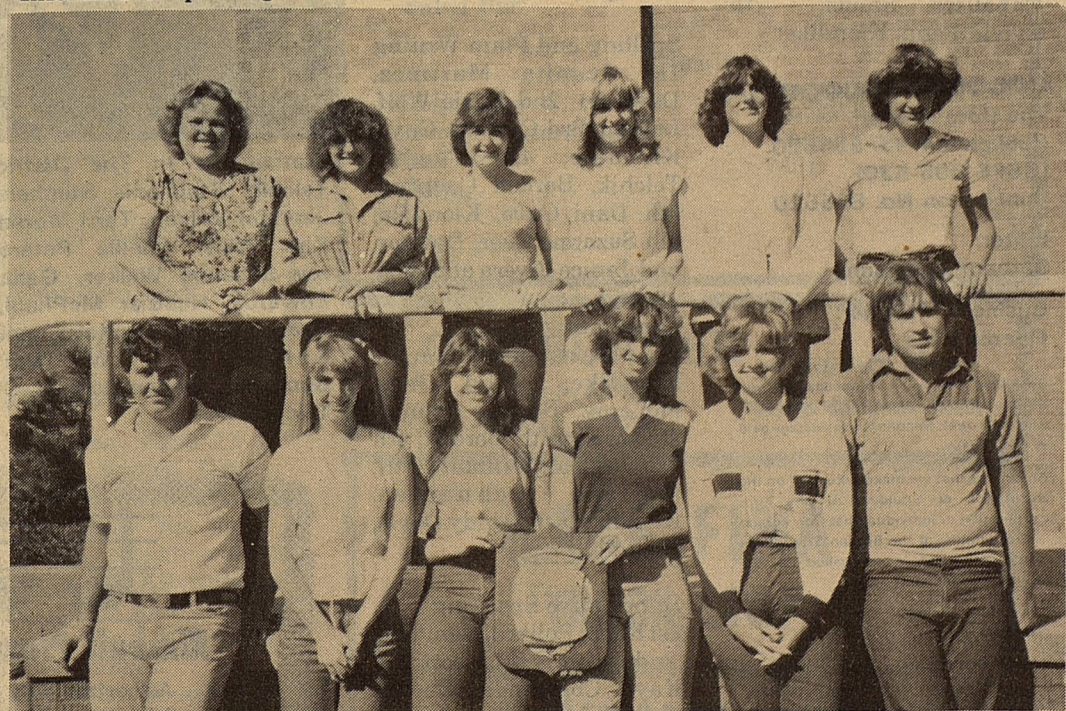
donated by Town and Country Meat Center of Snyder, a generous gift to the Crusade.

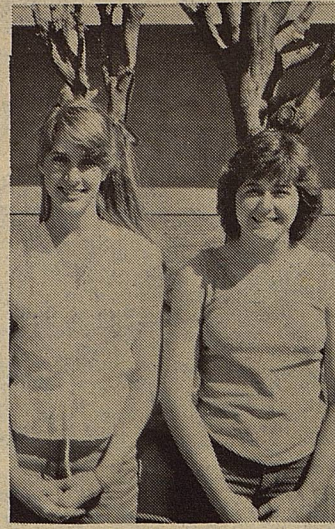

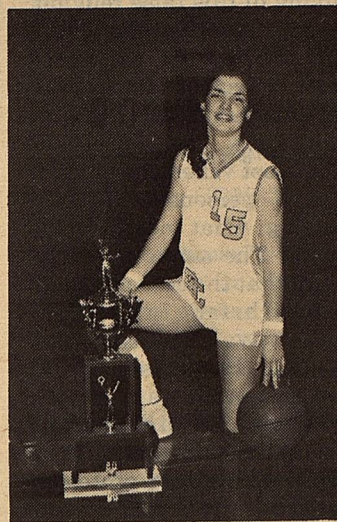
41-38 in regional play. This also marked the 3rd year that Griffin has made first team all district.

Boys Place 3rd at Loop

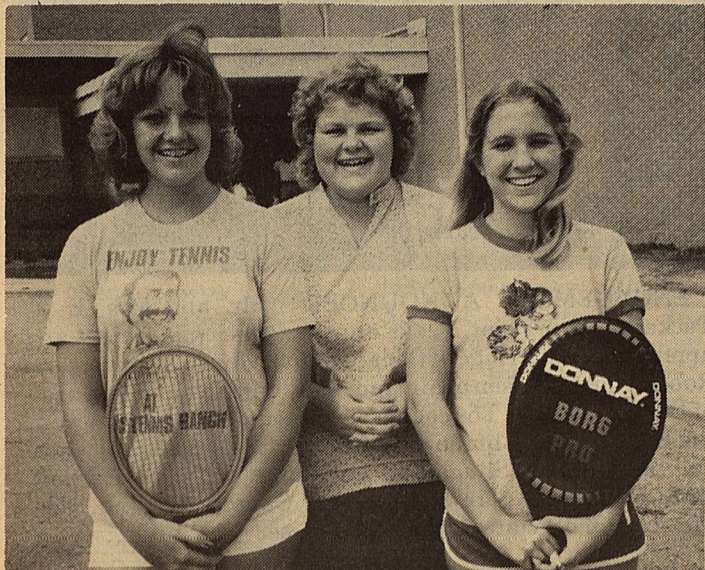

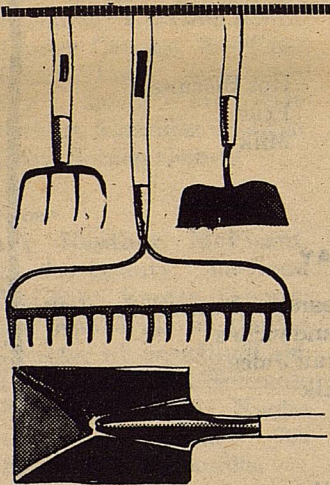

Students Aid Crusade

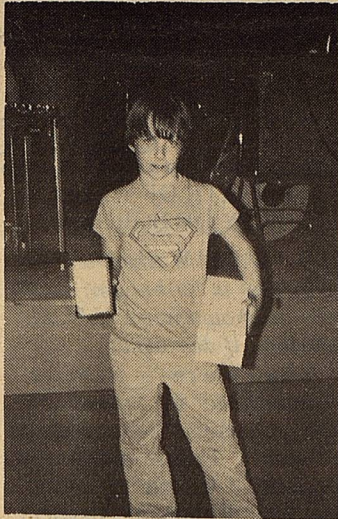
Students of Borden County Elementary school accounted for \$800.00 of the steer raffle this year benefiting the Borden County Cancer Crusade.

Your County Agent Says by Alan Day

RABIES A CONSTANT THREAT

Rabies continues to be a constant threat in Borden County. Pet owners should make sure their animals get yearly vaccinations.

Cases of rabies usually increase with the advent of warm weather, so current vaccinations are especially important in the battle against rabies.

Veterinarians recommend annual rabies vaccinations for all dogs and cats three months of age and older.

Last year was a generally light year statewide for rabies cases in dogs and vats, with 46 and 34 confirmed cases, respectively. However, of the total number of 945 confirmed rabies cases in Texas, 643 were in skunks. So skunk transmitted rabies is an ever-present problem. Here in Borden County, we have had 3 cases of rabies in skunks in the past 6 months.

Other confirmed rabies cases during 1980 were as follows: fox, 46; bat, 95; raccoon, 8; cattle, 32; horse, 21; and other (goat, sheep, bobcat, coyote, squirrel and opossum), 20.

All skunks that are acting abnormally (around the house in the day time, etc.) should be suspected of rabies. If you do kill one, you should take it to a veterinarian to be sent off and checked.

While little can be done about rabies in wild animals, all pet owners can take a preventative step in protecting their animals with annual vaccinations.

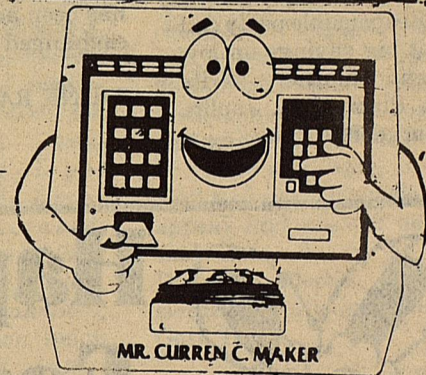

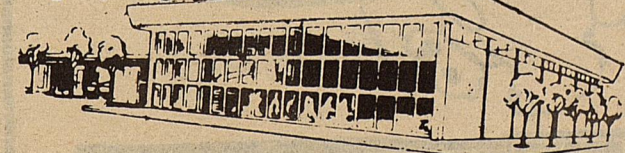

ASCS News

COMMODITY LOANS

The interest rate on commodity loans made after April 1, 1981, is now 14.5 percent. The final date for putting 1980 crop grain sorghum, corn or upland cotton under a price support loan is May 31, 1981.

REPORT SMALL GRAIN ACREAGES

All planted wheat, oats, rye, or barley acreages must be certified by May 15, 1981. To qualify for 1981 program benefits and for crop history in the future, a farm must have a report of acreage filed.

MEASUREMENT SERVICE

Reporting crop acreages accurately is the only requirement for participation in the 1981 Farm Program. For a nominal fee, your crops can be measured by this office guaranteeing the acreage and assuring you of full program coverage.

PREVENTED PLANTING

If a producer is prevented from planting spring seeded program crops such as corn, grain sorghum, or cotton due to a natural disaster or other reasons beyond his control, an application for prevented planting credit must be filed within five days from the final planting

date. The final planting date established for these crops in Borden County is: Corn-May 15, Grain Sorghum-June 20, and Cotton-June 15.

NO 1980 CROP CORN, SORGHUM DEFICIENCY PAYMENT

Under current legislation, deficiency payments are made to producers when the average market price received by farmers during the first five months of the marketing year (October through February) is less than the established "target" price.

The national weighted average price received by farmers during the October 1980 through February 1981 period was \$3.11 per bushel for corn and \$3.04 per bushel for sorghum. Since these prices are above the 1980 target price of \$2.35 per bu. for corn and \$2.50 per bu. for sorghum, no deficiency payments are required.

EMERGENCY FEED PROGRAM (EFP)

Just a reminder that all applications under the emergency feed program will expire April 30, 1981. You must furnish feed purchase documents for EFP assistance to the county office by May 30, 1981. No assistance will be paid for documents furnished after this date. You are also reminded that feed for which assistance is paid upon MUST BE FED BY APRIL 30, 1981. Also feed for which assistance has been paid shall NOT be exchanged or sold.

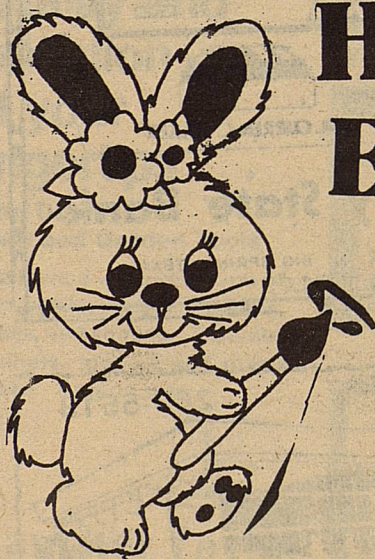
