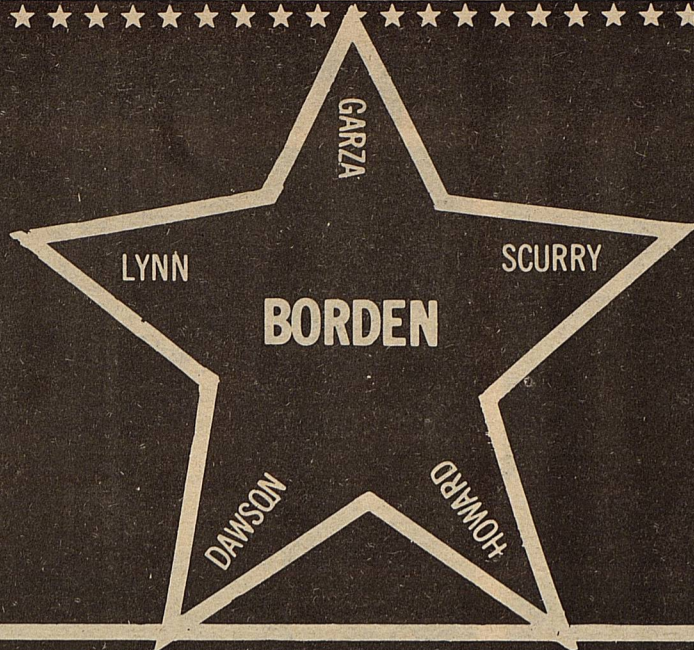

## President Reagan Proclaims Small Business Week

A study found that in a recent seven year period, small businesses with less than 50 employees created 56 percent of all the new jobs in the Nation. Small business directly or indirectly provides the livelihood of more than 100 million Americans.

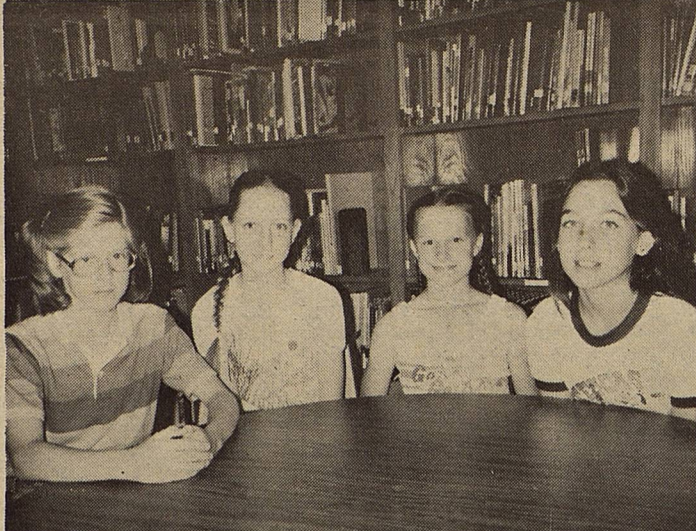
The President urged all Americans involved in small business to continue their resourcefulness, adding that "it is with justifiable pride that the American small business man can point to himself as the backbone of our Nation."

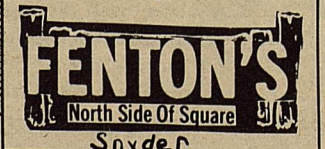

Some of the other area schools and their ratings were Loop, III, Whiteface II, Wilson II. Judges for the event were Sam Roberson from Snyder, G.T. Gilligan from Kermit, and Charles Traylor from Abilene.

In the 800 meter run, Jeanette Massingill came in 1st for the second year in a row and Ronda King and Cindy Balague placed 2nd and 6th respectively. The principal objective of American civilization is to get organized. Any impromptu, disorganized, unscheduled or unrehearsed activity without rules, coaching and supervision is subversive and anti-social. Uniforms must be provided for all participants in games and scores must be kept so that there can be trophies, ribbons, contracts or letters of intent prepared for the winners. The alternative is anarchy.

If there are no new movies to be seen, there is nothing good on TV, and no activities have been planned, everyone is going to die of boredom unless something is provided for people to do, especially young people. The spectre of ennui is so horrible that young folks are bound to turn to drugs or alcohol to escape from its fearsome clutches, and society must be blamed for not furnishing enough programmed activities to occupy their idle time.

There is the possibility, of course, that some spare time can be taken up by working for pay and making a contribution toward the family income or the future expense of a college

education. There is also the real satisfaction to be derived from a solitary effort that doesn't require organization and, as a matter of fact, may be hampered or distracted by it. Getting good at playing the guitar or painting a picture or reading a foreign language is accomplished mainly by solitary practice, once the basics have been learned. Without human company there is the pleasure of raising and training an animal, such as a bird dog or a sheep dog, and there can hardly be anything more satisfying than the training of a saddle horse to work with the rider in roping calves and cutting cattle. After dark, a couple of buddies restoring a junk car or repairing an engine, or building a couple of canoes for use next summer find that there's not enough time. Being organized is okay, but it limits initiative and imagination and the sense of personal pride that is provided by the solo effort. Making a dress, flying an airplane, playing the piano, painting a masterpiece, running the Marathon, none of these require being a member of a team or belonging to an organization. This type of individual project, of course, requires more initiative and personal effort than joining a club or being on a team.

For the person who has the desire to create and the inner drive to work without waiting for some

organization to plan his schedule for him, the opportunities for individual accomplishment are probably greater, on the whole, in Gail, Texas than they are in Stockholm, Washington, London, or Moscow, where every activity is organized, with a committee, a bureau, a title, an administrator, and a budget; and freedom thrives in towns like Gail while it chokes to death in the world's capitals.

## Work At Home Offer Be Careful

Tempted by a "work at home" offer?

Be careful, and proceed with caution, or create your own "work at home" business, advises Linda McCormack, a family resource management specialist.

Mrs. McCormack is on the home economics staff of the Texas Agricultural Extension Service, The Texas A&M University System.

In many "work at home" cases, the potential "employee" or "investor" (you) is asked to send a membership or registration fee to a company "for more information" or "to obtain the materials necessary to start the job," Mrs. McCormack notes.

Too often, these "job materials" and "investment secrets" turn out to be simply promotional literature, not work, she says.

If you want to make money at home, and if you have an idea of what you want to do, place your own advertisement in the paper, the specialist says.

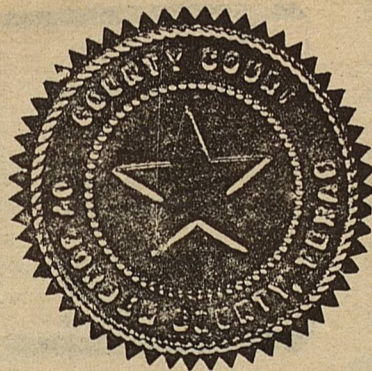

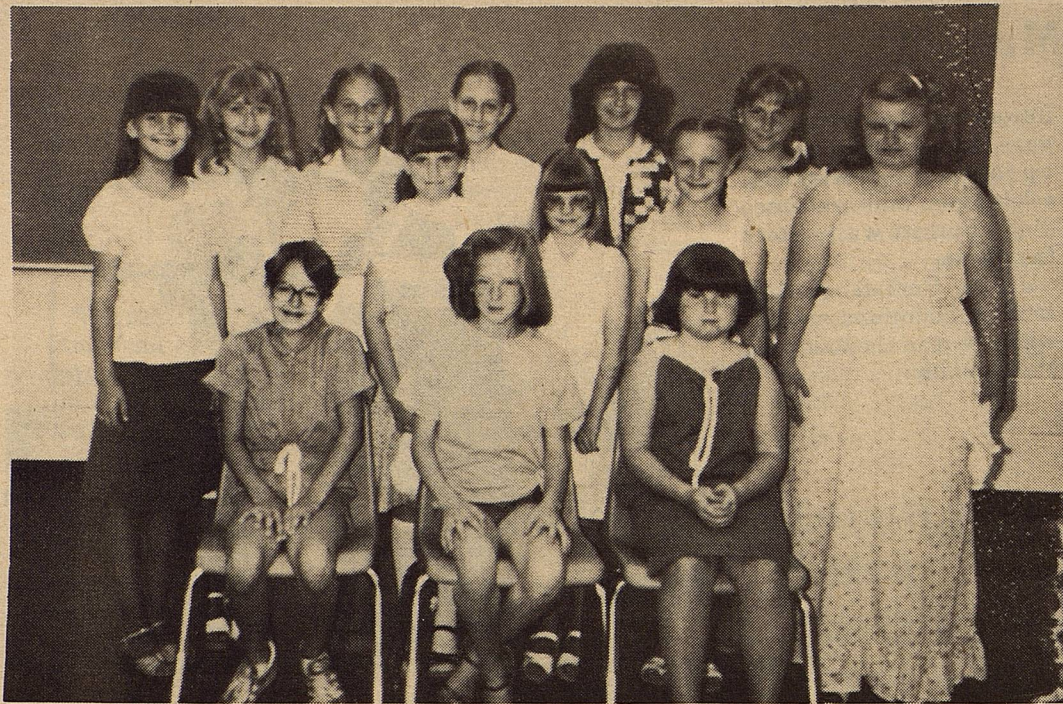

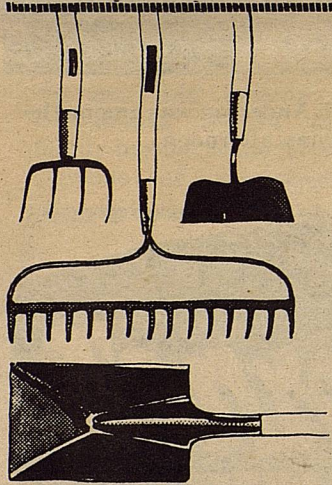

County High School Ag room beginning at 1:30 p.m. The M-44 certification will be done by a representative of the Texas Department of Agriculture. The M-44 is a ground mounted device used to control coyote populations.

Certification for the M-44 is for life requiring no recertification. This allows you to purchase all needed materials to set your own control program.

In conjunction with this program, there will be a trapping seminar done by Joe Gilmore. Mr. Gilmore is a local trapper and will show some techniques for setting traps and snares.

This portion of the program will begin at approximately 3:30 and will conclude between 5:00 and 5:30 p.m.

Make plans to attend this program if you have coyote problems and want to know more about trapping. This will be an excellent opportunity for you to be licensed and learn more

about controlling coyote kills.

### PECAN MANAGEMENT SHORTCOURSE

There will be a tri-county Pecan Management Shortcourse given May 19th at the Plains Community Center in Borden County. The program will begin at 8:30 a.m. and will conclude at 12:30 p.m.

Dr. George McEachern, pecan specialist from Texas A & M, will be on hand to give the program. Topics to be covered include spraying, grafting, planting and general pecan management.

The program will begin at the Plains Community Center and will move to the Herman Ledbetter Orchard to get an actual first look at what will be discussed. Come prepared to go out in to the orchard and get a first hand look.

### FABRIC PESTS ABOUND IN SPRING

Springtime brings about uninvited visitors into the house that are often overlooked, fabric pests.

Carpet beetles and clothes moths are a continuing problem in Texas, particularly since more woolens are being worn today either as a 100 percent fabric or the popular wool synthetic blends.

Such materials should be stored properly during the off season to protect them from these pests.

Before storing, dryclean all woolen fabrics, including clothing, blankets, coats and scarves. This removes all growth stages of fabric pests, from eggs to adults.

After drycleaning, store fabrics in clothing bags, using liberal applications, of moth balls or crystals. Blankets and other large or bulky items can be stored in plastic garbage bags or wrapped in heavy kraft paper and tightly sealed with tape. Be sure moth balls or crystals are inter-layered with these goods prior to sealing.

Another method of ridding fabrics of potential damaging pests is to hang them outside in bright sunlight during the hottest part of the day for several successive days. Make sure both the inside and outside of the garments are exposed to sunlight. Follow this with vigorous brushing.

Another good practice in battling fabric pests is to empty closets and vacuum them thoroughly. Wool feeding pests can live on natural accumulations of lint found in corners and on shelves and baseboards. After cleaning, apply a residual household spray.

With proper care and maintenance, woolen clothing and other goods will be protected from fabric pests and will be shipshape for next winter.

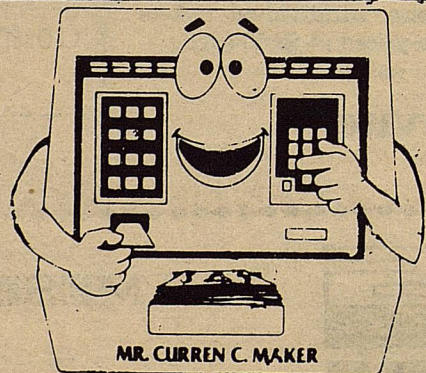

### RECORD CHANGE

Please help keep our records up to date by notifying this office of any changes in your farm acreages, change in address, sale of land, etc.

### EMERGENCY FEED PROGRAM

All receipts for feed purchased during the feeding period ending April 30, 1981, must be filed by May 30, 1981.

Producers are reminded that an amount of feed equal to that purchased under the Livestock Feed Program must be fed to the applicant's livestock during the feeding period. Feed left on hand at the end of the feeding period cannot be sold, traded, or disposed of by any method other than feed the applicant's livestock.

### 1980 COMMODITY LOANS

The final availability date for price support loans on 1980 crop cotton and grain sorghum is May 31, 1981. The interest rate on 1980 commodity loans is still 11.5 percent for the life of the loan.

### 1981 LOAN INTEREST RATE

The 1981 commodity loan interest rate has been raised to 14.5 percent. The rates will be reviewed October 1st and April 1st each year and may be adjusted up or down during the period the loans are outstanding.

### SMALL GRAIN CERTIFICATIONS

The final certification date for small grain acreages of wheat, barley, oats and rye is May 15, 1981.

All small grain acreages whether planted for grazing or for harvest as grain should be reported timely.

To be eligible for program benefits under the 1981 program producers must certify by the established crop certification deadline. Reports must also be accurate and cannot vary more than the larger of one acre of 5 percent of the reported acreage.

### MEASUREMENT SERVICE

Measurement service is available for producers who are not sure of the acreage planted to program crops for harvest during the 1981 crop year. An accurate certification is one of the eligibility requirements of the 1981 Farm Program.

### Can vitamins prevent cancer?

HOUSTON, TX. — Vitamins are proving more than mere breakfast supplements. Scientists are studying compounds found in several common vitamins to learn more about the growth and development of cancer cells.

Dr. Guy R. Newell, director of cancer prevention programs at The University of Texas M. D. Anderson Hospital and Tumor Institute, explains that retinoids, components of vitamin A, are attracting considerable scientific interest for their ability to control cell growth in certain body organs.

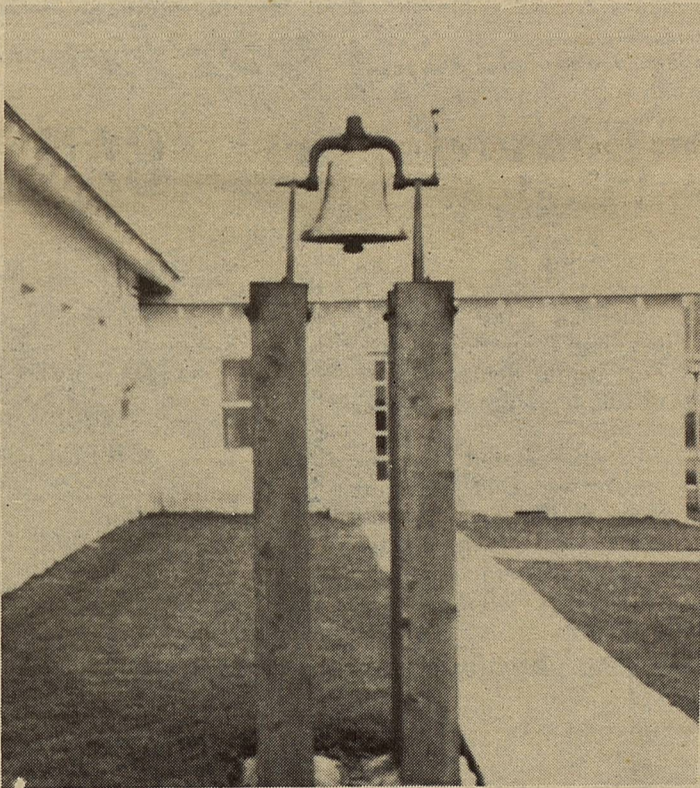
"Retinoid deficiency may improve the ability of a carcinogen (cancer-causing agent) to act on the cell's DNA," he says. "DNA serves as the blueprint for normal cell replication. Scientists hope eventually to find ways to supplement the diet to prevent, slow down or even reverse the development of cancer at this basic cellular level."

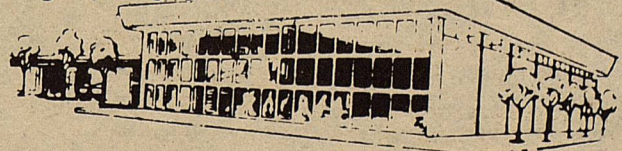
